County Commissioners proposed to be chairpersons of county education boards

The Ministry of Education has drafted the Basic Education Bill, 2024, for legislation to appoint County Commissioners as chairpersons of the County Education Boards (CEBs). This would mark a departure from the Basic Education Act, 2013, which is set

to be repealed. The Act currently stipulates that the Cabinet Secretary appoints an educationist with at least five years of experience and based in the county. In a press statement sent to newsrooms, the Cabinet Secretary for Education, Ezekiel Machogu, stated that the Bill would,

however, retain the County Director of Education or their representative as the Secretary to the County Education Board, consistent with the current Basic Education Law. The proposed changes were unveiled during the stakeholders' forum on the Draft Sessional

Paper and Bills to implement the recommendations of the Working Party at the Kenya Institute of Special Education. Machogu, who presided over the occasion, said the changes followed recommendations by the Presidential Working Party on Education Reforms (PWPER), which was

established to address the various challenges observed across all levels of Kenya's education system. In attendance were the Principal Secretaries for the State Departments of Basic Education,

State set to transfer remaining devolved functions to counties

In December of last year, President William Ruto gave the Department of Devolution and IGRTC two months to document and transfer all the devolved functions that remained with the National Government to the counties

The National Government is evaluating land assets as a precursor to the full transfer of the properties to the counties. The Principal Secretary for the State Department for Devolution, Ms. Teresia Mbaika Malokwe, said her Department is currently undertaking the valuation of land assets in partnership with 30 county governments to determine their condition and financial status before they are fully transferred. Ms. Mbaika noted that the Inter-governmental Relations Technical Committee (IGRTC) has prepared a report of the devolved functions that need to be transferred to counties in line with the Presidential directive that sought to unbundle the remaining functions from the national government. In December of last year, Pres-

ident William Ruto gave the Department of Devolution and IGRTC two months to document and transfer all the devolved functions that remained with the National Government to the counties. Speaking in Naivasha during the Second Intergovernmental Relations Symposium organized by the

IGRTC, the PS said an appraisal of the last 12 years had shown that devolution is working. She said there was a need to enhance the skills gap and capacity for county governments to enable them efficiently to handle transferred functions with billions of shillings that come with this transfer. “As we transfer the functions, there is a need to enhance skills, the capacity of the counties, and enhanced funding for the people to get value from the transferred functions,” Mbaika stated.

She at the same time called for enhanced accountability of resources at the counties to ensure Kenyans get value for money in terms of resource allocation and service delivery. “There has been concern about management of funds in the counties and we appeal to counties to ensure that the taxpayers get the services they pay for with their taxes,” the PS said. Ugenya Member of Parlia-

ment (MP) David Ouma Ochieng' on his part said the ongoing process of transferring remaining functions to counties would empower devolved units more in terms of influence, economy, and resources.

He called for continued agitation for the transfer of all remaining functions and powers in line with the local laws and policies already adopted.

Ochieng', who is also a member of the Speaker's Panel in the National Assembly, also noted that the transfer of more resources to counties should follow the transfer of functions adding that this would empower more people at the local level which would then turn around the fortunes of millions of citizens.

The MP however called on counties to effectively commit to prudently utilize and invest the transferred resources for the benefit of locals and at the same time advised county governments to enhance their revenue collections by moderniz-

ing their systems which would help seal leakages exploited to siphon public funds.

This, he said, would address frequent disputes and grind locks that have seen county governments lock heads with the national government over delays in disbursement of funds and on revenue sharing formula.

The MP called for the adoption of Alternative Dispute Resolution mechanisms to unlock

emerging apprehensions between the two levels of government outside the legal framework which hinders and delays key decisions.

The IGRTC Chair Kithinji Kiragu decried what he termed as rampant corruption in the counties and called for accountability and transparency on the part of the county governments, adding that public servants should serve wananchi with dedication and integrity.

Technical Vocational and Technical Training, and University Education and Research: Dr. Belio Kipsang, Dr. Esther Mutoria, and Dr. Beatrice Inyangala, respectively.

The Cabinet Secretary assured the stakeholders that the government would restore the Sh22,244 capitations for the Free Days Secondary Education programme.

"The reduced capitation to Sh17,000 was due to the restrictive fiscal space. The restoration of Sh22, 244 will help secondary schools to operate," he noted.

The changes in the Universities Bill, 2024 seek to bar universities from offering diploma programmes.

Machogu (pictured) said the universities should restrict themselves to offering graduate and post-graduate programmes and leave diploma and other certificate courses to middle-level colleges.

Among the public documents the Ministry of Education presented



to stakeholders for discussion and comments included the Sessional Paper on a Policy Framework for Education Reforms in Kenya, 2024.

"The sessional paper will anchor all the recommendations in the Report and provide the vehicle through which the Report will be presented to Parliament for adoption," the CS said.

The bills were the Technical and Vocational Education and Training Bill, 2024, the Kenya National Qualifications Framework (Amendment) Bill 2024, Tertiary Education Placement and Funding Bill, Kenya Literature Bureau (Amendment) Bill, 2024 and Kenya National

Examinations Council (Amendment) Bill, 2024.

Others were the Kenya Institute of Curriculum Development (Amendment) Bill, 2024, the Basic Education Bill, 2024, the Education Appeals Tribunal Bill, 2024, the Basic Education Scholarships and Bursaries Bill, 2024, the Science Technology and Innovation (Amendment) Bill, 2024 and the Universities Bill, 2024.

The Stakeholders were drawn from teachers' unions, faith-based organizations, vice-chancellors of public universities, members of civil society, senior education officials and all the semi-autonomous organizations in the education sector.

Government allocates Sh5b for subsidized fertilizer distribution across all 47 counties

The government has allocated Sh5 billion for the provision of subsidized fertilizer, which will be distributed to farmers across the 47 counties during this long rainy season. Government Spokesperson Isaac Mwaura stated that the government's program on the distribution of subsidized fertilizer has positively impacted the country's agricultural sector in the last three quarters of 2023.

"The sector grew by 6.1 percent in the first quarter, 8.2 percent in the second quarter, and 6.7 percent in the third quarter," he said.

Speaking at Konza Technocity in Machakos County, the Government Spokesperson announced that eighteen counties are also set to benefit from Sh4.5 billion under the County Aggregated Industrial Parks Program.

He said each county will be allocated Sh250 million, which they will

utilise to create job opportunities for the youth and promote the local manufacturing industries in their areas.

Counties that will benefit include Bungoma, Busia, Embu, Garissa, Homa Bay, Kiambu, Kirinyaga,

Machakos, Meru, Migori, Mombasa, Murang'a, Nakuru, Nandi, Nyamira, Siaya, Trans Nzoia and Uasin Gishu.

Mwaura added that the County Governments Additional Allocation Bill, 2023 has provided addi-

tional Sh46,362,301,459 to counties for financial year 2023/2024, where Sh10,116, 848,690 is an additional allocation from the National Government's share of revenue that has been set aside for the implementation

of the fertilizer subsidy, industrial parks and construction of county headquarters.

The Bill has also allocated Sh454 million to five counties for construction of county headquarters offices in Isiolo, Lamu, Tana River, Tharaka Nithi and Nyandarua.

The Government Spokesperson said the purpose of constructing the headquarters in those counties is to promote devolution and ensure appropriate infrastructure necessary to perform their respective functions.

Uwezo Fund unveils tailored loan products to boost regional economies

The Uwezo Fund is in the process of developing loan products specifically geared towards improving each region's value chains to spur economic growth in those areas through the production of unique items by women and youth.

The Principal Secretary for Small and Medium Enterprises (MSME) Development, Ms. Susan Mang'eni, singled out the Ushanga Initiative in Kajiado County, through which women make and sell beads both locally and internationally.

She emphasized the need to replicate this initiative by encouraging

youth and women in other regions to produce specific products from their areas to earn a living, with support from the Uwezo Fund. Ms. Mang'eni, speaking in Kajiado South Constituency during the Joint Economic Empowerment Sensitization Program and Cheque Issuance event held at Shapashina Stadium, Oloitokitok, issued Uwezo Fund cheques worth Sh .5 million to 21 groups.

She kicked off the one-week sensitization forum, stating that the multi-agency sensitization program, dubbed the 'Mashinani Sensitization Initiative,' will establish crucial linkages and un-

lock opportunities within the MSME space in this county.

The PS mentioned that the joint sensitization team will proceed to engage in interactive capacity-building programs in Rombo, Kimana, Kuku, Entonet, and Mbirikani wards.

The multi-agency capacity-building program will integrate various components supporting MSMEs' development in the constituency, including training and capacity building, technology adoption, access to affordable finance/credit, acquisition/modernization of infrastructure, creation of market linkages,

In a land where tradition and modernity dance in harmonious rhythm, the legislative proposal stands as a beacon of progress, illuminating the path toward a future where the guardians of tradition are duly recognized and justly rewarded. As the bill's provisions take root, they herald not merely a change in policy, but a testament to the enduring spirit of community, and the timeless wisdom of Kenya's village elders.

On the sidelines of the Second National Executive Retreat in Naivasha,

Nakuru County, Dr. Raymond Omollo, Principal Secretary for Internal Security and National Administration alongside Senior Security and Administration Officers from the Ministry as well as representation from the Office of the Attorney General and Department of Justice, State Department for Public Service, State Department for Performance & Delivery Management, Public Service Commission (PSC), Salaries and Remuneration Commission (SRC) and Kenya Institute for Public Policy Research and Analysis (KIPPRA), participated in a consultative review that focused on development of a framework for engaging village elders, including methods for their recognition and support.

Rising HIV infections prompt urgent action in Kisumu's fishing communities

The National Synchronic Disease Control Council (NSDCC) has launched an outreach program to contain fresh HIV infections among the fishing community in Kisumu County.

Through this initiative, the NSDCC aims to train and enhance the capacity of 140 Beach Management Unit (BMU) leaders to bolster the fight against the virus.

Steve Kathaka, the Kisumu and Siaya Regional HIV/AIDS Coordinator, stated that the targeted BMU leaders would undergo a Training of Trainers program on curbing new HIV infections, teenage pregnancies, and sexual and gender-based violence (SGBV). They will then cascade this information to their peers.

Kathaka added that each of the BMU leaders would reach out to 700 others working under them to effectively convey the message.

He emphasized that the focus on the fishing community is due to the rising numbers of new infections within this group, which undermines the progress made in combating the virus.

"Data shows us that a significant number of new HIV infections occur within the fishing community. That's why Kisumu, Siaya, Homa Bay, and Migori counties rank among the top five in HIV burden in the country," he said.

He attributed the rise in infections to the migratory nature of fishermen and the availability of cash

which fuels transactional sex.

This, he added, has further contributed to a sharp rise in teenage pregnancies in Kisumu with up to 6,000 cases reported in Kisumu County in the year 2022.

The trend, he said, is worrying since the teenagers who get pregnant are also exposed to HIV adding to the number of new infections in the area.

"The number of cases is worrying because the same route for the pregnancies is the same route for HIV transmission," he said.

SGBV, he added, was rampant amongst the fisherfolk in Kisumu with Nyakach, Nyando and Seme Sub-Counties recording the highest number of cases.

This, he said, was attributed to the nature of the work since fishermen venture into the lake and stay away from their families for days and when they return home conflicts arise.

Speaking at Asat Beach in Kisumu County during the launch of the three days' outreach program, Kathaka said the BMU leaders will receive training on HIV prevention, use of PREP and PEP and adherence to Antiretroviral therapy and Tuberculosis (TB) drugs.

Adherence to ARV treatment and TB drugs, he said remains a big challenge among the fishing community adding that the BMU leaders shall be equipped with the necessary information and materials to educate their peers on the importance of taking the drugs.

"This is a mobile population and adherence to treatment and attendance for health talks is wanting. As they venture into the lake some of them forget their drugs at home thus interfering with their treatment," he said.

"That is why we are saying as you go fishing and you are on treatment please carry your medication with you so that you remain healthy," he said.

The TOTs, he added, will also be engaged in sensitizing the community against non-communicable diseases especially cervical cancer which is on the rise in the area.

Caused by Human Papilloma Virus (HPV), which is common in uncircumcised men, he said, NSDCC has embarked on a programme to scale up Voluntary Medical Male Circumcision to reverse the tide.

The interventions, he said, are set to create a demand for services and regenerate the vigour of fighting HIV in the area.

Nakuru County shifts focus to regional markets for agricultural growth

The County Government of Nakuru is implementing a range of strategies through public-private partnerships to enhance value chains in crops and livestock, supporting the pillars of food and nutrition security, growing exports, and reducing imports.

She further disclosed that, in line with the Kenya Kwanza manifesto, her administration had also put in place measures to

revolutionize agriculture from a subsistence activity to an agro-enterprise that provides residents in the region with employment and a source of gainful employment.

"It is the conviction of the Kenya Kwanza leadership that sustained agricultural growth is critical in uplifting standards as well as generating rapid growth to this nation," Governor Kihika said.

"I have advised my team to work on the comparative advantage of a value chain for each of the eleven (11) sub-counties.

She noted that KEMSA has undergone significant reforms, adding that through the regional network, the agency would be able to ensure timely distribution of health com-

Additionally, she mentioned that the launch comes with improved technology that will track the tendering and supply processes at the agency to ensure that counties receive the commodities on time.

The Kisumu RDC has so far processed Essential Medicines and Medical Supplies (EMMS) and program orders valued

at Sh295.4 million. These orders are earmarked for Kisumu, Bungoma, Busia, Siaya, and Vihiga Counties.

Additional orders under processing valued at Sh152.8 million include Kericho, Kisii, Nyamira, and Migori Counties.

KEMSA Board Chairman Irungu Nyakera emphasized the transformation of the facility into a vibrant hub which is seamlessly connected with the National Supply Chain Centre in Embakasi.

Pottery is one of the oldest forms of art that gained a lot of popularity worldwide and greatly contributed to helping mankind solve some of the challenges faced.

In the new millennium, however, pottery has been largely viewed merely as a decorative art of beauty and scenery, rather than as a means to address and solve some of the challenges humanity is currently facing. For instance, it offers a viable solution to climate change, pollution, and lifestyle diseases.

For many years, pottery has entailed the process and product of developing vessels and other objects with clay and various raw materials. These items range from functional vessels, such as plates and bowls, to decorative pieces like tableware, ornamental items, and sanitary wares.

However, with changing technologies and innovations, the world has been swiftly transitioning from traditional earthenware to metallic and plastic products, which have significantly contributed to global pollution and climate change.

According to Ms. Robbie Felix, a Pamacoltrist and Founder President of Planeta Sano, ceramics or pottery are forms of earthenware that have been utilized since the inception of the art to conserve our environment.

Felix, a Costa Rica native, states that the prevalent modern mentality favoring disposability is what ails the world, leading to human-made calamities like pollution and climate change.

The Planeta Sano organization has been sup-

porting women and youth groups in Kenya and Uganda in permaculture activities to enable them to safeguard their local environment and embrace traditional agricultural methods for healthier living.

In Kenya, the organization has been assisting women's groups like the 'Rongo Women Permaculture' in pottery making for economic development and fostering environmentally friendly surroundings.

However, in the twenty-first century, the numbers of traditional pottery craftsmen and women have dwindled, with the few remaining primarily found in remote African villages. Felix emphasizes the importance of passing down craftsmanship knowledge to future generations, highlighting the role of pottery in conserving our already polluted environment. She notes that Africa has a large pool of educated youths who require minimal training to work in agriculture and pottery sectors to generate income.

Damaris Anyago, a member of the Rongo Women Permaculture group, reveals that by embracing permaculture, the community can benefit

from the health advantages and environmental conservation offered by pottery. Using clay pots, for example, to cook meals not only enhances flavor but also adds nutrients like potassium to food.

Potassium, a mineral found in clay soil, plays crucial roles in the human body, such as facilitating nerve response to stimulation, muscle contraction, and regulation of blood pressure. Anyago

notes that the group earns a maximum of Sh2,000 daily through pot sales, indicating the Migori community's growing appreciation for this forgotten artistic lifestyle.

She acknowledges that the introduction of modern kitchen technologies like metallic pots and plastic utensils led to the abandonment of pottery due to perceived drawbacks such as weight and difficulty in use.

New rail wagons to clear 100,000 tonnes of cargo backlog in Mombasa

The Government has commissioned 430 new rail wagons to improve efficiency in the country's freight services. The arrival of the wagons will also bolster the clearance of a backlog of 100,000 tonnes of steel pellets, coils, and other loose cargo at the port of Mombasa.

Speaking in Mombasa during the commissioning exercise, State Department for Transport PS Mohamed Daghar said the

wagons will enhance the capacity of the Standard Gauge Railway (SGR) and the Metre Gauge Railway (MGR) by gradually replacing the current wagons that are over 40 years old. The wagons are of different specifications and have additional safety features. They can carry double-stack containers and have a load capacity of 70 and 64 tonnes on SGR and MGR, respectively.

The last consignment of 20 wagons is set to arrive in May, bringing the

total number of wagons acquired this year to 500, where 300 wagons will

be for SGR and 200 are for MGR. In January of this year, Transport Cabi-


net Secretary Kipchumba Murkomen flagged off 50 wagons. "It's really important to increase efficiency at the Port of Mombasa and one way of increasing efficiency is to ensure that the dwell time and ensure both containerised and conventional cargo is discharged efficiently and quickly," said Daghar, speaking at the Portreitz Freight Station.

The PS noted that the best way to discharge bulk cargo like steel pellets and coils is by using the train


system whether it is the SGR or MGR.

He said the government is determined to continue serving the neighbouring land-locked countries through efficient rail transport.

Daghar also said the government is keen to ensure that the northern corridor that starts at the Port of Mombasa to Uganda, Rwanda, Burundi, South Sudan, and the Democratic Republic of Congo remains competitive and efficient.

The Ministry of Education has completed the development of a draft policy and legislative proposals for the implementation of the Presidential Working Party on Education Reforms (PWPER) report and recommendations.

Consequently, Education Cabinet Secretary Ezekiel Machogu has invited stakeholders and the public to submit written memoranda on the policy and legislative proposals for sustainable development in education, training, and research.

“Pursuant to Articles 10 and 232 of the Constitution regarding public participation, stakeholders and members of the public are encouraged to participate in the submission of any input they might have on the policy documents by March 15th, 2024,” he stated.

In August 2023, the PWPER report was launched by President Dr. William Samoei Ruto. Chaired by Prof. Raphael M. Munavu, the Working Party examined the challenges affecting the education sector in Kenya and addressed, among others, access, relevance, equity and quality, governance and financing of education.

The 2024 Sessional Paper on a Policy Framework for Educational Reforms in Kenya repeals colonial education policies that provided inferior education and prepared natives for non-skilled labor and menial work.

This was meant to prepare them to serve at the bottom of society, deepening racism, inequalities, imbalances in access, and discrimination against the natives.

Education, training, and research reforms further present a diversity of cultures and traditions in knowledge, and to champion Afrocentrism in the curriculum, he said.

The Principal Secretary for the State Department of Information, Communications Technology (ICT) and Digital Economy, Eng. John Tanui, has said the government is in full control of the e-citizen platform and dismissed recent allegations that the system is privately run.

Tanui said the system, which has been in development since 2013 and piloted with the support of the World Bank, is foolproof in supporting the digitization of government services, with over 15,000 services onboarded to date.

The PS stated that the government took over the system's operation last year after entering contractual arrangements with local innovators to ensure its interests are met, adding that the process of standardizing the critical system was successfully achieved.

tion, Communications and Digital Economy and the National Assembly Committee on Communication, Information Innovation, led by Dagoretti South Member of Parliament (MP) John Kiarie Waweru, who also chairs the committee.

Eng. Tanui said the digitization programme being championed by the Ministry is based on the Digital Master Plan 2022-23 which was estimated to cost Sh500 billion.

"To this end, we are looking for ways of involving donors in the digitization programme and the World Bank is ready to fund the Konza Technopolis.

DP Gachagua outlines multi-billion strategy for water access by 2030

The Government has developed the first National Water and Sanitation Investment and Financing Plan (NAWA-SIP), which will cost Sh995 billion, as it envisions universal access to water and sanitation by the year 2030.

“To ensure full implementation of the NAWA-SIP, 40 per cent (Sh395 billion) will be from concessional financing, 31 per cent (Sh309 billion) through PPPs, 11 per cent (Sh109 billion) from public contributions including national and county revenues, 11 per cent (Sh109 billion) from donor grants, and eight per cent (Sh80 billion) from commercial financing,” said Deputy President Rigathi Gachagua.

Gachagua said that the government has allocated close to Sh80 billion for the Ministry of Water, Sanitation, and Irrigation in this

Financial Year 2023/2024 for the progressive realization of access to safe water and sanitation services and the improvement of food security in the country.

The DP made the remarks in a speech read on his behalf by Zachariah Njeru, the Cabinet Secretary for Water, Sanitation, and Irrigation during the 2024 Water and Sanitation Investors Conference (WASIC) held at Kenyatta International Conference Centre (KICC), Nairobi.

In the last year, Gachagua disclosed that over four million people have been connected to water by over ten projects completed and commissioned, bringing the national water coverage to 72 per cent.

Although sewerage development has historically remained behind as priority was given to the expansion of water supply services, the DP said that in the past year, 13 towns have been connected with

sewerage services, thus improving urban sewer coverage to 34 per cent.

In the agricultural sector, Gachagua pointed out that the area under irrigation has increased by 7.2 per cent in the past year to over 700,000 acres through the implementation of the National Expanded Irrigation Programme, Community-Based Irrigation Schemes, and other programmes.

“Through the implementation of various development initiatives and programmes, the Government is targeting to improve national water coverage to 80 per

cent, improve sanitation coverage to 85 per cent, and increase the area under irrigation to over 900,000 acres by the year 2027,” the Deputy President said. Whereas investments in infrastructure are a top priority for the government, he noted that a conducive enabling legal, regulatory, and policy environment is a critical success factor in the realization of the country’s ambition of adequate access to water and sanitation services.

“We have developed the Water Act (Amendment) Bill, 2023, which seeks to promote private investment in the water sector through the Public-Private Partnerships (PPPs) model to enhance the sector’s capacity to provide

water services through the PPP financing model,” said Gachagua.

In reaching the underserved, the DP disclosed government plans to construct 100 dams in the next five years and will seek to use the PPP model to harness private sector financing, which will expand the fiscal space for investments in priority programs and projects.

“The ministry is carrying out feasibility studies and designs of over 40 dams with a total capacity of over 200 million cubic meters. This will cushion the country against floods and droughts; provide water for domestic and irrigation use, thus contributing to food and water security,” he said.

Commenting on the

paradigm shift from rain-fed agriculture, Gachagua disclosed that the government has enacted the National Irrigation Policy, Irrigation Act 2019, and Irrigation (General) Regulations 2021, as well as has launched the National Irrigation Strategy to guide irrigation development and contribute to food security.

Njeru noted that in order to ensure sustenance of advancements made in water coverage, adoption of commercially viable governance structures is also essential in water services provision.

He lamented that Water Services Providers (WSPs) are losing revenue through Non-Revenue Water (NRW), which currently stands at 45 per cent.

State commits to revive and position KBC as a regional leader in broadcasting

The Government has initiated measures aimed at aligning public sector advertising policy guidelines with a view to revive and position Kenya Broadcasting Corporation (KBC) as a regional leader in broadcasting.

State Department for Broadcasting and Telecommunications Principal Secretary, Prof Edward Kisiang'ani said that the government is keen to revive the KBC through a modernization framework which will make it the premier national broadcaster in Africa.

"This effort requires the national broadcaster to take the lead in the dissemination of information in Kenya," said Prof Kisiang'ani.

The PS said all public sector electronic (radio and television) advertisements from Ministries, Departments and Agencies (MDAs) that

fall under the National Government, Independent Commissions and Public Universities shall be handled by the Kenya Broadcasting Corporation (KBC) upon authorization by the Government Advertising Agency (GAA).

Prof Kisiang'ani, in a circular sent to all government agencies,

pointed out that the national network coverage commanded by KBC gives an assurance for a nationwide reach by advertisers.

The PS said that the new policy shift is buttressed by the Public Procurement and Asset Disposal Act, 2020 that allows direct procurement, "for the acquiring of goods, works or services provided by a public entity provided that the acquisition price is fair and reasonable and compares well with known prices of goods, works or services in the circumstances."

Going forward, Prof Kisiang'ani said, "It has been deemed prudent to initiate measures to ensure that as public sector advertisers seek to access their target audiences through campaigns and other statutory announcements, the Government leverages on the provisions within its realm to revive and fully utilize its institutions."

World Bank offers Nakuru funds for slum upgrade

The State Department of Housing and Urban Development has allocated Sh1 billion to upgrade informal settlements in Nakuru under the second phase of the Kenya Informal Settlement Improvement Programme II (KISIP). The State under the World Bank-funded program has granted the County Government of Nakuru Sh500 million towards on-going projects to improve access to basic services in the low-income settlements of Kwa-Murogi, London, and Lake View within Nakuru Town and Karagita slums in Navasha.

The initiative, besides slum upgrading, is also targeting the improvement of drainage infrastructure, waste management, improvement of roads in the slums, and installation of street lighting and high mast flood lights.

County Chief Officer in charge of Housing and Urban Development Mr Kamau Kuria said the devolved unit's administration, with development partners including the State Department of Housing and Urban Development and World Bank, had also finalized designs towards the upgrading of Kapkures and Kiratina slums in Nakuru municipality, Mwisho wa Lami settlements in Njoro Sub-County and Tayari low-income settlements at an additional cost of Shs 500 million.

Speaking after the KISIP National Project Coordination Team (NPCT) and the County

Project Coordination Team (CPCT) inspected the ongoing projects in the four settlements Mr. Kuria said the project also entails the issuance of title deeds, laying of sewerage lines and water connectivity among others.

The Chief Officer assured the residents that both NPCT and CPCT were ensuring that the proper project scope was captured by the project consultants to ensure the beneficiaries get value for money.

He added that the County Government was also mapping out possible areas of extension of trunk infrastructure to the settlements to enable access while focusing on investment and socio-economic support for the dwellers.

Kuria, who also doubles up as the CPCT Coordinator, noted that the team of experts from Nakuru Municipality, Environment, Social Services, Roads and Infrastructure, Land Physical Planning, Urban Development, as well as Supply Chain and Accounting personnel, would ensure the success of the projects.

According to KISIP National Project Coordinator George Arwa More than 400 informal settlement schemes in the country are set to benefit from the Sh31.7 billion multilateral donor funding to provide low-cost housing and general infrastructure improvement among other crucial amenities.

The funding has been given out by the World Bank (\$150 million or Sh24.1 billion) and the French Development Agency (43 million

Euros or Sh7.6 billion) and will address infrastructure, water, lighting, and social inclusion in 33 counties.

Mr Arwa indicated that the upgrade designed by the World Bank seeks to enhance land tenure security and improve infrastructure and services such as roads, drainage, pedestrian walkways, and water connection.

The project further seeks to link beneficiaries to socio-economic opportunities and build the capacity of national and county governments to develop and implement slum upgrading and prevention policies and strategies.

"Urban population in developing countries like Kenya is increasing at an alarming rate. By 2020, Kenya had witnessed close to 7.6 million proportion of urban population living in slums while in Sub-Saharan Africa, it is estimated that more than 230 million urban populations currently live in informal settlements. The numbers keep bulging daily," Mr Arwa observed.

The first phase of KISIP saw Nakuru County receive a Sh429.7 million grant from the World Bank that was majorly channeled towards improving the drainage infrastructure, waste management, and tarmacking of roads in eight slums, as well as the installation of flood lights.

The slums that benefited in the first phase included Kaptembwa, the biggest in Nakuru Town with a population of over 120,000.

Others were Kivumbini, Lake-View, Kwa-Ronda, Flamingo, Kaloleni and Bondeni.

State to increase the representation of women in diplomacy

The Government has rolled out robust measures to increase the representation of women in diplomacy, science, politics and industry in order to reduce gender inequality in efforts towards attaining the United Nations Sustainable Development Goals.

The Principal Secretary for Foreign Affairs Dr. Korir Singoei said women have made a substantial impact in diplomacy despite the difficulties associated with navigating the global political landscape.

Dr. Singoei, made the remarks in a statement read on his behalf by the Deputy Director-General, Political and Diplomatic Affairs Ambassador Lucy Kiruthu during a conference on Women in Diplomacy held at the University of Nairobi.

The PS advocated for a

re-evaluation of the position of women in science and technology, while also promoting the involvement of young female diplomats in the ever-evolving fields of engineering, mathematics, and technology.

Additionally, Dr Singoei noted that scientific and technological experts should be integrated into diplomatic negotiations by governments.

“Over the years, diplomacy has been viewed as a feminine role because of their attributes such as

soft skills, leveraging on these skills is essential in fostering peace and bringing change adding that women are the negotiators of change in diplomacy,” he said.

Ms Tatiana Valovaya, the 13th Director-General at the UN Office, Geneva, and the first woman in that position highlighted the significant role that women have played in the development of the various institutions within the United Nations.

Valovaya observed that while women have contin-

ued to play a significant role in peacebuilding and are responsible for changing the face of diplomacy.

“This was notably through their strength and determination especially in taking up roles as diplomats and also at the helm of leadership at the United Nations,” the Director-General said.

She noted that diplomacy is an area that has become important as states realise the fundamental need to strengthen, promote and protect their national inter-


ests and to fortify relations with other states.

The UN Director-General exemplified the role of women in diplomacy citing the 1592 Treaty of the Cambrai (Ladies Peace) where peace was brokered by two women on behalf of the King Francis I of France and Charles V, the Spanish Emperor.

The University of Nairobi in collaboration with the Ministry of Foreign and Diaspora Affairs has been having joint discourses bringing

together practitioners and academics in the discipline of International Relations.

The Women in Diplomacy Conference was centred around conversations on Climate Action and Women, Peace and Security and the role of women, Women and Governance- Perspectives from Multilateral settings, Career Development and Leadership for Women in Diplomacy as well as the Role of a Woman Diplomat in Science, Technology and Innovation.

Taita Taveta receives mobile grain dryers to curb post-harvest losses

Taita Taveta County has received mobile grain dryers from the National Government to assist farmers in mitigating post-harvest losses for their produce.

Agriculture and Livestock Development Cabinet Secretary Mithika Linturi, who launched the dryers, said the equipment comes in handy to ensure efficiency in drying grains to prevent post-harvest losses while enabling the government to realize its vision of improving grain value chains and achieving food security in the country.

“As a ministry, our main mission is to curb post-harvest losses mainly occasioned by unfavorable weather conditions, poor storage, and inadequate drying facilities during harvesting time,” said Linturi at Voi NCPB during the launch, stating that each dryer has a capacity to dry 14 tonnes of maize in two hours and costing farmers Sh70 to dry a 90-kilogram bag of maize.

The CS, accompanied by Taita Taveta County Governor Andrew Mwadime, Crops Development Principal Secretary Paul Rono, the Chairperson of the Agricultural Finance Corporation Board, Eng. John Mruttu, Taita Sub-County Deputy County Commis-

sioner, Maina Ngunyi, among other leaders, encouraged farmers to utilize the mobile dryers to ensure that their harvests are well-dried and stored to avoid post-harvest losses.

The machines tap power from a running tractor engine commonly referred to as power take-off (OTP).

He stated that post-harvest loss management has been a major challenge that farmers have been struggling with stating that,

“We are now ready to start drying our grains as we promised because our main vision is to minimize post-harvest losses, and one of the ways to do this is by supporting our farmers to dry their maize and store it properly.”

The CS guaranteed farmers that the government is committed to supplying 12.5 million bags of subsidized fertilizer this year as per the analysis conducted in collaboration with the 47 county governments.

As a ministry our mission is to curb post-harvest losses mainly due to poor storage - Linturi

At the same time, Linturi launched the distribution of sunflower seeds under the edible oil promotion project by the national government.

He disclosed that for every purchase of subsidy fertilizer, farmers will be given free sunflower seeds as the government seeks to boost sunflower farming aimed at increasing local production of sunflower oil and subsequently reducing importation of edible oils.

Apart from edible oil, the CS said the sunflower's by-products could also be used as animal feeds, hence boosting livestock production in the long run. The CS said the government has stepped in to assist farmers in all sectors so that they can produce more.

Echoing the same sentiments, the Crops Development PS disclosed that the national government has donated about 16,000 metric tonnes of sunflower seeds to Taita Taveta farmers and urged them to make good use of the seeds to maximize production of the precious commodity in the region.

“These 16,000 metric tonnes of sunflower seeds we have brought are very important in producing edible oils and as food for livestock after harvesting, please make use of them so that we can come back

and buy these products at a good price,” Rono said.

Governor Mwadime thanked the national gov-

ernment for the speedy intervention stating that

fertilizer subsidies increased agricultural pro-

duction and the grain dryers will go a long way in helping farmers reduce post-harvest losses.

Machogu calls for timely curriculum revisions ahead of CBC transition in 2027

Education Cabinet Secretary Ezekiel Machogu (pictured) is calling on universities to revise their curricula and ensure that they are aligned with the Competence Based Curriculum (CBC).

Machogu emphasized that timely realignment of higher education curricula with CBC is essential, especially since the first cohort of the new curriculum is expected to transition to universities in 2027.

"I must also add that your universities should now start repositioning themselves for the arrival of CBC graduates from Senior School in a few years," he said.

Mr. Machogu made these remarks in Mombasa County when he officiated the opening of a five-day training workshop for Vice Chancellors drawn from the 42 public universities. Dubbed "Developing strategic, focused, and result-oriented university leaders", the Cabinet Secretary highlighted that the theme resonates with the country's national education development goals.

"It reflects our determination to have in place university administrators who refuse to condone the problems bedeviling

our institutions, and instead burn the midnight oil in search of strategic solutions that align with our national development goals in education," added Machogu.

He further emphasized that good leadership fosters a spirited drive towards providing quality and relevant education for all Kenyans.

"Such leaders can foster a culture of excellence, innovation, and competitiveness in our higher education institutions," the Cabinet Secretary con-

cluded.

At the same time, he defended the new higher education funding model saying it seeks to address the financing challenges experienced by universities.

"You may recall that one of the most disturbing issues that I was confronted with upon being appointed to office was the spiraling pending bills for universities, which stood at Sh60.1 billion," the Cabinet Secretary said.

As a result, the CS said the government has taken deliberate and robust steps to resuscitate universities from the financial and administrative turmoil they had sunk into.

"It is therefore encouraging to note that President William Ruto moved fast to launch the Higher Education Funding Model on May 31st, 2023, which was implemented in September last year to all first-year students with the aim of correcting the financial health of universities," the Cabinet Secretary said.

He emphasized that the New Higher Education Funding Model ensures that beneficiaries are awarded loans, scholarships or both where students are classified into five bands depending on their families' level of need.

Senators pledge swift action to revitalize troubled sugar sector

The once vibrant sugar sector in the country still faces a myriad of challenges despite government intervention.

The bitter-sweet struggle for sugarcane farmers from the Western Kenya region, however, is waning for the struggling sub-sector.

This follows a commitment by the Senate to fast-track the passing of the Sugar Bill, 2022, which is meant to resuscitate the ailing industry.

The Bill has undergone public participation and is currently in the Senate before being enacted into law.

The Bill addresses key issues, proposing the introduction of a sugar development levy, the re-introduction of the Kenya Sugar Board, the establishment of a Sugar Arbitration Tribunal and the Kenya Sugar Research Training Institute, a sugarcane pricing committee, as well as the delineation of sugar catchment areas into five zones.

These zones include the Rift Valley, covering Kericho, Nandi, and Uasin Gishu, and Upper Western, comprising Bungoma and Trans-Nzoia Counties.

The Southern catchment area encompasses Homa Bay, Kisumu, Migori, Narok, and Kisii, with Lower Western covering Busia, Kakamega, Siaya, and Vihiga. The Coastal region comprises Kwale, Lamu, and Tana River Counties. This move aims

to remove unhealthy competition among millers who have previously resorted to buying premature cane, which weighs less, resulting in low returns for the farmer.

The Bill also proposes the introduction of a Sugar Development Levy to be charged on both local and imported sugar to support the local sugar industry.

The levies collected will be allocated where 15 per cent will go for the main-

tenance of local factories, 15 per cent to local research training, and 40 per cent for cane development for farmers.

It further recommends 15 per cent of the levy to cater for the Sugar Regulation Board while 10 per cent will be for roads and infrastructure development in sugar belt regions and managed by the Kenya Rural Roads Authority of the respective catchment areas. The Bill is also proposing that the roles of the Kenya Sugar Board (KSB) currently being undertaken by the Sugar Directorate of the Agriculture and Food Authority (AFA) established under the Agriculture and Food Authority Act, 2013 revert to the former.

Farmers across sugar growing areas have been pushing for the reinstatement of KSB to regulate the sector directly instead of operating through AFA, arguing the latter lacked the autonomy to address challenges in the sugar industry. During a public participation forum held in Kakamega County by the Senate Standing Committee on Agriculture, Livestock and Fisheries, stakeholders supported the recommendations and asked the Parliament to address woes in the sugar sector once and for all.

Chief of Staff calls out rampant corruption in county employment

The Head of Public Service and Chief of Staff, Felix Koskei, has decried the persistent corruption and nepotism in the employment sector across the 47 counties, which he said affects service delivery in the devolved units. Koskei cited the escalating corruption incidents where politically connected individuals illegally acquire public funds through misuse of and tampering with the tendering, procurement, and revenue collection systems.

The Chief of Staff also raised the alarm over illegal payments for duplicated works through

which county government employees collude in paying for projects already undertaken by the National Government.

Speaking in Naivasha during the Inter-governmental Relations Symposium, Koskei regretted the interference in the employment of unskilled, unqualified, and inexperienced staff in most counties, which he noted has affected the quality of service delivery. Consequently, he expressed concern over the bloated workforce in counties, which has seen most budgetary allocations go to recurrent expenditures at the expense of development to uplift the lives of the residents.

Kenya to boost Maritime safety through information sharing

Kenya will adopt the use of a satellite based Indo Pacific Regional Information Sharing (IORIS) platform to facilitate the coordination and exchange of information for effective response to maritime threats and support a sustainable fisheries sector in the region.

Kenya will adopt the use of this concept by virtue of being a steering committee member and strategic partner for the EU/CRIMARIO II (European Union/Critical Maritime Routes Indo-Pacific) project in the Western Indian Ocean region.

Representing Kenya and speaking during the second steering committee meeting, the Principal Secretary for the State Department for Shipping and Maritime Affairs Geoffrey Kaituko lauded the adoption of the platform whose role is to enhance day-to-day information sharing and strengthening the coordination and monitoring of maritime safety and security operations amongst

civilian agencies and/or military users.

"The platform is a maritime information sharing tool that enables coordination and communications via a secure encrypted online environment providing maritime centres," Mr Kaituko said.

The system, the PS added provides maritime centres, organisations and agencies with a means to analyse, plan and coordinate maritime operations from the Western Indian Ocean, through Asia and Southeast Asia and across the Pacific Ocean to Latin America.

He also noted that the platform will be able to enhance information exchange and analysis and crisis/incident management while strengthening inter-agency cooperation in maritime surveillance, policing, investigation and judicial matters.

"IORIS will provide users with the unique capability to exchange operational information on a diverse range of maritime threats, in real-time and will connect domestic and

international stakeholders to address the evolving challenges manifesting within the maritime domain," he noted.

He said Kenya remains firmly committed to the objectives of CRIMARIO II project and looks forward to continued engagement on the implementation of the outcome of the meeting and avail its commitment to strengthening regional efforts to address common challenges and seek shared prosperity.

The meeting brought together over 60 government agencies from the INDO-PACIFIC region and was co-chaired by CRIMARIO and the Sri-Lanka Navy.

It served as another milestone for the governance of the platform which is supposed to endorse, amongst others, legal documents consolidating the governance structure and establishing rules for the information sharing.

Kenya's presence in the Committee is critical in enhancing maritime security along the coast and on its waters all together.

New technologies to cushion farmers against climate change

The Kenya Agricultural and Livestock Research Organization's (KALRO) innovative technologies are bolstering farmers' determination to maintain their livestock operations amid rising threats of climate change.

The organization, which has already been recognized as a center of excellence in the agricultural sphere, is a true testament to Kenya's resolve to place scientific adaptation systems to cushion farmers from climate-induced losses and damages.

KALRO has developed new livestock breeds, climate-smart feed, fodder, and vaccines to combat emerging and prevalent diseases in its store after years of research and development.

According to the Naivasha-based Dairy Research Institute Director Dr. Samuel Mbuku, farmers continue to benefit from new livestock breeds from cows, pigs, dairy goats, and poultry that give farmers value for their investments.



Dr. Mbuku said the institute has for instance produced the Sahiwal cattle breed that is highly competitive thanks to its high production and resilience to drought and diseases.

The breed borne out of years of research, is suited to smallholder farmers due to its low input consumption ratio as compared to other exotic breeds, amidst the high cost of animal feeds occasioned by disruption in supply chains.

In addition, Dr. Mbuku said farmers continue to access highly productive new pig breeds including the Duroc, Hampshire, and the Large White that promise farmer's quick earnings within months, with lower production costs.

The director also hailed the new indigenous chicken breed that has attracted a high demand due to its production and is geared to meet increased meat and egg demands across the country.

Hence, he emphasized that to enhance the health and well-being of livestock, Dr. Mbuku said the organization has developed vaccines for East Coast Fever and Foot and Mouth diseases that have for years posed a threat to farmers.

Consequently, the director said the organization continues to tap research to develop climate-smart feed and fodder varieties that respond to the emerging adaptation needs of farmers across the country.

World Vision ends decades-long water crisis for residents of Sololo

It is all smiles for 12,000 residents of Sololo town in Marsabit County and its environs after two water projects were launched by a Non-Governmental Organization operating in the area. The projects, launched and funded by World Vision Kenya, have put an end to acute water shortages spanning decades in the area.

The organization, which also marked its 50th year of existence in Kenya, has extended support to the local Moyale Constituency bursary kitty by donating Sh9 million to enable needy students to continue their education.

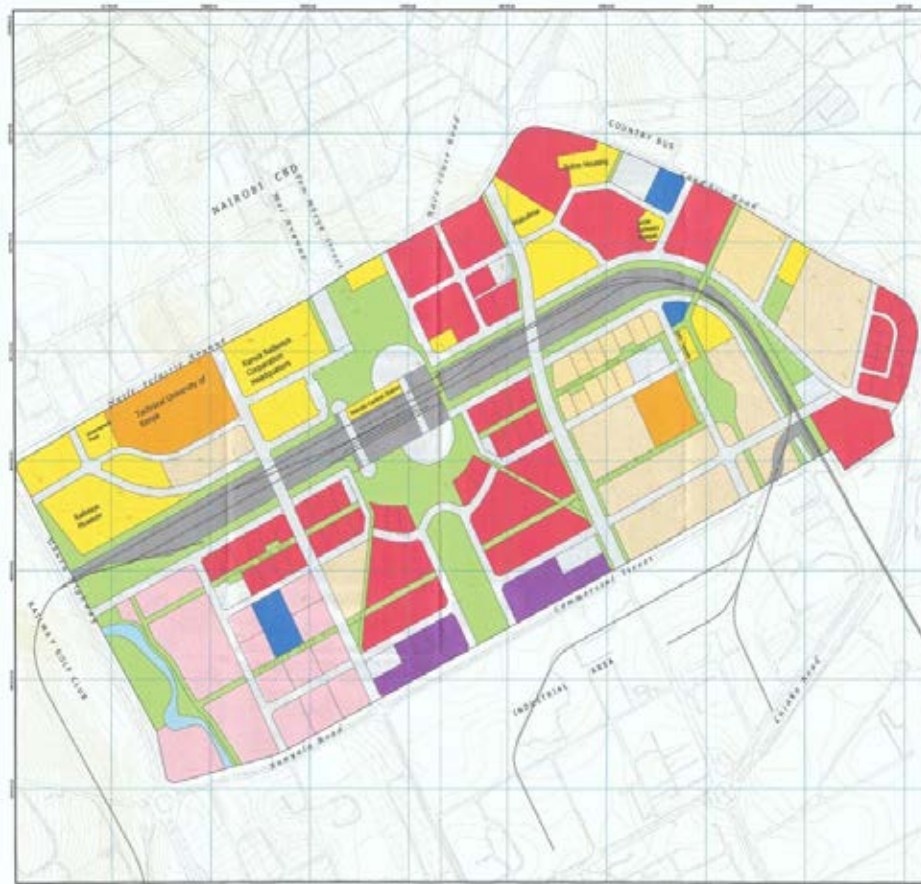
World Vision Country Director Gilbert Kamanga said the project, entailing the sinking and equipping of two boreholes at a cost of Sh26 million, was informed by the suffering that members of the community, particularly women and children, endured when sourcing the essential commodity.

Kamanga pointed out that the organization implemented the project in collaboration with the Moyale Constituency Development Office and the Omeriye Foundation in line with the Government's Vision 2030 development plan.

During the commissioning of the project, which would provide 976 households with portable water for both domestic and livestock use, Kamanga stated that the availability of the essential service would also enhance access to quality education for local children. On the same note, the country director advised local communities, who are predominantly pastoralists, against early marriages.

The Nairobi Railway City Strategic National Installation and Project Plan (2023-2033)

Nairobi Railway City is gazetted as a Project of Strategic National Importance in Gazette Notice No. 4710 dated 21st May 2021, pursuant to provisions of Legal Notice No. 156 of the Physical and Land Use Planning (Classification of Strategic National on Inter County Projects) Regulations, 2019.

Consequent to this classification, **the statutory responsibility for the Physical and Land Use Planning activities for the entire Nairobi Railway City lies solely with the Director Physical Planning while all development control activities within the jurisdiction of the Nairobi Railway City is under the sole authority of the Cabinet Secretary responsible for Physical Planning Matters**, as provided for under the provisions of section 13(g) and 69 (4) of the Physical and Land Use Planning Act, 2019, respectively.

KEBS unveils radiotherapy calibration system for cancer treatment

The introduction of the Cobalt 60 (CO-60) radiotherapy calibration system marks a significant transformation in Kenya's healthcare landscape, positioning the country's pursuit of excellence in both healthcare and industrial sectors.

The Cobalt 60 radiotherapy calibration system, the first of its kind in East Africa, was procured through collaboration between Kenya Bureau of Standards (KEBS) and the International Atomic Energy Agency (IAEA).

This cutting-edge system is poised to revolutionize cancer treatment by ensuring precise radiation doses, thereby

maximizing treatment effectiveness while minimizing associated side effects.

Trade and Industry Cabinet Secretary Rebecca Miano, who spearheaded the launch after unveiling KEBS' strategic plan, hailed the acquisition as a significant advancement in healthcare.

She emphasized the crucial role of precise calibration in administering cancer treatment, highlighting its impact on patient safety and therapeutic efficacy.

The CS emphasized the importance of adherence to quality standards in penetrating international markets.

Miano highlighted the

challenges faced by Kenyan enterprises in meeting stringent export market requirements, primarily attributed to non-compliance with quality control processes.

She expressed optimism that the Strategic Plan would address these challenges, particularly for Micro, Small, and Medium Enterprises (MSMEs), by providing a roadmap for standardization and enhancing their acceptability in regional and international markets.

Miano urged industries to strictly adhere to KEBS standards, emphasizing the pivotal role of quality compliance in driving industrialization and creating employment oppor-

tunities.

KEBS Managing Director Esther Ngari underscored the years of collaborative efforts with the IAEA, dating back to 2008, which culminated in the acquisition of the Cobalt 60 system.

This collaboration, she noted, has been instrumental in fostering innovation and capacity building in cancer treatment.

In Nakuru County, the devolved unit's fight against cancer has received a major boost after acquiring its second high-tech diagnosis and treatment machine that employs a new radiation technique that not only increases efficiency but also reduces

side effects from powerful rays.

The Linear Accelerator (LINAC) radiotherapy machine is designed to treat a broad spectrum of cancers and significantly enhance patient care.

The new equipment will offer high-energy X-rays through linear accelerators that help burn cancerous cells much faster compared to cobalt units, which have previously been in use.

According to the County Executive Committee Member (CECM) in charge of Health Services Ms Roselyn Mungai cancer patients will spend less time undergoing radiotherapy treatment following the installation of new

technology that shortens the average session by half.

The new technology is said to have less side effects as it only targets the cancerous cells.

"When normal cells are burnt together with harmful ones, longer healing period, nausea and unnecessary weight loss result," said the CECM

Ms Mungai explained that unlike the usual radiation therapy equipment, this latest model offers precision by directing the rays to the actual tumour.

"This way we treat the cancer with high doses of radiation but sparing other structures of the body. We basically hit the tumor hard, while minimizing side effects," she stated.

Kenya, Kazakhstan to collaborate to revamp Postal Corporation

The Government is working on modalities of positioning the Postal Corporation of Kenya (PCK) as e-commerce and Logistics hub in the region.

The Cabinet Secretary for Information, Communication and the Digital Economy Eliud Owalo said his Ministry has developed an e-commerce strategy, a National Addressing System Policy and a bill to ensure that there is the requisite infrastructure to facilitate e-commerce in the country.

Owalo was speaking when he met a delegation from the Republic of Kazakhstan and senior officials from his ministry who are in the country to discuss possible ways of restoring PCK while leveraging on technology.

The CS said transforming the Postal Corporation of Kenya into an e-commerce hub is one potential area of partnership which the Kenyan and Kazakhstan governments can explore.

The CS observed that Kenya is embarking on a major digital transformation and is in the process of rolling out 100,000 kilometres of fibre-optic cable to facilitate connectivity.

He further said the government is currently establishing and operationalizing 25,000 free Wi-Fi hotspots, setting up 1,450 digital hubs for purposes of digital skilling and job creation in the country, digitalizing government services and assembling cheap smart enabled phones.

He added that his Min-

istry has laid out the requisite horizontal infrastructure and a data center at Konza Technopolis.

The CS also noted that Kenya is establishing a robust risk mitigation framework around digital platforms to limit exposure to cyber-attacks.

He expressed interest in liaising with the international community to benchmark on best cases practices on cyber security management.

He underscored the importance of optimally utilizing emerging technology such as Artificial Intelligence (AI), Internet of Things (IoT) and big data analytics.

Owalo revealed that his ministry is seeking partnerships to revitalize the Kenya Broadcasting Corporation (KBC) in the area of upgrading of transmission infrastructure, upgrading of the studios, remodeling of the content and positioning Kenya News Agency (KNA) as a one stop source of credible news both for KBC and the private sector.



Speaking the Principal

Secretary for Broadcasting and Telecommunications, Prof. Edward Kisiang'ani stated that the ministry is developing the Postal Corporation of Kenya for enhancement of last mile deliveries countrywide and turning it to an e-commerce hub for income generation.

Kisiang'ani urged the delegation to share knowledge with Kenya on how to manage a national broadcaster and make it profitable.

Speaking as the Head of the official Kazakhstan delegation, an Assistant to the President for External Affairs, Mr. Erzhan Kazykhan said that Kenya is a major partner of Kazakhstan in the African continent and expressed optimism in strengthening the bilateral ties between the two nations.

He highlighted key milestones they have achieved in the area of digital technology advancement and committed to support Kenya to achieve set goals in technological development and revamping the PCK.

CS urges farmers to embrace innovative seed tech to enhance food self sufficiency

Agriculture and Livestock Development Cabinet Secretary Mithika Linturi is urging farmers in the country to embrace the innovative seed technologies recommended by the African Seed Trade Association (AFSTA) to enhance productivity and ultimately bolster food and nutrition security.

Mr. Linturi noted that the Ministry is working towards the realization of the government's Bottom-Up Economic Agenda (BETA) goals, particularly focusing on the agenda for food and nutrition security.

"We encourage our farmers to plant new, clean, and certified seeds. Studies have shown that adopting and planting certified seeds can increase yields by one and a half times. This leads to poverty reduction and improved livelihoods, as farmers can produce enough to meet domestic consumption and have a surplus to sell," the CS said.

Speaking at the AFSTA annual congress held in Mombasa, the CS praised

the association for its hard work in establishing harmonized seed regulations in Africa, including measures to facilitate the safe movement of seeds within member states transparently and without spreading any pests of quarantine importance.

During the meeting, effective measures such as stimulating the breeding and availability of improved seed varieties, which results in increased variety choices for all farmers, and encouraging investment in seed businesses in member

states were noted. The CS also highlighted that seed certification, variety testing, and release regulations have tended to restrict seed trade within African countries.

The three-day conference which was attended by more than 60 nationalities aimed at increasing food security by advising farmers to buy from established agro-vet seed companies instead of buying "fake seeds" to avoid disappointments.

He noted that coordination of the regional trade

blocks seed regulations was completed through a consultative process with stakeholders in the seed industry in Kenya.

"The process is ongoing and it is important that all stakeholders in the seed industry are conversant with the harmonized seed regulations to enhance seed trade with the COMESA, EAC and regional trade blocks," Linturi said.

He urged seed companies to take advantage of the synchronized seed regulations to widen and promote a competitive and sustainable market for crop seed within their regions.

"Challenges of cross border trade by seed companies have been an ongoing concern for a long time. This inhibits both creation of employment opportunities and trade within the region," Linturi noted.

He added that there have been numerous efforts to address this, including having a one stop border post infrastructure. But a lot needs to be done to build the capacity of the border personnel through training, he said.

State allocates Sh600m to fortify national parks against human-wildlife conflict

■ The Government will spend Sh600 million to install electric fences and watchtowers around national game parks to mitigate human-wildlife conflict.

Tourism and Wildlife Cabinet Secretary Dr. Alfred Mutua says the government is planning to scale up wildlife conservancy electrified wire fences in areas prone to human-animal conflicts. An electric fence is a barrier that uses electric shocks to deter people and animals from crossing a boundary.

Dr. Mutua specifically noted that human-wildlife conflict remains a big threat to conservation efforts, especially in areas surrounding the national reserves. The CS said wild animals in national parks invade community lands during drought seasons in search of water, while people drive their livestock into the parks in search of pasture. Dr. Mutua said the mitigation measures will include improving electric

fences, constructing water dams, ongoing awareness creation, and restocking of herbivores to reduce predation.

"Constructing electric fences will go a long way in solving the human-wildlife conflict as it will help stop the wild animals from leaving their natural habitats and protect lives and crops," Mutua said.

He went on, "The electric wire fence will be effective in diverting the animals from attacking people, their livestock and farms."

The idea is that when the wires touch an animal such as an elephant on the soft flesh of its chest or its trunk, delivering a shock, it turns and returns to the park. Dr. Mutua said fencing national parks and conservancies will mitigate human-wildlife conflict and ensure the safety of both wildlife and communities.

He says it's hoped that the electric fences around the game parks will deter wild animals from straying into neighbouring communities.

Kenya, Germany initiate talks on migration and mobility partnership

■ Kenya and the Federal Republic of Germany have launched negotiations to develop an agreement on comprehensive migration and mobility partnership between the two states.

According to a brief joint statement issued at the end of a five-day meeting in Berlin, the two countries committed to working together to cement partnerships on migration and mobility between them.

"Our discussions were held in a friendly atmosphere where both sides have agreed to strengthen close collaboration in all aspects of migration between Kenya and Germany," the statement read.

"We have had a fruitful conversation with our counterparts in a very cordial environment. The discussions are meant to build collaborations and kinship on matters of migration between the two countries, which have historically enjoyed very cordial relationships," observed Roseline Njogu, the Principal Secretary of the State Department for Diaspora Affairs.

The negotiations between the two countries took place in Berlin, Germany, and were led by Mr. Shadrack Mwandime, the Principal Secretary for Labour and Skills Development.

The German delegation was led by Dr. Joachim Stamp, the German Federal Government Special Commissioner for Migration agreements.

On behalf of the Kenyan team, Mr Mwandime appreciated the speed at which the discussions were moving, saying it was in the interest of the country to finalize the agreement as soon as possible, to pave the way for its implementation.

"In the next few weeks, Kenya and Germany will continue to work on the draft agreement with the aim of finalising it soon," the joint statement said.

The on-going negotiations are a result of initiative conceptualised between President Ruto and Olaf Scholz, Chancellor of the Federal Republic of Germany, last year. By Julius Ndegwa (PCO) in Berlin.

Government urges investors to establish mineral processing centers in Kenya

The government will give priority to mining investments committed to establishing value-addition and mineral-processing centers in Kenya as part of incentivizing investors to support the state's agenda for job creation in the mining sector.

The Principal Secretary for the State Department for Mining, Elijah Mwangi, said Kenya's vast mineral endowments have the potential to effectively address the unemployment challenges facing the country through the establishment of a local mineral processing plan, a move that would provide employment opportunities for Kenyan youths.

Calling for investors to apply for licenses to exploit Kenya's mineral resources, the PS said the policy on

mineral processing and value addition encouraged the setting up of plants and refineries locally to accelerate mineral value addition processes. This would not only be a catalyst for the creation of jobs but would also significantly increase the value of Kenya's minerals in the regional and international markets, Mwangi noted.

The PS was speaking in Tharaka Nithi County during a meeting with Governor Muthomi Njuki and other county leaders to explore ways of enhancing cooperation between the two levels of government to promote the full exploitation of minerals in the region. "We are asking investors to apply for the mineral rights. The priority

will be on investors who have expressed interest and capability to set up value addition centers, refineries, and processing plants that will not only increase the value for our minerals but also create jobs for communities and youth in this sector," he said.

The investment's call comes at a time when the country is investing heavily in value addition in agricultural, manufacturing, livestock, and extractive sectors to promote the growth of local industries. This strategy is being viewed as the critical cog that will place Kenya on the trajectory of an industrialized nation. The PS further disclosed that all mineral applications would be processed by April as he called upon all miners and dealers to get the required licenses to avoid being declared non-compliant.
