## Serikali yatenga Sh 57b kuboresha viwango vya elimu nchini Kenya

### ENDELEA KUTOKA UK1

Msemaji wa Serikali, Isaac Mwaura alisema. Mwaura pia aliwafahamisha wanafunzi watarajiwu wa chuo kuu kwamba, wanawenza kutuma maombi ya ufadhilli wa masomo na mikopo bila kitambulisho ili kuhakikisha hakuna mwanafunzi anayekosa kuendelea na elimu ya juu kutokana na michakato ya kiusimamizi. Akizungumza jijini Nairobi, Mwaura alisema kuwa, mnamo Juni mwaka jana, serikali ilianzisha mtindo mpya wa ufadhilli wa mageuzi ya elimu. Mtindo huu unatetea kundwa kwa mfumo wa elimu ambao unakuza usawa katika elimu na mafunzo katika ngazi za elimu ya juu na vyuo. "Waombaji walio chini ya umri wa miaka 18 wanawenza kutuma maombi ya mikopo na ufadhilli wa masomo kwa kutumia nambari zao za usajili za KCSE na kuam-

batanisha nakala ya vyeti vyao vya kuzaliwa badala ya vitambulisho.

Wale walio na umri wa miaka 18 na zaidi amba bado hawajapata vitambulisho wanashauriwa kuambatanisha kadi zao za kusubiri kama ushahidi wa maombi yanayosubiriwa ya vitambulisho," alieza. Aliongeza kuwa mtindo huo mpya wa ufadhilli unalenga kutoa ujuzi na ustadi wa kutosha katika taaluma za kimkakati ili kuchochera maendeleo ya kiviwanda na kiumumi yanayowiana na matarajo ya Wakanya. "Mfuko huu uliundwa ili kukabiliana na mapungufu makubwa ya ufadhilli yaliyosababisha na mpango wa awali wa Differentiated Unit Cost (DUC), ambao ulikusudiwa kufidia asilimia 80 ya gharama za elimu ya chuo kikuu kwa wanafunzi waliofadhiliwa kupitia mikopo na ufadhilli wa masomo," alisema.

### ENDELEA KUTOKA UK1

Katibu alieza kuwa mtihani halisi wa majaribio utafanyika Novemba mwaka huu, na Mtihani wa Darasa la Tisa utafanyika Novemba 2025. Hii itasaidia katika kudhibiti, kuweka, na kuendeleza majaribio, na katika kutumia majaribio ili kuongoza upangaji wa wanafunzi kwa njia sahihi. Alifafanua kwamba, mwelekeo wa upangaji wa Daraja la Kumi utahama kutoka kuchagua shule maalumu zinazofanya vizuri na kuchagua mkindo wa tasnia am-bayo watajiunga nayo. "Katika upangaji wa Daraja la Kumi, msisitizo utakuwa katika kutambua njia sahihi—iwe ni STEM, michezo na sanaa ya ubunifu, au sayansi ya kijamii—kabla ya kuchagua shule. inayohusisha madarasa 3,500 inaendelea na fedha zinatengwa kwa ajili ya kuongeza madarasa 7,500 na kufanya jumla ya vyumba 11,000. Pia, alitaja majadiliano yanayoendelea na Hazina ya Taifa kuhusu ruzuku ya masharti ya Sh3.4 bilioni zilizotengwa kwa NG-CDF kwa ajili ya kujenga madarasa 3,400 zaidi. Wabunge wameahidi kuwiana na kiasi hiki, hivyo kuongeza idadi ya madarasa ya ziada hadi 6,800.

Dkt Kipsang alifafanua kuwa wanafunzi wa Darasa la Tisa watahudumiwa katika shule

za upili. Alisitisiza kuwa Jopokazi la Rais kuhusu Marekebisho ya Elimu lili-iripoti kwamba, asilimia 93 ya Wakanya walipendeleta watoto wao kusalia katika shule za msingi ili kuruhusu ushiriki mkubwa wa wazazi.

"Nataka kufafanua kuwa ifikapo Januari 2025, tuwe na vyumba vya madarasa vya kutosha kwa ajili ya wanafunzi wa Darasa la Tisa. Utaratabu huu utawawezesha wazazi kushirikiana zaidi na watoto wao, kwani shule nydingi za msingi ni za kutwa. Hii inalingana na asilimia 93 ya Wakanya ambao walipende-

lea shule za upili kuwa sehemu ya shule za msingi," akaeleza.

Katibu Kipsang pia alisitisiza kwamba, mafunzo kwa wakuu wa shule za msingi yamefanya na kwamba, mafunzo ya sasa yan-alenga kuwatayarisha walimu wakuu wa shule kwa wanafunzi wanaohama kutoka Shule ya Sekondari ya Junior (JSS). Alisitisiza kuwa, kujengewa uwezo na upangaji upya wa vitendeakazi kwa walimu kutaendelea ili kuhakikisha utekelezaji mzuri wa mtaala mpya.

The Ministry of Interior and National Administration has developed the Draft Strategic Goods Control Bill, 2024 to provide for the control of trade in strategic goods, technology and related services. The draft Bill is ready for public participation and scrutiny for purposes of informing its review.

The Bill seeks to balance between trade and security in the management and control of strategic goods and dual use goods in addition to the fulfilment of Kenya's obligations under the United Nations Security Council Resolution (UNSCR) 1540. In addition to the domestication of the UNSCR 1540, the Bill will play a crucial role in the domestication of the following international treaties and conventions: the Nuclear Proliferation Treaty (NPT); the Biological and Toxic Weapons Convention (BTWC); and the Chemical Weapons Convention (CWC).

The SG Bill thus aims at controlling export, import, re-export, transit and trans-shipment of strategic goods and related information and technology, for purposes of ensuring that strategic goods are not diverted and utilized for non-peaceful uses. This will be by: Facilitating legitimate trade; Enhancing national and regional security; Promoting the Non-proliferation of Weapons of Mass Destruction; Promoting regional trade standardization and harmonization; Fulfilling Kenya's international obligations and commitments; and Enhancing of foreign policy interests.



# Uchimbaji madini ya chuma Taita Taveta kuajiri zaidi ya wakazi 2,000

Ujenzi wa kiwanda kinachopendekezwa cha kuchakata madini ya chuma katika Kaunti ya Taita Taveta, unaotarajiwa kuajiri zaidi ya wakazi 2,000, hivi karibuni utakuwa wa mabadiliko makubwa na hatua muhimu kuelekea ustawi. Hii ni kufuatia serikali ya Kaunti ya Taita Taveta kukabidhi sehemu ya ardhi kwa ajili ya kituo hicho kwa mfanyakishara mkubwa Dkt. Narendra Raval. Jamii ya Mbololo katika Eneo Bunge la Voi ili-kubali kwa kauli moja kutenga sehemu ya ardhi ya jamii ya Mbulia kwa ajili ya kiwanda cha kuyeyusha chuma cha mabilioni ya shilingi. Wakati wa hafla ya kukabidhi jengo hilo, Dkt. Raval alitangaza kwamba ujenzi wa kituo hicho cha zaidi ya Sh10 biliioni ungeanza mwezi huu, huku kukiwa na muda wa kukamilika unaotarajiwa wa miezi minane. Alisitisiza dhamira yake ya ushiriki wa ndani, akisema, "Ujenzi utanza mwezi huu. Wakati ujenzi ukiendelea, tutajiri zaidi ya wakazi 2,000 wa Taita Taveta. Hata hivyo, baada ya ujenzi kukamilika, mpango wetu ni tofauti. Hatutaki mtu mmoja achimbe madini huku wengine wakitazama tu. Sitaki kujichimba mwenyewe; Nataka kila mtu achimbe madini pamoja na wachimbaji wengine. Tut-

amuunga mkono kila mchimbaji madini kwa mbinu za kuboresha na kufanya maendeleo." Akizungumzia masuala mapana ya kijamii na kuchumi, Dkt. Raval alian-gazia tatozo la ukosefu wa ajira miongoni mwa Gen-Zs na kusitisiza umuhimu wa kuunda nafasi za kazi ili kushugulikia suala hili. "Nchi inakabiliwa na matatizo na Gen-Zs. Sio kosa lao, lakin ni tatozo la ukosefu wa ajira. Watu hawana wakati wa kwenda mitaani ikiwa wana kazi," alisema. Akiwa na zaidi ya Gen-Zs 14,000 kwa sasa wameajiriwa katika makampuni

yake, Raval anatazamia kwamba, kwa mazingira ya kufanya kazi yenye usaidizi na usaidizi wa serikali, miradi itapanuka kote nchini, na kutengenza nafasi zaidi ya 200,000 za ajira kwa vijana wa Kenya. Alikariri ahadi yake ya kuunda nafasi za kazi na kusaidia jamii, akisema, "Mimi sio mwansasia. Nitafanya kazi ambayo Mungu amenituma kuifanya, ambayo ni kutengeneza ajira kwa nchi. Kampuni yetu imekuwa hapa kwa miaka 45, na tuko hapa kukaa. Watoto wote hapa ni watoto wangu. Ikiwa mtoto mali fulani analala kwenye tumbo tupu, hiyo sio shida yao; labda ni shida yangu. Nataka vijana wafanye kazi katika viwanda vyetu na wapate riziki." Ardhi ya Mbulia iliyotolewa kwa mwekezaji huyo ipo karibu na eneo la Kishushe lenye madini ya chuma. Kanda hii ina wezo mkubwa wa kuchimbaji madini

na usindikaji wa madini kutokana na amana zake kubwa za madini ya chuma.

Katibu wa Madini katika Wizara ya Madini, Uchumi Baharini, na Masuala ya Bahari, Elijah Mwangi, alifichua kuwa serikali ilitambua Taita Taveta kama kaunti muhimu kwa uongezaji thamani na uchakataji wa madini ya chuma. Katibu, ambaye hapo awali aliwasiliana na viongozi wa mitaa na wananchi, alisema kuanzishwa kwa mtambo huo kutafungua uwezo kamili wa maliasili na kuimasha uchumi wa kanda. "Ongezeko la thamani ya madini huleta fursa nyingi, ikiwa ni pamoja na ajira kutoka kwa usindikaji, uchenjuaji, na viwanda, pamoja na uhamisho wa uujuzi, uujuzi, teknolojia, na uzalishaji wa mapato," PS ilisema. Alibainisha kuwa serikali ya kitaifa imejitolea kusaidia wawekezaji na wachimbaji madini katika eneo hili, ikilenga kubuni nafasi nyingi za kazi kwa vijana wa Kenya. Kwa wachimbaji waliopewa leseni, Mwangi alisitisiza umuhimu wa kuzingatia mikataba ya maendeleo ya jamii. "Kwa wale waliopewa leseni za wachimbaji madini, tutahakikisha Kamati ya Makubaliano ya Maendeleo ya Jamii (CDAC) inakupewo ili jamii ipate fedha zinazostahili kwa ajili ya maendeleo," alisema. Pia alitaja kuwa kufuatia agizo la Rais William Ruto la kubuni sheria zinazoru-

husu uchimbaji madini katika mbuga, wizara im-eunda mfumo wa kuweesa shughuli za uchimbaji madini katika maeneo haya. "Katika mwezi ujao, timu itafanya ushirikish-waji wa umma ili wale wanaopenda uchimbaji madini katika mbuga za Taita Taveta waweze ku-changia maoni yao juu ya kile kinachohitajika," alisema, akiongeza kuwa hii itakuza uchimbaji endelevu wakati wa kuhifadhi mazingira ya hifadhi. Gavana wa Kaunti ya Taita Taveta Andrew Mwadime aliwataka wakazi kue-puka siasa za mapema na za migawanyiko na kulenga kusaidia miradi na uwekezaji wa serikali ndani ya kaunti hiyo. Alipongeza jamii kwa uamuza wao wa kumpatia ardhi mwekezaji huyo, akitafsiri kuwa ni ishara tosha ya utayari wao wa kukumbatia maendeleo. Katika mahojiano na KNA mjini Mombasa, mwandishi, Bi Neema, alieleza furaha yake kuhusu kuandika kitabu kuhusu mpigania uhuru mashuhuri Bi Menza, ambaye alipigania uhuru kutoka kwa wakoloni wa Uingereza. Menza alikuwa katika miaka ya 1920 kwa sababu za asili, na Tamasha la Mekatilili wa Menza hu-fanyika kila Agosti katika kaunti yake ya asili kwa kumbukumbu yake.

Huduma hizi zitawezesha uundaji wa mikakati ya uboreshaji na uzuiaji wa makazi duni. Kupitia mradi huo, kaunti, baada ya miezi tisa, itaunda waraka wa Sera Maalumu ya Kaunti ambayo itaangazia mambo yanayochangia kuenea kwa vitongoji duni huko Nyeri. Kulingana na Fredrick Maina, Mwenyekiti wa Timu ya Kuratibu Mirradi ya Kaunti ya Nyeri (CPCT) kwa KISIP II na Afisa Mkuu katika Idara ya Ardhi, waraka huo pia utajumuisha mipango inayolenga kuboresha hali ya maisha ya wakazi katika makazi yasiyo rasmi. "Washauri wa mradi watatusaidia kuandaa mwelekeo wa kisera unawiana na Katiba na sheria nyininge zilizopo.

Kando na kuhakikisha uboreshaji wa makazi duni, hati hiyo pia itakuza utu kwa wale wanaoishi katika vitongoji duni," Maina aliambia KNA. Baada ya kutengenezwa, hati hiyo itatumwa kwa Bunge la Kaunti ya Nyeri ili kupitishwa na kutekelezwa. Lengo ni mikakati hii kujumuishwa katika Mpango Jumuishi wa Maendeleo wa Kaunti ya Nyeri, ambao utahitaji Serikali ya Kaunti hiyo kutenga pesa mahususi kwa mikakati ya kuboresha makazi duni na kuzuia. Kwa Kaunti ya Nyeri, Maina alisema Kamati

# Innovative fish farmer thrives in Nyeri, pioneers local catfish hatchery

For someone who ventured into aquaculture without any formal training in the field, Livingstone Waithaka is doing quite well for himself.

In under two years, Waithaka has made a name for himself in Nyeri County and its environs as the sole supplier of Catfish (order Siluriformes) fingerlings, saving other fish farmers the hassle of traveling to Mwea (Kirinyaga), Sagana (Murang'a), or Thika (Kiambu) to fetch the fingerlings.

Last month, he put the County Department of Agriculture on the national stage during the 4th Annual National Stakeholders Review Workshop. His spectacular presentation on the use of the sawdust hatchery system, also known as the Recirculating Aquaculture System (RAS), in fish farming earned him first place.

In this system, the water used to raise fish is continuously purified and recycled. Waste products like solid matter, ammonium, and carbon dioxide are either removed or converted into non-toxic substances. The clean water is then replenished with oxygen and channeled back into the fish tank. Waithaka demonstrated that it is possible for fish farmers in high-altitude areas like Nyeri to overcome cold temperatures and create a conducive environment for catfish to breed and survive.

## 2,000 catfish juveniles

When KNA visited his farm in Ithenguri, Waithaka was tending to his latest batch of over 2,000 catfish juveniles hatched using the RAS system. The fish were swimming in a heated pond, a contrast to the freezing 19°C outside.

"When I built my first fish pond in July 2022, I realized I could not find fingerlings in Nyeri. Upon inquiry, I was informed that the main challenge with managing a fish hatchery in Nyeri was maintaining constant warm breeding temperatures. That motivated me to start looking for a solution," says Waithaka.

Nyeri is a high-altitude zone where temperatures can drop as low as 10°C depending on the season. Scientific research documented by Mwea Aqua

Fish Farm shows that for catfish to breed, the water temperature must be maintained at around 29°C. This meant Waithaka needed to develop a reliable system to maintain the water at the prescribed temperature. The RAS system was born from this need.

The ingenious system Waithaka developed consists of a water boiler connected to RAS. Both units are equipped with automatic sensors and pumps that work together to precisely maintain the pond's water temperature at 29°C. Temperature fluctuations are automatically detected and corrected by the RAS, which adjusts by either opening the inlet to allow warm water to circulate or closing it to prevent overheating.

"I assembled my first system using locally sourced materials. It was fully electrical, but it soon became too expensive to operate, requiring at least Sh2,000 daily for electricity. I then switched to using firewood for the water boiler, but that also became untenable due to high operating costs," he explains.

In his third attempt to improve energy efficiency, he discovered that sawdust could be used as

an alternative fuel for the boiler, while electricity powered the RAS. Sawdust was cheaper and burned longer.

Excited by this new solution and eager to test its efficiency, Waithaka traveled to Makindi Fish Farm in Thika to purchase fingerlings.

"I bought 400 fingerlings to test the system. Within one month, my fingerlings, initially 2 inches in length, grew to 4 inches due to the warmth. I was very impressed and decided to increase my stock to 600 fingerlings," he continues.

While retrieving his second batch of fingerlings, Waithaka conducted further research to deter-

from mature fish in his ponds. The experiment in a plastic basin failed as the eggs did not hatch. The second attempt, in an aquarium, was more successful, with 98 percent of the eggs hatching. However, he still faced challenges ensuring the hatched fish survived past the second week.

"Despite hatching more than 90 percent of the eggs, the system failed, and all the fingerlings died. This happened again, but I adjusted the system. My breakthrough came with the fourth attempt at hatching, where 90 percent of the fingerlings survived past the second week. This confirmed that my invention was effective," he says.

Waithaka now has two hatcheries, each capable of holding up to 150,000 fingerlings at full capacity. Fingerling prices vary by size: Sh10 for those measuring two inches and Sh15 for larger fish. To meet the demand for meat, Waithaka has three additional ponds that can hold up to 20 mature fish, which are sold at Sh400 per kilogram.

The County Department of Agriculture and the Aquaculture Business Development Programme (ABDP) have also con-

mine what was needed to graduate from rearing catfish to hatching his own fingerlings.

"I questioned why I should travel all the way to Thika for fingerlings when I had developed a system that addressed the main challenge affecting catfish hatcheries," he says.

For his first experiment, Waithaka extracted eggs

tributed to his success. Waithaka notes that while ABDP provides technical support, the Department has played a key role in publicizing his work.

ABDP is a program jointly funded by the Government of Kenya and the International Fund for Agricultural Development (IFAD). Its overall goal is to reduce poverty and increase food security and nutrition in rural communities.

"Last year, ABDP provided me with liners worth over Sh100,000 and several bags of fish feed, which was a significant boost since accessing fish feed is a major challenge for many fish farmers.

The County government has also contributed to my success by marketing my work to other farmers. In fact, most of my customers are referred to me by the county," she told KNA.

The county government is also constructing a modern open-air market in Chaka town where farmers will be able to sell their fish directly to clients. Ms. Gathiga expects the market to be completed before the end of the year, benefiting women and youth groups currently involved in aquaculture projects.

Similarly, the county has received several awards for its strides in advancing fish farming. Ms. Gathiga attributes the recognition to the combined efforts of the county government, relevant stakeholders, and local farmers.

## intense grassroots campaigns

She also notes that the program's success is due to intense grassroots campaigns, with a total of 60 fish-eating campaigns conducted across the eight sub-counties to date.

Waqo alisitisiza kuwa serikali inahitaji kuwaitakishwa usalama wa migodi katika eneo hilo. "Wadau wote lazima washirikishwe katika mazungumzo ili kujadili masuala yanayofanya uchimbaji kuwa changamoto katika ukanda huu.

## Nakuru kuwekeza katika mifumo ya hali ya juu ya kudhibiti majanga kwa usaidizi wa Uingereza

Gitau Thabanja, ushirikiano na shirika hilo lenye makao yake makuu nchini Uingereza, liliopewa jina la Tomorrow's Cities, litahissha kuwekeza katika mifumo thabiti ya ta-hadhari ya mapema am-bayo huongeza utabiri wa hali ya hewa wa hali ya juu, mifano ya hatari, na mbinu za mawasiliano ya hatari zinazolenga jamii. Mpango huu unalenga kushughulikia majanga kama vile mafuriko, maporomoko ya ardhi, ukame, moto, matete-meko ya ardhi, na zaidi. Bw. Thabanja alisitisiza kuwa uharibifu unaosababishwa na majanga ya asili, kama vile janga la mafuriko la Mai Mahiu, unapa-swa kuwa ukumbusho wa hali ya hatari ya Kenya kwa hatari zinazosababishwa na hali ya hewa. Aliongeza kuwa, kuto-kana na mafuriko yanayotoke mara kwa mara na majanga mengine ya asili ambayo yamesababisha uharibifu kote nchini, swali sio "ikiwa" maafa mengine yatatokea, bali "ni lini" na "wapi." Akizungumza wakati wa mkutano wa mtandaoni ulioitishwa na pande hizo mbili, Thabanja aliangazia hitaji la Kenya kubadili mtazamo wake kutoka kwa majibu tendaji hadi hatua za kudhibiti maafa. ## Nyeri yageukia jiko la kuokoa nishati kukabili mabadiliko ya hali ya hewa

Serikali ya Kaunti ya Nyeri inahimiza matumizi ya jiko la kuokoa nishati katika wadi zake 30 kama sehemu ya juhud za kukabiliana na athari za mabadiliko ya hali ya anga. Chini ya Mpango wa Ufadili wa Hatua za Hali ya Hewa (FLLoCA), Kaunti, kupitia Idara ya Maji, Mazingira, na Mabadiliko ya Tabianchi, imetoe jikos zisizotumia mafuta kwa taasisi 29 za ECDE katika muda wa miaka mwili iliopita. Idara inakusudia kupanua mpango huu kwa jamii za wenyiji, haswa mionganoni mwa familia zilizo hatarini na za kipato cha chini, kuzihimiza kuitisha majiko ambayo sio tu yanatumia mafuta kidogo lakini pia hutoa moshi kidogo. Mpango huu ulianzishwa mwaka jana wakati wa majukwaa shirikishi ya Tathmini ya Hatari ya Hali ya Hewa (PCRA), ambayo yalibainisha hatari za mabadiliko ya hali ya hewa katika kila eneo na mapendekezo ya hatua zinazoweza kutekelezeka za kupunguza na kukabiliana na hali hiyo. "Mpango wa jikos wa

kuokoa nishati unanuiwa kukuza uhifadhi na ulinzi wa mazingira kwa kupunguza utegemezi wa kuni, hatimaye kuchangia katika usimamizi endelevu wa misitu. Unapozuru nyumba nyingi, bado hutumia makaa ya jadi ya mawe matatu, ambayo huchangia uchafuzi wa hewa," Mkurugenzi wa Mabadiliko ya Tabianchi wa Kaunti ya Nyeri Yvonne Mathenge alieleza KNA. "Kwa sasa, lengo letu ni kupunguza kiasi cha kuni zinazotumiwa na kuboresha afya ya wale wanaofanya kazi karibu na maeneo haya," aliongeza. Bi. Mathenge alibainisha kuwa ikilinganishwa na

jiko za kitamaduni, jiko jipya huhifadhi hadi asilimia 95 ya joto kutokana na vifaa vinavyotumiwa na idadi ndogo ya vipumuaji kwenye vifaa.

Hata hivyo, watumiaji binafsi wana uhuru wa kuchagua aina ya mafuta wanayotumi, kulingana na upatikanaji na uwezo wa kumudu. Anasema taasisi nyingi za masomo amba zo wametembelea aidha zinatumia nishati ya kuni lakini baadhi ya nyingine zimetumia mbaa za mkaa, maarufu kama briquettes. "Tulipofanya tathmini shirkishi ya hatari ya hali ya hewa (PCRA), moja ya mambo ambayo jamii ili-kuja nayo kama mkakati ni kuitisha jikos za kuokoa nishati katika ngazi za kaya. Katika ngazi ya kamati ya kata wakati wa mabaraza yetu wakazi walisema waliona kuwa hatua hizi ni jambo la kufaa kuchukuliwa. Tunataka kuboresha maisha ya wale walio katika mazingira magumu kwanza kwa sababu hii imeangaziwa katika ripoti ya PCRA," alisema. Jiko za kuokoa nishati zimetengenezwa kwa te-

knolojia ya kisasa na iliyoundwa kutumia mafuta kidogo ikilinganishwa na mbinu za jadi za kupikia. Hii inaleta akiba kubwa kwa shule, pamoja na kumpunguza kwa ukataji miti na uchafuzi wa mazingira. Kila jiko limejengwa ili kudumu na ufanisi, ku-hakikisha kwamba manufaa yanaende-lea kwa muda mrefu. Kaunti ilizindua vikao vya PCRA mnamo 2023 katika wadi zote 30 ili kubaini hatari na hatari za mabadiliko ya hali ya hewa katika kila eneo ili kusaidia kuja na hatua zinazowezekana za kukabiliana na kukabiliana na hali hiyo. Wakati huo Idara ya Maji, Mazingira na Mabadiliko ya Tabianchi ilikuwa tayari imefanya mikutano ya PCRA katika kata zote 30. Kulikuwa na jumla ya wajumbe 20 amba walunda sehemu ya wajumbe wa kamati ya mabadiliko ya tabia nchi wakiwemo wawakilishi kutoka makundi yenye maslahi, wanavikundi vya jamii, maafisa wa serikali, na mashirika binafsi.

Gavana Kahiga alikuwa ameteta kuwa KWS inapaswa kutoka kwa Mbuga ya Kitaifa ya Kifadhi ya Kitaifa ya Aberdare. Timu ya kitaalamu ya wataalam ilianzishwa na Wizara ya Utalii ili kuongoza mchakato wa mptito.

### Kwale inapokea ruzuku ya Sh 272m kuimarisha uvuvi

Serikali ya Kaunti ya Kwale imepokea ruzuku ya Sh272 milioni kutoka kwa mradi wa Kenya Marine Fisheries and Socio-Economic Development (KEMFSED) ili kukuza sekta ya uvuvi katika kaunti hiyo. Ufadhilli huu ni sehemu ya mgao wa Sh1.76 bilioni katika ruzuku za KEMFSED kwa wawakilishi wa vikundi 628 vya jamii vinavyofanya kazi kuboresha maisha katika kaunti za Kilifi, Mombasa, Kwale, Tana River na Lamu. Hii ni awamu ya tatu ya ruzuku inayolewa kukuza pato la uvuvi inayotolewa kwa vikundi vya maslahi ya pamoja kutoka kwa jamii za wavuvi. Achanan anasema mradi wa KEMFSED utaimirisha ushirikiano wa uvuvi na ufugaji wa samaki na kaunti za pwani na kuwapa wavuvi fursa bora ya uvuvi wa baharini. Alibainisha kuwa mfumo wa chakula cha majini una jukumu muhimu katika kuhalikisha usalama wa chakula, kuboresha lishe na kukuza ukuaij wa uchumi.

### Kaunti yaokoa mamilioni kwa paneli za juu hospitalini

Kukatika kwa umeme amba zo zilidhoofisha bajeti yake ya uendeshaji. Kwa ufungaji wa paneli za juu, sasa kutakuwa na upungufu mkubwa wa utegemezi wa gridi ya taifa. Pia alifchua kuwa serikali ya kaunti itaokoa zaidi ya KSh 7 milioni kila mwaka kwa bili za umeme, pun-guzu kubwa kutoka kwa matumizi ya awali ya kila mwezi. Mnamo Juni na Julai, baada ya usakinishaji, bili zilikuwa KSh 1.1 milioni na KSh 1.2 milioni, mtawalia, na kusababisha akiba ya angalau KSh 600,000 na KSh 700,000 kwa mwezi," Gavana huyo alibainisha. Mutula aliendelea kusema kuwa matumizi ya nishati mbadala katika kituo cha afya yata-punguza kiwango cha kaboni na hivyo kuchangia katika uendelevu wa mazingira.
