"Tunashukuru kupokea pesa kuitia biashara ya kuondoa kaboni, na wakazi wanapaswa kuelewa kwamba kwa kuhifadhi mazingira yetu, tutaende- lea kupata manufaa," Irungu alisema. Alibainisha kuwa kat

Mkurugenzi wa mipango ya kaboni wa NRT Rangelands Mohamed Shibia alisema kuwa Kenya ilizalisha kaboni ndogo zaidi duniani na akaongeza kuwa jamii zimejitelea kuhi- fadhi ardhi za malisho kuitia ulishaji wa mzunguko.

"Huu ni mradi wa wafugaji kuboresha mashamba yao ya malisho na kuondoa kaboni kama njia ya kisasa ya uhifadhi wa nyanda za malisho. Kaboni angani ndio inayochangia mab- adiliko ya hali ya hewa na hilo ndilo tunalojitelea kushughulikia," Shibia alisema.

Alifichua kuwa, mradi wa kaboni wa Northern Range- lands, amba ni mradi mkubwa zaidi wa kuondoa kaboni, un- akadiria kuondoa zaidi ya tani bilioni 50 za gesi ya kaboni katika miaka 30 na kuzalisha fedha kwa jamii za wafugaji. ### THE REGULATORY IMPACT STATEMENT IN THE MATTER OF PUBLIC PARTICIPATION ON:- THE DRAFT AFFORDABLE HOUSING REGULATIONS 2024

#### 1. A Statement of the objectives of the proposed Affordable Housing Regulations, 2024

The Proposed draft Affordable Housing Regulations 2024 seek to facilitate full operationalization of the Affordable Housing Act in the development of affordable housing, institutional housing and associated social and physical infrastructure across the country. The main objective and reason for the proposed Affordable Housing Regulations, 2024 is to operationalize Affordable Housing Act, 2024 and provide clarity on its implementation.

Specifically, the Regulations seek to:

- (a) Provide for eligibility, application, validity and revocation of exemptions from imposition of the Levy under section 6 of the Act
- (b) provide the criteria for application for allocation and re-allocation in case of default of an affordable housing unit under section 48
- (c) prescribe the requisite deposit for affordable housing unit under section 49(2)(a)
- (d) Provide for diversity and inclusion within affordable housing schemes pursuant to Section 59(2) (i) of the Act
- (e) Provide for the criteria for change of affordable housing unit under Section 59(2);
- (f) Provide for loan interest rate or administration fee under section 51 of the Act
- (g) Provide for procedure relating to off-take of affordable housing units;
- (h) Provide for the eligibility criteria to enter into an agreement to develop institutional housing
- (i) Provide for the application procedure for approval to develop institutional housing through implementing agencies
- (j) Provide for eligibility to enter into agreement to finance off-take, application for approval
- (k) Provide for application for approval to offer off take
- (l) Provide clarity on development of associated physical and social infrastructure
- (m) Provide for conduct of Public participation by the Board
- (n) Provide for notice of affordable housing on settlement
- (o) Provide for withdrawal of voluntary savings under Section 52;
- (p) Provide for rural affordable housing unit
- (q) Provide for restrictions on disposal of affordable housing unit.

#### 2. The effect of the proposed Affordable Housing Regulations 2024 include the following:

- a) The proposed regulations will provide guidance on the implementation of the provisions of the Affordable Housing Act 2024.
- b) The implementation of the Regulations will ensure achievement of the Government housing commitment which is to turn housing challenge into an economic opportunity; and ensure housing production to create quality jobs for the 100,000 or so young people graduating from TVETs every year directly in the construction sector and indirectly through the production of building products.
- c) These Regulations will facilitate achievement of the economic and social rights guaranteed in Article 43(1)(b) of the constitution through:
  - i. increasing the supply of housing to 250,000 per annum; increasing the supply of affordable homes from 2 per cent to 50 per cent;
  - ii. structuring affordable long-term housing finance schemes;
  - iii. growing the number of mortgages from 30,000 to 1,000,000 by enabling low-cost mortgages;
  - iv. strengthening Jua Kali industry capacity to produce high quality construction products and materials; and
  - v. Providing for collaborations and partnerships with developers to participate in the affordable housing program
- d) The enactment and implementation of these regulations will open up affordable home financing for development of sustainable fully serviced affordable housing schemes with integrated communities and households with all the requisite social and physical infrastructure.
- e) These Regulations will cushion Kenyans against high rentals; high lending rates by financial institutions therefore promoting home ownership across the Country.
- f) The Regulations will further provide for charging of an affordable and sustainable home financing on loans to cushion the vulnerable from largely inaccessible lending
- g) The Regulations will guard against market distortions by ensuring that envisaged partnerships with the Fund, are not exclusive or preferential and do not confer market advantage to any partners over competitors.
- h) The implementation of the Regulations will enable the Government to enhance economic participation of special interest groups and micro, small and medium enterprise in the creation of jobs and general economic development.
- i) Further, the Regulations will promote economic growth by linking MSMEs and Jua Kali sector to the affordable housing projects.

#### 3. Possible alternative and practicable means of achieving the foregoing objectives, including other regulatory as well as non-regulatory options:

The Affordable Housing Act under Section 59 gives powers to the Cabinet Secretary in consultation with the Board to prepare and table the regulations within 30 days of commencement of the Act. The preparations and submission of the Affordable Housing regulations 2024 to parliament is therefore a legal requirement under the Act and thus does no other option is available.

#### 4. Assessment of the costs and benefits of the proposed Affordable Housing Regulations, 2024 and of any other practicable means of achieving the same objectives;

The implementation provides a framework for the delivery of Affordable Housing and Institutional Housing. The implementation of the proposed Affordable Housing Regulations, 2024 may have some potential challenges. The resultant effect may include an increase in the cost of business that may adversely impact businesses that are financially weak.

It will also however create employment opportunities for businesses in the Real Estate sector or businesses supporting the Real Estate sector owing to increased opportunities. Further the lack of adequate capacity by some of Kenyans to acquire and be allocated affordable housing units due to lack of income to support the repayments of the allocated unit may result in (i) default by unit purchasers that may affect the Fund and subsequent repossession of the units where it is impractically possible for a unit buyer to remedy the situation; (ii) Non-performance by the implementing agencies who have been entrusted to implement the affordable projects under the Affordable Housing Act, 2024; and the risk of inadequate affordable housing units in the initial period of the program.

However, enactment of the proposed regulations will not occasion any additional costs towards implementation, as it seeks to further provide clarity on the implementation of the various provisions within the Affordable Housing Act, 2024. The proposed Regulations seek to provide a robust implementation mechanism for provisions identified under Section 59 (2) and further enable better implementation of the Act. The development of the proposed regulations therefore will create a positive impact in the achievement of the intended objective of the Affordable Housing Act, 2024.

#### 5. Any other matter specified by the Regulations

The proposed Regulations provides the basis for effective and structured way of undertaking development of affordable housing and provision of affordable homes to Kenyans. The regulations provides a well coordinated approach and application for off take thus incorporating the private sector in provision of the affordable housing. The regulations also provides flexibility for innovation and eligibility across income levels as well as provisions for voluntary savings towards home ownership. Lastly, the regulations also encourage participation of implementing agencies from National and County Governments.

### FRAUDULENT ACTIVITIES BY KEBS IMPERSONATORS

It has come to the attention of the Kenya Bureau of Standards (KEBS) that certain individuals, working for a private company going by the name **Multi-Works and Rights Enforcements Co. Ltd** which identifies as a consumer rights/protection organisation and purports to be affiliated with KEBS, are defrauding Kenyans under the guise of conducting product inspections in retail outlets that, allegedly, are in breach of the Standards Act and enabling legislation.

KEBS has received numerous complaints raised against the afore-mentioned organisation by retailers across the country. These complaints range from invasion of business premises, seizure of goods, on-the-spot fines, solicitation of bribes, to arrests and detention of the individuals in charge of the retail premises for the sake of extorting ransom money from them.

**As the government premier conformity assessment body in the country, KEBS places high premium on its reputation, security and trust of its stakeholders, including the business community. We therefore advise the public as follows:**

- When KEBS staff are out of station in the execution of its legal mandate, which includes conducting market surveillance, they officially identify themselves and, where applicable, produce the Certificates of Appointments and KEBS Staff Identification Cards confirming authenticity of the assignment. This identification can be further confirmed by sending an SMS with HR#Staff Number to 20023.
- KEBS routinely conducts market surveillance as per its approved workplans, where goods available for retail in markets are sampled for analysis, and conducts entry, search and seizure activities pursuant to the Standards Act, **KEBS does not impose on-the-spot penalties/fines, neither does its Inspectors possess arresting powers.** In addition, during a market surveillance field inspection activity, and in line with the provisions of the Fair Administrative Action Act, KEBS Inspectors issue Sample Collection Forms and Seizure Notification Forms to culprits and give them sufficient timelines to respond to KEBS findings.
- KEBS is not affiliated with **Multi-Works and Rights Enforcements Co. Ltd** and persons purporting to be employed by the organisation, who have gone around the country impersonating KEBS Inspectors and conducting illegal activities in the name of KEBS ranging from invasion of business premises, illegal seizure of goods, illegal on-the-spot fines, solicitation of bribes, to arrests and detention of the individuals in charge of the retail premises for the sake of extortion. **KEBS is consequently engaging with the relevant authorities with the aim of instituting criminal proceedings against the organisation, its members and its enablers.**
- Economic operators confronted by individuals claiming to work for KEBS, who fail to identify themselves and their assignment as described here in above, and who conduct illegal invasion of business premises, illegal seizure of goods, illegal on-the-spot fines, solicitation of bribes, and illegal arrests and detention of the individuals with the aim of extortion, should immediately report the matter to **KEBS during working hours from 8.00 AM - 1.00 PM and 2.00 PM - 5.00 PM, Monday to Friday through Toll-Free Line 1545 and the DCI through Toll-Free Line 0800 722 203.**

Baraza la Magavana (COG) limepongeza serikali za kaunti kwa kutumia Teknolojia ya Habari na Mawasiliano (ICT) katika majukumu yao katika sekta zote ili kuimarisha utawala bora na kuboresha utoaji huduma.

Mwenyekiti wa Kamati ya Teknolojia ya Habari na Mawasiliano ya COG Bw Wisely Rotich am-baye aliandamana na Mwenyekiti wa Kamati ya Kudumu ya Bunge ya ICT Bw Allan Chesang alibainisha kuwa kaunti zime-tumia teknolojia ya kisasa katika sekta mbalimbali zikiwemo za fedh, afya, elimu, kilimo na biashara, ambayo imeboresha utoaji wa huduma na ufanisi.

Rotich, ambaye ni Gava-na wa Kaunti ya El-geyo Marakwet, alikuwa akizungumza wakati wa kongamano la Kamati ya Kudumu ya Seneti kuhusu

mafungo ya ICT mjini Mombasa, ambayo pia ilihudhuriwa na Waziri wa Habari, Mawasiliano na Uchumi wa Kidjitali, Eliud Owalo, Katibu wa Idara ya ICT na Dijitali Mhandisi John Tanui, wanachama wa kamati ya ICT, na wakuu wa mashirika ya umma ndani ya wizara. Mada ya mku-tano ilikuwa "Kuimarisha sera za sekta ya ICT na mi-fumo ya kisheria nchini Kenya."

"Kulingana na Ajenda ya Rais kuhusu Mpango Mkuu wa Kidjitali na kwa kutambua uwemo mkubwa wa ICT kuimarisha

utoaji wa huduma, serikali za kaunti zimepata maendeleo ya kustaa-bisha katika kuunganisha ICT na teknolojia mpya ya kisasa katika shughuli za kaunti katika sekta zote. Nitaangazia mafanikio, mapungufu, na maeneo ya ushirikiano kati ya ngazi mbili za serikali na washi-kadai wengine," Rotich alisema.

Katika mifumo ya fedha na ukusanyaji wa mapato, Mwenyekiti wa kamati ya CoG alibainisha kuwa ka-tika miaka mitano iliyo-pita, kumekuwa na juhud Kutoka ngazi mbili za serikali kuandaa mfumo wa usimamizi wa ukusanyaji wa mapato.

"Kufikia sasa, kaunti 34 zina mfumo wa uku-sanyaji. Hii imeimarisha uwazi na usalama katika shughuli za kifedha na kwa hivyo tunahitaji kwenda mbali zaidi kwa kutengeneza programu za simu za kukusanya ush-



uru na malipo ya huduma za serikali.

Pia ni kusudio la CoG, Rotich aliongeza, kuwa Serikali za Kaunti zitaun-ganisha mifumo ya usi-mamizi wa fedha na huduma za serikali za kielektroniki ili kurahi-sisha utayarishaji wa ba-jeti, ununuzi na kuripoti michakato ya kifedha," Rotich alisema.

Gavana huyo aliendelea kudokeza kuwa serikali

za kaunti zinaendelea ku-kumbatia mbinu ya sasa ya matibabu ili kupanua huduma za afya katika maeneo ya mbali na kutekeleza rekodi za afya za kielektroniki ili kuboresha huduma za wagonjwa.

Zaidi ya hayo, Mwenyekiti alibainisha kuwa kaunti zimeun-ganisha mifumo ya taarifa za afya na data za afya za kitaifa ili kuhakikisha mtiririko wa data hauta-

tiziki na kusaidia upan-gaji wa sera ya afya na kuongeza kuwa katika sekta ya elimu, kaunti zimeshirikiana na EIDU, taasisi ya sekta ya kibin-afsi inayoangazia elimu ya kielektroniki katika Elimu ya Chekechea(ECDE) am-bapo kaunti tisa zimen-ufaika na mpango huu huku zaidi ya wanafunzi 250,000 wakitumia juk-waa hili.

## Government to support gender-responsive interventions to climate change

The Government has underlined its com-mitment to support gender-responsive ap-proaches to mitigate the effects of climate change among men, women and children.

To achieve this, the Government wants to design appropriate interventions which highlight the differential impact of climate change on different genders through their varied interactions with the environment.

Speaking while officially opening the Pre-SB 60 Strategy meeting to chart the continent's Unified Climate Action Agenda, Gender and Af-firmative Action Principal Secretary, Ms Anne Wang'ombe said the Gov-ernment recognizes that climate change does not affect everyone equally and any meaningful cli-mate action must prior-itize gender-responsive approaches to ensure in-clusivity and equity.

"We believe that the conclusions and recom-mendations of this map-ping exercise will go a long way in informing appropriate interventions in the target sectors of Water, Energy and Ag-riculture, with a hope to

extend the same to other sectors in future.

The findings will fur-ther be very useful to our upcoming National Gen-der and Climate Change Action Plan that ought to be informed by current data from across sectors," said the PS.

Ms Wang'ombe called for unified efforts and forging of a common agenda in confronting the climate crisis and to am-plify the voices of women and other vulnerable groups so as to integrate gender perspectives into our climate policies and actions.

The Africa Group of Ne-gotiators Experts Support (AGNES) strategy meet-ing is meant to deliberate and formulate a unified position of the African climate agenda based on the outcomes of COP28 which underscored the need to address gender, health, agriculture, wa-ter security among other components, ahead of the sixtieth session of the Subsidiary Bodies (SB 60) to be held in Germany in June this year.

# Serikali kutia saini mwafaka wa Sh5.8B wa kiwanda cha kusafisha dhahabu Kakamega

Serikali iko mbioni kutia muhuri mkataba wa uwekezaji wa madini wa Ksh 5.8-billioni ili kuandaa njia ya kuanzishwa kwa kiwanda cha kwanza cha kisasa cha kusafisha dhahabu nchini Kenya katika eneo la Lidambitsa, Ikolomani, Kaunti ya Kakamega. Kiwanda cha kusafisha dhahabu kitatoa soko fulani na la kutegemewa kwa maelfu ya wachimbaji wadogo na wadogo katika sekta ndogo ya dhahabu ya Kenya kutoka kaunti za uchimbaji dhahabu za Migori, Kakamega, Narok, Kisumu, Nandi, Pokot Magharibi, na Isiolo. Kaunti zingine zilizo na akiba nyngi za dhahabu ambazo zitafaidika ni pamoja na Turkana, Siaya, na Marsabit. Waziri wa Madini, Uchumi Baharini, na Masuala ya Uvuu, Salim Mvurya, alisema Kiwanda cha Kusafisha Dhahabu cha Kakamega kinabadilisha sekta ndogo ya dhahabu nchini Kenya. Alisema kuwa vifaa hivyo vya uongezaji thamani vinashikilia ufunguo wa kuharakisha ukua na kuanzisha uvumbuzi katika sekta ya madini kama sehemu ya kukuza maendeleo ya kijamii na kiuchumi kwa wachimbaji madini wa dhahabu kote nchini Kenya. Waziri huyo aliendelea kufichua kuwa serikali inatafuta wawekezaji wa kimkakati zaidi kufanya ubia wa uwekezaji unaohitaji mtaji katika sekta ya madini ambaa unatan-guliza uongezaji thamani na urutubishaji wa madini, ikiwa ni pamoja na shaba, klinka, diatomite na man-



ganese. "Uanzishwaji wa kiwanda hiki cha kusafisha dhahabu unaendana na dira na dhamira tunayoshikilia sana katika kunda vituo vya kuongeza thamani ili kuongeza thamani na bei ya madini yetu," Waziri alisema. Hatua kubwa tayari zime-pigwa kuelekea utendakazi wa mtambo huu wa mabilioni ya shilingi. Serikali tayari imepata sehemu ya ardhi ya ekari 14 na kuchakata hati za

umiliki wa ardhi kwa ajili ya tovuti ya kituo hicho. Uidhinishaji wa ziada na Mamlaka ya Kitaifa ya Kusimamia Mazingira (NEMA) kuhusu kufuata mazingira na barua ya kutopinga na serikali ya Kaunti ya Kakamega pia imekubaliwa. Jumuiya ya wenyeji pia imeingizwa kwenye bodi kama wadau wakuu katika mchakato huo. Hatua ya mwisho kabla ya mwekezaji kuhamia kwenye tovuti itakuwa

mazungumzo muhimu na serikali juu ya hisa ya serikali katika uwekezaji huu wa faida. Kwa mujibu wa Sheria ya Madini ya mwaka 2016, serikali ina mamlaka ya kupata asilimia 10 ya hisa za Riba Zilizobebwa kwa ajili ya shughuli kubwa za madini. Katibu wa Idara ya Mambo ya Nje ya Madini, Elijah Mwangi, anasema msukumo usiokoma wa kuanzishwa kwa vituo vya kuongeza thamani ya madini nchini Kenya ni kiini cha mageuzi yanayotarajiwa katika sekta ya madini. Anasema kuwa wachimbaji wadogo ambaa wanashikilia nyadhifa za chini kabisu katika mfumo wa ikolojia wa uchimbaji lazima wapate haki zao zinazostahiki kuptita faida iliyoimarshwa kutokana na biashara ya dhahabu iliyochakatwa. Anabashiri kuwa kiwanda hicho cha kusafisha sio tu kitatengeneza nafasi za kazi kwa maelfu lakini pia kitavutia maendeleo zaidi katika eneo hilo. "Azimio letu thabiti limikuwa kuwa na wachimbaji madini wapate thamani ifaayo kwa bidhaa zao. Hili litawezekana kwa kukuza vitema uchumi ambavyo vitachakata madini na kusababisha bei nzuri ya madini yao na

Haya ni matokeo chanya ya vifaa vya uongezaji thamani katika sekta ya madini," alieza. Kiwanda cha Kusafisha Dhahabu cha Kakamega kinakuwa mkataba mwingine mkuu wa uwekezaji na serikali baada ya kutiwa saini Februari kwa kandarasi ya Sh4.8 billioni na Soy-Fujax Limited ya kufufua Fluorspar Mining katika eneo la Kimwarer katika Kaunti ya Elgeyo Marakwet. Kulingana na Utafiti wa Kiuchumi wa 2022, wastani wa uzalishaji wa dhahabu nchini Kenya kutoka 2017 hadi 2021 ulikuwa kilo 360. Sehemu kubwa ya uzalishaji huu ilifanywa na wachimbaji wadogo ambaa idadi yao inakadirwa kuwa zaidi ya laki mbili. Hata hivyo, kuko-sekana kwa soko zuri na unyonyaji wa daima unaofanywa na mada-lali wasio waaminifu kumewaweka wachimbaji wadogo kwenye maisha ya ufukara. Ni mzunguko huu ambaa serikali inataka ku-vunja na kuingiza faida katika biashara zao. Uwekezaji wa pamoja wa mwekezaji huyo, Kam-puni ya Uchina ya Heng Nuo Rongchang Trading Company na H. Nuo Kenya Company Trading Limited, utaona ujenzi wa kinu na maabara ya madini kwenye eneo hilo. Ili kukuza uendelevu wa kiutendaji, mwekezaji anapanga kuingia ubia na vyama vya ushirika vya uuzaji vya wachimbaji dhahabu ili kupanua usaidizi wa kiufundi wa vifaa kwa ajili ya kuongeza tija ya kila siku.

## Walinzi Pwani ya Kenya waongeza doria vitisho vikiongezeka Bahari ya Shamu

Ili kukabiliana na uvuvi haramu na kuzuka upya kwa uhar-amia katika Bahari ya Shamu, Huduma ya Walinzi wa Pwani ya Kenya (KCGS) inategemea mpango wake madhubuti wa uboreshaji wa kisasa ili kui-marisha doria katika eneo la maji nchini.

Mkurugenzi Mkuu wa KCGS Bruno Shioso anasema kuwa shirika hilo liko mbioni kupata meli ya kisasa inayowenza kufanya doria katika bahari ili kusaidiana na meli kuu ya KCGS iliyopatiwa jina Doria.

Mkurugenzi Mkuu Shioso anasisisita kwamba meli ya MV

KSGS Doria ni imara na inashika doria mara kwa mara ili kuzuia shughuli haramu katika bahari ya Kenya.

Anataja shughuli zake nyngi zilizofanikiwa, ni pamoja na uokoaji wa hivi majuzi wa wavuvi wanenambo wali-toweza baada ya mashua yao kuharibika na kupigwa na wimbi hatari wakati wa msa-fara wa uvuvi. Huko wavuvi hao watatu wakiokolewa, kwa ba-hati mbaya, mmoja anaaminika kupoteza maisha baada ya kuzama.

Wavuvi hao waliookolewa walikuwa wamekwama baharini kwa siku 22 kabla ya kuokolewa na meli ya China ya

Lui Quinng Yuan U108, ambayo kisha iliwakabidhi kwa KCGS.

"Kwa sasa tuko katika harakati za kupata meli za ziada. Tumeshiriki katika majadiliano na wauzaji kutoka nje ya nchi na tumewatemeblea wawili kati yao nchini Ufaransa na Uhlanzi," alisema Shioso.

"Bado tunajaribu kuona ni maeneo gani tunaweza kushirikiana na kutafuta rasilimali zinazofaa kutoka kwa serikali kuweza kununua meli zaidi," aliongeza.

Pia, kama sehemu ya juhud za kisasa na kupanua ufikiaji wao Pwani na katika maji ya bara, KCGS inajenga vituo vi-pya vya ofisi ikiwa ni pamoja na

nyumba za wafanyakazi.

"Tuna miradi mikubwa mitatu, mmoja kule Baringo; ku-jenga kituo cha kisasa cha kutoa huduma kwa maafisa huko, imekamilika kwa karibu asilimia 95," alisema na kuongeza kuw miradi mingine inaendelea Mbita na Ziwa Victoria.

Shioso alieza kuwa uvuvi haramu, usioripotiwa, na usio-dhibitiwa umesalia kuwa tishio kubwa lakini tangu kuundwa kwa kikosi cha Walinzi wa Pwani, tishio hilo limepungu-zwa.

"Kama serikali, tunaelekeza kwenye Uchumi wa Baharini. Moja ya mifumo muhimu na inayopatikana kwa urahisi ni nani anayeingilia maji yetu," Shioso alisema, akiongeza kuwa kuwa na vifaa zaidi kutaimaria-doria.

Wakulima nchini watanaufaika na nyenzo safi za upanzi ili kuongeza uzalishaji na mapato ya kilimo, kutokana na kuanzishwa kwa kituo cha maabara kili-chogharimu Sh260 milioni kinachonuiwa kuharakisha upimaji na kutolewa kwa aina mpya za mazao.

Kushughulikia nyenzo mpya za upanzi chini ya kituo hicho cha kisasa kuanzishwa kuchukua chini ya miaka mitano ikiliganishwa na katya miaka 10 na 13 chini ya taratibu za kawaida. Mkurugenzi Mkuu wa Huduma ya Ukaruzi wa Afya ya Mmea (KEPHIS) Prof Theophilus Mutui alisema wanashirikiana na Kituo cha Kimataifa cha Viazi (CIP) na Taasisi ya Kimataifa ya Kilimo cha Kitropiki (IITA), na kwamba maabara hiyo mpya itazinduliwa katika muda wa wiki mbili zizajo..

"Maabara ya The Roots, Tubers, and Bananas-East Africa Germplasm Exchange (RTB-EAGEL) inalenga kuleta mapinduzi ya kilimo cha mimea ya mizizi na migomba katika Afrika Mashariki ili kuhifadhi na kuimarisha utofauti wa kijeni wa mazao muhimu kwa usalama wa chakula na maendeleo endelevu ya kilimo," Prof Mutui aliongeza.

Pia alieleza kuwa maabara hiyo itawezesha ubadilis-

hanaji wa RTB kama vile viazi vitamu, viazi, mihogo, viazi vikuu na ndizi kati ya programu za ukuzaji za CGIAR na washirika wa utafiti wa kilimo katika

kanda (NARES). "Maabara hii itatuwezesha kuimarisha uwezo wetu na ushirikiano na washirika ili kuweza kuongeza uwezo wa kufanya tishu na kuzidisha kwa haraka nyenzo za kupanda na kusafisha," alisema.

Alieleza kuwa afua tatu kuu zinazolengwa kuptita maabara ya EAGEL ili kuchangia katika kuongeza uzalishaji ni upimaji na kutolewa kwa aina mpya katika nchi mbalimbali, kudhibiti wadudu na magonjwa pamoja na kutoa mbegu bora kwenye mfumo wa mbegu.

"Maabara hii itakuwa ikitoa huduma kama vile kupokea Germplasm kutoka kwa programu za ufugaji, uchunguzi ulioihinishwa

kimataifa, uondoaji wa pathojeni, na pia usambazaji katika kanda," alisema.

Mkurugenzi Mkuu alishukuru msaada kutoka kwa serikali ya Kenya na mfadhili GIZ kwa kuchangia baadhi ya pesa za ujenzi wa maabara ya RTB-EAGEL chini ya mpango wa Crops to End Hunger (CtEH).

"KEPHIS iko tayari na itaunga mkono mradi huo. Maabara mpya kabisa yenye vifaa vipyaa sio tu itaimari-sha uwezo wetu wa miundombini na vifaa lakini pia itatoa mafunzo kwa wafanyakazi ili kutekeleza majukumu yao," Prof Mutui alisema.

Dkt Morag Ferguson kutoka IITA na meneja wa mradi huo alisema lengo kuu la maabara litakuwa kuwezesha usafirishaji wa mizizi, na migomba, ili kuzuia wadudu na magonjwa katika nyenzo zao za kupanda na kuwezesha harakati za kikanda katika nchi tofauti sawa na KALRO katika kanda hii na Afrika Kusini mwa Sahara.

"Mara nyingi, huwa kuna vikwazo katika suala la kuhamisha aina mpya kutoka ambapo zinazalishwa hadi nchi nyingine. Tunataka kuwezesha hili na kulifanya lifanyike kwa haraka zaidi na kuharakisha mchakato wa jinsi wakulima wanavyopokea nyenzo," alisema.

"Kitengo cha upasuaji akina mama wajawazito kitachangia kwa kiasi kikubwa kupunguza vifo vya uzazi, wakati kitengo cha watoto wachanga kitaimarisha utunzaji wa watoto wachanga katika hatua ya kuboresha huduma za afya kwa akina mama na watoto wachanga katika eneo hili," Dkt Lusi alisema.

### Serikali kujenga masoko ya kisasa Narok kwa Sh 1.3B

IDARA ya Serikali ya Makazi na Maendeleo ya Miji, kupitia Mpango wa Kuchochera Uchumi (ESP), iko tayari kujenga masoko manane katika vituo mbalimbali ya biashara katika Kaunti ya Narok kwa gharama ya Sh1.3 bilioni.

Gavana wa Narok Patrick Ntutu aliidhinisha miradi hiyo katika vituo vya biashara vya Ololulunga na
