Waziri wa Habari, Mawasiliano na Uchumi wa Dijitali anasema vituo hivyo, ambavyo vitakuwa vimeunganishwa intaneti, wakufunzi na kompyuta, vitawaongoza wanafunzi kuelekea enzi ya dijitali ambapo wanaweza kujipatia mapato na kuathiri ulimwengu wa kidijitali

Serikali inapanga kuanzisha angalau vituo 1,450 vya kidijitali katika kila wadi kote nchini ili kuwawezesha vijana kupata ujuzi wa dijitali, kusaidia kuziba pengo lilipo, na kupunguza viwango vya uhaba wa ajira.

Waziri la Habari, Mawasiliano na Uchumi wa Kidijitali Eliud Owalo alifichua kuwa mipango pia iko mbioni kufanikisha vituo hivyo kuwawezesha vijana kupata ujuzi wa dijitali.

Owalo alisema vijana wataweza kupata ulimwengu kidijitali, kufanya kazi, na kupata riziki na kuendeleza jamii kuptit jukwaa.

"Kupitia ICT, tutatengeneza ajira kwa vijana," aliongeza. Vituo hivyo, alisema Waziri, vitakuwa na

“ Tunataka watu waunganishwe na Australia, Singapore, na Canada kufanya kazi wakiwa vijijini kwa sababu dunia ni kijiji cha kimataifa,” alibainisha Owalo. Alitangaza kwamba Serikali inanunua simu za kisasa za bei nafuu ili kuwawezesha wananchi kupata huduma zote za serikali zinazop-

tikana kwenye e-citizen.

“ Tunalenga kuzuia wazazi kupata huduma muhimu kutokana na hongo katika ofisi za serikali kwa kutoa huduma zote muhimu kwa urahisi kuptit simu za kisasa,” alisema.

Wakati huo huo, Waziri aliwasihi wanafunzi kutia bidii katika masomo yao na kuacha tabia ambazo zinaweza kuhatarisha kufanikiwa kwao maishani.

“ Elimu ndio urithi wa pekee unaoweza kupata kutoka kwa wazazi wako, hivyo chagua marafiki wako kwa busara na ufanye kazi kwa bidii kwa ajili ya maisha yako

ya baadaye” alisema.

Waziri huyo alisitisiza kwamba elimu ndio uwekezaji wa thamani zaidi ambao mtoto anawea kupokea kutoka kwa wazazi wake, na kwamba nidhamu, kujitolea, na kupenda vitabu ni muhimu.

Alisema kufaulu vyema ndio njia pekee ya kuonyesha shukrani kwa wazazi kwa upande wa wanafunzi.

Shule za msingi za umma 5,421 kote nchini zimepokea Sh 2.6 bilioni ikiwa ni awamu ya kwanza ya mpango wa ufadhilli uliobuniwa kusaidia taasisi hizi za masomo kuboresha matokeo katika masomo.

Kupitia kitita hicho, ambacho ni ruzuku inayofadhiliwa na Wizara

ya Elimu kuptit Mpango wa Elimu ya Msingi ya Kenya (KPEEL), kila shule itapokea Sh 480,000 ikiwa ni awamu ya kwanza ya Sh1.2 milioni, ambazo zitatengewa kila taasisi ya mafunzo katika awamu tatu.

Akizungumza katika Shule ya Watu Wenye Ulemavu wa Akili Garissa wakati wa kuadhimisha siku ya ulemavu wa ugonjwa wa Tawahudi duniani, Afisa Mkuu Mtendaji wa NCPWD, Harun Hassan alisema kuwa watu wenye ulemavu wametengwa kwa muda mrefu, na wanaendelea na mipango ya kuwasaidia katika siku zijazo.

Baraza pia lilitoa kambi za matibabu bila malipo, tathmini za ulemavu, tathmini za elimu, na vipindi vya tiba kwa watu wenye ulemavu waliohuduria hafla hiyo.

# Serikali kuajiri walimu 20,000 ifikapo Julai ili kupunguza uhaba

Serikali imejitolea kuhakikisha uwiano wa walimu na wanafunzi unaafikiwa kwa kuajiri walimu 20,000 zaidi mwaka huu ili kukabiliana na upungufu mkubwa unaoshuhudiwa nchini.

Waziri wa Elimu Ezekiel Machogu, akizungumza katika Shule ya Kitaifa ya Wasichana ya Kolanya katika Kaunti ya Busia,

alibainisha kuwa serikali tayari imeajiri zaidi ya walimu 50,000 katika mwaka wake wa kwanza ofisini.

"Tangu uhuru, serikali imeweka rekodi kwa kuajiri walimu 56,750 ili kusaidia kukabiliana na uhaba mkubwa wa walimu unaoshuhudiwa nchini," Waziri Machogu alibainisha.

Hivyo basi, Waziri huyo aliwataka wanafunzi kote nchini kukumbatia taasisi

za TVET ili kujipatia ujuzi unaofaa kwa soko la ajira ndani na nje ya nchi.

"Serikali imehakikisha maeneobunge yote yanakuwa na taasisi ya TVET ili kuhakikisha kuwa tuna kizazi kipyachenye ujuzi wa soko la ajira ndani na nje ya nchi," Waziri Machogu alisema.

"Tayari, serikali imetoa Sh23 bilioni mgao wa shule za upili za umma, kumaliza mzozo wa

kifedha uliodumu, ambao ulitishia kutatiza shughuli katika taasisi hizo," aliongeza.

Waziri huyo ambaye pia alithibitisha tena dhamira

ya serikali ya kuboresha miundomsingi ya shule, aliwazawadia shule za wasichana za Kolanya na St Pauls Amukura hundi ya Sh10 milioni kila moja ili kuboresha miundombinu kukidhi viwango vya kutosheleza idadi ya wanafunzi katika shule hizo mbili.

Machogu pia alitoa wito kwa wazazi kutumia taasisi mbalimbali za TVET kuwapa watoto wao ujuzi unaoendana na soko la ajira. "Ulimwengu mzima sasa unaelekeea tena kwenye kozi za kiufundi na ndiyo maana tumetilia

mkazo mafunzo ya TVET ili kutimiza ndoto ya CBC pamoja na kufikia maono ya 2030," waziri alielea.

Kauli yake inajiri huku Mbunge wa Teso kusini Mary Emase, akitaka serikali kuwapandisha vyeo walimu kama kichocheo cha kufaulu kwa ujumla shulenii.

"Tuna walimu wenye shahada ya uzamifu lakini bado wako shule ya msingi, ni wakati wa wizara kuangalia upya suala hili na kutekeleza mapendekezo ya jopo kazi la kumpandishwa vyeo walimu," alisema Emase.

Akizungumza Nairobi katika kikao na wanahabari, Mwaura alisema takwimu za ajali za barabarani kutoka kwa Mamlaka ya Kitaifa ya Uchukuzi na

wa shughuli za maendeleo hata kwa yale yanayoitwa maeneo yaliyotengwa. "Lazima kama serikali tutuhamini mwekezaji kwani hadi sasa amejiri watu 11,000 katika kampuni zake zote nchini," Mwangi aliliza. ### PUBLIC PARTICIPATION ON THE DRAFT VETERINARY PRACTICE BILL 2024 (THE REVIEWED VETERINARY SURGEONS AND VETERINARY PARAPROFESSIONALS ACT 2011)

Effective delivery of Veterinary services is important for the development of the Animal Resource Industry in Kenya comprising livestock, wildlife, farmed wildlife, companion and aquatic animal species. The Animal Resource Industry has been identified as a priority key social economic enterprise in Kenya under the Bottom-Up Economic Transformation Agenda. The industry plays an important role in the national economy with a direct contribution of about 42 percent to the agricultural GDP and 12 percent to the national GDP (FAOSTAT, 2005). It plays a crucial role in ensuring food and nutritional security; supporting animal resource-based livelihoods and generating national income for the Kenyan population; enhancing production and productivity of animal resources; strengthening commercialization and market access of animal resources; improving Resilience for ASAL communities; and enhancing animal resource industry data management.

Following the promulgation of the Kenya Constitution 2010 and subsequent review, development and amendments of key policy instruments to align them to the Constitution, and the need to address the modern challenges faced in the Animal Resource Industry, harmonize and consolidate laws, the State Department for Livestock Development in collaboration with key stakeholders has reviewed the VSVP Act 2011 and developed a Draft Veterinary Practice Bill 2024. The Bill is to provide for the establishment of the Kenya Veterinary Council; to provide for the training, registration, licensing, practice and employment of veterinary surgeons, veterinary para-professionals and veterinary specialists; to provide for the regulation of animal health training institutions; for the regulation of animal health and welfare; to provide for the establishment of the Veterinary Medicines and Vaccines Authority, for the regulation of veterinary pharmacy; to provide for the regulation of veterinary medicines, vaccines and other biologicals, nutrients and for connected purposes. Thus, a highly skilled human resource is required to provide services at all levels of the Animal Resource Industry development as provided in the Sessional Paper No. 2 and 3 of 2021 on the Veterinary Policy and the National Livestock Policy respectively.

In compliance with the provisions of the Statutory Instruments Act No. 23 of 2013, the Ministry announces to public availability of the above draft Bill on the websites of the Ministries of Agriculture and Livestock Development ([www.kilimo.go.ke](http://www.kilimo.go.ke)) and Information, Communication and Technology ([www.ict.go.ke](http://www.ict.go.ke)), for access and perusal.

The Cabinet Secretary for Agriculture and Livestock Development is therefore calling for views and proposals from members of the general public and any concerned stakeholders, for consideration in finalization of the draft Veterinary Practice Bill 2024.

Chelugui alitoa wito kwa serikali za kaunti katika maeneo yanayolima kahawa kusaidia wakulima na miche bora ya kahawa ili kuongeza uzalishaji wa kahawa.

"Lengo letu ni kuongeza uzalishaji wa kahawa hadi zaidi ya tani 200,000 kila mwaka. Kwa sasa uzalishaji ni takriban tani 100,000 na uzalishaji mkubwa unaweza kupatikana kwa kutoa huduma za nyanjani kwa wakulima. Hili litafanywa na serikali za kaunti," akasema.

"Ahadi hii inawiana na moja ya malengo ya Eneo Huru la Biashara Huru la Bara la Afrika kuunda soko moja katika bara hili na kuen-deleza ukuaji wa uchumi, kubuni ajira na kuangamiza umaskini," alisema.
