

Wakati huo huo, Bw Gachagua alisema vita

"Changamoto ya pombe haramu na dawa za kulevyo ni ya kweli, na watu wengi wanataka kukataa ukweli.

Tulipoingia ofisini na Rais Ruto, tulipata changamoto kubwa kuhusu pombe haramu na mihadarati kote nchini na haswa katika eneo la Kati ya Kenya.

Tulichukua hatua kali na tumepiga hatua kubwa bila kukatizwa ili kuokoa nchi yetu," alisema.

Aliongeza: "Nime-waonya viongozi, yeyote atakayetaka kuingilia ataitwa kwa majina ili aaibishwe. Hatuwezi kuruhusu kuuzziwa sumu iliyojifichwa kama pombe ili kuua watoto wetu."

Alitoa wito kwa Kanisa na mashirika ya dini kungana na serikali katika kuwaokoa vijana walio-athirika na maovu hayo na kuwarekebisha wale walioathirika.

Naye Mkuu wa Shule ya Sekondari Lwanda Dudi Dkt Elizabeth Aseka aliukaribisha mradi huo kwa matumaini kuwa utasaidia kupunguza gharama za bili za umeme ambazo kwa sasa ni zaidi ya Sh30,000 kwa mwezi kwa shule yenye wanafunzi 565 ambapo 150 wanalala shulen.

"Bili zetu za stima ni kubwa sana, na zime-ongezeko sana katika siku za hivi karibuni. Hii ni changamoto kubwa sana kwetu kwa sababu ufa-dhili ni tatizo kwa sababu tunategemea ufadhili wa serikali. Kwa hiyo, kuna wakati unahitaji kulipa bili hizi ambazo ni kubwa sana na bado serikali hijatoa fedha," Dkt Aseka alisema.

Alisema kuwa Kam-puni ya Kenya Power and Lighting Company (KPLC) wakati mwingine hutoa onyo la kukata stima kwa kushindwa kulipa bili za stima.

"Kwa hiyo wakati mwingine tunatishiwa kuwa stima itakatwa na hivyo tunalazimika ku-



tumia pesa za shughuli zingine ili tulipe bili

za stima ili kupunguza usumbuwa wa masomo," aliongeza.

"Pia tunakumbana na hitilafu za stima na kunapokuwa na hitilafu, tunapata tatizo kubwa sana kwetu kwa kuwa tuna sehemu ya bweni shulen," Dkt Aseka alisema.

Mwalimu Mkuu wa Shule ya Upili ya Wavulana ya Mwihiila iliyoko Khwiseri, Maurice Ajulu, anasema shule hiyo inatumia zaidi ya Sh75,000 kulipa bili za stima kila

mwezi.

Anasema, ili kupunguza gharama ya stima, shule hiyo imeweka sola kuwashaa taa, lakini bado wanakabiliwa na changamoto kwa kuwa shule hiyo ni kubwa, ina eneo la ekari 33.

Kuangaza eneo lote kutahitaji taa nyingi za mlingoti lakini hatu-wezi kufanya hivyo kwa wakati mmoja kwa sababu ya shida za kifedha, lakini angalau tumeanza. Hilo ni eneo lingine am-baloo tunaweza kuhitaji usaidizi ili kuboresha us-alama wetu," alisema.

Bw Ajulu alisema kubadili aina ya balbu zinazotumiwa na shule na kuweka balbu zenye ufanisi zaidi za kuokoa kawi kutasaidia shule hiyo katika kupunguza gharama ya stima.

Naye Mwalimu Mkuu wa Shule ya Sekondari Lwanda Dudi Dkt Elizabeth Aseka aliukaribisha mradi huo kwa matumaini kuwa utasaidia kupunguza gharama za bili za umeme ambazo kwa sasa ni zaidi ya Sh30,000 kwa mwezi kwa shule yenye wanafunzi 565 ambapo 150 ni wa bweni.

Familia 1,500 zisizojiweza Murang'a kupokea ufadhili kutoka kwa Serikali

Baadhi ya familia 1,500 zilizo hatarini kutoka Kaunti ya Murang'a zitapokea usaidizi wa kifedha kuptitia mpango unaofadhiliwa kwa pamoja na serikali na Benki ya Dunia.

Familia hizo kutoka kaunti ndogo za Murang'a Mashariki na Murang'a Kusini zinatarajiwa kuanza kupokea usaidizi wa kifedha kwa matumizi na kuanzisha miradi ya kuzalisha mapato kufikia mwisho wa mwezi huu.

Katika mpango huo uliopewa jina la Mpango wa Kujumuisha Uchumi (EIP), kila familia imepangiwa kupokea Sh 2,000 kwa mwazi kwa mwaka mmoja na nyongeza ya Sh. 30,000 kama mtaji wa wa mali. Mratibu wa Huduma za Kijamii katika Kaunti ya Murang'a, Bi Lucy Gakera, alisema kuwa Sh 2,000 zimekusudiwa kusaidia familia kununua chakula na bidhaa nyine muhimu.

Gakera aliambia KNA



Sehemu ya wanufaika wa Mpango wa Ujumuisho wa Kiuchumi kutoka Kaunti Ndogo ya Murang'a Mashariki wakifunzwa jinsi ya kuwekeza usaidizi wa hali ya juu wa kifedha.

kuwa mpango huo unafanyiwa majaribio katika kaunti ndogo mbili katika kila kaunti tano, zikiwemo Kisumu, Taita Taveta, Makueni, Marsabit na Murang'a.

"Hii ni kundi la pili. Kundi la kwanza liliufaika 2021, na washiriki walichaguliwa kutoka kaunti ndogo mbili ambapo familia 750 katika kila kaunti ndogo zilichaguliwa," alisema Gakera. Serikali, alibainisha, imepeleka

washauri kutoa mafunzo na kuongoza familia kuhusu miradi endeleu zinazoweza kuwekeza kwa mtaji zinazopewa.

"Washauri tayari wako tayari, wanatoa mafunzo na kuzielekeza familia ili kuhakikisha zinatumia fedha hizo kwa uangalifu, hasa kwa ajili ya kuanzisha miradi endeleu."

"Mtaji huu utatolewa kwa awamu mbili: mwanzoni, familia zitata Sh. 20,000, ikifua-

tiwa na nyongeza ya Sh. 10,000 baadaye," aliongeza.

Gakera alieleza kuwa familia hizo zili-chaguliwa kutoka kwa rejista moja iliyomarishwa iliyokamilika mwaka wa 2022, ambayo iliorodhesha familia kulingana na mazingira magumu yao.

"Kwa sasa tunafungua akaunti za benki kwa walengwa, na mchakato huu unatarajiwa kuka-milika ndani ya wiki moja. Familia zinapaswa kuanza kupokea msaada wao wa kifedha mwishoni mwa Julai, "alisema.

Kulingana na Gakera, walengwa hao pia wanatarajiwa kuunda vi-kundi vya kuweka akiba na kujikimbu ili kusaidia kuweka akiba. "Akiba hiyo inakusudiwa kusaidia familia baada ya mpango kumalizika. Watapata mwongozo wa jinsi ya kuweka akiba ipasavyo ili kuhakikisha wanakuwa na uwezo wa kujitegemea baada ya muda wa usaidizi kuka-milika," aliongeza Mratibu huyo.

Washiriki wengine ni pamoja na Alfred Githui Muriu kutoka Shule ya Nairobi na Lenny Muriungi Mutuma kutoka Shule ya Upili ya Oloolaiser kaunti ya Kajiado. Watano hao watashiriki katika toleo la 65 la Olympiad la Kimataifa ya Hisabati (IMO), mashindano ya hisabati ya ubingwa wa dunia kwa wanafunzi wa shule za upili yanayofanyika kila mwaka kwa mzunguko katika nchi tofauti. Hafla hiyo ya mwaka huu lilifanyika kuanzia Julai 11, 2024 hadi Julai 22, 2024, katika Chuo Kikuu cha Bath nchini Uingereza, na washiriki kutoka zaidi ya nchi 100 kote Amerika Kaskazini, Ulaya, na Asia. Nchi kama vile Canada, Amerika, China,

India, na Korea Kusini zil-iwakilishwa.

Naibu Mratibu wa Kituo cha Hisabati, Sayansi na Teknolojia barani Afrika (CEMASTE) cha Uhndisi wa Teknolojia ya Sayansi na Hisabati (STEM) Martin Mungai alidokeza kuwa washiriki walichaguliwa kutoka kundi la wanafunzi 8,000 walioshiriki vyema katika mashindano ya Olympiad ya Hisabati ya Kenya 2023 na 2024 (KMO).

Mbali na hilo, alisema, Tony Rotich pia atajunga na MIT kwa masomo ya shahada ya kwanza kwa udhamini kamili. Mungai alieleza kuwa wanafunzi hao watano walikuwa bora zaidi kwa jumla katika Olympiad ya Kenya ya Hisabati ya mwaka huu inayoandaliwa kila mwaka kuanzia 2022 na CEMAS-TEA kwa ushirikiano na Kituo cha Elimu ya Hisabati na Kompyuta kutoka Chuo Kikuu cha Waterloo Canada na Chuo Kikuu cha Nairobi.

Alisikitika kwamba Elvis Obilemire Atsulu wa Shule ya Upili ya Nyang'ori ambaye pia alifuzu kwa shindano hilo hakuweza kushiriki kwa kukosa Visa ya Uingereza.

Bodi ya Viwango vya Uhasibu katika Sekta ya Umma (PSASB) ilianzishwa tarehe 28 Februari 2014 kwa mujibu wa vifungu vya 192 hadi 195 vya Sheria ya Usimamizi wa Fedha za Umma (PFM, Sheria) ya 2012. Sheria inaitwika PSASB jukumu la kuagiza mifumo na kuweka viwango vinavyokubalika kwa ujumla kwa ajili ya maendeleo na usimamizi wa mifumo ya uhasibu na fedha na vyombo vyote ya serikali na mashirika ya umma.

PSASB imekamilisha utayarishaji wa Mpango Mkakati wa 2023-2027 ambao utasaidia vyombo vyote ya serikali na mashirika ya umma katika kuweka viwango vinavyokubalika kwa ujumla kwa ajili ya maendeleo na usimamizi wa mifumo ya uhasibu na fedha.

Mpango huo pia utachangia Ajenda ya Maendeleo ya Kitaifa kwa kusaidia vyombo vyote ya serikali na mashirika ya umma katika utekelezaji wa viwango vya uhasibu, viwango vya ukaguzi wa ndani na usimamizi wa hatari. Utumiaji wa viwango hivi unatarajiwa kuimariswa uwazi na uwajibikaji katika sekta ya umma kama inavyotarajiwa katika Kifungu cha 201 cha Katiba ya Kenya.

Kwa hiyo, PSASB imebainisha mada nne(4) muhimu za kimkakati katika rasimu ya mpango mkakati, ambazo ni:

1. Ubora, usahihi, na usawa wa taarifa za kifedha, ukaguzi wa ndani na usimamizi wa hatari
2. Ukuzaaji wa uwezo katika uhasibu wa sekta ya umma, viwango vya ukaguzi wa ndani na miongozo ya usimamizi wa hatari
3. Kuzingatia viwango vilivywewe, miongozo na mifumo
4. Uwezo wa taasisi.

wa hafla hiyo, Katibu wa Maendeleo ya Mifugo Jonathan Mueke alisema kuwa sekta ya mifugo ni sehemu muhimu ya uchumi wa Kenya, ikichangia hadi asilimia 12 ya Pato la Taifa na kuajiri nusu ya wafanyakazi wa kilimo.

"Mifugo, ikiwa ni pamoja na ng'ombe milioni 22, kondoo na mbuzi milioni 63, ngamia milioni tatu, na punda milioni 1.8, ni uti wa mgongo wa maisha ya jamii nyngi za mashambani, hasa katika maeneo kame na kavu (ASALs) ambapo Wakanya milioni 10 wanategemea mifugo," Mueke alisema.

Katibu pia aliongeza kuwa kondoo na mbuzi, ambaa mara nyingi hujulikana kama mifugo wadogo, wana jukumu muhimu kwa kutoa mapato, ajira, na mapato ya nje.

Hata hivyo, sekta hiyo inakabiliwa na changamoto kubwa kama magonjwa, wadudu, hali mbaya ya hewa na masuala ya upatikanaji wa soko, alisema.

Alilalamika zaidi kuwa magonjwa yanayovuka mipaka kama vile ugonjwa wa miguu na midomo, homa ya Bonde la Ufa, kimeta, na PPR hubabisha hasara kubwa

za kiuchumi kutokana na viwango vya juu vya vifo, gherama za matibabu na afya duni ya wanyama.

"PPR, ambayo pia inajulikana kienyeji kama "sotoka ya mbuzi," inatisha sana. Ugonjwa huo uliripotiwa kwa mara ya kwanzia nchini Kenya mwaka wa 2006 huko Turkana na tangu wakati huo umesababisha mili-

puko mikali, ambayo kimsingi inaathiri kaunti kame na kavu. PPR si tu inatisha afya ya wanyama wadogo, lakini pia inahatarisha wanyama wengine wa porini, na hivyo kutatiza juhudzi za kuudhibiti," katibu alijuta.

Mueke alisema kuwa ili kukabiliiana na madhara makubwa ya PPR kwenye utoshelevu wa chakula na

uchumi katika maeneo ya mashambani, mkakati wa kimataifa wa kuuangamiza umeandaliwa na kupitishwa nchini Kenya.

Alibainisha kuwa mkakati huo unalenga kudhibiti na kuangamiza PPR ifikapo mwaka 2027, akisisitiza kupunguza kipaumbele cha magonjwa mengine ya wanyama wadogo (SRDs). Athari za kiuchumi za PPR ni kubwa, huku hasara ya kila mwaka katika kaunti za ASAL ikikadiriwa kuwa Sh1.67 bilioni mwaka wa 2016.

"Udhibiti wa magonjwa unazuia upatikanaji wa masoko yenye faida ya mifugo na mazao ya mifugo kutokana na vikwazo vinavyozingatia biashara viliviyowekwa ili kuzuia kuenea kwake.

Vizuizi hivi vinazua usafirishaji wa wanyama na bidhaa zao, na kuathiri ustawi wa kiuchumi wa jamii za wafugaji zinazategemea mifugo," Mueke alisema.

1.0 Background

Bachuma Quarantine Station was initially conceptualized as a Disease-Free Zone (DFZ) and a flagship Project under the Kenya Vision 2030 blue print. The goal of the DFZ Program was to contribute towards poverty reduction and food security. The overall objective was to improve livelihoods and increase the Livestock Sub-Sector contribution to the national economy by promoting trade in animals and animal products through improved access to international markets.

The expected outputs of Disease-Free Zones included increased supply of quality meat, by 48,000 MT, for sale locally and export; creation of over 100,000 employment opportunities; reduction in human deaths arising from diseases transmissible from animals to humans; increased milk production for sale or household consumption by 5 million litres; increased hides and skins value and rangeland and environment improvement of 2 million hectares per year.

The value of the benefits was estimated at Ksh. 16.2 billion annually. Direct beneficiaries would be livestock owners (pastoralists, agro-pastoralists, ranchers, mixed farmers and dairy farmers), livestock traders, associated operators and chambers of commerce, public and private sector animal health service providers and Community-Based Organizations engaged in the Livestock Sub-Sector. The Disease-Free Zone concept is not entirely feasible in Kenya due to existing land ownership models. Consequently, the concept of Disease-Free Zones was dropped in favour of quarantine stations and disease-free compartments.

The livestock value chain disease risk management concept based on quarantine stations was conceptualized in 2013 and approved for implementation after revision of the previous Kenya Disease Free Zoning program of Vision 2030. The purpose of the quarantine stations is to increase access to Kenya's animals and animal products to local and international markets and realize some of the objectives under the previous DFZ concept. The national livestock finishing system that feeds into the quarantine stations will be at the county level through government and private sector initiatives at the various holding grounds, feedlots, ranches, and large farms. Strategic holding grounds have been identified within the Counties of Marsabit, Isiolo, Laikipia, Tana River, Lamu, Narok, Baringo, Kajiado, Kwale, Taita Taveta, and West Pokot amongst others for use towards the realization of this concept.

The World Organization for Animal Health (WOAH) and the World Trade Organization (WTO) guidelines require animals destined for export to be quarantined in a standard veterinary-approved facility. For Kenya to fulfill this requirement, the development of a national livestock quarantine facility, Bachuma Livestock Quarantine Station (BLQS), was initiated in Bachuma livestock holding ground in Taita-Taveta County. This quarantine station was fully funded by the Government of Kenya though construction was discontinued at 80% completion due to funding challenges. The current livestock holding infrastructure at BLQS are nine (9) cattle pens each measuring 50m x 80m capable of holding 500-600 heads of cattle, six (6) sheep and goat pens each measuring 35m x 80m capable of holding 1400 heads, and three (3) camel pens each measuring 50m x 80m capable of holding 400 heads. Other installations at various levels of completion include fencing, electricity and water installation and reticulation, Laboratory building, staff houses, office block, emergency slaughterhouse and post mortem building, maintenance workshop, feed store, and wildlife protection trench.

The overall goal of BLQS is to provide a controlled environment for monitoring the health of animals destined either for export or local markets live or as products, and veterinary certification. The Quarantine Station is expected to process 50,000 cattle, 100,000 sheep and goats, and 10,000 camels annually. The facility is to be expanded based on livestock demand. The Director of Veterinary Services will provide the necessary regulatory and sanitary controls.

1.1 Proposed Operational Framework

The proposed operational framework to manage the Bachuma Livestock Quarantine Stations is as follows;

- Providing a long-term lease to a private operator through the provision of the Land Act No. 6 of 2012. This act provides for the lease process and activities to be undertaken by the procuring entity while retaining ownership of the land in a Build, Operate, and Transfer (BOT) model.
- Under this lease, the private operator will manage the station, and develop all infrastructure, transport, and equipment necessary for handling the livestock during Transportation, housing, feeding, and disease screening under the oversight of the Director of Veterinary Services (DVS). The operator will deploy all manpower necessary to operate the facility.
- The partner will charge fees per unit animal processed as the revenue generation model within an approved framework in consultation with the State Department for Livestock.

2.0 Objective of the assignment

The objective of this lease arrangement is to engage an appropriate partner for the lease to undertake the overall management of the Bachuma Livestock Quarantine Station and the associated facilities. The land available for lease in the BLQS project is 15,000 acres inclusive of the developed infrastructure.

2.1 Specific objectives

- To complete pending works in Bachuma Livestock Quarantine Phase I and II as per the designs with SDLD
- Operationalize Bachuma LQS and Support the livestock screening activities at the station in collaboration with the Director of Veterinary Services (DVS).
- To undertake expansion of the remaining phases of the quarantine station as per the recommended master plan

2.2 Scope of Work

To achieve the objectives of Bachuma Livestock Quarantine Station, the successful bidder will complete the pending works at the quarantine station as initiated by the State Department for Livestock. The client will provide detailed designs and bills of quantities for the pending works.

Towards operationalization of the quarantine station, the successful bidder shall develop a comprehensive strategy that outlines the management approach and plans for meeting requirements for target export markets for livestock and livestock products. The bidder will understand and analyze the import regulations, sanitary and phytosanitary measures, labelling requirements, traceability, sustainability, and other measures applied by target markets. The bidder will participate in creating demand for livestock and livestock products from Kenya assessing their competitiveness and market potential and offering recommendation to traders and livestock producers. The bidder will work closely with livestock producers at county level to ensure a sustainable supply of livestock and livestock products to identified niche markets.

The bidder will document and advise the DVS on any issues relating to market access for prompt action

2.3 Expected deliverables

The following are the expected deliverables from the successful bidder.

- Design an appropriate Livestock quarantine operation management system approved by the DVS
- Deploy management team at Bachuma both for the requisite administrative and Livestock handling and screening
- Undertake all required development and requirements for housing and feeding of quarantine-based livestock including expansion as per the master plan approved by the SDLD.
- Mainstream an appropriate provision for feeding of livestock at the quarantine and during shipment
- Provide all the necessary station equipment for both administration and livestock handling operations
- Provide appropriate transport for livestock from the counties to the station and for shipment.
- Maintain appropriate records including the identification and traceability for livestock processed through the quarantine station.

2.4 Duration of the assignment

The successful bidder shall take possession of, equip, operate, maintain, modernize and expand the Bachuma Livestock Quarantine Station for a concession period of 30 years.

State Department for Correctional Services Principal Secretary Dr. Salome Beacco has commissioned one hundred housing units at the Shimo la Tewa GK Prison as part of on-going reforms targeted at improving the welfare of prison officers.

to ensure offenders can be impacted with knowledge on modern skills as well as increase production.

She revealed that the government, through the State Department, is planning to recruit more Prison Officers in phases to further enhance service delivery.

The PS later toured Kwale Probation Station and the Kwale Main and Women Prisons where she challenged staff to embrace innovative practices to address emerging challenges.



Teknolojia hii hupa kila kipande kili-chokatwa kitambulisho cha kipekee cha dijiti ambacho data yake haiwezi kubadilishwa, kufutwa, au kupotoshwa na mhusika yeyote katika msururu wa kuongeza thamani. "Kila jiwe kwenye onyesho letu lina simulizi iliyohifadhiwa kwenye

mtandao wa blockchain. Inalinda utambulisho wa kipekee wa mawe ya wachimbaji madini na kusaidia ufuatilaji wa bidhaa hiyo popote duniani," anaeleza Irene Walowe wa Taita Gems katika Kituo cha Vito cha Voi. Kutumwa kwa teknolojia ya blockchain ya NFT ili kuimarisha usalama wa soko la vito na kulinda vitambulisho vya kipekee vya mawe ya thamani na nusu ya thamani yanayochimbwa na wachimbaji wa madini wanawake katika vijiji vya mbali vya Kaunti ya Taita-Taveta ni hatua kubwa katika linasaidia wachimbaji

mali ya kidijitali katika sekta ya madini ya Kenya. Teknolojia hii inatazamwa kama mbinu ya vitendo zaidi katika kukuza utambulisho wa chapa ya vito na kuingiza ndani sababu ya ufuatilaji katika vita dhidi ya magendo ya vito. Pindi jiwe la vito linapchorwa kidijitali na taarifa zote muhimu zinanaswa katika mtandao wa NFT blockchain, maelezo hay-awezi kamwe kubadilishwa au kubadilishwa na mtumiaji wa mwisho, awe mnunuzi au sonara. Teknolojia hii, iliyotengenezwa na GEM-FUND-shirika ambalo linasaidia wachimbaji

hivyo kupunguza hewa ya kaboni pamoja na kulifanya liwe na gharama nafuu katika kipindi hiki ambacho gharama ya mafuta ni kubwa," alisema. Ubunifu huo hata hivyo bado haujatolewa sokoni huku Prof Kamau akilalamikia gharama ya juu ya vifaa viliviyotumika kuunganisha gari hilo ambalo alisema ni changamoto kuu katika uzalishaji mkubwa wa tuktuk.

Ili kurahisisha utengenezaji wao, Prof Kamau alitoa wito kwa serikali kubuni sera zinazosaidia kutumiwa kwa magari ya umeme na kuhakikisha kuondolewa kwa ushuru wa vipuri ikiwa ni pamoja na chuma, betri na vifaa vingine.

lakini utakuzwa kila mahali. Tutaeneza teknolojia hii kwa wachimbaji migidodi kote nchini Kenya na kwangineko. Vito kwenye mtandao wa T3 vinaonekana polepole katika maduka ya Kenya na vitapatikana duniani kote hivi karibuni," alisema. Biss anaeleza kuwa ufuatilaji na vigezo vya uwazi vinaposhughulikiwa, masuala kadhaa yanayohusiana kama vile taratibu za kazi na malipo ya haki pia yatashughulikiwa. Anasema kuwa kwa kuzuia magendo na kuongeza uwazi katika kuripoti kuhusu madini ya vito, teknolojia hii inaweza kuwa rasilimali kubwa katika kuendesha lengo la nchi la kuwa na wachimbaji madini ku-changia asilimia 10 katika Pato la Taifa la Kenya. Hawa 'wanunuzi wa dhamiri' mara ny-tingi huongozwa na hofu kwamba ununuzi wao unaunga mkono kwa njia isiyo ya moja kwa moja shughuli haramu kama vile magendo, kuendeleza unyonyaji wa wachimbaji wadogo, au kuhimiza utovu wa kazi kama vile matumizi ya watoto katika mchakato wa uchimbaji madini. zaidi, ikiwa na kasi ya zaidi ya kilomita 60 kwa saa. Hata hivyo, bei yake ni ya juu kidogo kuliko tuk-tuk za kawaada, kwa Sh450,000.

"Tumeunda tuk-tuk, tumeweka injini za umeme, na kuongeza paneli za juu ili kuchaji betri zake mara tu zinapoisha. Haina kelele, haina gharama, na ni safi," alisema Prof Kamau wakati wa Wiki ya Ubunifu ya Chuo Kikuu.

Alisema kuwa msukumo wake ulikuwa kutoa usafiri wa ufanisi, wa gharama nafuu, na unaotunza mazingira, kupunguza kutegemea mafuta ya kawaada na kupunguza athari kwa mazingira.

"Kuzinduliwa kwa miradi hii ya maendeleo ya maji kinalenga kuhakikisha upatikanaji wa maji salama na ya kutosha kote katika Kaunti ya Makueni kwa matumizi ya ma-jumbani, unyunuzaji na viwandani," alisema Mutula

Katika ziara hiyo, Mutula pia alizindua miradi miwili ya chekechea (ECDE) ambapo madarasa na vyoo vitatu na ofisi zilijengwa kwa Sh7 milioni.

Katika vituo vya ECDE vya Kyaani na Katilani, madarasa mawili, ofisi na vyoo vitatu kwa kila moja vilijengwa.

"Serikali yangu imeanza kuhakikisha wanafunzi wa ECDE wanajifunza katika mazingira mazuri na yanayofaa," alisema Mutula alipokuwa akizindua miradi hiyo.

Mradi huo, ambao hutoa maji yake kutoka Mito Kiringa na Thiba, umeongeza uzalishaji wa maji kutoka mita za ujazo 10,000 hadi mita za ujazo 30,000 kwa siku, na hivyo kumaliza mgao wa kudumu wa maji na uhaba katika maeneo mengi ya kaunti.

Mradi huu, uliotekeli-

zwa kupitia juhudzi za ushirikiano kati ya serikali ya kitaifa na kaunti, ni hatua muhimu katika kutoa ufikiaji wa maji safi na bei nafuu kwa wote katika kaunti.

Miji ambayo inanufaika na mradi huo ni pamoja na Kagumo, Kagio, Kerugoya, Sagana, Makutano, Kandongu, Kangai, na Mutithi. Pia kuna mipango ya kuupanua kuhudumia wakazi wa Gichugu ya juu, zikiwemo wadi za Karumandi, Baragwi, Kabare, na Njukiini.

Mradi huo unaosimam-iwa na serikali ya kaunti kupitia Kampuni ya Maji na Usafi wa Mazingira ya

Kirinyaga (KIRIWASCO), umewezesha huduma endelevu ya saa 24 kutoka kwa huduma ya awali ya saa 18, hivyo basi kupunguza uhaba wa maji na mgao.

Waziri wa Kaunti anayeshughulikia Mazingira, Maji na Unyonyuzaji, James Kinyua amebainisha kuwa kutokana na ziada ya mita za ujazo 20,000 za maji zinazozalishwa kwa siku, huduma za maji sasa zitasambazwa katika maeneo ambayo hayana huduma.

Tunafanya upimaji wa kila mwezi ili kuhakikisha ubora unadumishwa," akasema, akibainisha kuwa maji safi yatapunguza pakubwa kuenea

kwa magonjwa yanayotokana na maji na kuwa na athari chanya katika viwango vya kijamii na kichumi vya kaunti.

Mpango huo, unaonogozwa na Idara ya Mabadiliko ya Tabianchi, ni sehemu ya mpango wa Financing Locally Led Climate Action (FLLoCA).

Mradi huo pia unazingatia Sheria ya Kitifa ya Mabadiliko ya Tabianchi ya 2016, ambayo inaziamuru kaunti kujumuisha shughuli za mabadiliko ya hali ya hewa katika programu zao za maendeleo na mundo ya usimamizi.

Vikaushio vitaongeza uwezo wa usindikaji na ubora wa kahawa inayozalishwa na viwanda vilivvolengwa. Mkurugenzi wa Mabadiliko ya Tabianchi katika Kaunti ya Nyeri Yvonne Mathenge alisema serikali ya kaunti hiyo inatarajia kuendeleza mpango huo kwa angalau viwanda vingine vinne katika siku zijazo.

Vikaushio vya sola vile vilesitasaidia kuboresha mchakato wa ukaushaji, na hivyo kuhifadhi ubora wa kahawa na thamani ya juu ya soko la bidhaa hiyo.

"Tunahimiza vikaushio vya sola kwa sababu mwisho wa siku ina maana wanaokoa gharama za uendeshaji na ni faida kwao (wakulima). Kwa hivyo, ni jambo zuri na linarahisisha kazi kwa sababu wana uwezo wa kuchakata zaidi, kutumia muda mchache na kutumia gharama ndogo," aliongeza.

Mwaka jana, Idara ya Maji, Mazingira na Mabadiliko ya Hali ya Hewa ya Kaunti ilioa pendekero ambalo lingefanya kaunti hiyo kutenza asilimia ya bajeti yake ya maendeleo ya kila mwaka kukabiliana

Katika hotuba iliyotolewa kwa niaba yake na Mkurugenzi wa Utawala na Fedha, Josephat Onyari, katika hoteli moja ya Mombasa, Mkurugenzi Mtendaji wa IGAD Dkt Workneh Gebeyehu alibainisha kuwa mafuriko ya hivi majuzi yamesababisha zaidi ya watu 300,000 kuyahama makazi yao, kuharibiu nyumba 10,000, na kutatiza huduma muhimu ikiwa ni pamoja na huduma za afya.

"Maafa haya makubwa yanahitaji hatua za haraka na madhubuti. IGAD, kwa ushirikiano na washirika wetu, inatambua hitaji la dharura la kushughulikia changamoto za afya zinazokabili jamii zilizoathiriwa," Dkt Gebeyehu alisema.

Msaada huo uliwezekana kupitia michango ya nchi wanachama wa IGAD ambazo ni Djibouti, Ethiopia, Kenya, Somalia, Sudan na Uganda na washirika wa maendeleo kujenga upya na kuimarisha mifumo ya afya na kujenga jamii zenyne uwezo wa kuhimili changamoto za siku zijazo.

Wakati huo huo, litanisaidia kujikita katika shughuli nyingine bila kuhangaikia maji," alisema Zipporah Lang'at, mmoja wa walionufaika wakati wa zoezi la kukabidhiwa huko Naibor, wadi ya Segera.

Aidha alifichua kuwa hapo awali alitumia muda wake

mwangi kuchota maji jambo ambalo lilimnyima fursa ya kujishughulisha na shughuli nyingine za kujikimu kimai-sha.

Mkurugenzi wa mpango wa Habitat for Humanity Kenya Nixon Otieno alisema wana nia ya kusaidia wanawake wafugaji ili kupata mapato kuititia kilimo na shughuli mseto za mai-sha. Zaidi ya hayo, alidokeza kuwa mpango huo unaendana na ajenda ya serikali ya kuongeza uzalishaji wa kilimo kuititia teknolojia ya kilimo kinachoingatia hali ya hewa. Karani wa Kaunti ya Laikipia Koinange Wahome alipongeza mpango huo aki-bainisha kuwa utaboresha upatikanaji wa maji katika kaunti hiyo jambo ambalo bado ni changamoto hasa nyakati za kiangazi.

"Nimefurahi kwamba kupitia ushirikiano huu, tunapiga hatua katika kuttatu changamoto za maji. Juhudi hili zinaendana na maono yetu ya kusambaza matangi 50,000 ya maji ifikapo 2027 kwa wakazi," alisema Wahome.

Shirika la Utafiti wa Mifugo na Kilimo Kenya (KALRO) limezindua uundaji wa mfumo endelevu wa uzalishaji wa mbegu za mpunga ulioi-dhinishwa amba unata-rajiwa kubadilisha maisha ya wakulima kwa kutoa mbegu ya mpunga ilioi-dhinishwa kwa bei nafuu ili kuboresha uzalishaji.

Kupitia mradi wa miaka mitano wa Ushirikiano na Korea kwa Kilimo Bunifu (KOPIA), KALRO itasaidia uzalishaji wa mbegu zinazokomaa haraka, kuongeza mbegu bor goa zilizoidhinishwa na usambazaji wa mbegu zilizoidhinishwa za mpunga kwa wakulima wa mpunga.

Akizungumza mjini Mwea wakati wa uzinduzi wa mradi huo, Mkurugenzi Mkuu wa KALRO Dkt Eliud Kireger alisema sekta ya mpunga nchini Kenya haijidakhi ongezeko la mahitaji ya mchele. Suala hili limechangiwa na kuongezeka kwa watu

wa tabaka la kati na kukua kwa miji, huku watu wengi wakitegemea mchele kwa chakula.

"Matumizi ya mchele nchini yanapanda hasa kwa sababu ya vijana wanaocha 'ugali' na m kutumia mchele. Idadi ya watu mijini nchini Kenya pia inakadirwa kufikia asilimia 50 ya watu wote ifikapo mwaka 2050, ambayo ina maana kwamba mahitaji yao ya chakula yatasababisha upungufu mkubwa

wa mchele," alisema.

Mkurugenzi Mkuu alielesa kuwa kwa sasa, mahitaji ya mchele kwa mtu mmoja kwa mwaka ni kilo 28 lakini, kwa kuangalia mwenendo wa sasa, Wakenya wanatarajiwa kutumia takriban kilo 30 za mchele kwa kila mwananchi ifikapo 2027 ikiwa ni jumla ya tani milioni 1.8 za mchele.

"Kwa sasa tunatumia takriban tani 950,000 hadi milioni moja za mchele

ambapo tunazalisha tani 200,000 tu, upungufu wa asilimia 80 na ili tuweze kuziba pengo hilo, tunahitaji kuwa na mfumo wa mbegu amba unata-hakikishia mbegu bora za bei nafuu, ili wakulima waweze kuongeza uzalishaji," alisema.

Alielesa kuwa ili kuki-dhi mahitaji hayo, serikali kupitia Agenda ya Mabadi-liko ya Kiuchumi kuanzia mashinani 'nguzo ya kumpunguza uagizaji bidhaa kutoka nje', inalenga kuwa na kasi ya ukuaji wa mwaka ya asilimia 25 katika uzalishaji wa mpunga.

"Tunatumai katika miaka minne hadi mitano ijayo, tutakuwa tumeziba pengo hilo kwa asilimia 50 hadi 60 ya kile tunachozalisha, na hii itafanywa kwa kuboresha upatikanaji wa mbegu zilizoidhinishwa sokoni kwa mazao ya juu," aliongeza.

Dkt Kireger alisema kuwa katika mfumo wowote wa uzalishaji wa mazao, umuhimu wa ubora wa mbegu na mifumo bora ya mbegu hauwezi kupuuzwa.

Eneo la Mlima Kenya kufaidika na mpango wa maendeleo ya maji na usafi wa Sh63b

NA WANGARI MWANGI(KNA)

Shirika la Maendeleo ya Maji la Tana (TWWDA) linatafuta Sh 63 bilioni kui-marisha usambazaji wa maji na kuboresha huduma za usafi wa mazingira katika kaunti tano za ukanda wa Mlima Kenya katika muda wa miaka mitano ijayo. Mapendekezo haya yameainishwa katika Mpango Mkakati wa 2023-2027, unaolenga kuongeza upatikanaji wa huduma bora za maji kutoka asilimia 57.8 hadi 90 ifikapo mwaka 2027. Aidha, shirika linalenga kuongeza huduma za usafi wa mazingira kutoka asilimia 8.1 hadi 30 ifikapo mwisho wa kipindi chq utekelezaji.

Ili kufikia malengo haya, TWWDA itategemea seri-kali kuchangia Sh 8.5 bilioni kusaidia miradi hiyo. Miradi hii itatekelezwa katika kaunti za Embu, Kirinyaga, Nyeri, Tharaka-Nithi, na Meru.



Katibu Msimamizi katika Idara ya Maji na Usafi wa Mazingira, Stephen Kihara (wa pili kushoto), Mkurugenzi Mtendaji wa Tana Water Works Development Agency Mha Phillip Gichuki (Wattatu Kulia) pamoja na wajumbe wa bodi ya shirika hilo wakati wa uzinduzi wa Mpango Mkakati wa shirika wa 2023-2027 kwenye Bantu Resort katika Kaunti ya Nyeri.

Ushirikiano kati ya Sekta ya Umma na Sekta ya Kibinasi utachangia Sh 30 bilioni katika mpango huo huku Sh 21.7 bilioni zikipatikana kutoka kwa washirika wa maendeleo. Na Sh 3.5 bilioni zitakazobaki zitakotana na shughuli za kuzalisha mapato ndani ya shirika.

Akizungumza katika

hoteli ya Nyeri wakati wa uzinduzi wa mpango mkakati huo, Afisa Mkuu Mtendaji wa TWWDA Mhandisi Philip Gichuki alisema kuwa Shirika hilo linanuia kutekeleza miradi 32 ya maji katika azma yake ya kuongeza maji katika kaunti zote tano.

Aidha, shirika limepanga

miradi 14 ya usafi wa maz-

ingira ambayo itagharimu Sh 8 bilioni kutekeleza.

"Tunalenga kufikia asilimia 90 ya upatikanaji wa maji ifikapo 2027. Mpango mkakati umeweka malengo mahususi yanayohusu kaunti mahususi. Tuna miradi mikubwa ya usambazaji maji ambayo tunataka sana kufikia idadi ya watu ndani ya kaunti hizi na maji ya kutosha. Tunapofanya miradi ya maji, tunapaswa pia kuhakikisha kuwa taka zinazozalishwa zinashughulikiwa. Kwa hivyo, tutakuwa pia na kipengele cha usimamizi wa taka," aka-bainisha Mhandisi Gichuki.

Miradi hiyo ni pamoja na ujenzi wa mradi wa usambazaji maji wa Sh 1.6 bilioni katika kaunti ya Embu amba unafaisha takriban wakazi 250,000 na mradi wa usambazaji maji kwa wingi wa Sh 1.1 bilioni wa Kirinyaga unaolenga wakazi 100,000 wa Kirinyaga Kusini Mashariki.

Bodi yaonya umma kuhusu dawa bandia za kisukari

Bodi ya Kuthibiti Dawa na Sumu (PPB) imeta-hadharisha umma kuhusu dawa feki za ugonja wa kisukari, ikiwataka wagonjwa kuwa makini na kutoa taarifa kwa yeote anayeza dawa zinazotiliwa shaka.

Afisa Mkuu Mtendaji wa PPB Dkt Fred Siyo aliwema Bodii lipokea tahadhari kutoa kwa Interpol kuhusu dawa feki za Ozempic pens (semaglutide). Apidra Solostar pens (glulisine), zinazotumiwa kitubu kisukari aina ya 1 na aina ya 2, zimepewa jina la Ozempic (semaglutide) pens.

"Kwa hivyo, Bodi ingependa kufahamisha umma kwamba Ozempic pens kwa sasa hazijasajiliwa au kuidhinishwa na Bodi kuuza Kenya.

Kwa hivyo, bidhaa yoyote inayouzwa kama Ozempic pens ni kinyume cha sheria, na Bodi haiwezi kuthibitisha usalama, ubora na ufanisi wake," Dkt Siyo alielesa.

Ili kulinda usalama wa umma, alisema Bodi imechukua hatua za haraka

na kuongeza ufuatilaji ili kuthibitisha kama Ozempic pens feki zinauzwa katika Kenya kwa sasa.

"Bodi inatahadharisha umma na watalamu wa afya dhidi ya biasara, usambazaji, uuza jwa jumla, reja reja, kutoa, kusambaza, matumizi au usimamizi kwa wagonjwa wa Ozempic pens, kwa kuwa vitendo kama hivyo ni haramu na vinahatarisha afya na usalama wa umma," Afisa Mkuu Mtendaji aliwema.

Alitoa wito kwa umma na watalamu wa afya kutoa mara moja taarifa zozote kuhusu Ozempic pens kwa Bodi ya Dawa na Sumu.

Katibu wa Michezo Mhandisi Peter Tum ana matumaini kuwa timu ya Kenya italeta angalau medali nane za dhahabu kutoka Michezo ya Olimpiki ya Paris 2024.

Mhandisi Tum alikuwa akizungumza katika afisi ya Wizara katika Talanta Plaza huko Kamati ya Kitaifa ya Olimpiki ya Kenya (NOCK) ikitangaza hadharani orodha ya mwisho ya kikosi cha Kenya katika michezo hiyo.

Matokeo bora ya Kenya

katika historia ya Michezo ya Olimpiki yalikuwa mwaka wa 2008 wakati wa Michezo ya Olimpiki ya Beijing, ambayo nchi ilijizolea jumla ya medali 16: medali sita za dhahabu, medali nne za fedha na sita za shaba. "Mimi si mwanariadha, lakini nina imani timu hii italeta nyumbani angalau medali nane za dhahabu. Maandalizi yamekuwa ya hali ya juu ndani na nje ya nchi kuitia mashrikisho yao, na timu tunayoipeleka Paris ndiyo bora zaidi," alisema Tum ambaye atakuwa mkuu wa wajumbe wa timu hiyo na kiongozi wa ngazi ya juu kabisa serikali.

Aliogezza, "Ninataka kumshukuru Rais William Ruto

kwa kuiaga timu mnamo Julai 5 na kuhakikisha kuwa marupupu wakati huu ni ya juu sana. Aina hii ya motisha inatuhakikisha medali nyinyi."

"Kando na kushiriki Olimpiki, Kenya pia itakuwa ikijitangaza. Tutaonyesha uwezo wetu wa utali kama kivutio bora zaidi barani Afrika, pia tutaangalia biashara, na ndio maana tumesimamia Nyumba ya Kenya huko Paris.

Timu hiyo inajumuisha

wanariadha 81, maafisa wa timu 33, washiriki 26 wa timu ya usimamizi, na washiriki watano wa familia ya Olimpiki. Ni timu ndogo ikilinganishwa na kikosi kilichosafiri hadi Michezo ya Olimpiki ya Tokyo 2020. Rais wa Nock Paul Tergat alisema wanariadha hao zaidi ya 80 watashiriki michezo tofauti, ambayo ni: riadha, raga, voliboli, judo, na kuogelea.

"Ni siku nane rasmi kabla ya michezo ya Olimpiki ya Paris, kumaanisha kwamba tuko kwenye mkondo wa mwisho wa mwaka muhimu kwa wanamichezo. Michezo inakaribia kuanza. Ni wakati wa kila mwanariadha kuingia katika hali ya kushindana.
