Gachagua alisema

kuwa serikali imetenga takriban Sh80 bilioni kwa Wizara ya Maji, Usafi wa Mazingira na Umwagiliaji katika Mwaka huu wa Fedha wa 2023/2024 kwa ajili ya utekelezaji wa maendeleo wa upatikanaji wa huduma za maji safi na salama na uboreshaji wa uhakika wa chakula nchini. Naibu Rais alisema hayo katika hotuba iliyo somwa kwa niaba yake na Zachariah Njeru, Katibu wa Maji, Usafi wa Mazingira na Umwagiliaji wakati wa Kongamano la Wawekezaji wa Maji na Usafi wa Mazingira (WASIC) la 2024 lili ofanyika katika Kituo cha Mikuiano cha Kimataifa cha Kenyatta (KICC), Nairobi. Katika mwaka jana, Gachagua alifichua kuwa zaidi ya watu milioni nne wameunganishiwa maji na zaidi ya miradi kumi iliyokamilishwa na kuanza kutumika, na kufanya huduma ya maji kitaifa kufikia asilimia 72.

Baraza la Kitaifa la Kudhibiti Maambukizi ya Maradhi (NSDCC) limezindua mpango wa kuwafikia watu ili kudhibiti maambukizi mapya ya HIV mionganii mwa jamii ya wavuvi katika Kaunti ya Kisumu. Kathaka aliongeza kuwa kila mmoja wa viongozi wa BMU atawafikia wengine 700 wanaofanya kazi chini yao ili kuwasilisha ujumbe kwa ufanisi. Alisitisiza kuwa umakini kwa jamii ya wavuvi unatokana na kuongezeka kwa idadi ya maambukizi mapya ndani ya kundi hili, jambo ambalo lin-adhoofisha mafanikio yaliyopatikana katika kumpambana na virusi hivyo. "Takwimu zinatuonyeshwa kuwa idadi kubwa ya maambukizo mapya ya HIV hutokeea katika jumuiya ya wavuvi. Ndiyo maana Kaunti za Kisumu, Siaya, Homa Bay na Migori zimeorodheshwa kati ya tano bora katika mzigo wa HIV nchini," akasema. Alihusisha kuongezeka

kwa maambukizi na tabia ya kuhama kwa wavuvi na upatikanaji wa fedha ambazo huchochaea ngono ya kibashara. Hili, aliongeza, limechangia zaidi ongezeko kubwa la mimba za vijana huko Kisumu huku visa 6,000 vilivyoripotiwa katika Kaunti ya Kisumu mwaka wa 2022. Mwenendo huo, alisema,

unatia wasiwaso kwa vile vijana wanaopata mimba pia wanakabilawa na HIV na kuongeza idadi ya maambukizi mapya katika eneo hilo. Imesababishwa na Virusi vya Papiloma ya Binadamu (HPV), ambayo ni ya kawaida kwa wanaume ambayo hawajatahiriwa.

Miradi hiyo iliyozinduliwa na kufadhiliwa na shirika la World Vision Kenya, imemaliza uhaba mkubwa wa maji uliodumu kwa miongo kadhaa katika eneo hilo.
