

Waziri wa Afya Bi Susan Nakhumicha alisema hatua hii muhimu inasilitiza kujitolea kwa pamoja kushughulikia hitaji lisilotimizwa la huduma za upangaji wa uzazi na kuboresha matokeo ya afya kwa wanawake na familia kote nchini Kenya.

Katika hotuba ili-yosomwa kwa niaba yake na Kaimu Mkurugenzi Mkuu wa Afya, Dkt Patrick Amoth, wakati wa kupokea msaada wa dawa za kupanga uzazi kutoka FCDO-USAID katika Kituo cha Kitaifa cha Kusambaza dawa na vifaa vya afya cha KEMSA huko Embakasi, Bi Nakhumicha alisema kuwa hafla hiyo ni ushuhuda wa dhamira isiyumba ya washikadau





Mvurya calls for protection of water catchment areas against encroachment

The Cabinet Secretary for Mining, Blue Economy, and Maritime Affairs, Salim Mvurya, has called for the protection against encroachment of water catchment areas and riparian land in a bid to mitigate the effects that climate change has on the environment.

Speaking during the World Tree Planting Day event held at Lake Kenyatta in Lamu, Mvurya highlighted the need to curb the encroachment of riparian land, citing the effect the recent floods had on people downstream where at least 228 people lost their lives during the deluge.

“The people who have been most affected by the floods are those who have been living very close to water catchment areas,” he stated, adding that the national and county governments need to work closely to curb encroachment of these riparian lands.

He said apart from the water catchment areas being gazetted, the national government has committed efforts and resources to plant 15 billion trees to enhance water retention, prevent soil erosion, and create micro-climates that support agricultural productivity.

“In addition to the immediate ecological advantages, the tree planting exercises seek to enhance the country’s capacity to mitigate the effects that climate change has brought upon different parts of Kenya,” Mvurya added.

His sentiments were echoed by Blue Economy and Fisheries Principal Secretary Betsy Njagi who stated that there needs a constant monitoring of the water catchment areas and riparian lands against encroachment.

Bodi ya Wahandisi ya Kenya (EBK) inapanga kuanzisha Shule ya Uhandisi ya Kenya, ambayo itachukua jukumu muhimu katika kuhakikisha kuwa miradi ya miundomsingi inatekelezwa kwa viwango vya juu vya uhandisi.

Kulingana na Msajili na Afisi Mkuu Mtendaji wa EBK, Mhandisi Margaret Ogai, shule itatoa vifaa na fursa za kujifunza, kukua kitaaluma, na kupata ujuzi, na pia kutoa programu za kujinoa kitaaluma kwa wahandisi.

"Hii inawiana na Ajenda ya Mabadiliko ya Kiuchumi ya kuanzia mashinani, lengo la nguzo ya kiuchumi katika kuendeleza miundombinu ya kwango cha kimataifa ili kusaidia ukuaji wa uchumi na ushirikiano wa kikanda," Mhandisi Ogai alisema.

Akizungumza na MyGov baada ya hafla ya kuzinduli kwa mpango mkakati wa EBK iliyoongoza na Waziri wa Barabara Kipchumba Murkomen jijini Nairobi, Msajili alisema kuwa EBK inachangia ukuza wa wafanyakazi wenye ujuzi wa uhandisi kuitipu usajili, leseni, na udhibiti.

"Kwa kuhimiza wahandisi kufuata mbinu na teknolojia za ubunifu, wahandisi wana jukumu muhimu katika kubuni na kutekeleza miradi ya miundombinu, ikiwa ni pamoja na barabara, madaraja, mifumo ya unyunuzaji na vifaa vya usindikaji wa kilimo," Mhandisi Ogai alisema.

Alieleza kuwa maendeleo haya ya miundombinu ni muhimu kwa kuongeza uzalishaji wa kilimo na kukuza ukuaji shirikishi katika maeleo ya mashambani.

Usafirishaji wa kwanza wa mbolea hadi Ethiopia kupiga jeki Bandari ya Lamu

Kuwasili kwa tani 60,000 za kwanza za mbolea inayoelekea Ethiopia kutaimari-sha utendakazi wa Bandari ya Lamu iliyogharimu Sh75 bilioni, sehemu muhimu ya mradi wa Uchukuzi wa Lamu-Sudan Kusini hadi Ethiopia (LAPSSET).

Ali Mbogo, Mwenyekiti wa Mamlaka ya LAPSSET (LCDA), alitaja mradi huo kuwa mwamko wa kuchumi kwa Kenya na eneo zima la Afrika Mashariki.

Alisitisiza kuwa mradi huo unaomilikiwa kwa pamoja na serikali tatu, utafanya visiwa vya Lamu kufufuka na kuwa muhimu kwa uchumi ya nchi na kanda.

Ukanda wa LAPSSET unalenga kuimarishe uchukuzi, kukuza ushirikiano wa kiuchumi, na kuchochea maendeleo ya kijamii na kiuchumi Ethiopia, Kenya, na Sudan Kusini.

Mradi huo unajumuisha Bandari ya Lamu, Reli ya kisasa, barabara kuu, mabomba mawili ya mafuta, viwanja vya ndege vitatu vya kimataifa, na miji mitatu ya mapumziko.



Wafanyakazi wakipakia mbolea inayoelekea Ethiopia

Kukamilishwa kwa gati tatu za kwanza za kisasa za Meli hadi ufuoni na Mamlaka ya Bandari ya Kenya (KPA) kunaelekea kuongeza ufanisi wa Bandari ya Lamu.

"Maendeleo haya ya kina yatachochea msururu wa shughuli za kiuchumi, na kufanya Kenya kuwa kituo cha biashara ya kimataifa na vifaa, muhimu sana katika kukuza uhusiano wa kibashara na masoko ya Asia," alisema Mbogo wakati wa mukutano wa kila mwaka wa Jamii ya Wanauchumi wa Kenya huko Mombasa.

Mwenyekiti wa LAPSSET

alibainisha kuwa Afrika ndilo bara lisilounganishwa zaidi duniani na uagizaji wa bidhaa za ndani kati ya nchi za Afrika ni takriban asilimia 17.

Bandari ya Lamu, Mbogo aliongeza, imeipa Kenya njia mbadala ya biashara kwani nchi inategemea Bandari ya Mombasa.

"Ukienda Mama Ngina Waterfront, utaona njia hiyo. Tuna njia nyembamba sana. Iwapo lolote lingetoka kwenye mkondo huo, basi tutalemaza sio uchumi wa nchi hii pekee bali Afrika Mashariki nzima,"

alisema.

Bandari ya Lamu ni bandari ya asili yenye rasimu ya mita 18 na mita 21 wakati wa mawimbi ya chini na mawimbi makubwa mtawalia.

"Tumejenga bandari kwa njia ambayo gati tatu zina mita 1,200 ambazo zinaweza kuruhusu meli kubwa katika bandari hiyo bila changamoto yoyote. Meli hizo haziwezi kuingia katika Bandari ya Mombasa," alisema Mbogo.

Tangu kukamilika kwa gati la kwanza mwaka wa 2019, Bandari ya Lamu imekuwa ikitumika kwa kiwango cha chini, lakin bodi ya Mamlaka ya Maendeleo ya Ukanda wa LAPSSET ilifanikiwa kuwashawishi Waethiopia kuitumia Bandari hiyo ambayo iko karibu ikilinganishwa na bandari za Djibouti na Tadjourah zote za Djibouti.

"Njia kutoka Lamu hadi Moyale ni ndefu, ni kilomita 1,300 lakini bado ni fupi kwa kilomita 300 ikiliganishwa na njia ya sasa ambayo Waethiopia wantumia kuagiza bidhaa zao kutoka Djibouti ambayo ni kilomita 1,600," Mbogo alisema.

KISIP 2 ni mradi wa serikali unaotekelze na Serikali ya Kenya (GOK) kuititia ufadhili wa Benki ya Dunia na AFD. Ni mradi muhimu wa kuwezesha Ruwaza ya 2030 unaozingatia ajenda ya Serikali ya kuwezesha wakazi katika mitaa ya mabanda.
