The Government plans to roll out more Huduma Centres and accompanying services in all the 314 sub-country.

Public Service, Performance, and Delivery Management Cabinet Secretary Mr. Moses Kuria said the centers, fondly referred to in government circles as the "crown jewel of government," have transformed public service delivery by providing prompt and seamless service using digital

"They seek to save Kenyans the agony of moving from one state office to another in search of public service, which often was frustrating and discouraging, into a onestop-shop," said Mr. Kuria.

The Cabinet Secretary indicated that Huduma Centers have, for the past ten years, stood out as a successful project of the government.

Speaking in Nakuru during celebrations to mark the 10th anniversary of Huduma Center's existence, Mr. Kuria said the state would continue empowering the centers with training, manpower, and other resources to enable more members of the public to access various public services and information from integrated service platforms aimed at promoting efficiency in public service delivery.

Huduma Kenya, a 2030 flagship project, was launched in 2013 to transform public service delivery into more accessible, effective, efficient, dig-

KNBS, Central Bank to conduct 2023 foreign investment survey

The Kenya National Bureau of Statistics (KNBS) is joining forces with the Central Bank of Kenya (CBK) to undertake the 2023 Foreign Investment Survey (FIS).

This comprehensive survey is designed to collect transactional and stock data related to enterprise capital, trade, services, employment, and assessments of the business environment. The data obtained will play a critical role in shaping policy responses concerning private capital flows.

Mr. Collins Omondi, the Director in Charge of Micro-Economics Statistics at KNBS, has announced that the FIS survey will kick off next month, with a focus on gathering data from companies that have made investments in Kenya between January 2021 and December 2022.

The survey's primary goal is to measure and track national statistics related to the stocks and flows of inward and outward foreign investments during the calendar years 2021 and 2022.

This initiative marks the seventh iteration of the survey since its inception in 2010. The survey is scheduled to run for 40 days and will target 1,150 firms that are involved with foreign

nified, and citizen-centric public service.

It has operationalized three additional platforms: the Huduma Mashinani-outreaches that take services to far-flung areas, Government Huduma contact centers that provide first and second-level escalation for all complaints, inquiries, and updates to Kenyans via telephone and social media.

Huduma M and E services provide government information through the Huduma website. The centers currently offer more than 21 services from 12 ministries, departments, and agencies, with the most sought-after services being the issuance of duplicate identity cards and seasonal parking tickets for Nairobi County, NHIF, and NSSF claims.

Mr. Kuria said the first Huduma Sub-County Center will be rolled out in Molo, adding that the establishment of such facilities at the grassroots will save millions of shillings citizens use to access

Huduma centers as most of them are in county headquarters except Nairobi and Kajiado, which have five and two centers, respectively.

"My Ministry is exploring the possibility of collaborating with the National Government- Constituency Development Fund (NG-CDF) for funding the establishment of some of the sub-counties Huduma Centers. Huduma Kenya is known as the trusted interface between the citizens and government services, and that's the reason Huduma is here to stay," said the CS.

On digitization, he commended Huduma's leadership for being innovative and embracing the digital era, which resonates well with the digitization pillar of the Bottom-Up Economic Transformation Agenda (BETA).

assets and liabilities.

Omondi has further revealed that the survey will also encompass data related to investor perceptions of the business environment in Kenya, which can have a significant impact on decisionmaking for investment and business activities.

Speaking in Nakuru after a training program for over 200 statisticians who will conduct the exercise, the Director indicated that the survey will be administered to sampled enterprises in Kenya with international transactions.

"The government and other stakeholders need to be updated on the flows and stocks of Kenya's foreign assets and liabilities and equity shares to help update our balance of payment statistics," Omondi explained.

The objective of the study according to Omondi is to provide necessary information to guide policy response to private capital flows,

against an ever-increasing competition where some neighbouring countries have been receiving more of the foreign firms.

He added that the data to be gathered will help the Kenyan government to assess investors' perception on the business climate with a view to identifying possible policies to be introduced.

The other objective, the Director said, will be to ensure compliance with international standards in data monitoring and presentation that could also be used by international

institutions and researchers. A representative from Central Bank of Kenya's Department of Research Dr. Daniel Amanda said the State depends significantly on the survey to formulate monetary policies.

He noted that through the study, policy makers will be able to identify constraints facing foreign investors, adding that the survey was also aimed at improving the quality and updating national statistics on stocks and flows of foreign capital as well as international trade.

Stadium development accelerates for Africa **Cup of Nations 2027**

¬he two main stadia in Kenya, Kasarani and the Talanta Sports City Jamhuri Stadium, which will host the 2027 Africa Cup of Nations (AFCON), will be ready by December

The Cabinet Secretary for Youth Affairs, Creative Economy, and Sports, Ababu Namwamba, spoke in Diani during the First Joint Regional Stakeholders Meeting for Africa Cup of Nations Afcon27 for East Africa Pamoja AF-CON'27.

The meeting, held at a hotel in Diani, Kwale County, brought together representatives from Kenya, Uganda, and Tanzania. Namwamba revealed that the Moi International Sports Center Kasarani, with a capacity of 60,000, will undergo renovations to meet the requirements of the Confederation

of African Football (CAF).

The Talanta Sports City Jamhuri Stadium, which is yet to be constructed, will be Kenya's main stadium. He expressed confidence that these facilities would be ready for CAF inspection several months before the AFCON in 2027.

Namwamba said, "The start of these projects has taken longer than anticipated because the military, who were assigned the job, have their internal processes to follow. But all is well now.

He added, "I can confirm that in the latest briefing, I had a meeting with my colleague, CS for Defense Adan Duale, and we agreed on key areas. The groundbreaking for Talanta Sports City Stadium will be done next month, and it will take two years to be ready.

Other stadia that will undergo renovations are the Nyayo National Stadium, Bukhungu Stadium in Kakamega, Kirigiti Stadium in Kiambu, Jomo Kenyatta Stadium in Kisumu, and Kipchoge Keino Stadium in Eldoret.

The newly built Ulinzi Sports Complex and National Police Sacco Stadium will be used as alternative venues during the closure of Kasarani and Nyayo..

This meeting marked the first time that the three countries, after being awarded the hosting rights, convened to deliberate, prepare a roadmap, and lay the foundation for the biggest football showpiece in the

¬he Government has adopted a consultative approach with citizens at the grassroots acting as the center of national planning in bid to foster acceptance of development projects in the counties.

Dr. Idris Dokota, Principal Secretary (PS) State Department for Cabinet Affairs, said any development projects by the government will be determined by people in a strategy aimed at encouraging public participation and promoting transparency in resource allocation.

The PS stated that the involvement of communities in the planning and budgeting process will ultimately have the net effect of having projects being accepted and owned by the targeted beneficiaries thereby eliminating the feeling of being sidelined in nation-

Dr. Dokota was speaking in Mwatate during a public participation forum on the 2024/2025 Medium-Term budget.

"We must get your views on what you need done and where. The era where projects and programs were decided and imposed on you is long gone. The government needs your views and ideas for what you need to be done," the PS said.

Noting that the last time such a forum that targeted community participation was last held in 2012 on the eve of the devolved governance system, the PS stated that the new approach will lead to widespread acceptability of development projects.

Mwatate Member of Parliament Peter Shake hailed the move to include citizens in planning and termed it a testament to the government's willingness to listen.

Ministry of Lands develops 2023–2027 Strategic Plan

The Ministry of Lands, Physical Planning and Urban Development is developing a new strategic plan to bolster the improved land tenure measures instituted by the State Department for Lands and Physical Planning.

The plan will contribute to the success of the on-going digitization of land records at Ardhi House and help in the regulation of the construction industry, housing development and human settlement.

The Strategic Plan also aims to identify other strategic issues including spatial and attribute data for sustainable development as well as institutional capacity strengthening in the entire ministry.



In a speech read on his behalf by the Secretary for Administration in the State Department for Lands Mohammed Ahmed Maalim (pictured), Lands and Physical Planning Principal Secretary, Nixon Korir, said the 2023–2027 Strategic Plan shall also help in the development and management

of public buildings, physical and social infrastructure in the country.

Korrir said the strategic plan will help in regulation and development of the construction industry, housing development and human settlement in the country.

Speaking during a workshop held at a Nairobi hotel to gather inputs and insights from external stakeholders to ensure that the plan aligns with their needs and aspirations, Korir said the Strategic Plan will be a game changer since it will address all loopholes bedevilling the land tenure and titling sector.

He said the forum sought to validate the draft strategic plan with the inputs and comments of all stakeholders expected to be submitted to the Ministry by 24th November, 2023.

"I thank the Food and Agricultural Organisation (FAO), my staff and other stakeholders for their valuable support and input in coming up with the important draft plan that provides a roadmap which clearly shows the desired future of the Ministry, strategic initiatives and actions that will steer its performance and operations towards its goals in the next five years," PS Korir said.

Once the Strategic Plan is finalized, PS Korir noted, it will be disseminated to all stakeholders to create a common understanding on their role towards making the vision of the Ministry a reality adding that successful implementation of the plan is dependent on the synergies created between and within State Departments, and external stakeholders.

The PS further noted that other goal of the strategic plan is to identify research, innovation, and technology in land and built environment and urban and metropolitan development.

Kenya prepares to welcome global experts for key industrialization conference

As the Ministry of Trade, Investments and Industry prepares to host the first Industrialization Conference in Nairobi later this month, the Principal Secretary for Industrialization Dr. Juma Mukhwana (pictured) explains to MyGov writer Yobesh Onwong'a how the event aims to rally desired political momentum, resources, partnerships and alliances towards an African industrial drive. Excerpts are reproduced here below.

Q: Kenya is scheduled to host the first ever industrialization conference in Nairobi. Please tell us what this conference is all about. When will this take place and where?

A: The Kenya Industrialization Conference will take place from the 20th to the 22nd November 2023 at the University of Nairobi Grounds under the auspices of Africa Industrialization Week which will also be happening at the same time in Niamey in Niger.

Q: What is the background of this event in Africa, and how relevant is it to Kenyans?

A: Africa's Industrialization and Economic Diversification aims to highlight Africa's renewed determination and commitment to industrialization as one of the central pillars in attaining the con-

tinent's economic growth and development goals as articulated in Agenda 2063 and Agenda 2030. Considering the key and strategic inter-dependencies between industrialization and the AfCFTA Agreement, the Summit aims to rally desired political momentum, resources, partnerships, and alliances towards an Africa-Industrialization drive. This is informed by the continent's resolve to drive structural transformation, built around leveraging Africa's rich and diverse natural resources, while at the same time embracing current advances in technologies, continental and global geo-socio-political trends, and emergence of tradable services. This is anticipated to unlock the evolution of a vibrant Pan-African enterprise and capital base that

will unleash an inclusive and sustainable industrialization pathway that carries along the participation of all economic agents, including Small and Micro-Enterprises (SMEs), youth, and women in the generation of national wealth and creation of jobs as well as expansion of entrepreneurship opportunities for Africa's populations. Kenya being a leading proponent of Pan- Africanism and an economic giant in Sub- Saharan Africa, is bound to take a leading role towards the realization of AfCFTA in the continent.

Q: How does Kenya's industrialization priorities play to augment the aspirations of this country and the continent at large? A: The transformation of the Kenyan economy to create shared growth, decent jobs and economic



opportunities for all is a priority of the Kenya Kwanza Government which puts emphasis on in-country value- addition touching on the livestock sector for the hides, growing cotton for the revival of tanneries, local assembly of motor vehicles (electric buses and motorcycles), mobile phones assembly and retention while according preference to the locally made- goods and services.

Q: How has Kenya's performed in the manufacturing sector?

A: According to the World Bank, Kenya's Manufacturing, value-added percentage of GDP was reported at 7.2442 per cent in 2021 and the State Department for Industry aspires to grow this to 15 per cent by 2027 and to 20 per cent by 2030.

Q: How is this Industrialization conference organized?

A: The State Department for industry and Kenya Association of Manufacturers in collaboration with other stakeholders' have organized the Kenya Industrialization Conference 2023, to accord an opportunity for a thought-process involving experts drawn from academia, industry, policymakers and development partners from Kenya, the African Continent, and the rest of the world.

Q: What is the theme of this year's conference and how does it resonate with Kenya's Industrialization Agenda? A: The Assembly of Heads of State and Government of the African Union (AU Assembly) adopted the African Union Theme of the Year 2023 as the year for "Acceleration of AfCFTA Implementation". This augurs well with Kenya's vision 2030 on the country's economic transformation through accelerating industrialization.

Q: What are the objectives of the Kenya Industrialization Conference?

A: The Conference will be an opportunity to examine Kenya's industrial concerns, with a focus on industrial development as a foundation for economic prosperity. Industrial development holds immense promise in helping raise the productive capacity of our people and creating ever- increasing employment opportunities.



Mango processing facility opened in Tana to address post-harvest losses

BY SADIK HASSAN(KNA)

The unveiling of the Integrated Fruit Processing Plant (IFPP) in Hola promises to mitigate post-harvest losses of mangoes and provide a lifeline for many farmers in Tana River County. Here, tons of fruits have been going to waste due to the absence of a processor and a ready market.

The Sh245 million mango

processing project, executed by the Coast Development Authority (CDA), was initially conceived in 2017. However, due to financial constraints and other challenges, its construction progress has been slow.

The enhancements to the Integrated Fruit Processing Plant involve the installation of a pulp processing plant, the construction of auxiliary facilities, and the imple-

mentation of a waste management system. Ms. Malonza also stated that the launch of the plant aligns with the Bottom-Up **Economic Transformation** Agenda (BETA) focused on agriculture and reducing post-harvest losses for farmers. "Mangoes have long been a cornerstone of the local economy in Tana River County, benefiting over 30,000 households, said Malonza. She added that farmers harvest over 50,000 tons in a season and transport more than 35,000 tons to markets and industries in Mombasa, Garissa, and Nairobi.

NACADA's expanded powers to target illicit alcohol, drug supply

The Government is introducing new legislation to empower the National Authority for the Campaign Against Drug and Alcohol Abuse (NACADA) to control the supply of illicit alcohol and drugs.

Interior Cabinet Secretary Prof. Kithure Kindiki announced that under the new legislation, NACADA will, for the first time, have the authority to address manufacturers and suppliers of harmful alcoholic beverages and those involved in drug distribution at their source.

Currently, the sole mandate of NACADA is limited to conducting public education and awareness campaigns against alcohol and drug abuse.

These campaigns target various institutions such as schools, workplaces, colleges, universities, technical institutions, county governments, ministries, para-

statals, national government administrative offices, etc "We have proposed legislation to bolster NACADA's authority, enabling it not only to curb the demand for drugs and alcohol but also to progressively tackle the supply chain.

Therefore, we aim to dismantle the production and distribution network of alcohol and drugs as comprehensively as we address the demand for these substances. This legislation will

significantly strengthen the fight against drug and alcohol abuse," he emphasized.

The Interior Cabinet Secretary made these remarks during a ceremony at the Ihururu Rehabilitation and Treatment Centre in Tetu, Nyeri County.

The event marked the accreditation of the facility, which opened its doors in September this year following an assessment by NACADA to ensure it met all the necessary requirements for providing addiction treatment. NACADA, and the national government to eradicate this problem.

"The training centre will spur economic devel-

opment in the area, the nearby markets will host our students, while the local community will benefit from job opportunities at the facility.

On her part, the County Executive for Education and ICT Elizabeth Muli said the institution is among other technical training institutes focused on agriculture, to secure food security and sustainable agribusiness in the country.

At the same time, Mary Wamaitha, a local business lady, lauded the government for opening the institution saying it will spur economic growth in the area.

"My hotel business has now started to thrive, I used to cook only tea, beans, mandazi and chapati, but which could not be finished by evening sometimes as we had fewer customers then," Wamaitha noted.

Copyright Board launches awareness initiative for artistes on copyright protection

The Kenya Copyright Board (KECOBO) is set to initiate an extensive capacity-building programme aimed at educating musicians, content creators, and publishers on copyright protection laws and policies.

The programme will also engage authors, collective management organizations (CMOs), and other stakeholders to underscore the importance of copyright protection laws and policies.

Mr. Joshua Kutuny (*Pictured*), the newly appointed Chairman of the Board of Directors of Kenya Copyright Board, revealed that the program's primary objective is to equip individu-

als in the creative industry with the skills necessary for creating high-quality content, protecting their work, and effectively monetizing it.

This initiative aims to improve their livelihoods and contribute to the growth of artists, content creators, and songwriters' careers.

Kutuny also announced the Board's commitment to collaborating with relevant stakeholders to adopt new technologies that enhance mechanisms for collecting and distributing royalties and monitoring the use of music and other content.

This step is taken to encourage transparency and improve revenue collection.

The Chairman was speak-

ing at the KECOBO offices when he chaired his first meeting after taking over the mantle of the office following his appointment to the position by President William Ruto.

Kutuny announced that the Board will ensure the ratification of desired copyright treaties that are beneficial to Kenyan creatives and the economy.

All CMOs are expected to comply with provisions of the MoU they signed with the state - Kutuny

"The Board and the Ministry will expedite the process of enactment of the proposed Copyright Amendment Bill 2023 to ensure there is adequate legislative support for the industry," he said.

During the meeting, the Board was informed of the recent High Court decision on Constitutional Petition No. E151 of 2023 in which the court nullified the CMO licenses earlier issued by the management.

The chairman said to ensure the operationalization of CMOs and the smooth collection and distribution of royalties, the Board, using the Copyright Act issued provisional licenses to three CMOs, Kenya Association of Music Producers, Performers Rights Society of Kenya, and Music Copyright Society of Kenya effective 8th November 2023, for a period of six months.

"Within this period, all CMOs are expected to com-



ply with provisions of the memorandum of understanding they signed with the government and comply with provisions of the CMO regulations 2020," Kutuny stated.

He noted that the Board of Directors is aware of some of the challenges KECOBO is encountering, assuring that they will address the issues collectively, internally and with engagement with the relevant stakeholders.

"This will ensure that there is transparency and accountability in money collected and distributed to the artist," added Kutuny. On good governance, the board resolved to strengthen mechanisms for both KE-COBO and CMOs to ensure there is prudent utilization of resources and eradication of corruption and mismanagement.

During the meeting, the Board of Directors were taken through the status report of KECOBO by the Executive Director, where he tabulated the journey the institution has been through and the current operational and financial milestones and challenges experienced by the institution.

Some of the milestones achieved by KECOBO include the launch of the National Rights Registry (nrr. copyright.go.ke), the online copyright registration system that enables rights holders to register and obtain certificates of registration virtually which has improved copyright registration from about 3,000 to above 50,000.

CS-Cooperatives Bill to re-energize the growth, development of the sector

The Government has underlioned its commitment to create an enabling environment for a robust cooperative sector, a main source of financing for Micro, Small and Medium Enterprises (MSME's) in the country.

Cooperatives and MSME's Cabinet Secretary Simon Chelugui said in view of this, the Ministry is implementing the Sessional Paper No. 4 of 2020 on National Cooperative Policy themed "Promoting Cooperatives for Socio-Economic Transformation".

Chelugui said the Cooperatives Bill has received Cabinet approval and has been forwarded to the Attorney General for submission to Parliament.

Speaking during the annual Cooperative Leaders Consultative Conference, the CS said that the Coffee Bill, 2023 and the Coffee Policy was presented to joint Senate and Motional Assembly Departmental Committees and their input incorporated. The Bill is at its second reading in the Senate

"This Bill will reinstate the Coffee Board of Kenya and the Coffee Research Institute as stand-alone institutions which is expected to

re-energize the growth and development of the coffee sub sector especially in the areas of research and market access," he said.

Chelugui explained that the Sacco Central and Shared Services have been operationalized and more Saccos are joining each day.

The bill seeks to establish the Office of the Commissioner for Cooperative Development at the national level of government and the Office of the County Director for Cooperatives in each county government.

The office of the Commissioner for Cooperative Development will be responsible for promotion, registration, and regulation of cooperatives and provide for inter-govern-

mental cooperative relations.

Chelugui said that the objective of this bill is to provide a legal framework that promotes a sustainable and competitive cooperative sector for socio-economic development in a devolved system of governance.

"The bill seeks to promote uniform norms and standards in the registration, regulation, supervision and management of cooperatives and establish a framework for consultation and co-operation amongst counties," the CS said.

He explained that this will be established through the implementation of the Bill's proposal on the framework for good governance and ethical conduct in cooperatives.

He said the Office of the Commissioner for Cooperative Development shall be an office in the Public Service and shall be responsible for the growth, development, and regulation of cooperatives in Kenya.

Chelugui commended the cooperative leaders for organizing the conference saying it brings together cooperative leaders, policymakers, experts, and representatives from diverse sub-sectors for the purpose of assessing sector performance, sharing insights, and catalyzing positive change within the sector which is a positive move for the crucial sector.

"We will be having our first ever Correctional Service Week and we are hopeful that the event will be able to change perceptions and create acceptance of reformed offenders upon release back to the community," she said.

The State Department for Correctional Services has two technical departments, the Kenya Prisons Service (KPS) which solely deals with custodial offenders, and Probation and Aftercare Service (PACS) which deals with non-custodial offenders.

Kerio Valley shifts from violence to crop farming and water projects

Por decades, the Kerio Valley basin, in the North Rift region, has been synonymous with deadly banditry attacks that has caused untold suffering characterized by death and lifelong injuries to the resident of the valley.

The deadly raids perpetrated by heavily armed cattle rustlers have for many years frustrated government socio-economic development programmes rendering the region to remain perpetually marginalized.

Although the cattle raids were hitherto linked to outdated cultural practices associated with dowry and marriages, this has since spiraled into murderous attacks that spare neither children, women nor the elderly.

However, researchers, opinion leaders, and other civil society associations have cited scarcity of resources such as inadequate water and pasture caused by the harsh climatic con-

ditions as some of the reasons for capacitating and fuelling banditry in the Kerio Valley.

But with the guns gradually going silent following a decisive move by the current government to deal with the menace head-on, there is a ray of hope for peace reigning, hence giving room for development programmes to be implemented.

Already, there is a sustained campaign by government and non-state state actors, led by the Kerio Valley Development Authority, KVDA, across the cattle rustling scarred counties of Turkana, West Pokot, ElgeyoMarakwet, Baringo, and Samburu for the pastoralist communities to diversify their source of livelihood from solely relying on the conventional livestock keeping to crop farming.

The challenge facing the communities who are ready to try out horticulture as a source of livelihood is the lack of adequate water to sustain crop farming as well

MoH to unveil **National Long-Lasting Insecticidal Treated Nets to** combat Malaria

¬he Ministry of Health will launch the National Long-Lasting Insecticidal Treated Nets (LLINs) distribution campaign this week to combat the spread of malaria and ensure a malaria free future in the country.

According to the Principal Secretary For Public Health and Professional Standards Ms Mary Muthoni Muriuki, beyond being a mere distribution effort, the LLINs campaign signifies the Ministry's commitment to combat malaria which represents a formidable step towards Universal Health Coverage with nets and entails a substantial impact in Kenya's on-going battle against malaria.

Ms Muriuki noted that the distribution of LLINs to community members has demonstrated tremendous progress in the fight against malaria, marked by a significant drop in malaria prevalence from 8 per cent to 6 per cent nationally, according to the Kenya Malaria Indicator Survey in 2015 and 2020, respectively.

"Despite these gains, malaria still accounts for 13-18 per cent of all out-patient attendance in public health facilities (DHIS2, 2022) and an estimated 15 per cent of all admissions to health facilities based on passive case reports," the PS said in a statement distributed to newsrooms.

She said the Kenya Malaria Strategy 2019-2023 (KMS) aims to reduce the burden of malaria in the country to at least 75 per cent of 2016 levels by 2023 which ultimately strives for a malaria-free Kenya and in order to sustain the achieved gains and contribute further to effective malaria vector control, the Ministry of Health, through the Division of National Malaria Control, plans to conduct a mass LLIN campaign countrywide.

The 2023/24 LLINs Distribution Campaign, Ms Muriuki said is set to cover 22 high malaria-burden counties, with the goal of distributing 15.3 million Long Lasting Insecticidal Treated Nets (ITNs) to approximately 23 million people.

"These counties are situ-

ated in the Lake and coastal regions like Kisumu, Siaya, Busia, Migori, Kisii, Nyamira, Lamu, Kilifi, Tana River, Kwale, Mombasa, Taita-Taveta Vihiga, Homabay, Bungoma, Kakamega West Pokot, Turkana, Trans-Nzoia, Narok, Baringo, Kirinyaga - are at the forefront of our efforts to combat malaria and the primary goal of this campaign is to provide essential protection to vulnerable populations and ensure that every household in high-risk malaria regions has access to LLINs", Ms Muriuki noted.

Through active community engagement, the PS said, the campaign seeks to empower individuals to take control of their health, fostering a sense of resilience and collective responsibility in the fight against malaria.

She said the campaign aims to significantly reduce the incidence of malaria, contributing to improved health outcomes, reduced healthcare costs, and an overall enhancement in the well-being of the popula-

The PS said that the success of this nationwide endeavor is a result of collaborative efforts from the Ministry of Health, the National Malaria Program, and a network of dedicated health partners and their commitment underscores the collective determination to make a lasting impact on the nation's public health landscape.

"Innovative tools and technologies will be employed to ensure the efficient execution of the distribution process, guaranteeing that LLINs reach every household in need and the emphasis is on delivering tangible health outcomes and creating a lasting impact on communities", Ms Muriuki said.

She said the LLINs distribution launch will take place this week in Homa Bay County, Ndiru Stadium and guests, including representatives from the Ministry of Health, led by the Cabinet Secretary for Health Ms Susan Nakhumicha and Homabay Governor Gladys Wanga, international health organizations, and community leaders, will join forces to mark the beginning of this transformative campaign.

or gemstone enthusiasts and international collectors, Tsavorite stands as the ultimate prize, crowning a collector's life achievements.

Renowned for its legendary beauty, characterized by a vibrant green hue, Tsavorite has surpassed other precious stones, attaining a royalty-like status. To miners, it's not only the enchanting gem that can transform the destitute into millionaires but also the promised gateway to a realm of wealth.

"Tsavorite remains the most coveted gem for miners and dealers due to its rarity and exceptional value. It's considered a uniquely Kenyan treasure as it's found in Taita-Taveta County," states Mr. David Zowe, Chair of Taita-Taveta Artisanal Miners Association.

Taita-Taveta County boasts an array of semi-precious and precious stones, including rubies, amethyst, tourmalines, kyanites, red garnets, and peridot, among others. The region also hosts other industrial minerals like iron ore, quartz, and manganese. However, no mineral captures the imagination of miners in the region and beyond quite like Tsavorite.

Tsavorite symbolizes the immense potential the region possesses to become a global mining powerhouse, potentially transforming

the lives of thousands of residents currently grappling with poverty. According to the Kenya National Bureau of Statistics (KNBS) 2021 Poverty Report, Taita-Taveta County has a poverty rate of 33.9 percent, slightly lower than the national average of 38.6 percent.

Despite being a multibillion-shilling industry, the mining sector's fortunes and revenues have failed to significantly improve the quality of life for the local population. The sector loses millions annually due to rampant Tsavorite smuggling, traders' non-disclosure of sales, and dealers and miners deliberately evading state royalties.

To address these challenges, the government recently designated Tsavorite as one of the 14 strategic minerals in Kenya. Strategic minerals are considered vital to the country's economic well-being and essential for sensitive sectors like defense. Other minerals listed as strategic in Kenya include radioactive minerals

like Uranium and Thorium, Cobalt, Copper, Graphite, and Niobium, among oth-

As a recent addition to this exclusive category, Tsavorite seems to have reached maturity. This means that the entire value chain, from prospecting and exploration to mining, trading, and dealing in this gem, must be sanctioned by the govern-

Mining Principal Secretary (PS) Elijah Mwangi explains that miners interested in extracting Tsavorite will collaborate with the National Mining Corporation (NMC) to ensure compliance. Licensing and permit issuance will be handled on a case-by-case basis.

Mr. Stephen Mwadime, Chair of Mwatate-based Chawia Minerals Community Based Organization (CBO), affirms that miners will support measures aimed at empowering them.

KenGen Steps Up Geothermal to Curb Suppressed Inflows at the Large Hydropower Dams

¬he Kenya Electricity Generating Company PLC (KenGen) has announced a revamped plan to step up electricity generation from geothermal power plants in a strategic move to cushion Kenyans from the effects of low water inflows

at the large hydropower sta-

A statement to newsrooms indicates that by last week, Masinga Dam, which is Kenya's largest hydropower dam, recorded water levels of 1,039.42 meters above sea level (mASL) against a total capacity of 1,056mASL.

This was slightly above the minimum operating level of 1,037mASL, having received only 7.5 millimeters of rainfall in the last 24 hours.

"Despite the ongoing rains in most parts of the country, we are receiving very low inflows at our dams at the Seven Forks, located along

the Tana River," said Ken-Gen Managing Director and CEO, Eng. Peter Njenga.

"This poor hydrology means that we now have to turn to another source to meet the growing demand for electricity in the country," he added.

According to a daily electricity dispatch report by KenGen, the large hydroelectric power stations, which ordinarily would produce a combined maximum capacity of 626MW, were only able to achieve 471MW at their peak

Kerio Valley shifts from violence to crop farming and water projects

as for domestic use and for the livestock considering that the region is largely arid and semiarid, coupled with the effect of climate change.

In an effort to address these challenges, KVDA has pumped in Sh. 550 million to enhance water availability with an objective of increasing food security through irrigation, and transforming the region from relief food-reliant to food-

secure

KVDA Managing Director Sammy Naporos said the funds would go towards the construction of 24 boreholes, six water pans, and three small-scale dams across the region. "Some of the projects are already complete and in use, others are in the process," said the MD during an interview with KNA in his Eldoret office.

"We intend that this programme will ensure water ac-

cess because we are focusing on offering alternative livelihood sources for the residents. We realize the big stock, cattle, sheep, and even camels have been the major contributors to cattle rustling and banditry, and therefore the need for a paradigm shift from relying purely on pastoralism and opting for crop farming in an effort to address the rampant cases of insecurity.

Already, Mr. Naporos said

the beneficiary communities have been trained in crop farming, and some are already into vegetable growing which has offered sustainable food and income for the families.

He adds that although what they have input might be a drop in the vast region, he hoped it would create a positive impact on the communities as well as build resilience against climate change.

In Samburu County, Noontoto village, KVDA constructed a 40,000 cubic meter dam, benefiting 3,000 households as well as providing water to 50,000 livestock as well as

wildlife.

"Because of this intervention by KVDA, we have witnessed a gradual shift from traditional livestock keeping to horticulture, scores of farms are mushrooming in the neighboring villages as herders take up vegetable framing through irrigation, tomatoes, kales, cabbages, capsicum, potatoes, and traditional vegetables are sprouting up," according to Kimia Lolmeweti, one of the pioneer crop farmers in the village.

Lolmeweti said he has used water from the dam to irrigate his one-acre farm growing vegetables for subsistence use and commercial purposes.

"I already sold the first harvest to vegetable vendors within my neighborhood of Kisima centre and also to those from Maralal town and earned around Sh. 15,000 from tomatoes alone," says an elated Lolmeweti.

He adds that traditionally the Samburu are pastoralists and their entire livelihoods centre around livestock, but since KVDA constructed the dam, he says, a section of the community is embracing vegetable and fruit farming as an economic activity.

KenGen Steps Up **Geothermal Power**

over the past 24 hours.

"One of the large power stations, Masinga, has been shut down most days of November as part of our ongoing water management program to ensure we can meet the energy demands for the longest duration possible," said Eng. Njenga.

Even as the situation at the dams continues to remain largely subdued due to low inflows, several parts of the country continue to experience heavy rains, with cases of flooding reported in several places, including areas along the lower Tana River, Garissa, Mandera, Turkana, Meru and several parts in the Coastal re-

"We are continuing with our tree-growing campaign in support of the Government's 15 billion trees challenge, taking advantage of the onset of rains to ensure the viability of the seedlings," said Eng. Njenga.

The NSE-listed company said that it planned to plant at least 500,000 tree seedlings every year and had already planted 104,292 trees in the current financial year (from July 2023), bringing the total to 2,557,516 trees grown over the last nine years.

"We urge Kenyans to take advantage of the rains and plant trees in their homes and even in the workplaces and business areas as this is

one way of not only greening the planet but also helping put protection against strong winds and heavy rains, which may sometimes cause flooding," said Eng. Njenga.

KenGen made the shift to its current geothermal-led strategy following repeated failure of hydro generation over the years. This poor hydrology is attributed to climate change, characterized by unpredictable rainfall patterns, making it difficult to plan and implement a sustainable water management program in large dams.

The CEO said KenGen's strategic move to geothermal had helped cushion Kenyans from the effects of climate change which has seen rainfall levels drop significantly in the country over the past few years.

He said, "Notably, our investments in geothermal energy ensured uninterrupted electricity supply, even in the face of challenges posed by a prolonged drought and reduced hydropower generation."

Eng. Njenga went on to say that KenGen was angling to acquire more geothermal drilling licenses in the Great Rift Valley as part of the company's plans to increase geothermal

generation capacity which he said was clean and more reliable as geothermal is not dependent on weather.

Kenya has a potential 10GW of geothermal energy of which only 950MW has been exploited, with about 799MW having been developed by KenGen in the Olkaria and Eburru Hill Geothermal Fields in Nakuru county.

KenGen boasts a diverse energy portfolio including, geothermal, hydro, wind, and thermal, adding up to 1,904MW of which 86 percent is drawn from renewable

he government has in the last one year laid the foundation for a bottom-up transformation, putting the country on the path to economic recovery.

President William Ruto in his State of the Nation address to Parliament outlined every brick his administration has used in laying the foundation for the much-needed recovery.

While he has instituted reforms in some sectors, he has invested more in others to hasten the socio-economic transformation.

In the agriculture sector, President Ruto noted that his administration has disbursed 5.5 million 50kg bags of fertiliser to farmers at a subsidised cost of Sh2,500, down from Sh6,500.

"This has increased the acreage under maize by an extra 200,000 acres and enhanced production by an additional 18 million bags," said the President.

This means that farmers across the country have harvested at least 50 million 90kg bags of the staple, what has led to a fall in maize prices to an average of ShI45 for a 2kg packet, from a high of Sh200.

Besides maize farmers, the inputs' subsidy has also benefitted tea, coffee, rice, potatoes, cotton and edible oil crops farmers.

In the coffee sector, the government has allocated Sh4 billion to the Cherry Fund to enable farmers earn four times advance pay for their crop.

The President said the ongoing coffee reforms will give farmers the necessary representation and weight at the Nairobi Coffee Auction.

"These measures are expected to aid ongoing efforts, including expanding production to new counties and double coffee output in the next four years," said President Ruto.

When the Kenya Kwanza Administration took over, among the things that were identified as a big threat to the economy were mounting public debt that stood at Sh8.5 trillion and external shocks like the Ukraine-Russia war.

The government embarked on fiscal consolidation to reduce the budget deficit to 5 per cent of the gross domestic product as well as raise more revenue.

President Ruto noted that efforts to stabilise the situation have yielded much progress that in December, the government will be able to settle the first \$300 million instalment of the \$2 billion Eurobond debt that falls due in April next year.

"I can now state with confidence that we will and shall pay the debt that had become a source of much concern. We have also normalised our relationships with the International Monetary Fund, World Bank, the Africa Development Bank and various development partners to such an extent that

From employing more teachers to digitising government services, President lays down his path to prosperity

they are now working with us to implement the bottom-up economic transformation plan," said the President.

One of the initiatives that define the Kenya Kwanza Administration's bottom-up agenda is the Hustler Fund, which provides affordable credit and mobilises savings for individuals and small businesses.

Launched on November 30, 2022, the fund has disbursed over Sh36.6 billion and saved Sh2.3 billion from some 7.5 million repeat borrowers, whose overall repayment rate is at an impressive 73 per cent.

The top borrower of the fund has so far accessed Sh4.5 million in 816 transactions, while the top voluntary saver has Sh631,491, said President Ruto.

The fund, he added, has disputed the

notion that Kenyans are not credit worthy or high-risk borrowers. The affordable housing initiative is also firming up as the building of 46,792 units in various parts of the country goes on, while another 40,000 are ready to commence construction.

The President said through the scheme, some 50,000 Kenyans, who were previously unemployed, are now engaged directly and indirectly in the projects, and the numbers will significantly increase in the next phases.

Some 746,795 housing units are in the pipeline, undergoing various stages of delivery, said the President.

In the education sector, 56,750 new teachers have been employed, while 8,200 primary school teachers were retrained to equip them with capacity to effectively deliver learning and teaching at the Junior School level.

And changes to the entry requirements for admission to teacher training colleges have seen enrolment increase by 300 per cent to 20,456 trainees. In the health sector, four new laws that will anchor the implementation of the bottom-up approach to healthcare are being implemented.

These are the Primary Healthcare Act, the Social Health Insurance Act, the Digital Health Act and the Facility Improvement Financing Act.

These laws will usher in and guarantee a new era in the provision of healthcare, covering all essential services from preventive, promotive, curative, palliative and rehabilitative services, guaranteeing every Kenyan access to comprehensive and quality care, said the President.

Further, the government has employed

To prevent the imminent collapse of Goma in Eastern DRC, which would have had serious consequences for the wider East African region, Kenya deployed troops under the East Africa Community Regional Force. The government has continued to anchor the fight against Al+Shabaab in Somalia under the African Union Transition Mission in Somalia. President Ruto said only a democratically accountable system that is sensitive and responsive to the diverse composition of Sudan can secure peace in the country.

20,000 new healthcare workers, and deployed 8,429 others whose contracts had lapsed as well as enrolled 3,394 interns across the country to increase the availability of human capital in our public health sector.

President Ruto announced the doubling of enrolment to the National Youth Service to 40,000 from next year, and directed that every village, centre, town and city in Kenya be properly represented in the recruitment.

To consolidate this proposition, he said 80 per cent of future recruits to all national security services will be from the well-trained, talented and committed NYS graduates.

Kenya successfully hosted the inaugural Africa Climate Summit, the 43rd Ordinary Session of the Executive Council, the 5th Mid-Year Coordination meeting of the African Union and the Regional Economic Communities, and the first-ever African edition of the Berlin Climate and Security Conference in Nairobi, bringing over 30 Heads of State and governments to the country and over 30,000 delegates from different parts

These events have not only put Kenya on the map but also raised it's international profile as a leader in driving adoption of renewable energy, peace and continental agenda.

The agency put the figure of those displaced by floods at more than 85,000 households, as it called for humanitarian assistance. Dr Irshad Idris, the secretary general/chief executive officer of the Kenya Red Cross, called for urgent emergency action to address the ongoing crisis. He pointed out that the public health system is at risk of collapsing due to outbreak of waterborne diseases like cholera. In Budalano'i Runyala

In Budalang'i, Bunyala Deputy County Commissioner Paul Papa issued an alert and asked residents to evacuate to higher grounds as a precautionary measure. "Our primary concern is the safety of our residents. Given the forecasted heavy rains and the increased risk of flooding, I urge the chiefs and assistant chiefs to strongly advise all

residents in low-lying and flood-prone areas to evacuate to higher grounds immediately," he stated. The Meteorological Department has forecasted that the country would continue to experience the El nino

Why State has tightened control on fruits exports

THE GOVERNMENT IS keen on safeguarding the country's fruit export market, in particular of mangoes and avocados, by tightening control on shipments. This follows illegal practices by some exporters seeking to cash in on rising demand. Last week, the government announced new restrictions on mango exports,

few days after suspending export of avocados. Agriculture and Food Authority (AFA) said the regulations that include mandatory physical inspection of mango consignments would prevent the mixing of mangoes and other fruits by exporters. The practice had emerged following the suspension of avocado exports at the end of last month to prevent export of immature fruits that tarnish the country's reputation. "All mango exporters with effect from November 13 are required to apply for physical inspection of their consignments at their pack houses," said AFA Director-General Willis Audi. He added that AFA had taken the measure after realising that some exporters were mixing consignments of mangoes and avocados to beat the temporary ban. Mangoes are the second most important export fruits in Kenya, after avocados. ■

State steps up drive to provide all public institutions with internet







Schools and hospitals at the grassroots among institutions that will benefit from the last mile internet connectivity project

t least 455 public institutions, including schools, hospitals and county offices, will be linked to the national internet connection as the government expands the drive to connect all its organisations and boost communication.

This follows the launch of the fourth and fifth phases of the Last Mile County Connectivity Project (LMCCP) by Head of Public Service Felix Koskei and ICT Cabinet Secretary Eliud Owalo.

The plan under Phase IV entails the connection of 455 sites, including primary and secondary schools, which will enhance accessibility to the National Optical Fibre Backbone Infrastructure (NOFBI).

"As we reflect on the accomplishments of the initial phases, we acknowledge the successful completion and maintenance of the interconnected network, comprising over 650 government buildings and an extensive fibre network spanning more than 87 kilometres," said Mr Koskei in Machakos, adding that the project is being supported by the Belgium government.

He observed that the establishment of the Network Operating Centre (NOC) has further bolstered the government's capacity to monitor and manage the network effectively, ensuring its seamless operation and sustainability.

Mr Owalo stated that the government has implemented the Last Mile County Connectivity Project across the 47 devolved units as part of building the digital superhighway. Through the project, the ministry has connected all county and sub-county headquarters to the National Optic Fibre Backbone Infrastructure.

The offices can now seamlessly access inter-county communication services. IFMIS and video conferencing, among

He noted that through LMCCP. the government has facilitated virtual meetings for all CSs and PS's by providing advanced modern idea hubs and video conference solutions in their offices. The project has witnessed remarkable achievements, including the installation of over 10,000 IP telephony lines, the deployment of high-speed internet services and the integration of video conferencing facilities.

"For far too long, we have stood on the sidelines, watching the world engage in maritime activities, perhaps believing that it was beyond our grasp and too intricate to navigate." This perception has unfortunately led to insufficient investment in the sector creating an opening for foreign entities to seize control of local shipping in our region. It is high time we change this narrative and realize that the potential for us to not only participate but excel in maritime endeavors is well within our reach," he added. The PS said the thriving trans-shipment of cargo between the ports in different countries involved in the maritime trade is a testament to the potential for the development of local shipping sectors.

He said the discussions will focus on ways of reserving local shipping opportunities for regional players.

The PS said the issue at hand is the limitations of local ship's registries, a consequence of unfavorable policies and regulatory frameworks.

He added that to truly harness the potential of the maritime sector, the region must undergo a paradigm shift and implement measures to enhance the appeal of the ship's registers.

'These include favorable taxation policies, a streamlined ship registration process, competitive registration iees, and unfettered access to essential services for ship repairs, maintenance, and surveying.
