Real time tracking system to enable citizens assess performance of state

PS says the GDMIS will see all departments reporting and providing the implementation status of all projects under their purview onto a common system

The rollout of the Government Delivery Management Information System (GDMIS) is set to revolutionize the way the government reports on its achievements. Dr. Idris Dokota, the Principal Secretary for Cabinet Affairs, made this announcement during a workshop involving 18 Ministries, Departments, and Agencies (MDAs) in Mombasa. He explained that GDMIS will enable all state departments to report on the

implementation status of projects under their purview through a common system.

Dokota emphasized that the online system has the potential to track the implementation status of all cabinet decisions and presidential directives in real time, providing analytics for accountability and accuracy of government milestones. Additionally, GDMIS will provide a toolkit for citizens to assess government performance in service delivery and

fulfilling election campaign pledges.

"The development of GDMIS is aligned with the government's digitalisation agenda which seeks to ensure that implementation of programmes and projects is done collaboratively with little room for repetition or overlaps," he noted.

The Principal Secretary stated that the GDMIS once fully implemented would provide a wide spectrum of coverage including legislation as well as the status of treaties and conventions the country was party to and domesticating within its laws.

The PS stated, "This system will centralize project data, increase transparency by providing real-time project updates, and instill high accountability by mapping out respon-

Energy sector gets boost with KPRL asset acquisition by KPC

The acquisition of Kenya Petroleum Refineries Limited (KPRL) assets by the Kenya Pipeline Company (KPC) is set to streamline KPC's operations, with a primary focus on pipelines and petroleum product storage capacity in Kenya and the wider region.



Energy and Petroleum Cabinet Secretary, Davis Chirchir, highlighted that this acquisition will not only boost petroleum and product storage capabilities but also expedite the per capita usage of Liquefied Petroleum Gas (LPG).

This will be achieved by establishing LPG bulk import handling and storage facilities

at KPRL's storage tanks in Changamwe, Mombasa.

During the Share Transfer Agreement signing ceremony for the acquisition of KPRL by KPC at the National Treasury in Nairobi, Chirchir emphasized that this move will support the upgrade and

sibilities."

The system features a centralized hub for managing government accomplishments, a task and milestone tracker that enables focal technical officers to define tasks, assign them, set deadlines, and track progress, and a secure platform for internal communication, providing real-time reporting and analytics that facilitate data-driven project decisions.

The PS advised agencies to "embrace the whole of government approach methodology for collective governance and remove the silo mentality that threatened government operations."

The Director for Monitoring and Evaluation in the Office of the Chief of Staff and Head of Public Service, Matthew Rotich, said the system, while providing a bird's eye view on the scope of government projects will also be able to identify challenges that could derail

government initiatives.

Rotich observed that prior to the creation of the GDMIS, Cabinet Decisions and Presidential Directives lacked a well-structured method for coordinating implementation, reporting, and enhancing collaboration for effectiveness and efficiency.

Consequently, he said, numerous directives have remained unimplemented or unfulfilled or have been challenged by courts and the public.

"The absence of a structured system has culminated in competition for scarce resources within the different sectors giving space for duplication, fragmentation and lack of coordination in the articulation of government agenda," Rotich said.

He disclosed that the GDMIS as an Impact Level Reporting System aims at enhancing communication, feedback, implementation tracking, and challenge resolution mechanisms for Cabinet Decisions, and Presidential Directives.

KPC's acquisition of KPRL assets set to accelerate petroleum operations

rehabilitation of KPRL, enabling the planned capacity enhancement of the pipeline system across the country and expanding the storage capacity for the nation.

Chirchir further noted that this takeover will position Mombasa as a dominant trading hub in East Africa, assisting in managing price fluctuations of petroleum and petroleum products in the local market. Additionally, the acquisition is expected to bolster the petroleum supply chain infrastructure, ensuring supply security and cost-efficiency by reducing demurrage costs.

The acquisition's ultimate goal is to enhance efficiency and promote synergy within the petroleum value chain by optimizing the utilization of existing downstream petroleum infrastructure.

"The acquisition of Kenya Petroleum Refineries Limited by Kenya Pipeline Company is symbiotic. It is envisaged that the financial performance of both institutions will

improve. Moreover, the operationalization and growth of KPRL under the new shareholder will bring social and economic benefits to the coast region and to Kenya at large" the CS said. Currently, Chirchir further said, the Kenya Petroleum Refineries Limited facilities are leased by Kenya Pipeline Company who operate and manage the facility and the the acquisition therefore changes

the arrangement in that Kenya Pipeline Company shall own Kenya Petroleum Refineries Limited.

KPRL, Chirchir noted, shall remain a legal entity as a subsidiary of KPC and in line with the Kenya Kwanza agenda of jobs creation, there shall be no loss of employment because of this acquisition.

"You may wonder why the Government has approved the change from

leasing to ownership through share transfer, yet the leasing arrangement was working," said the CS.

Speaking during the hand over ceremony, the National Treasury Cabinet Secretary Prof. Njuguna Ndung'u said the Government through the National Treasury is transferring 100 per cent of its shares held at KPRL to KPC without any monetary consideration.

Lalambela Springs, a natural marvel in the heart of Kasighau Hills

Nestled at the heart of the dense indigenous forest atop the scenic Kasighau hills is a natural marvel: a series of ancient natural springs christened Lalambela by the residents.

The cool waters from the springs have flowed down the craggy face of the ancient rocky hills for ages, irrigating parched farms and quenching the thirst of thousands in the low-lying, arid villages.

The permanent springs constitute the backbone of the Bungule Community Water Project, which serves thousands of rural homes in Bungule and Jora villages neighboring Tsavo National Park in Voi Sub-County. During the drought season, the project also provides water to homes in some parts of Rukanga village.

Mr. Daudi Mwashighadi, the Secretary of Bungule Water Project, explains that the community, through a project committee, is wholly responsible for the project, including



operations such as billing, distribution, and the rehabilitation of sections that require repair.

Despite the project's success, the burgeoning human population and rampant deforestation in the Kasighau hills have become major challenges requiring prompt intervention. These challenges

have led to a significant reduction in the springs' water yield over the years. As a result, water rationing is sometimes necessary, particularly during the dry season, to allow for the refilling of watering troughs for livestock and wild animals.

"The destruction of the sources and the felling of trees for charcoal burning have adversely affected the volumes of water from the springs," he says.

Such challenges are common in most community-owned and operated water projects in Taita-Taveta County. Data from

the Department of Water indicates that the county has 112 community water projects. These projects, mainly located in rural areas, serve over 50 percent of the county's population. Urban and semi-urban zones are primarily served by Taita-Taveta Water and Sewerage Company (TAVEVO), which is supplied by a pipeline from Mzima Springs.

County Executive Committee Member (CECM) for Water and Environment, Granton Mwandawiro, emphasizes that community water projects are a crucial component of the county government's ambitious vision to provide universal access to clean and affordable water for thousands of residents in this arid county.

Speaking at Taita-Taveta University during the unveiling of the Water, Sanitation, and Hygiene (WASH) Environment Coordinating Forum, Mr. Mwandawiro adds that the monumental challenges facing these water projects, including inadequate funding, management issues, and addressing the degradation of water sources, can be effectively addressed by implementing structures to formalize the operations of rural water providers.

Gov't, partners unveil Sh750m Blue Economy project in Kilifi

The Government and its development partners have initiated a significant Sh750 million Blue Economy Project, expected to bring benefits to over 50,000 households in Kilifi County.

The Regenerative Seascapes Project for Planet Earth, Nature, and People (ReSea) was officially launched by Salim Mvurya, the Cabinet Secretary for Mining, Blue Economy, and Maritime Affairs. The launch event took place at Dabaso Primary School in Kilifi North Constituency, Kilifi County.

The ReSea Project's primary objective is to enhance climate and socio-economic resilience for households along Kenya's coastline, spanning from Takaungu in Kilifi South Constituency to Mareneni in Magarini Constituency, as explained by CS Mvurya.

This initiative is a component of a three-year Sh3.3 billion project ex-

ecuted by Missions Inclusive in collaboration with the International Union for the Conservation of Nature, with funding provided by Global Affairs Canada.

During the project's launch, Mvurya emphasized that the majority of beneficiaries would include women and youth groups involved in climate change initiatives and the blue economy.

"The project will mobilize women, youth groups, and proactive climate change and blue economy organizations. We aim to start from the ground up, forging connections with existing capacities to align with the priorities of local communities," Mvurya said.

The CS ordered the Kenya Wildlife Services (KWS) and the Kenya Coast Guards (KCG) to stop harassing fishermen who use illegal fishing gear, but instead help them follow the law by empowering them acquire the right fishing gear.

PUBLIC CONSULTATION ON FREQUENCY SPECTRUM PRICING STUDY

The Communications Authority of Kenya (CA) is the regulatory authority for the ICT industry in Kenya with responsibilities in telecommunications, cyber security, e-commerce, broadcasting, multi-media and postal/courier services. CA is also responsible for managing the country's numbering and frequency spectrum resources, managing and administering the Universal Service Fund (USF) as well as safeguarding the interests of users of ICT services.

In furtherance of its responsibility to develop a responsive legal, regulatory and licensing regime, and in its effort to effectively manage the frequency spectrum resource, the Authority is in the process of reviewing its existing frequency spectrum pricing framework. To this end, the Authority has contracted Ms. Advatech Group and LS Telcom to jointly carry out a Frequency Spectrum Pricing Study.

The two (2) consultants intend to carry out stakeholder consultations on the existing frequency spectrum pricing framework and will contact stakeholders on behalf of the Authority. The consultants will help the Authority to gather data and key insights regarding the current state of spectrum pricing in Kenya, and its alignment with broader market dynamics, policies and regulations.

The stakeholder consultation process will be carried out between **13th November 2023** to **27th November 2023**. The Authority therefore calls on stakeholders to actively participate in this process and provide feedback during the consultation period.

The comments received will inform the review of the frequency spectrum pricing framework.

Audit board empowers County Audit Committees to safeguard public funds

The Public Sector Accounting Standard Board [PSASB] has assigned the County Audit Committees the task of fortifying their internal audit systems and mechanisms to prevent the misappropriation of public funds.

According to PSASB chair Pius Nduati, this initiative aims to bring the counties in line with the government's zero-fault audit directive, which mandates the resolution of all pending audit queries by June of next year.

Nduati mentioned that the board has established necessary policies and audit

manuals that will provide guidance to the county audit committees in resolving all

audit queries related to the utilization of public funds. Since the inception of

devolved units, the Office of the Auditor General has raised audit queries running into billions of shillings stemming from unsupported use of public funds through both recurrent and development expenditures.

For instance, the Auditor General has raised significant audit queries, including the utilization of funds without proper documents, such as invoices and vouchers, the loss of funds due to ghost workers, and breaches of procurement laws, among other issues.

Nduati tasked the county audit teams to explore strategies to enhance governance systems of audit systems and align them with international best practices to enhance accountability and transparency of financial resources.

“Efficient internal audit systems are critical towards ensuring prudent management of financial resources and in entrenching good

governance and accountability in both national and county governments”, said Nduati.

The Board chair tasked the county audit departments to put in place preventive measures including adoption of technology to ensure all raised audit queries are addressed on time.

PSASB CEO Fredrick Riaga said all county audit departments must transition from cash accounting systems to accrual accounting in the use of public resources.

Speaking during a sensitization workshop of county audit teams in Naivasha, Riaga said the strengthening of audit systems will mitigate and cushion the public from loss of financial resources.

According to the Head of Audit at the Council of Governors Andrew Musungu, there is need for continuous training of audit commit-

tee members on emerging trends on best practices to ensure the proper use of funds.

He added that enhanced audit systems will ensure the counties address emerging concerns of pending bills amounting to billions of shillings that continue to plague counties by ensuring all audit queries are given a clean bill of health before payments.

Musungu said the Council of Governors has partnered with the Ethics and Anti-Corruption Commission to strengthen governance systems in county governments to seal all corruption loopholes.

In addition, Musungu said EACC has continuously helped counties carry out corruption risk assessments, development of policies such as Anti-corruption, whistleblower and conflict of interest policies that have enhanced governance structures.

State elevates mental health support for civil servants with new directorate

The Psychological and Mental Wellness Department in the State Department of Public Service has been upgraded to a Directorate to give it the capacity to deal with escalating cases of mental health breakdowns among civil servants in the country.

The Principal Secretary in the State Department for

Public Service Mr. Amos Gathecha who was speaking to the media in his office said to curb the increase of mental illnesses among civil servants, the Public Service Commission (PSC) has upgraded the Psychological Counselling and Mental Wellness Department into a fully-fledged directorate headed by a secretary at Job Group T.

Gathecha recalled that during the Covid-19 pandemic in 2020, some 5,000 officers sought counselling services from the department due to high stress levels, drinking problems and absenteeism but to-date, the number has soared to 13,000.

“Once this Directorate is fully operationalized, the Government will establish

a Psychological Counselling Centre in the Public Service to address mental health illnesses among civil servants effectively,” Gathecha noted.

To fully address the spiraling cases of mental health breakdowns in the public service, the PS added, the State Department will establish counselling desks in all the 52 Huduma Centres in the country to cover officers in the grassroots.

Gathecha said his State

Kenya calls for genetic enhancement to boost meat and leather production

The government is urging animal production specialists to focus on the genetic improvement of livestock in the country in order to boost milk, leather, and meat production. Jonathan Mueke, the Principal Secretary of the State Department for Livestock, pointed out that despite Kenya having one of the

largest herds in Africa, production along these three value chains has remained low.

According to Mueke, genetic improvement is crucial for developing the right breeds across different regions.

This approach is seen as vital as the government aims to secure international markets for these products.

By having the right breeds, the country can significantly benefit from the livestock sector.

The State Department, Mueke mentioned, has initiated various interventions to enhance production along these three value chains. He highlighted the importance of the livestock sector in the Bottom-Up Economic Transformation Agenda

(BETA), emphasizing that it plays a key role in creating jobs, reducing poverty, and offering young people opportunities for better livelihoods.

Through these interventions, the State Department aims to increase earnings from the leather value chain from the current annual revenue of Sh16 billion to Sh100 billion by the year 2027.

This growth is expected to result in a substantial increase in the number of jobs in the sector, with projections indicating a rise

from the current 20,000 to 100,000 jobs during the same period.

In the dairy value chain, the State Department projects an increase in milk production from the current 4.6 billion liters to 11 billion liters by the year 2027, the PS said.

Speaking during the annual Animal Production Society of Kenya (APSK) symposium in Kisumu, the PS pointed out feed production as the biggest challenge affecting livestock production in the country.

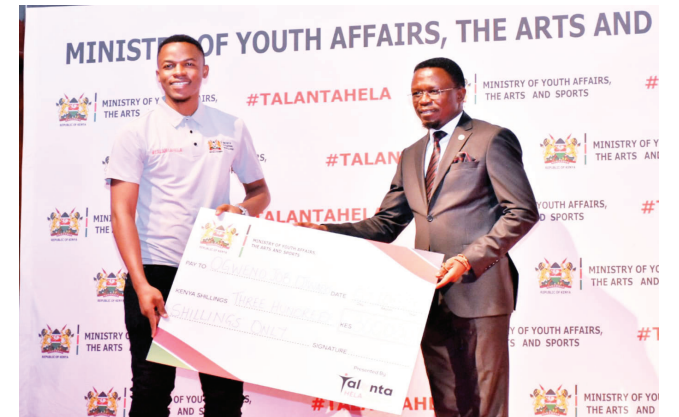

Eliud Owalo, the Cabinet Secretary for Information, Communications, and the Digital Economy, emphasized the importance of ensuring that cybersecurity measures are in place as digital technology continues to transform various aspects of life, including financial transactions, education, agriculture, and healthcare. Owalo highlighted the

necessity of providing a safe digital environment for people to fully benefit from these innovations. He stated that the government is adopting a proactive and multifaceted approach to cybersecurity, focusing on protecting online infrastructure, such as the e-Citizen platform, and ensuring the stability of essential services, with a primary

concern for the safety and well-being of citizens and businesses.

Owalo mentioned that the e-Citizen platform currently hosts 13,382 government services. To prevent cyberattacks, the government conducts periodic security audits and penetration tests, implements remedial actions to address vulnerabilities, strengthens infrastructure and networks, and maintains continuous monitoring of network traffic.

This comprehensive approach to cybersecurity

aims to create a secure digital environment that allows Kenyan citizens to harness the benefits of technology while safeguarding their online activities.

Speaking when he officially inaugurated the National Security Symposium at the National Defence University- Kenya in Lanet, Nakuru County, Owalo said the government is a strategic player both regionally and globally in cybersecurity, due to the continued investments in robust ICT infrastructures.

Education ministry to prioritize health care access for special needs students

The Ministry of Education is actively working to ensure that children with special needs and disabilities are included in the Universal Health Care (UHC) program, making these services available to all school-going children.

Education Cabinet Secretary (CS) Ezekiel Machogu highlighted that the UHC program will provide learners with access to critical therapy and rehabilitation services, effectively alleviating the severity of their special needs and disabilities.

Addressing the audience during the 29th graduation ceremony of the Kenya Institute of Special Education (KISE), Machogu noted that this initiative will not only benefit those already in school but will also encourage many out-of-school children with special needs and disabilities to enroll and take advantage of the program's services.

"Today, the Institute is awarding 664 diplomas

in Special Needs Education and 207 certificates in various aspects of special needs. With this, the country now has a force of more than 30,000 solid professionals to serve in the areas of special needs and disabilities," the CS said.

Machogu said the role of parents in the growth, development and education of children cannot be gainsaid.

"Indeed, this is the reason parental empowerment and engagement is one of the guiding principles of the Basic Education Curriculum Framework," he said, adding that the engagement of parents of learners with special needs and disabilities is critical in the provision of assistive devices, care and management in both school and home settings.

"I am aware that the Institute has initiated the process of putting up a parental empowerment centre. I assure you that the Ministry of Education will continue to give necessary support towards

the completion of the centre. This will go a long way in building the capacity of the parents towards individualized education programs for the learners as well as their life skills enhancement," Machogu said.

The CS highlighted that the Diploma in Special Needs Education is required to be aligned

Today, the Institute is awarding 664 diplomas in Special Needs Education - CS

with the Competency-Based Curriculum (CBC) as he directed the Kenya Institute of Curriculum Development (KICD) to liaise with relevant stakeholders and hasten the completion of the curriculum, as well as the Diploma in Sign Language Interpretation, which has been pending for over eight years.

"The Government has remained committed to the education of learners with special needs and disabilities. In this light, we have emphasized that the learners are provided with appropriate assistive devices, technologies and specialized learning materials," Machogu said.

The CS announced that the Ministry has decided to centralize the provision of these devices through the Kenya Institute of Special Education.

"We shall shortly flag off the first batch of this centralized distribution of assistive devices and specialized materials for learners with special needs and disabilities valued at Sh87 million. This

will benefit 101 schools covering all the visually and hearing-impaired schools," Machogu explained.

He added that the next batch for special schools supporting the other specializations, including physical disabilities and intellectual impairment, will also be dispatched in a month's time.

"Noting the gap that has existed in respect to repair and maintenance of assistive devices and technologies across the country, we must depart from the point where there is no deliberate plan in place to service these critical devices that has previously led to unnecessary wastage and loss," said the CS.

Machogu said that the Ministry has identified KISE to offer this critical service to special schools, units and inclusive programmes across the country. This will ensure that learners with special needs and disabilities continue to benefit from these worthy devices for the longest time possible.

State turns to digital tech to tackle climate change

champions across all government ministries who will refer serious mental health cases to professional counsellors at the Chiromo Campus of the University of Nairobi, and the Ministry of Health.

He revealed that the State Department will also re-

engineer the National Youth Service (NYS) by increasing its intake from 20,000 recruits annually to 100,000 in the next five years.

"We will make the NYS self-sustaining, give it the capacity to generate its own income, grow its own food with the aim of shedding its dependence on the Exchequer for funding," Gathecha

said.

He said the 100,000 acres of land owned by the NYS country wide will be put under cultivation and irrigation to grow maize, banana, and vegetables to boost the country's food security.

The PS said that the mechanical unit of the NYS will be revamped to give it

the capacity to seek government contracts to build roads, bridges, build small dams and sink boreholes throughout the country.

The PS also said that once the NYS has been re-engineered, the Government will enter contracts with potential employers in the Arab world, Australia, and the Middle East with the goal of exporting skilled and semi-skilled labour to those countries.

The workers, the PS said,

will repatriate their incomes back home and inject foreign exchange into the national economy.

He revealed that the State Department will increase the current 52 Huduma Centres to every constituency to make them 290.

The new Huduma Centres in every constituency, PS Gathecha added, will give services to digitally illiterate people in the rural areas through provision of driving licenses, NHIF cards, certificates of good conduct

and passports in the long run.

The PS directed all officers in the civil service to join professional bodies which regulate various cadres like accountants, engineers, auditors, quantity surveyors, doctors, nurses to minimise cases of their professional being infiltrated by quacks.

The professional organisations, Gathecha said, will regulate various professions and institute disciplinary action and push out pretenders.

Tsavo East National Park to be fenced to address human-wildlife conflict

The Kenyan government has unveiled an ambitious plan to address the ongoing human-wildlife conflict in Makueni County by fencing off Tsavo East National Park. This conflict has been associated with the loss of lives and property in the region.

Dr. Alfred Mutua, Cabinet Secretary for Tourism

and Wildlife, revealed that a budget of Sh50 million has been allocated to fence a 65-kilometer stretch of Tsavo East National Park, running from Masongaleni to Ganze Line.

"We have Sh50 million that is ready, and I urge the Director General of the Kenya Wildlife Service to visit my office with the necessary documents for me to

sign.

This will allow us to procure the required services and commence the project immediately," Dr. Mutua announced during an address to the residents at Kyuasini market in Kibwezi East Sub-County.

"In the last three years that we have witnessed increased drought due to climate change in the country,

we have also witnessed people killed by wild animals, others injured, and property destroyed. This is a problem now I will address it with finality, and I have taken it seriously as one of the very important projects in the country," the CS noted.

During the Baraza, the Cabinet Secretary also revealed that he will allocate another Sh100 million, to fence-off the 70 kilometers stretch, between Ngiluni to Masongaleni.

"There is a distance between Ngiluni and Mason-

galeni of 70 kilometers, that requires Sh100 million. I have a meeting next month to allocate the funds, to ensure the works start by the end of the month," Dr. Mutua assured.

Promising the residents that the government will compensate those killed, injured or property destroyed, the CS urged them to have some patience.

"We have Sh1.1B allocated for compensation this year, but we need 5.7B annually to compensate people in Meru, Isiolo, Kajiado, etc," he said.

Government to work with shipping agents to empower seafarers

The Government, in collaboration with the State Department for Shipping and Maritime Affairs, has initiated a partnership with the Kenya Ships Agents Association (KSAA) to enhance the skills of seafarers in the maritime sector.

Following a meeting with KSAA, Salim Mvurya, the Cabinet Secretary for Mining, Blue Economy, and Maritime Affairs, announced that they have reached an agreement to facilitate the placement of seafarers on ships, providing them with valuable sea time and employment opportunities within the ship-

ping industry.

Mvurya further stated that the two parties have also committed to developing industry-relevant courses that will be offered at shipping and maritime training facilities for seafarers and cadets.

The Kenya Ships Agents Association and its members have played a pivotal role in creating opportunities for 5,500 seafarers since 2018, according to the CS.

He also revealed that the government is in the process of establishing a Maritime Logistics Centre of Excellence facility in Kwale, with an estimated cost of Sh1.5 billion. This initiative aims to equip young people with the necessary skills for the blue economy.

Mvurya acknowledged the significant contribution of KSAA to the national economy through their involvement in the shipping business. They handle cargo imports, customs clearance, and provide transport

services to the final stages of the shipping process, he noted.

He noted that there is a need for the department to interact with them to understand their issues, the opportunities provided and engage on the important areas of policy regulation relevant to the sector and discuss the way forward.

Mvurya said the county governments within the coast region have committed to work with the state department so that there can be more seafarers and cadets. The CS confirmed the government's commitment in working together with the industry players to level the playground and enable the shipping business to have as many people as possible to participate.

On his part, Governor Abdulsamad Nassir lauded the Kenya Maritime Authority for providing the County Government of Mombasa with the curriculum on shipping and maritime

courses saying that they are now able to convert the Mtongwé Vocational Centre for purposes related to maritime.

He said the county government will co-sponsor the conference that is set to take place in Mombasa in November, adding that it is key to opening the sector.

The KSAA Chairman Silvester Kututa said that the maritime industry will be a major driver of the economic development of the country, asking the government to work on a policy framework that will play a leading role in achieving the goal.

Kututa said the association plays a key role in the formation of curriculum in institutions training seafarers, adding that with the consultation with the government, more opportunities will be generated as they are now going to the drawing board to put together their thoughts in improving the shipping business.

New NG-CDF Board warned against engaging in politics

As the National Treasury formalises the appointment of a former Kisumu Town West Constituency MP Olago Aluoch as the new Chairman of the National Government Constituency Development Fund (NG-CDF) Board for a period spanning the next three years, Cabinet Secretary Prof. Njuguna Ndung'u is urging the new Board members to steer the Fund away from politics.

The appointment of the lawyer-cum former legislator comes at a time when the Government is keen on increasing funds to the NG-

CDF kitty to support even more development projects across the country.

Prof Njuguna Ndung'u says (NG-CDF) continues to change the lives of Kenyans especially those at the bottom of the pyramid and he does not expect less from the incoming Board led by Mr Aluoch.

Speaking in Mombasa during the official opening of an Induction Training Workshop on Corporate Governance Prof. Ndung'u said, "the Government has allocated a total of 53.5 billion Shillings towards the Fund in the current FY (2023/24), translating to an increment of 21 per cent compared to the last Financial Year (2022/23)

which stood at 44.3 billion Kenya shillings.

"The additional budgetary allocation is an appreciation of the good work being realized through the NG-CDF in various constituencies," the CS said.

At the same time, the CS cautioned the newly NG-CDF Board members to steer clear of politics and embrace the prudent utilization of resources under the fund.

Other Members include Janet Teiya and Masitsa Naomi Shiyonga, who joins the other team of independent directors serving their second term and the alternate directors drawn from Ministries, Departments and Agencies (MDAs).

The Board, which has career civil servants serving as directors, is also expected to navigate around and explore new innovations that can support the Fund to expand to cover a wider scope of de-

velopment projects in all regions, Prof Ndung'u said.

The CS outlined achievements of the NG-CDF which has so far awarded Sh69.8 billion bursaries, constructed 26,452 new classrooms, constructed 1,156 new dormitories, funded the construction of 76 new Kenya Medical Training College (KMTTC) campuses, and technical training institutions, and funded the purchase of 1,005 new buses for schools and other education institutions and many others.

He emphasized that through persistent implementation of the priorities and pillars of the Bottom-Up Economic Transformation Agenda (BETA), this country is set to get out of the abrasions of persistent economic turmoil.

He said that stabilizing and sustaining the dynamics of the markets will lead to a stable economic turnaround and eventually national development.

2023/2024 FISCAL YEAR**

Horticultural Crops Directorate (HCD) established by the Agriculture and Food Authority Act of 2013 is mandated to develop, regulate and promote the horticulture industry.

Kenya is one of the leading producers of avocado in Africa. Some of the leading destinations for the Kenyan avocado include The Netherlands, United Arab Emirates, France, Spain, Turkey, China, Germany, United Kingdom among others.

In line with its mandate, the Directorate enforces sector Regulations to ensure that quality produce is marketed locally and internationally. This includes ensuring that mature Avocado is harvested and exported, in a bid to sustain and grow our international markets and minimize interruption of the crop cycle occasioned by harvesting of immature Avocado.

The Directorate undertook a survey to authenticate the maturity indices of the avocado fruits in the major production zones. Following the findings of the survey, we hereby notify the Kenyan Avocado stakeholders that:

1. The closing of **Hass, Pinkerton, Fuerte** and **Jumbo** harvesting season and export by sea for the 2023/2024 fiscal year shall be in force with effect from **3rd November 2023**
2. Export clearance (including fruit consignments from the EAC region) shall be granted for **air shipment**, subject to inspection by the Directorate. Traceability information will be required for all consignments.
3. The notice applies to all exporters, importers and processors.

The Directorate shall continue to closely monitor Avocado maturity trends and patterns, review the notice in mid-January 2024 and guide appropriately.

Local farmers embrace integrated pest management to tackle Fall Armyworm

Kenyan farmers are now equipped to combat the fall armyworm infestation through an integrated pest management system introduced by the Kenya Agricultural and Livestock Organisation (KALRO) in partnership with the Korea-Africa Food and Agriculture Cooperation Initiative (KAFACI).

KALRO Director General, Dr. Eliud Kireger, emphasized the significance of integrated pest management in controlling the fall armyworm, offering a sustainable, cost-effective, and environmentally friendly approach that encompasses various strategies to prevent and reduce the pest population over the long term. The KAFACI Fall Armyworm Project has been working closely with farmers in Machakos County to validate the value of this approach.

During the 2023 progress monitoring meeting of the 'integrated management of fall armyworm for sustainable food security in Africa' in Nairobi, Dr. Kireger reported that farmers have enthusiastically embraced these technologies. This adoption has

had a transformative impact on managing the pest, resulting in increased maize yields.

The initiative aims to enhance maize productivity by effectively managing the fall armyworm, not only in Kenya but also across the African continent. Kenya ranks among the top nations in white maize consumption, with a current per capita rate of 60 kilograms nationally per year and 103 kilograms per person in rural areas.

While maize production in Kenya had been on a continuous expansion trajectory, the invasion of the fall armyworm in 2017 presented a significant agricultural chal-

lenge. This invasive pest led to substantial losses in agricultural activities, including an increase in production costs due to the application of pesticides, a reduction in maize production, a surge in imports, and subsequent food insecurity and higher prices. The most vulnerable households, least equipped to manage the fall armyworm, were the hardest hit.

Research studies conducted under KAFACI in 2020 revealed that most farmers had to apply up to five sprays in a season to control the worm. Despite these efforts, they still recorded over 50% yield losses and zero yields without pes-

ticide application.

KAFACI Executive Secretary, Keunpyo Lee, highlighted the seriousness of the fall armyworm problem in multiple African countries. This led the Korean government to take up the issue, and the project currently operates in 16 African nations. Lee called on African countries to enhance their capacity for monitoring and evaluating the fall armyworm while developing appropriate technologies to protect maize and other crops from the pest's invasion.

The KAFACI Fall Armyworm Project is a five-year initiative with the possibility of extension if the fall armyworm persists in the region. The project has been funded with US\$1.6 million, with each participating country receiving US\$20,000 per year for the entire five-year period.

Dr. Subramanian Sevagan, Principal Scientist at the International Center of Insect Physiology and Ecology (ICIPE), who has over 40 years of experience in fall armyworm management, noted that the pest's damage has decreased over time.

Nyeri to partner with National Museums of Kenya to revamp Mau Mau historic sites

The Nyeri County Government has committed to collaborating with the National Museums of Kenya (NMK) to enhance and develop three significant Mau Mau heritage sites within the county. These sites include the Nyeri Museum, which houses historical artifacts from the colonial era of the Kikuyu community.

Additionally, the county government will work in partnership with NMK to improve the Mau Mau flag site, a location of great historical significance where freedom fighters gathered twice in history. On July 6th, 1952, they declared war against the colonial administration and its supporters. Then, on December 19th, 1963, they assembled once more to surrender their weapons, signi-

fying the end of the uprising.

During a breakfast meeting at the Museum, Nyeri Governor Mutahi Kahiga shared the plans and further revealed a proposal to establish a dedicated Mau Mau Museum in Karuna-ini, Tetu Constitu-

ency. This specific location marks the site where Field Marshal Dedan Kimathi was captured and shot by British soldiers on October 21st, 1956. The collaborative efforts aim to preserve and promote the historical significance of

these Mau Mau sites.

"We, as the county government, are ready to work with the national government to improve the status of these sites," Kahiga said.

"I have spoken with the president and appealed to him to give us a 99- or 100-year lease for a 10-acre piece of land in Karuna-ini where Dedan Kimathi was shot. Our plan is to build a museum where we can preserve Mau Mau artefacts," he added.

In his address to the freedom fighters, the county boss also assured them that he will continue to pursue their compensation.

He noted that whereas the British Government had compensated a few of the Mau Mau torture victims, most of the freedom fighters were yet to receive any form of justice for the atrocities faced during the freedom struggle.

State vows to revive Marsabit Stadium project amid quality concerns

The Government is eager to revive the stalled Marsabit Stadium project to provide the much-needed sporting infrastructure and facilities in the area. The Sports and Youth Affairs Cabinet Secretary (CS), Ababu Namwamba, directed an immediate assessment of the work already completed, aiming to determine the next course of action to finish the project.

While visiting the project site, Namwamba mentioned that the Department of Public Works and a team of technical officials from the County Government would commence assessing the structural integrity of the construction work done on the VIP pavilion, the pitch, track, and the public pavilion. They would provide guidance on the next steps.

Accompanied by Marsabit Governor Mohamud Ali, the CS stated that the assessments by the teams would guide the government's decision on whether to proceed with the delayed work or initiate the project anew.

While a section of the work on the public pavilion and the

playing field carried out by Benisa Limited appears commendable, the main pavilion constructed by Arid Lands Contractors is a cause for concern due to visible cracks and a tilted dais.

This company was engaged by the County Government to build the VIP pavilion at a cost of Sh78 million, with an advance payment of Sh46 million for mobilization fees. The National Construction Authority (NCA) has raised questions about the integrity of their work.

Benisa Limited, contracted by Sports Kenya, was responsible for building the public pavilions and the main pitch to international standards at a cost of Sh295 million. The flagship project was commissioned by former President Uhuru Kenyatta in mid-2017.

Cabinet Secretary Namwamba expressed his concern about the lack of progress on such a vital facility, along with six others across the country, despite public funds having been allocated.

ICT experts call for cybersecurity training to counter rising threats

Information Communication Technology (ICT) practitioners in Kenya have called for increased training and re-tooling of experts in the sector to address the growing cybersecurity threats facing the country. The call comes in response to a significant rise in cyberattacks in Kenya, with reported losses amounting to Sh7.7 million in 2018 and a staggering increase to 444 million in 2023. This sharp increase has ranked Kenya among the top three most targeted countries in Africa.

During a Governance, Risk, and Compliance (GRC) conference held in Kisumu, ICT practitioners highlighted the need to train more professionals in the field, particularly in cybersecurity. Building the country's capacity to combat cybercrime is essential.

Mercy Omolo, President of the Information Systems Audit and Control Association (ISACA) Kenya Chapter, emphasized that the shortage of skilled ICT professionals in the face of emerging cyber threats is a major challenge for GRC. Organizations and state agencies in Kenya are struggling to deal with these growing cyber

security threats.

Omolo called for investments in training and retooling ICT professionals to help them adapt to these emerging threats and keep digital systems secure. ISACA, a technology association of professionals, has launched programs to enhance the capacity to combat cybercrime, including upskilling and issuing certifications to its 1,700 members. Speaking at the same conference, Dr. David Njoga, Head of Cyber Security at the National Computer and Cybercrimes Coordination Committee, explained that digitization and online government services have created digital footprints, attracting cybercriminals. This exposure has left government agencies and the private sector vulnerable to cyberattacks. Njoga stated that the government has implemented measures to mitigate these threats, including developing regulations to enforce the Computer Misuse and Cyber Crimes Act (2019), enhancing compliance with the law to ensure a stable digital economy.
