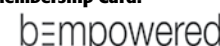

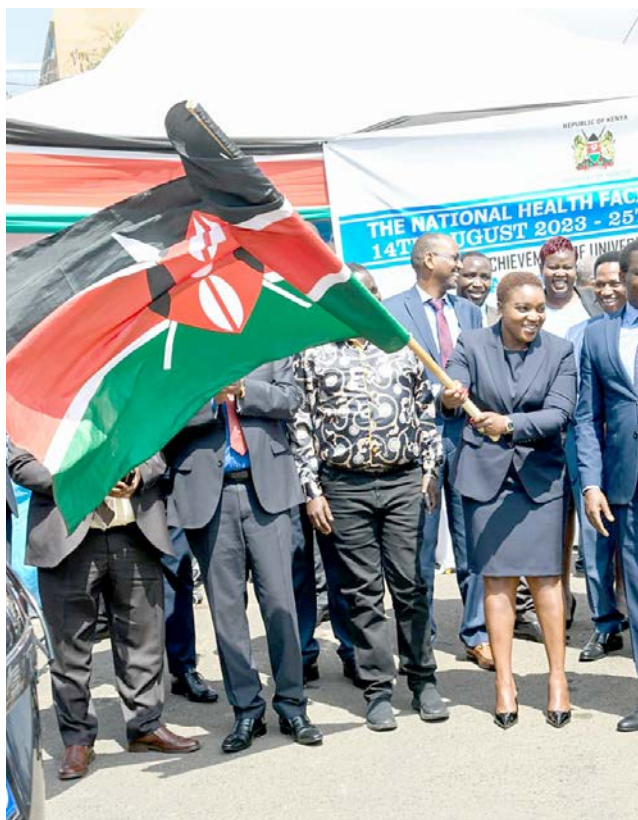

- "**Gross monthly salary**" constitutes basic salary and regular cash allowances such as housing, travel/commuter allowances and similar cash payments but excludes non-cash allowances and allowances that are not paid regularly such as leave allowance, bonus, gratuity, pension, severance pay or any other terminal dues and benefits.
- All employees irrespective of their contract of service shall pay the Affordable Housing Levy.
- Employees paying Affordable Housing Levy under Section 31B of the Employment Act, 2007 are not eligible for Affordable Housing Relief under Section 30A of the Income Tax Act Cap. 470.

Further to the Public Notice dated 3rd August, 2023 by the Ministry of Lands, Public Works, Housing and Urban Development appointing the Kenya Revenue Authority (KRA) as the collecting agent for the Affordable Housing Levy and KRA's Public Notice dated 4th August, 2023 on collection of the levy, KRA wishes to make the following clarifications to employees, employers and the public, with respect to Affordable Housing Levy, -

- "Gross monthly salary" constitutes basic salary and regular cash allowances such as housing, travel/commuter allowances and similar cash payments but excludes non-cash allowances and allowances that are not paid regularly such as leave allowance, bonus, gratuity, pension, severance pay or any other terminal dues and benefits.
- All employees irrespective of their contract of service shall pay the Affordable Housing Levy.
- Employees paying Affordable Housing Levy under Section 31B of the Employment Act, 2007 are not eligible for Affordable Housing Relief under Section 30A of the Income Tax Act Cap. 470.

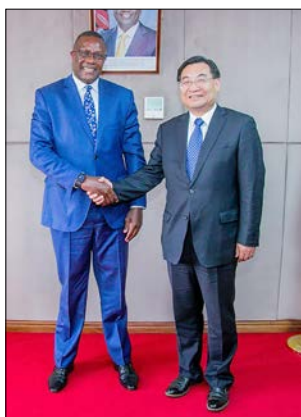

Ununuzi wa vifaa na kuboresha ni sehemu ya mipango ya KPA katika ushindani wa bandari kikanda. Kuwasili kwa STs hizi nne kunafuatia kustaafishwa kwa vifaa vya

awali, ambavyo vilikuwa vikitumikia bandari kwa miaka kumi na tisa iliyopita.

Bandari ya Mombasa kwa sasa ina jumla ya STs 16, magari 25 ya kubeba mizigo, na yanatarajiwa kupata magari mengine manne ya

kubeba mizigo na floti ya magari 27 ya kushughulikia makontena yasiyokuwa na mizigo inatarajiwa kununuliwa.

Mkurugenzi Mtendaji wa KPA, Kapteni William Ruto, alisema kuwa vifaa vya kisasa vitakavyotumika mara mbili vitazidisha ufanisi wa bandari na kupunguza muda wa kazi wa meli kwenye bandari kwa karibu asilimia 40.

Mshauri Mkuu wa Kiufundi wa UNDP nchini Kenya, Bw Roly Davila, alisema baadhi ya vipengele muhimu vya ushirikiano huo vimo katika nyanja ya kitambulisho cha kidijitali kama ilivyoinishwa katika MoU.

Alieleza kwa kina kwamba, MoU imeundwa katika nguzo tatu, ambazo ni: ushauri wa kiufundi na msaada wa uendeshaji, utekelezaji wa miradi na uhamasishaji wa rasilimali na ushirikiano.

“Rejista ya Kitaifa ya Kitambulisho cha Kiraia na vipengele vyake vyote ni kitu ambacho tumekuwa tukipigania kwa ushirikiano na washirika wa maendeleo kadhaa na sekta binafsi, na hii ni kitu ambacho nchi inaweza kunufaika sana nacho,” Bw Davila alisema.

Alisema UNDP imesaidia zaidi ya nchi 25 katika safari ya kitambulisho cha kidijitali.

Bw Bitok alisema serikali inafurahi sana kushirikiana na UNDP kwa kunufaika na uzoefu na ushauri wa kiufundi ili kufanikisha mradi huu wa kibinafsi.

Waziri wa Kilimo na Ustawi wa Mifugo, Mithika Linturi, amehakikishia wakulima katika Uasin Gishu kuwa, Serikali imetenga fedha kwa ajili ya kununua mahindi kupitia Bodi ya Taifa ya Nafaka na Mazao (NCPB) msimu huu.

Akizungumza Eldoret wakati wa ziara ya mashamba ya mahindi katika Kata ya Kiplombe katika Kaunti ya Uasin Gishu, Linturi ambaye alikuwa ameamana na Katibu Mkuu Kello Harsama (Maendeleo ya Mazao), na Jonathan Mueke (Mifugo), alitangaza pia kwamba Serikali imepata mashine za kukausha nafaka 100 ambazo zitasaidia wakulima kukausha nafaka zao.

Linturi alisema mashine hizo za kukausha zitasaidia wakulima kupunguza hasara baada ya mavuno kwa kuhakikisha mahindi yao yanakauka na kuhifadhiwa vizuri.

“Mashine za kukausha nafaka zitawezesha wakulima kuhifadhi ubora wa mahindi yao na kuongeza kipato chao. Hii ni maendeleo makubwa kwani hasara baada ya ma-

vuno imekuwa changamoto kubwa kwa wakulima hapo awali,” aliongeza.

Linturi pia alihakikishia wakulima kuwa Serikali itaendelea kuwasaidia kwa kutoa rasilimali, mafunzo, na fursa za kufikia masoko.

Wakulima katika eneo hilo walipokea kwa furaha uamuzi wa Serikali kuweka akiba ya fedha kununua mahindi yao, wakisema itawapa soko la uhakika kwa mazao yao.

Alisisitiza umuhimu wa kushirikisha vijana katika kilimo akisema kuwa kilimo kinatoa fursa nyingi kwa vijana kuunda utajiri na kuchangia katika maendeleo ya nchi.

Mwenyekiti wa Kamati ya Kilimo wa Kaunti ya Uasin Gishu, Edward Sawe, alipongeza hatua ya Serikali kuweka akiba ya fedha kwa ajili ya kununua mahindi na ununuzi wa mashine za kukausha nafaka akisema itasaidia si tu wakulima kifedha bali pia itawachochea kuendelea kuwekeza katika kilimo cha mahindi.

Na Kiptanui Cheroni (KNA)
