Shirikisho la Soka Ulimwenguni FIFA limezindua mpango wa Soka kwa Shule (F4S), unaonuiwa kuzinufaisha shule za msingi za Kenya.

Mpango huo, ambao ni mpango wa pamoja na Shirika la Umoja wa Mataifa la Elimu, Sayansi na Utamaduni (UNESCO) ulizinduliwa Kakamega mnamo Julai 30, 2023.

Kupitia mpango huo, FIFA inalenga kunufaisha zaidi ya watoto milioni 700, wawulana na wasichana kote ulimwenguni.

Mpango huu umeundwa ili kukuza talanta za masha na umahiri unaolengwa kupitia soka na kuchangia Malengo ya Maendeleo Endelevu ya Umoja wa Mataifa (SDGs) na vipaumbele vingine.

National feed strategy aims to boost livestock resilience and productivity

BY ERASTUS GICHOHI (KNA)

The Government needs to marshal more than Sh. 460 billion within the next 10 years to implement the National Feed Strategy that seeks to address a livestock feed deficit of 33 million metric tonnes every year.

The strategy will address the shortage through the promotion of 14 animal feed value chains which have energy-rich sources, adequate minerals, and vitamin concentrates.

This comes after it emerged that Kenya has lost 2.5 million livestock in the last two years following a prolonged drought that also led to starvation of animals for lack of quality feed.

According to Stanley Mutua, the Head of Animal Feeds and Nutrition Services at the Ministry of Agriculture, Kenya requires 55 million metric tonnes of animal feed annually but produces 40 per cent leaving a huge supply gap of 33 million metric tonnes every year.

"The current animal feed deficit stands at 33 million metric tons and the government requires to inject Sh460 billion in the next 10 years to address the shortage by implementing the National Feeds Strategy," said Dr. Mutua.

He said the Government, in collaboration with other non-state actors, will support investments in five key value chains to address the

gap including pasture, sorghum, sunflower, cotton, and maize silage.

Speaking in Naivasha during the African Union-backed Resilience African Feed and Fodder Systems project, Dr. Mutua said the government has instituted technical, policy actions, and institutional interventions to support and upscale the production of feeds for livestock which

millions of Kenyans depend on for a living.

The head of the animal feeds docket said the government's national feed strategy will help to address animal feeds and water shortage for livestock, feed quality, costs, and weak policies and strengthen feed data and information systems to inform better and timely interventions.

In addition, Dr. Mutua said the national government is already implementing various projects for fodder commercialization in the counties to help cushion farmers and other actors in the livestock value chain from adverse effects of climate change such as pro-

longed droughts, and other global crises such as the ongoing Russia-Ukraine war.

Dr. Christopher Wanga, the Director of Livestock Policy Research and Regulations at the Agriculture Ministry said animal feeds take up to 70 per cent of all inputs required by farmers with the high costs driving the use of low-quality feeds, leading to low productivity.

"Some 2.5 million livestock have died in the last two years as a result of drought and subsequent starvation as farmers lacked timely, cost-friendly, and quality animal feeds. This resulted in loss of livelihoods to millions of families," said Dr. Wanga.

Dr. Wanga said the livestock sector contributes 50 per cent to the total agricultural sector's Gross Domestic Product (GDP), and there's a need to undertake informed research and policy decisions to support the sector by addressing the current deficit of quality feeds.

The Director said the government is working on a livestock masterplan to build resilience, strengthen research capacity and upscale viable and innovative approaches to cushion the sector from external shocks.

The masterplan also aims at ensuring production of quality livestock products such as meat, milk, and eggs that meet the nutrition demands of the citizens.

LVBC ndiyo taasisi pekee ya EAC yenye makao makuu nchini Kenya na afisi zaz pekee wa kidiplomasia nchini nje ya Nairobi.

Jengo hilo ambalo linajengwa katika mwambao na Ziwa Victoria, linatarajiwa kusaidia katika uratibu mzuri wa huduma za shirika hilo.

Naibu Mbunifu Mkuu wa Idara ya Serikali ya Utumishi wa Umma David Waititu alieleza matumaini kuwa mradi huo, ambao umechukua muda mrefu kukamilika, utatekelezwa ndani ya muda uliowekwa.

Wanasayansi kutoka Shirika la Utafiti wa Kilimo na Mifugo la Kenya (KALRO) wameunda Mfumo wa Kudhibiti Wadudu (IPM) ili kudhibiti viwavi jeshi nchini.

Mdudu huyo analeta changamoto kubwa kwa uchumi, mazingira na utoshelevu wa chakula nchini kwa kusababisha uharibifu wa mazao, hasara na hivyo kuongeza kutegemea bidhaa kutoka nje ili kupunguza mahitaji ya ndani.

Hata hivyo, kutokana na hatua za Serikali, wakulima wamepeleka mafunzo na mashirika husika ya kilimo kama KALRO kuhusu mbinu za hivi za kudhibiti kuenea kwa viwavi jeshi.

Watafiti kutoka KALRO wanasema kupitia hatua mbalimbali chini ya IPM, wakulima wanaweza kupata taarifa kutoka kwa data za ufuatiliaji kuhusu mienendo ya uvamizi baada ya kupata mafunzo.

Wakiongozwa na Dk. Muuo Kasina, mtaalamu wa wadudu kutoka KALRO, watafiti wanasema, dhana ya IPM ni mbinu ya jumla inayotegemea mchanganyiko wa mikakati mbalimbali ya kudhibiti wadudu, ikiwa ni pamoja na mbinu za kibayolojia, kitamaduni, kimwili na kemikali na ni endelevu zaidi na inatunza mazingira ikil-

“Mpango huu ulianza na ukaguzi, kutunza mimea na kutumia mbinu za bayolojia-Kasina

tangu 2017 wakati uvamizi mkubwa wa kwanza ulipori-potiwa katika mashamba ya mahindi.

“Tishio la uvamizi wa viwavi jeshi limesababisha wakulima kulima mahindi yenye kemikali nyingi ili kuepusha mashambulizi kwani bila kuyatibu kunaweza kusababisha kuharibika kwa mazao kwa asilimia 100,” mwanasayansi

wa KALRO alise na.

Kasina alise na ili kukabiliana na changamoto ya utoshelevu wa chakula inayoletwa na mdudu huyo, wadau wa kilimo mwaka 2019, kupitia ushirikiano na Serikali ya Korea Kusini katika mpango uliopewa jina la KAFACI, kwa kushirikiana na Wanasayansi kutoka nchi 14 za Afrika, walianza mpango wa IPM ili kudhibiti tishio la wadudu hao.

“IPM inajumuisha ujuzi tofauti wa utunzaji wa mazao, kanuni bora za afya, na lishe kwa mmea na pia inazingatia ripoti za ufuatiliaji juu ya mwenendo wa uvamizi kupitia uchunguzi na ufuatiliaji wa kuenea kwa wadudu ili kutumia hatua za udhibiti,” alisema.

Alieleza kuwa mpango wa miaka mitano na utafiti ulioanzia 2020 hadi Desemba 2022 ulijaribiwa huko Machakos ambapo jaribio la IPM lilipata matokeo ya kuvutia.

“Mpango ulianza kwa utunzaji wa mazao, ufuatiliaji, na kuongezeka kwa udhibiti wa kibayolojia. Ingawa baadhi ya bidhaa za udhibiti wa kibayolojia dhidi ya wadudu hao zinaweza kusababisha magonjwa kwa wadudu, haina madhara kwa binadamu inapotumiwa mapema vya kutosha wakati kuna uwezekano mdogo wa kushambuliwa na wadudu,” alisema.

KWA UFUPI

Serikali kuinua kilimo biashara ili kukabiliana na ukosefu wa ajira

Serikali itaendelea kutekeleza sera na kanuni za kuwahimiza vijana kujiingiza katika kilimo biashara kama ajira rasmi mbadala. Hii ni kupitia kuanzishwa kwa ushirikiano wa kibinafsi na wama ambapo vijana wanahamasishwa kuchukua kilimo ambacho kina uwezo mkubwa wa kuunda ajira na kuchochea mageuzi ya kiuchumi ya nchi. Waziri la Vyama vya Ushirika na Maendeleo ya Biashara Ndogo na za Kati (MSMEs) Simon Chelugui alibainisha kuwa kutokana na wastani wa vijana milioni moja wa Kenya kujiunga na soko la ajira kila mwaka na uhaba wa nafasi za kazi, kilimo cha kisasa ndicho fursa itakayofuata.

Kutokana na kupanda kwa bei za vyakula, Bw Chelugui alitoa changamoto kwa vijana kujitosa katika sekta hiyo na kusaidia ujumuishaji wa mbinu za kisasa na endelevu zinazolenga kupunguza gharama za uzalishaji. “Vijana wengi ni wajuzi wa teknolojia. Ni wito kwao kutumia ujuzi wa kutatua changamoto katika sekta ya kilimo ili kuongeza uzalishaji na kuleta mapinduzi katika mfumo wa chakula duniani,” alisema.

Waziri alihimiza vya vya kiufundi, na vya vya kuanzisha kilimo biashara na vituo vya mafunzo ili kutoa jukwaa kwa wajasiriamali vijana kupata ujuzi wa kiufundi. “Ili kuhakikisha MSME zinazoongozwa na vijana hazichai nyuma katika mageuzi ya kiuchumi kutoka chini kwenda juu, kuna haja ya kukuza mazingira ya uvumbuzi kwa kuanzisha vituo vya utafiti na vitovu vya uvumbuzi vilivyowekwa kwa wajasiriamali vijana. Mkakati wa ujuzi wa sekta nzima unapaswa kuhakikisha uwiano wa msaada wa kiufundi na kujenga uwezo,” waziri alibainisha.

Akiashiria kuwa serikali imeanzisha mipango mbalimbali inayoweka mazingira wezeshi kwa vijana katika biashara ya kilimo, Bw Chelugui alisema mfumo wa elimu nchini Kenya unapaswa kuwahimiza vijana kufanya kilimo. “Tunapaswa kuacha kuwafundisha vijana wetu nadharia na badala yake tujikite katika vitendo na tafti ambazo zinaweza kutekelezwa kika-milifu na kwa urahisi,” waziri alisema.

Wakulima wa ngano nchini wamepata mavuno mengi sana na serikali inatarajia zaidi ya magunia milioni 1.2 kutoka kote nchini. Katibu wa Idara ya Ukuzaji Mazao Kello Harsama alisema serikali imepanga bei ya kununua ngano kuwa Sh5, 200 kwa gunia ya ngano gredi ya kwanza na Sh5,100 kwa ya pili. Akizungumza wakati wa hafla wa wanahabari ya uzinduzi wa Mkutano wa Afrika wa Teknolojia ya Kilimo (ACAT), katibu alisema chini ya mpango ambao ulikubaliwa kati ya Wizara ya Fedha, Wizara ya Kilimo, Chama cha Wasagaji nafaka na wakulima wa ngano, Chama cha Wasagaji nafaka kinatakiwa kununua ngano yote nchini kabla ya kuruhusiwa kuagiza kutoka nje.

“Chini ya mpango huu, ushuru wa bidhaa kutoka nje ume-punguzwa kutoka asilimia 35 hadi 10 na wasagaji wa ndani wamekubali kwamba kwanza watanunua mavuno yote ndani na hivyo kutoa soko zuri kwa wakulima,” Harsama alisema. Alifafanua kuwa baada ya wasagaji hao kumaliza ngano ya ndani, wataruhusiwa

kuagiza magunia engine milioni mbili kutoka nchi nyingine ili kukidhi mahitaji ya ndani ya takriban magunia milioni tatu kwa mwaka.

“Yanayoendelea kati ya Urusi na Ukraine ambapo usafirishaji wa ngano kutoka Ukraine umesimamishwa yanatia wasiwasi kwa sababu tulikuwa tukipata karibu ngano kutoka Ukraine na wale wanaoagiza ngano wanapaswa kuhakikisha kwamba wanapata usambazaji endelevu wa ngano kutoka vyanzo mbadala,” Katibu alieleza. Harsama aliongeza kuwa pia wanatarajia mavuno mazuri ya mahindi ya takriban magunia milioni 44, ambayo yanatosha kulisha nchi.

“Pia tumeanza kupokea mahindi kutoka Tanzania na Uganda huku tukisubiri mahindi yetu kukomaa. Kutokana na usambazaji wa mahindi kutoka nchi jirani bei ya gunia la mahindi imepungua kutoka Sh6, 000 hadi Sh5, 000,” alisema. Harsama alisema kutokana na kupungua kwa bei ya mahindi, baadhi ya wasagaji wamepunguza bei ya unga kutoka Sh220 hadi Sh175. Na Joseph Ng'ang'a (KNA)

Benki ya Dunia yatenga Sh 105m kusimamia rasilimali za maji Nile

Benki ya Dunia imetenga Sh105 milioni kwa utekelezaji wa Mradi wa Ushirikiano wa Pamoja wa Usaidizi kwa Ustahimilivu wa Tabia nchi katika ukanda wa Nile. Utekelezaji huo utafanyika katika nchi zote saba wanachama wa Afrika Mashariki ambazo ni Kenya, Burundi, Rwanda, Tanzania, Uganda, Jamhuri ya Kidemokrasia ya Congo, na Sudan Kusini. Naibu Katibu Mtendaji wa Tume ya Bonde la Ziwa Victoria Mhandisi Colletta Ruhama alithibitisha kuwa benki hiyo tayari

imejitolea kuunga mkono mpango huo ambao lengo lake ni kuboresha mifumo ya ushirikiano katika usimamizi na maendeleo ya rasilimali za maji katika Bonde la Mto Nile.

Mhandisi Ruhama alisema kupitia ufadhili huo, tume itatekeleza ubora wa maji katika bonde dogo la Ziwa Victoria na kuwianisha sera na kuandaa mkakati na mpango kazi.

Alisema, “Tunashukuru msaada mkubwa wa Benki ya Dunia unaojiri wakati idadi kubwa ya watu wanaoishi ndani ya Bonde la Mto Nile wanakabiliwa na

matatizo makubwa. Ufadhili huu utasaidia sana kutatua changamoto zilizopo.”

Ruhama alisema shughuli hizo zitafanyika katika nchi zote saba za Maziwa ya Ikweta ya Nile na nchi wanachama wa Afrika Mashariki. Alisema lengo la jumla la shughuli hiyo litakuwa kuwianisha na kuimarisha sera za ubora wa maji katika nchi za mabonde hayo. Aidha, Mhandisi Ruhama alisema tume hiyo inajadiliana na Benki ya Dunia kuhusu masuala ya bahari na uwezo wa kutambua ubora wa maji na ufuatiliaji wa kiwango cha maji ya Ziwa. “Makatibu ku-

toka nchi saba wanachama wamejitolea kuhakikisha kwamba wanakusanya rasilimali ambazo zitasaidia katika utekelezaji mzuri wa miradi hii,” alisema. Bonde la Mto Nile limekuwa likikabiliwa na vitisho vikubwa miongoni mwao vikiwemo ukataji miti, malisho ya mifugo kupita kiasi, na mmomonyoko wa udongo kutokana na kanuni duni za kilimo ndani ya vyanzo vya ziwa.

Uendelevu wa upatikanaji wa maji pia umebainishwa kuwa changamoto kubwa inayoathiri watu wanaoishi ndani ya bonde hilo.
