NOTICE TO IMPORTERS OF USED / SECONDHAND MOTOR VEHICLES

Kenya Bureau of Standards (KEBS) is a statutory body established under the Standards Act, Cap. 496, Laws of Kenya. KEBS is mandated to offer among other services, quality inspection of imports based on Kenya Standards or approved specifications.

Pursuant to the provision of KS 1515:2000 - Kenya Standard Code of Practice for Inspection of Road Vehicles, and Legal Notice No.78 of 28th April 2020 - The Verification of Conformity to Kenya Standards of Imports Order, we wish to notify all importers of used / second-hand motor vehicles including returning residents, diplomatic staff and the general public that in observance of clause 2.5 of KS 1515:2000 on the eight (8) year age limit requirement, only Right Hand Drive (RHD) motor vehicles whose Year of First Registration is from 1st January 2017 and later shall be allowed into the country effective 1st January 2024.

Vehicles exported to Kenya shall be expected to comply with KS 1515:2000 – Kenya Code of Practice for Inspection of Road Vehicles while vehicles from countries where KEBS has an inspection agency (i.e. Japan, United Arab Emirates, United Kingdom, Thailand, Singapore, and South Africa) shall be accompanied with a Certificate of Roadworthiness (CoR) issued by Quality Inspection Services Inc. Japan (QISJ) which is an inspection company contracted by KEBS.

Further, the Certificates of Roadworthiness for vehicles whose year of first registration is 2016 will not be valid after 31st December 2023. All vehicles issued with such certificates must arrive at the Port of Destination / Entry by 31st December 2023. Any vehicle registered in 2016 or earlier, arriving after 31st December 2023 will be deemed not compliant with KS 1515:2000 and shall be rejected at the importer's expense.

Bi Masha alibainisha kuwa, Kaunti ya Meru, yenye wakazi takriban 1,775,511, ndio inayotia wasiwasu hasa.

Kufikia 2023, kaunti hiyo ina watu 30,912 wanaoshi na HIV na kiwango cha maambukizi cha asilimia 2.4. 'Tishio Tatu' katika Kaunti ya Meru linahusisha maambukizi mapya ya HIV, mimba za utotoni, na unyanyasaji wa kingono na kijinsia miogoni mwa vijana na wanawake vi-jana wenye umri wa miaka 10 hadi 19. NSDCC imejitolea kushughulikia 'Tishio hili Tatu' kwa ushirikiano na mamlaka za mitaa, wataalamu wa afya na jamii kwa kutekeleza uingiliaji kati na sera zinazotegemea ushahidi.

IGAD yateua balozi wa kwanza kabisa wa vijana kwa uongozi shirikishi

Mamlaka ya Maendeleo ya Kiserikali (IGAD) imemteua mjambe wake wa kwanza wa vijana ili kuimarisha uju-muishaji wa vijana ndani ya shirika hilo.

Akizungumza katika kongamano la IGAD kuhusu uongozi 2023 mjini Mombasa, Dkt Workneh Gebeyehu, Katibu Mkuu wa shirika hilo, aliangazia kuwa vijana wanajumisha takriban 70% ya jumla ya wakazi wa eneo hilo.

Kwa kutambua umuhimu wao, IGAD imechukua hatua ya makusudi ya kuwashirikisha kikamilifu na kuwashirikisha vijana kama wadai muhimu katika masuala ya kanda.

"IGAD, kama shirika la kikamilifu, imejitolea kujenga uwezo wa watu wa kipekee kama vile vijana na wanawake katika ukanda wetu li kuwashirikisha katika masuala muhimu yanayohusu ukanda wetu, ikiwa ni pamoja na amani na usalama, mabadiliko ya hali ya hewa na masuala mengine muhimu," alisema Gabayehu.

Aidha alitangaza kuwa hivi

sasa IGAD iko katika mchakato wa kutunga sera ya vijana na amezitaka nchi wanachama kuharakisha mchakato huu. Mkurugenzi Mtendaji alisema hivyo, ofisi mpya ya mjambe wa vijana itakuwa na nafasi nzuri ya kueleza changamoto, mafanikio, na fursa zinazoe-nea kote kanda.

"Tunaweka kitaasisi masuala ya ushirikishwaji wa vijana, serikali za nchi wanachama na mashirika ya washirika wanapaswa kuchukua jukumu la kuongoza maslahi ya vijana kutumia uwezo wao kamili," aliongeza.

Wenyehiswa wa Kampuni ya Uzalishaji Umeme ya Kenya PLC (KenGen) watapokea mgao wa faida wa Sh2 bilioni kwa mwaka unaomalizika Juni 30, 2023, mojawapo ya ki-wango kikubwa zaidi ambacho kampuni melipa tangu Uuzaji wa Haki za 2016.

Hii inafuatia idhini iliyotolewa na wanahisa wa kampuni hii iliyoorodheshwa kwene NSE wakati wa Mkutano Mkuu wa 71 wa kila uliofanyika Nairobi, ikifungua njia kwa KenGen kulipa mgao wa kwanza na la mwisho la Sh0.3 kwa kila hisa, jumla ya Sh2 bilioni.

Malipo ya mgao yanatokena wakati kampuni ilipata faida ya baada ya kodi ya Sh5.2 bilioni, ikionyesha ukakamavu na utilivu wake wa kifedha kwa miaka. Akizungumza Nairobi wakati wa Mkutano Mkuu, Mwenyeiki wa Bodi ya KenGen, Julius Ogamba, alibainisha kuwa misingi imara ya biashara ya kampuni, utamaduni wa uvumbuzi, na mkakati thabiti wa upanuzi vimeendelea kufanya kampuni kuwa yenye faida, ikiongesha thamani kwa wanahisa wake mwaka baada ya mwaka.

"Matokeo yetu ya kifedha kwa mwaka yanachora picha ya ukuaji na uthabiti. Mapato yaliyongezeka kwa asilimia 14, kufikia Sh53.96 bilioni, kuonyesha afya na nguvu ya kifedha

ya kampuni," alisema Bwana Ogamba.

Mwenyeiki wa KenGen alien-delea kusema kuwa kampuni itaendelea kuendesa mifikati wake wa "Kutoka Mzuri Hadi Kubwa," ukilenga maendeleo ya jotoardhi na kukuza mapato. "Akitazama mbele, jithiada zetu za kuongeza uwezo wa uzalishaji kwa zaidi ya MW 154, hasa kutoka kwa miradi ya bomba la jotoardhi katika miaka miwili ijayo, zinaonyesha dhamira yetu ya kukidhi mahitaji yanayongezeka ya nishati safi nchini Kenya," Ogamba alisema.

Kwa upande wake, Mkurugenzi Mtendaji wa KenGen, na Afisa Mkuu Mtendaji Eng Peter Njenga, alisitisiza mae-neo ya kipaumbele ya kampuni kwa mwaka 2024, akisema itakuwa katika teknolojia mpya za kuzalisha umeme zaidi kwa kutumia mitambo ya umeme iliopo.

"Tunaendelea vizuri na midango mipy ya kuongeza uwezo wa uzalishaji kwa zaidi ya MW 154 katika miaka miwili ijayo kupitia urekebishi haji na kuboreshwa kwa mali zilizopo, kuonyesha dhamira yetu ya kukidhi mahitaji yanayongezeka ya nishati safi nchini Kenya," Eng. Njenga alisema.
