Shirika la Reli la Kenya (KRC) na Afristar, kampuni inayosimamia Reli ya Kisasa (SGR), zimepata ufanisi mkubwa kwa kusafirisha zaidi ya tani milioni 26.3 za mizigo kutoka nje kati ya Januari 2018 hadi Mei 2023.

Ufanisi huo, kulingana na taarifa kutoka kwa Shirika la Reli la Kenya na Afristar, inayosimamia SGR, linaonyesha jukumu muhimu lilofanywa na Reli ya Kisasa (SGR) katika kubadilisha usambazaji wa mizigo na kusaidia maendeleo ya kilimo nchini kote.

Ripoti ya Utendaji wa SGR ya Usafirishaji kutoka kwa KR na Afristar inafichua rekodi ya kuvutia, inayoonyesha usafirishaji usio na vizingiti wa mbolea iliyoagizwa kwa ruzuku kwa wakulima kote nchini.

Taarifa ya Afristar na KR inaongeza kuwa juhudi za pamoja za uuzaaji, ndani na katika masoko ya usafirishaji, zimedumishwa kuitia ushirikiano wa mara kwa mara na washikadu muhimu. Hasa, ziara



ya hivi majuzi ya maafisa kutoka Wizara ya Uchukuzi ya Uganda ilionyesha uunganishaji wa mizigo usio na vizingiti unaowezeshwa na mitandao ya reli ya SGR na MGR, na hivyo kuimariswa zaidi biashara ya kikanda. Ili kukabiliana na idadi inayoongezeka, ripoti hiyo inasema, KRC na Afristar zimeongeza matumizi ya mabehewa yote 1620 yaliyopo na kuhakikisha muda

wa na uhusiano wakimakati kati ya mitandao wa SGR na MGR umerahisisha uwasilishaji wa mizigo, haswa kuelekea Malaba-Kampala.

Hasa, taarifa inasema kuwa hatua hiyo muhimu iliafikiwa mnamo Julai 2021 wakati treni ndefu iliyuju-muiswa mabehewa 75 ilipozinduliwa, na kuongeza maradufu uwezo wa usafiri hadi tani 150.

Onguso alisema kuanzishwa kwa Apu ya wakulima ya KTDA, SMS na majukwaa ya USSD ni sehemu ya ajenda ya mageuzi ambayo yanalenga kutoa uwazi na uwajibikaji kwa kuwapa wakulima hali kamili ya hali ya akaunti zao.

Mkurugenzi huyo ali-bainisha kuwa utoaji wa mbinu mbalimbali utawahakikisha wakulima uwezo wa kufikia hali ya akaunti zao kwenye simu zao za mikononi. sisha mawasiliano ya moja kwa moja kati ya mkulima na kiwanda. 

World Vision and West Pokot County collaborate to protect children rights

West Pokot County has trained Children Protection Volunteers (CPVs) in a bid to protect children against any forms of violation.

This initiative has been taken due to the large number of children's rights violations that occur especially in remote areas within the county where locals are either unwilling to report or are less informed about children's rights.

The Department of Children's Services in collaboration with World Vision Kenya took the initiative to train and empower CPVs from every ward with a huge percentage being drawn from Kasei and Sigor Wards.

"We have trained 33 Children Protection Volunteers (CPVs) who are from all the 20 wards in West Pokot County and a good number from Kasei and Sigor on how to solve or channel child abuse cases," stated West Pokot Children's Officer Mr. Fredrick Nyatige.

Nyatige outlined that early marriages, Female Genital Mutilation (FGM), neglect, and school drop-outs are the many cases that mostly occur.

"Early marriages, neglect, FGM, and school dropout are the many cases occurring in the interior and we cannot trace them easily," said the Children's Officer.

He said children's rights violators in the border areas of West Pokot relocate to the neighbouring country of Uganda once they realise that the government wants to pursue them adding that many cases go unreported.

Nyatige appealed to the community to collaborate with the trained CPVs as they perform their duties to protect children against abuse.

"I am calling upon the community members to support the volunteers to help in ending children's rights violations in the region," he appealed.

He revealed that children offices have been opened at sub-counties of Alale

and Kacheliba respectively to cut short the long distances travelled when locals are seeking services at the county headquarters in Kapenguria.

"We have other new officers who have been deployed to North Pokot and Kacheliba Sub-Counties. Instead of the locals travelling to Kapenguria, they can get assistance at the Deputy County Commissioners' offices in Alale and Kacheliba respectively," Nyatige said.

He further urged the chiefs and their assistants to actively participate in the child protection campaign and also support the CPVs to unearth any child abuse cases in their areas.

The children's officer lauded World Vision among other partners, for sponsoring the training, noting that they have been at the forefront in supporting the marginalised communities.

Agnes Cheptoo, a beneficiary of the training thanked the government officers for the efforts they have put in to protect children.



Mradi huo amba ni wa kwanza kutekele-zwa nje ya Israel ulizinduliwa rasmi na Gavana Mutula Kilonzo Mdogo. Unafadiliwa na Hazina ya Kitaifa ya Kiyahudi-Amerika, Chuo Kikuu cha Arizona, na Taasisi ya Pamoja ya Chakula, Maji, Nishati na Usalama, Arava Valley ya Israel na serikali ya kaunti ya Makueni.

Ujenzi katika eneo hilo utakaokamilika miezi minne ijayo utaboresha kilimo, kutoa nishati na maji kwa shule na jamii inayouzunguka na kuongeza ufanisi wa matumizi ya ardhi.

Zaidi ya wakulima 300,000 katika kaunti 12 wamepata masoko katika mifumo ya thamani ya kilimo inayojumuisha ufunjaji wa ng'ombe wa maziwa na kilimo cha bustani kutoka kwa Mradi wa mifumo ya Soko la Mazao na Maziwa Kenya (KCDMS) ambao ni sehemu ya Shirika la Maendeleo la Kimataifa la Amerika (USAID).

Mradi wa Mifumo ya Soko la Mazao na Maziwa Kenya (KCDMS) umekuwa ukien-delea nchini kwa miaka mitano iliyopita na pia umewenza kufikia zaidi ya watoto 150,000 walio chini ya miaka miwili na walezi kwa usaizidi wa lishe.

mwaka jana, hajasaidia tu kupunguza umaskini kwa wakulima wadogo bali pia imeshughulikia uhaba wa chakula nchini.

"Kwa miaka mitano iliyopita tumekuwa tukishughulikia na mifumo tofauti ya thamani hasa ya parachichi, maembe, maziwa, ndizi,

karakara na pia shughuli zingine zote za uzalishaji ambazo zinafaidi wakulima katika eneo hili, hasa katika kaunti tisa kutoka eneo la Magharibi na tatu kutoka Mashariki mwa Kenya," alisema.

Serikali inaendelea na mikakati ya kuwawezesha wakazi wanaishi katika makazi yasiyo rasmi kuishi maisha endelevu na yenye heshima kuititia utoaji wa miundombinu ya usafi wa mazingira na majitaka.

Kulingana na Katibu wa Idara ya Serikali ya Nyumba na Maendeleo ya Miji Bw. Charles Hinga, watafiti wamegundua kwamba kadiri miji inavyokua na idadi ya watu kuongezeka, ndivo hatari inavyoongezeka pamoja na kuchipuka kwa makazi yasiyo rasmi.

Hinga, katika taarifa kwa MyGov alisema, inakadiria

kuwa zaidi ya theluthi mbili ya watu duniani wanatarajiwa kuishi katika mazingira ya mijini ifikapo mwaka 2050 huku sehemu kubwa ya ukuaji huu wa miji ikirajiwa katika miji inayoen-delea.

Katibu alibainisha kuwa kuititia Mradi wa Pili wa Uboreshaji wa Makazi yasiyo Rasmi ya Kenya (KISIP2) ambao ni mradi muhimu wa Serikali ya Kenya (GOK) unaotekelwa kwa ufa-dhili kutoka kwa Serikali, Benki ya Dunia na Agence Française de Development (AFD), wakazi wa makazi yasiyo rasmi watapewa fursa ya kuishi maisha ya heshima kuititia utoaji wa miundombinu ya msingi ya usafi wa

mazingira na barabara za kuyafikia.

Hinga alisema KISIP2 imengaziwa katika ajenda ya Serikali ya kuwezesha wakazi wa makazi yasiyo rasmi ndani ya kaunti zilizochaguliwa kunufaika kupata huduma za kimsingi na usalama wa umiliki wa ardhi na pia kuimarisha uwezo wa kitaasisi kwa uboreshaji wa makazi duni nchini Kenya.

"KISIP2 ambayo kwa sasa inasaidia takriban makazi 200 yasiyo rasmi katika kaunti 33 inalenga kuboresha makazi haya ili kuona maelfu ya wakazi wakinufaika kutohana na uboreshaji wa mtandao wa barabara, miji na usafi wa mazingira endelevu, mitaro ya kuon-

doa maji ya mvua na udhibiti wa taka, usalama na taa za barabarani na kuimarisha usalama wa umiliki kwa kumpanga, kupima na hatimaye kupata hatimiliki," ilisema katibu.

Mradi huo, Hinga alibainisha, utachangia pakubwa katika kutimiza Lengo la 11 la Malengo ya Maendeleo Endelevu ya Umoja wa Mataifa (SDGs) la miji na jamii endelevu kwa lengo la kuifanya miji kuwa jumuishi, salama, thabiti na endelevu.

Alisema mradi wa KISIP2 pia unatarajiwa kuchangia pakubwa katika kufikia malengo ya Ruwaza ya 2030 ya maendeleo na ajenda ya serikali ya makazi ya bei nafuu.

KWA UFUPI

KVDA yasambaza miche 50,000 ya miembere Tot

Mamlaka ya Ustawishaji wa Bonde la Kerio (KVDA), kwa ushirikiano na Serikali ya Kaunti ya Elgeyo Marakwet imeanzisha mradi wa kuimarisha ustawi wa kiuchumi na kuongeza misitu katika eneo hilo kwa kusambaza miche 50,000 ya miembere huko Tot, wadi ya Endo katika Kaunti Ndogo ya Marakwet Mashariki.

Mpango huu wa KVDA ni sehemu ya juhudi kubwa zaidi za kubadilisha Bonde la Kerio kutoka eneo liliokuwa likijulikana kama "Bonde la Kifo" hadi eneo la ufanisi.

Wakati wa zoezi la ugawaji, Katibu wa Idara ya Maeneo Kame, Nusu Kame na Maendeleo ya Kanda Dk Salim Dokota alisema mpango huu unalangana na agizo la rais la kuimaria misitu nchini kote.

Aidha Dokota alisema wizara imejitolea kupanda miti milioni 60 kupidia mamlaka za maendeleo za kanda katika kipindi cha miaka kumi ijayo.

Alibainisha kuwa wizara inaujua kuzidisha lengo lake la kila mwaka la miti milioni moja katika eneo la Kerio Valley, kwa kupanda miti milioni mbili kila mwaka.

"Zoezi hili ni endelevu na halitasa baada ya usambazaji mmoja." Dokota alisema na kusisitiza dhamira ya muda mrefu ya kuleta mabadiliko

katika bonde hilo. Alisitisiza zaidi uwezo wa kuleta mabadiliko wa Bonde la Kerio, ambalo kihistoria lime-julikana kama "Bonde la Kifo", akisema kuwa kwa mpango huu, eneo hilo litageuka "Bonde la Ufanisi."

Alibainisha kuwa kiini cha kuanzisha kiwanda cha maembe kaunti hilo kinatokana na uwezo wake wa kuwa kichocheo cha uchumi.

"Kwa kuwapatia wakazi wa eneo hilo chanzo endelevu cha mapato kupidia kilimo cha matunda, mpango huo unalenga kuzuia kushirikishwa katika shughuli zisizo halali kama vile migogoro ya silaha. Zaidi ya hayo, mradi huu umeweka kuchangia pakubwa katika kushughulikia masuala ya mabadiliko ya hali ya hewa katika kanda," Dakota alisema.

Gavana wa Elgeyo Marakwet Wisley Rotich alihakikisha juhudzi za utawala wake kukuza kilimo cha mazao ya biashara na maendeleo katika kaunti nzima. Mkurugenzi Mkuu wa KVDA Sammy Naporos alisema kwamba kwamba miche 750,000 ya miembere ilisambawza kaunti za Sambaru, Elgeyo Marakwet, Baringo na Laikipia katika mwaka wa kifedha uliopita.

Na Rennish Okong'o (KNA)

Serikali yatafuta ushirikiano ili kukuza uchumi baharini

Serikali inaendelea ushirikiano wa kimkakati na mataifa mengine yaliyoendelea katika bahari ili kusaidia kukuza Sekta ya Uchumi wa Baharini nchini ambayo kwa sasa haitumiki kikamilifu.

Akizungumza mjini London, Uingereza, Waziri la Madini, Uchumi wa Baharini na Masuala ya Bahari Bw Salim Mvurya alisema uchumi wa baharini wa Kenya uko chini ya unavyofaa kutumika, na hivyo kuna haja ya kushirikiana na makampuni ya kimataifa ya kuzalisha umeme wa baharini ili kukuza sekta hii ambayo ina uwezo mkubwa wa kuongeza Pato la Taifa (GDP).

Wakati wa mikutano na wawakilishi wa serikali ya Korea Kusini na serikali ya Bahamas, Mvurya na maafisa wa Korea na Bahamas walijidali na kukubaliana juu ya kimkakati ya nchi mbili ikilenga zaidi ushirikiano uliomarishwa katika sekta wa bahari kati ya nchi zao.

Katika mikutano wake na Balooz wa Bahamas Bw Paul Rolle ambae pia ni Mwakilishi wa Kudumu wa Shirika la Kimataifa la Usafiri wa Baharini (IMO), Balooz huyo alikubali kutoa

mafuzo ya safari za baharini kwa makadeti wa Kenya na kutoa fursa za ajira kwa mabaharia wa Kenya katika meli zake za mizigo na meli.

Kwa upande wake, Korea itatia saini makubaliano na Kenya ambayo mionganini mwa mengine yatafungua nija ya kutambua vyeti vya umahiri wa mabaharia kutoka mataifa yote mawili, jambo ambalo litarhisisha uajiri wa mabaharia wa Kenya wanaohitimu kutoka Chuo cha Bandari na kupata fursa katika kampuni za meli za Korea. Makubaliano hayo pia yatawahakikisha makadeti muda wa mafuzo ya baharini katika meli za Korea.

Waziri huyo pia aliwataka wawakezaji wa Korea kujitosa katika sekta ya meli na uvuvi nchini Kenya ambayo alisema kwamba imesalia bila kutumika kikamilifu.

Mvurya aliandamana na Katibu wa Masuala ya Meli na Usafiri wa Baharini Bw Shadrack Mwadime, Mwenyekiti wa Mamlaka ya Usafiri wa Majini nchini Kenya Hamisi Mwaguya na Kaimu Mkurugenzi Mkuu John Omingo.
