


Afisa Mkuu wa KeNIA Dkt Tonny Omwansa, alisema katika hotuba iliyosomwa kwa niaba yake na Bw George Masil kwamba uunganishaji kupitia nafasi za uwekezaji, ushirikiano na ujenzi wa uwezo utaharakisha mchakato wa vijana kufanya biashara tal-anta zao.

"Jukwaa la KIB linalenga ku-jaza pengo la ujuzi miongoni mwa wavumbuzi kuititia ujenzi wa uwezo ambaa utatolewa na vituo, vyuo viku na wadau wengine," alisema Omwansa.

Wakati huo huo, alisisitiza kuwa KIB itamaliza pengo la uju-muishi kwa kuhakikisha kwamba wavumbuzi kote nchini watapata fedha, ushirikiano na wateja wa ubunifi wao.

"Tulianzisha jukwaa hili ku-tatua shida za watu ambaa ha-wana washirika wanaoweza kufikia, lakini wanaweza kupata soko la dijitali kuungana na wa-shirika kadhaa kama vile serikali za kaunti," alisema Omwansa.

tuo vyote 260 vya kuwezesha vijana (YECS) kote nchini kuwa Vituo vya Ubunifi. Shirika hilo, kwa ushirikiano na wadau wen-gine litaanzisha mipango na shuguli za kujenga uwezo katika vituo hivyo ili kuvutia vijana.

"KeNIA kwa ushirikiano na Wizara ya Masuala ya Vi-jana, Sanaa na Michezo inata-kuhakikisha wavumbuzi kutoka maeneo yote nchini wa-nafahamika kuititia jukwaa hili," alkiongeza. Mchakato huo ulian-

zishwa mwaka wa 2020 na katika hatua za mwanzo, ulivutia wa-shiriki kutoka kaunti 20.

Shirika hilo limejitolea kupanua matumizi ya KIB kote nchini na ni kwa muktadha huu ambapo timu ilifanya uzinduzi Nakuru kwa eneo la

Rift Valley na Kisumu kwa maeneo ya Ziwa na Magharibi.

Watakuwa wakielekea Mom-basa kwa uzinduzi wa eneo la Pwani na kumalizia Nairobi wiki zizajo.

Sehemu hizi ni uimarishaji wa utoaji wa huduma; vi-wango vya juu vya maadili ya utaalamu; usimamizi mzuri, uwazi na uwajibikaji; usi-mamizi wa utendaji; ugavi sawa wa nafasi na rasilmali; Ushirikishi wa umma katika uundaji wa sera; na matumizi bora ya rasilmali na maende-leo endeleu.

Kiwango cha jumula cha uafikiaji kilikuwa asilimia 41.7, kikiwa kimeimarika kwa asilimia 1.7 kutoka mwaka wa kifedha uliotangulia, ku-maanisha kwamba utumi-shi wa umma umeendelea kuimarika katika kunyoo-sha maadili na kanuni katika utoaji wa huduma.

Matokeo yanaonyesha kuwa ingawa utumishi wa umma unatoa huduma kwa raia katika maeneo mengi, kuna haja ya kuzingatiwa kikamilifu maadili na kanuni za kitaifa

za utawala katika Ibara 10; na maadili na kanuni za utumishi wa umma katika Ibara 232.

Mnamo Desemba 31 2022, PSC iliwasilisha ripoti kwa Rais na Bunge inavyohitajika kisheria.

Vile vile, Tume ilitoa ripoti ya utafiti huo kuititia semina kwa njia ya video kwa wakuu wa wafanyakazi wa taasisi zi-lizotathminiwa katika sekta sita za utoaji wa huduma.

Sekta hizo ni pamoja na Tume za Kikatiba na Afisi Huru (CCIOs), Wizara na Idara za Serikali (MDAs), Vyuo Vi-kuu vya Umma, Mashirika ya Serikali na Mashirika men-gine ya serikali yaliyo na kiwango fulani cha uhuru, Tume za Kisheria na Mam-laka na Taasisi za Kiufundi na Mafunzo Anuai (TVETs).

Katika semina hizo, Mwe-nyekiti wa Tume ya Utumishi wa Umma, Balozi Anthony Muchiri alihimiza taasisi hizo kuhakikisha zimefuata maadili na kanuni za utumishi wa umma inavyoleta Katiba.

Familia 64,000 katika mji wa Maralal kaunti ya Samburu na vitongoji vyake hivi karibuni watapata maji safi na salama huku bwawa la Yamo lilikaribia kukamilika.

Awamu ya kwanza ya Bwawa la Yamo, lili na uwezo wa kuhifadhi lita 12 milioni za maji imekamilika na bwawa hilo linaweza kujaa katika misimu miwili ya mvua ya kawaida inayonesha katika kaunti hiyo kila mwaka.

Mradi huo, unaotekelizwa na Shirika la Maendeleo ya Maji la Kaskazini kwa gharama ya Sh1.4 bilioni unatarajiwa kuhudumia mji huo kwa wakati huu hadi mwaka wa 2038 ambapo wataalamu wanasesma vyanzo vipyta vya maji vitatambuliwa.,

Akizungumza wakati wa ziara katika mradi huo, Katibu wa Maji na Unyonyuzaji Dkt Kiprono Rono alisema bwawa hilo linaweza kutoa lita 6 milioni kwa siku am-

bayo yanakidhi mahitaji ya wakazi wa mji wa Maralal.

"Kazi ya ujenzi wa awamu ya kwanza ya bwawa imekamilika na awamu ya pili itahusu ujenzi wa kiwanda cha kuwekea maji dawa kitakachohitaji Sh1.5 bilioni ambazo serikali itatenga katika bajeti ijayo ili mradi huu uwewe kukamilika," alisema Kiprono.

"Pamoja na serikali ya kaunti, pia tutatambia miradi mingine ya maji katika kaunti na kupatia kipaumbe ili itengewe pesa katika bajeti miaka ijayo," akaongeza.

Katibu huyo alihakikishia nchi kwamba serikali imeweka mipango ya kuhifadhi maji kwa kujenga mabwawa makubwa 100,

kujenga mabwawa madogo na kuchimba visima nchini.

"Kutoka kwa idara ya utabiri wa hewa, kuna ishara kwamba mvua hii haitanyesha kwa muda mrefu, na kama serikali, tumeweka hatua za kuhakikisha tume-hifadhi maji kwa matumizi hasa msimu wa kiangazi,' alisema katibu.

Gavana wa Samburu Jonathan Leleliit kwa upande wake alisema changamoto kuu ya kupata maji safi ya kunywa ni kupata chanzo cha maji safi ambayo inaweza kupelekwa kwa mifereji kwa wakazi.

"Tunashukuru serikali kwa kuchagua kufanya maadhimisho ya siku ya maji ulimwenguni hapa. Kumekuwa na changamoto za maji katika kaunti hii na tunatarajia kwamba siku hii italeta siku njema zijazo kwa watu wa Samburu kupata maji safi," alisema Leleliit.

Mbunge wa Samburu Magharibi Naisula Lesuuda alifichua kuwa chini ya asilimia tano ya wakazi wa kaunti ya Samburu wana maji safi na salama na kwamba mengi yanapaswa kufanya kui-marisha hali.

Lesuuda aliomba wizara ya maji kutumia muundo wa kuunganisha stima kuhakikisha kila boma limeunganishwa maji.

Homa Bay, NGO zatia mkataba kujenga chuo cha michezo

Homa Bay hivi karibuni itakuwa mwenyeji wa soka baada ya Serikali ya Kaunti kutia saini na Shirika lisilo la kiserikali (NGO) Acakoro Football Academy kuanzisha chuo cha kukuza michezo eneo hilo.

Ushirikiano huu utafanikisha ujenzi wa chuo cha kisasa cha michezo na taasisi katika wadi ya Kanyamwa-Kosewe, kaunti ndogo ya Ndhiwa itakayonufaisha watoto wenye umri wa chini ya miaka 14. Chuo hicho cha kwanza kitajengwa katika ardhi ya ekari 20 iliyotolewa na serikali ya kaunti na kufadhiliwa na shirika hilo lisilo la kiserikali kwa gharama ya dola za Amerika 3.5 milioni.

Akizungumza baada ya kutia saini Mkataba wa Maelewano (MOU) na Meneja Mkuu wa Acakoro Bw. Lucas Mott, Gavana Gladys Wanga alisema kwamba mkataba huo uneleza ushirikiano wa muda mrefu wa kukuza

vipawa vya eneo hilo. "Mradi huu utafungua Homa Bay kwa nafasi za kuandaa hafla kubwa za michezo. Tuko na furaha mionganoni mwa kaunti 47, Acakoro, kwa usaidizi wa watu wa Austria imechagua Homa Bay kuanzisha chuo hiki," alisema Wanga.

Acakoro iliyoanzishwa 2013 kupitia ushirikiano wa Kenyan na Austria, Acakoro imekuwa chuo kikuu cha soka Kenya kinachotoa elimu bora pamoa na shughuli za michezo.

Kitakapoanzishwa, chuo hicho, kitatoa mafunzo ya michezo na elimu kwa watoto hadi Chuo Kikuu.

"Ushirikiano huu ni wa kipekee kwa kuwa Acakoro haitajenga chuo pekee lakini pia taasisi ya masomo kusaidia watoto kusoma na pia kushiriki michezo," alisema Wanga.

Katika kituo cha mafunzo, chuo hicho kitakuwa na viwanja viwili vya soka katika awamu yake ya kwanza.

- Set the "**Mode of Amendment**" to Online and click the next button;
- Check the box marked "**PIN**" and then select the sections you would like to update; and
- Update the details as appropriate, attach supporting documentation where necessary and submit.

Devolution Principal Secretary Ms Teresia Mbaika has expressed the State Department's commitment to a people-driven and deliberately inclusive participatory process where citizen participation is at the core of policy and strategy development, selection and implementation of projects and programs.

Speaking during a Familiarization Retreat for Agencies and Departments under the purview of the National

Assembly Departmental Committee on Regional Development in Naivasha, Ms Mbaika noted that the meaningful participation of the people in decision making processes at both levels of government has gone a long way in enhancing service delivery to the citizens in the country.

The PS noted that Kenya's "Constitutional dispensation places sacred premium to public participation, consultation and cooperation", add-

ing that "the Devolved System of Government is anchored on this principle of consultation, cooperation and co-ordination".

Ms Mbaika reiterated that the State Department has been in the forefront in providing the necessary policy and administrative environment for Devolution to flourish in the country.

She also emphasized that devolution is working for Kenyans despite serious challenges that have been ex-

perienced and documented "including attempts at clawing back to centralization and re-centralizing at county headquarters".

The PS, however, stated that the State Department is alive to such challenges and has put in place various mitigation measures adding that it shall continue to "provide policy leadership, facilitation and coordination through continuous and sustained stakeholder consultation, collaboration and cooperation".

She urged the Departmental Committee on Regional Development to support the devolution sector in getting the necessary resources as the success of devolution requires huge resources for continuous civic education, structured capacity building initiatives, highly committed personnel, institutions and organizations.

The PS thanked the Departmental Committee for the existing cordial relations adding that to further enhance the relations between

the two, a Liaison Officer has been appointed so as to create a seamless link for timely consultations with the National Assembly and the Senate

Speaking during the meeting, the Chairperson of the Department Committee on Regional Development, Peter Lochakapong, said the familiarization retreat had been organized so as to create synergies between the Committee and the Agencies and Departments under its purview.

State to set up drought tolerant cashew nut in ASALs

Crops Development Principal Secretary Kello Harsama has directed the Kenya Agricultural and Livestock Organization (KALRO) to establish cashew nut nurseries in Arid and Semi-Arid Land (ASAL) counties for economic diversification.

Harsama launched four new varieties of cashew nuts that are drought and disease resistant, and only take one and half years to mature as opposed to the traditional varieties that take five years.

The new varieties expected to increase farmers' earnings due to their short maturity have been named Kkororo-sho75, Kkorosh081, Kkorosh082, and Kkorosh0100.

The PS termed the development of the varieties "a big breakthrough in the agriculture sector" since farmers plant, harvest, and sell within a short duration.

The PS encouraged farmers and leaders from ASAL counties to grow cashew nuts as an alternative source of income.

"I have directed KALRO to start nurseries in other parts of Kenya where there is drought in Marsabit, Wajir, Isiolo, Samburu, Turkana, Elgeyo Marakwet, and Baringo. I will solicit funds for KALRO to set up nurseries in the ASAL counties so that people in those areas can start benefiting from cashew nuts because the market is available abroad and in Kenya," Harsama said.

"It is a good opportunity for Kenyans who want to cultivate in arid areas. This crop does not require a lot of rain, and it is drought tolerant. People should take advantage and plant it in abundance to get profit," he added.



Bw Linturi alisema kwamba madepo ya nafaka ambayo mbolea iliopunguza bei imehifadhiwa kote nchini katika maeneo yanayozalishwa mahindi yatafunguliwa kuanzia saa kumi na mbili asubuhi hadi saa kumi na mbili jioni kutoka Jumatatu hadi Jumapili kuwezesha wakulima kote nchini kupata mbolea chini ya mpango wa ruzuku wa mbolea kwa bei ya Sh 3,500 kwa gunia ya kilo 50.

Naibu Gavana wa kaunti ya Kericho mhandisi Fred Kirui alisema mtandao wa Safaricom unaotumiwa na bodi ya taifa ya nafaka na mazao kuhudumia wakulima wakati mwininge huwa inafeli na wakulima waliopokea arafa hawawezi kuhudumiwa haraka inavyohitajika.
