

Chombo hiki kinalenga kuthathmini na kufuatilia utekelezaji, ustawu, na utendaji wa miradi ya maendeleo ya serikali kuu, programu za kupewa kipaumbele, maagizo ya rais, na takwimu za uhalifu nchini kupitia mfumo wa Maafisa wa Utawala wa Serikali Kuu (NGAOs).

Kulingana na Katibu wa Usalama wa Ndani Dkt. Raymond Omollo, chombo hiki kitahakikisha habari kuhusu miradi na programu za serikali ina sifa ya kuwa ya wakati na kuaminika.

Alisisitiza kwamba, kulingana na mamlaka ya NGAOs, makamishna wa kikanda na kaunti wanafanya kazi kama wenye kiti wa Kamati za Utekelezaji na Ushauri wa Maendeleo wa Serikali Kuu. Mradi BETA utawezesha tathmini ya miradi inayօendelea, kutathmini maendeleo, na kuchambua bajeti."



"Mradi huo utaweza kutathmini mgao wa fedha na matumizi halisi katika mikoa na kaunti mbalimbali.

"Mfumo huu una uwezo wa akili bandia na pia unawenza kuttathmini miradi iliyosuasua, kutoa maoni juu ya changamoto za utekelezaji," aliongeza Dkt. Omollo.

Vivyo hivyo, kama wenye kiti wa kamati za usalama na ujasusi katika viwango vya kikanda na kaunti, Dkt. Omollo alifichua kwamba takwimu za uhalifu katika viwango vyote zitachu-jwa kwenye dashibodi, hivyo kuifanya shughuli za jinai zilizofanyika katika saa iliyopita, masaa 24, wiki moja, au hata mwezi mmoja ziweze kupati-kana kwa urahisi na mara moja.

Dkt. Omollo alisema, "NGAOs, kama mwanzo wa mawasiliano ya serikali na wananchi wa kawaada, watatekeleza jukumu kubwa katika kubadilisha na kuboresha athari za uwekezaji huu uliolengwa. Uwezo huu wa kuripoti kidigitali na uwezo ulioimarishwa wa uangalizi vinatuleta karibu na NGAOs zenye ufanisi, zenye kuwajibika vyema zaidi, na kuwa na ufanisi mkubwa."

M k u r u g e n z i Mkoo na Afisa Mkoo Mtendaji wa KenGen, Mhandisi Peter Njenga, alieleza furaha yake ya kuongoza mradi wa BESS chini ya mpango wa GREEN, akiutaja kama hatua muhimu kwa sekta ya nishati ya Kenya.

Uzinduzi wa malipo yasivotumia pesa taslimu kwa huduma za shughuli za ardhi katika maeneo tofauti ya nchi umesadida sana katika ukusanyaji wa mapato katika Idara ya Ardhi na Mipango ya Miji.

Bw. Mohamed Ahmed Maalim, Katibu wa Idara ya Ardhi, alisisitiza kuwa vifaa vya kuweka rekodi za ardhi na mpango wa kujiendesha katika ukusanyaji wa mapato vimekuwa na athari kubwa katika kushughulikia masuala kama vile ugawaji mara mbili wa ardhi na ukusanyaji hafifu wa mapato.

Akiongea katika Ukumbi wa Nidhamia, Malindi wakati wa kikao cha madjiliano na umma kuhusu Mswada wa Marekebisho ya Sheria ya Ardhi (Amendment) wa 2023 na Mapitio ya Kanuni za Sekta ya Ardhi, Bw. Maalim alisema, "Katika miezi minne hadi mitano iliyopita, tangu tanzu ukusanyaji wa mapato usio na pesa, mapato

ni mara tatu ya kiasi tulichokuwa tunakusanya kabla ya kuweka mitambo ya kujiendesha katika vituo hivyo, maana yake tumeweza kuziba mapengo yaliyokuwepo. Kituo

Mafanikio haya katika ukusanyaji wa mapato yalikuwa ya kuvutia hasa katika vituo ambavyo mfumo wa malipo usio na pesa ulitekelezwa, ikiinyesha ufanisi wa juhudzi za idara hiyo za kusahilisha michakato yake.

Mkutano huo, uliohudhuriwa na wawakilishi kutoka kaunti sita za pwani - Mombasa, Kwale, Kilifi,

Tana River, Lamu, na Taita Taveta - ulifanikishwa na maafisa wa ngazi ya juu kutoka Idara ya Ardhi katika Wizara ya Ardhi, Ujenzi wa Umma, Nyumba, na Maendeleo ya Mijini.

Afisa huyo alisema wizara inatarajia kufanya rekodi zote za serikali nchi nzima kuwa za kisasa ili kufanya shughuli za ardhi ziwe rahihi, na kuwahimiza Wakanya kuumia huduma za e-citizen kama ilivyoagizwa na Rais William Ruto.

Bw. Maalim wakati huo huo alitetea ada mpya za shughuli za ardhi zilizopendekezwa, akibainisha kuwa ada za sasa hajjafanyiwa marekebisho kwa muda mrefu na haziwezi tena kuwezesha wizara kutoa huduma bora kutokana na hali ngumu ya kiuchumi.

"Mipango hii haikutolewa na Wizara ya Ardhi pekee. Hii ni matokeo ya mikutano ya mashauriano na wadau mbalimbali ambayo ilisababisha mswada na kanuni za rasimu na kwa kuwa ushiriki wa umma ni lazima, wananchi lazima wapitie sheria na kanuni zilizopendekezwa na kutupatia maoni yao," alisema.

Alisema Idara ya Ardhi ilikuwa imeweka sheria na kanuni zilizopendekezwa kwenye tovuti yake ili Wakanya waweze kuzisoma na kutoa maoni yao.

## EAC yatenga Sh1 B kushughulikia uchafuzi katika Ziwa Victoria

Jumuiya ya Afrika Mashariki (EAC) imeanzisha uwekezaji wa kihistoria wa Sh 1 bilioni kushughulikia tatizo la uchafuzi katika Ziwa Victoria kupitia mpango unaolenga usimamizi endelevu wa maji machafu kutoka kwenye ziwa hilo.

Mpango wa Usimamizi wa Rasilimali Maji Mchanganyiko (IWRMP), unaofadhiliwa na Jumuiya ya Ulaya (EU) na Serikali ya Ujerumanikupitia Benki ya Maendeleo ya KfW, inalenga kusaidia kuboresha maji, kushughulikia masuala ya ukosefu, na kukidhi mahitaji ya miundombinu katika maeneo ya kipato cha chini. Tume ya Bonde la Ziwa Victoria (IVBC) na washirika wake wanatekeleza IWRMP, inayotarajiwa kuanza 2023 na kuendelea hadi 2026.

Mhandisi Arsene Mukubwa, Mratibu wa IWRMP, alisisitiza kuwa, jamii zinazoishi karibu na bonde la ziwa nchini Kenya, Tanzania, na Uganda zi-

nastahili kupata huduma za maji safi, usafi, na usimamizi salama. Akiongea wakati wa maadhisho ya Siku ya Choo Duniani katika Kaunti ya Kisumu, Mhandisi Mukubwa alilalama akisema maji yanayoshirikishwa yamebeba maji machafu kutoka viwandani na makazi katika miji inayozunguka.

"Huko Kaunti ya Kisumu, zaidi ya asilimia 90 ya nyumba zimeunganishwa na maji. Kiteknolojia, unapotoa lita 100 za maji kwa nyumba, wanatumia tu asilimia 15 na asilimia 85 inageuzwa kuwa taka. Hii ni kiasi cha maji yasiyosafishwa kinachotolewa kwenye mazingira," alifanua.

Hatua hii inalenga kuanzisha teknolojia za usafi za ubunifu katika makazi yasiyo rasmi, na Manyatta A Estate ya Kisumu imepangwa kuwa uwekezaji wa kipaumbile katika miundombinu bora ya usafi. Hii, alisema Mukubwa, itasaidia kuppunguza pengo la upatikanaji duni wa mfumo wa maji taka mitaa duni.



Sehemu ya 4(a) ya Sheria ya Vyombo ya Sheria, 2013 inapendekeza kwamba "lengo la Sheria hii ni kutoa mfumo kamili kwa ajili ya kutengeneza, uchunguzi, uchapishaji na uendeshaji wa Vyombo ya Sheria kwa kuhitaji mamlaka za kutengeneza sheria kufanya mashauriano kabla ya kutengeneza Vyombo ya Sheria." Aidha, Sehemu ya 5(3) ya Sheria ya Vyombo ya Sheria, 2013 inapendekeza kwamba "bila kikwazo cha kumaanisha aina gani ya mashauriano yaliyotajwa katika sehemu ndogo (1) yanawenza kuchukua, mashauriano hayo yatakuwa -

- jumuisha arifa, moja kwa moja au kwa matangazo; kwa taasisi hiyo, au kwa mashirika yanayowakilisha watu wanaoweza kuathiriwa na chombo kilichopendekezwa; au
- Kuomba maoni yatilewe ifikapo tarehe iliyowekwa au inaweza kuomba ushiriki katika mikutano ya umma kuhusu chombo kilichopendekezwa.

Chuo Kikuu cha Ulinzi wa Kitaifa-Kenya kilichapishwa chini ya Sehemu ya 24 ya Sheria ya Vyuo Vikuu ya 2012 kama taasisi maalumi inayotoa dirigii na inajitolea katika masuala ya usalama wa kitaifa.

Lengo la mpango huu ni kuongeza tija ya mifugo wa kienyeji, hasa katika kuongeza uzalishaji wa maziwa.

Linturi alisema Kituo cha Rasilimali za Jeni za Wanyama nchini (KAGRC) kitachukua jukumu muhimu katika kutekeleza mpango huu kwa kutoa nyenzo na utaalamu muhimu wa kijeni. Pamoja na kuzingatia vinasaba vya mifugo, Waziri alisitiza dhamira ya serikali katika kuboresha uzalishaji wa kilimo kwa ujumla. Wakulima wanahimizwa kufuata mifugo ya hali ya juu ili kukidhi mahitaji yanayoongezeka ya mazao ya mifugo katika masoko ya kimataifa. Zaidi ya hayo, serikali imeanzisha vikaushio vinavyo hamishika imetajwa kuwa Sh70 kwa mfuko wa kilo 90. Mpango huu unanuiwa kuzuia hasara baada ya kuanya, hasa katika msimu wa mvua unaoendelea. Waziri alilenga kukamilisha maelezo na kutangaza bei iliyorekebishwa ya shahawa za ngono za mifugo kabla ya mwisho wa mwaka.

Mkakati wa jumla ni sehemu ya juhudzi za serikali kusaidia sekta ya kilimo na kuimarisha usalama wa chakula nchini. Waziri huyo pia alitangaza kuwa serikali inanunua mahindi kutoka kwa wakulima kwa gharama ya Sh4,000.

Alisema bei hizo ni za uhakika wa faida kwa wakulima ili kuwalinda wakulima dhidi ya umma Kenya na kimataifa. Alisema taasisi itendelea kutoa huduma za

wakulima kwa bei ya chini. Aliongeza kuwa serikali imejipanga kuhakikisha hakuna mkulima atakayenyonywa ndio maana serikali inatoa mbolea kwa bei nafuu. "Ni muhimu sana kama nchi tujikite katika kujikwamua na aibu ya kukosa tegemeo la chakula. Naona na nina uhakika tukiendelea kupaenda miti na kuchanganya miti ya asili na matunda, atakuwa ameua ndege wawili kwa jiwe moja," alisema.

Mkuu wa Chuo cha Ahiti Ndomba, Dk J.W. Macharia, alisema msaada zaidi kutoka kwa wataalamu wa mifugo umeingizwa katika soko la ajira, katika sekta binafsi na ya umma Kenya na kimataifa. Alisema taasisi itendelea kutoa huduma za

kiufundi na mifugo ili kundeleta ongezeko la uzalishaji, tija, usalama na ubunifu wa usalama katika masuala ya bidhaa. Aliwashauri wahitimutumia kikamilifu kile ambacho wamewekeza kwa na kuitumia vizuri. "Kuza sekta hiyo, lakini pia utengeneze ajira kwa Wakanya wengine. Jitahidi kila

mara kutoa huduma ya ku-jitolea kwa sekta ya mifugo. Acha kazi yako izingumze kwa niaba yako na iwe fahari yako," alisema. Seneta wa Kirinyaga Kamau Murango, mwenyekiti wa Kamati ya Kilimo katika Seneti ambaye alian-damana na Waziri Mkuu, alishukuru kuendelea kwa serikali kuunga mkono afya ya wanyama na taasisi za mafunzo ya viwanda katika kaunti hiyo, akisema hii ni mojawapo ya hatua bora zaidi za Dira ya 2030. "Ni furaha yangu kuwa Ka-

tibu wa Baraza la Mawaziri ameahidi wfugaji wa ng'ombe wa maziwa kuwa watanunua mbegu bora kwa bei ya chini ikilinan-ganishwa na bei ya soko ya leo, ili kupunguza umas-kini na kuimarisha usalama wa chakula katika kaunti. "Pia tumeahidiwa vikaushi ambavyo vitakuwa na matokeo chanya, haswa kwa wakulima wetu wa mpunga, ambapo gunia la kilo 90 litagharimu Sh70 kukauka, ambayo ni bei nzuri ikilinan-ganishwa na bei ya sasa," Seneta alisema.

wezesha biashara, ubora wa pembejeo za kilimo na mazao, na kuimarisha uwezo wake wa kitaasisi.

Tahadhari maalum inatolewa kwa ukarabati wa chemchemi ya maji ya Cherangan'y kwa msaada wa washirika ikiwa ni pamoja na serikali ya Italia, uhifadhi wa bonde la mto Kerio pia ni muhimu ili kuangalia maporomoko ya ardhi ya kudumu kwa sababu ardhi imeachwa wazi kutohana na shughuli za kibinadamu, aliogezza Naporos.

Kulingana na mkurugenzi huyo, mpango huo pia utahissha ukarabati wa eneo la vyano vya bwawa la Turkwel ili kuondoa mchanga wa hifadhi ya maji na kukarabati eneo la kanda ambalo mara nyingi linakabiliwa na maporomoko ya udongo hatari.

Akizungumza alipofunga Mafunzo ya Kujumuisha Uzalishaji kwa Kanda ya Kati katika Taasisi ya Sayansi na Teknolojia ya Kiambu (KIST), Katibu katika Ofisi ya Baraza la Mawaziri, Dk. Idris Salim Dokota, alisema mafunzo hayo yataongeza sio tu tija kwa umma, sekta, lakini ma-
