Serikali imekumbatia sbinu mbalimbali za kupiga jeki uchumi wa kidijitali wa nchi kupitia uwekezaji mkubwa katika miundombinu na sera. Katibu wa Idara ya Serikali ya Teknolojia ya Mawasiliano ya Habari (ICT) na Uchumi wa Kidijitali, Mhandisi John Tanui, alisema kuwa serikali imezindua mipango kadhaa ya kukuza ujuzi wa kidijitali, kama vile mpango wa Ajira Digitali, huku pia ikianzisha mikakati ya kidijitali kama vile Mkakati wa Kitaifa wa Intaneti.

Mhandisi Tanui alitangaza kuwa kukumbatia dijitali kutakuwa njia ya kubadilisha uchumi, kunda nafasi za kazi zinazohitajika sana, na kuendesha ushirikishwaji wa kifedha na kiuchumi. Akizungumza alipozindua rasmi afisi ya Kamishna wa Ulinzi wa Data (ODPC) kanda ya Nakuru, Katibu huyo alisema serikali inaanzisha maabara za kidijitali nchini ili kuwawezesha wanafunzi na vijana kupata ujuzi wa kidijitali kwa ajili ya kupata nafasi za kazi nchini na kimataifa. Mhandisi Tanui alidokeza kuwa nafasi dijitali inazidi kuwa muhimu kama njia inayoweza maendeleo ya kijamii na kiuchumi na uundaji wa ajira barani Afrika, ikizingatiwa hadhi ya kipekee ya bara hili kama eneo lenye idadi kubwa ya vijana lakini kiwango cha juu zaidi cha ukosefu wa ajira kwa vijana. Kenya ina idadi kubwa ya vijana na inaongezeka, na zaidi ya nusu ya raia walio na umri wa chini ya miaka 35, hali ambayo Katibu alibainisha inatoa fursa ya kukuza uchumi na kunda nafasi za kazi.

Mhandisi Tanui alisema majukwaa hayo ndiyo suluhisho

bora kwa ajili ya kukabiliana na ukosefu wa ajira miongoni mwa vijana. Alieleza imani kwamba kuanzishwa kwa vituo vya kidijitali katika wadi zote 1,450 kote nchini kutaleta manufaa makubwa mara kutakapotekeleza kikamilifu. Vituo hivi, alidokeza, si tu vitasaidia katika kutoa huduma za kidijitali za serikali, lakini pia vitawawezesha vijana wabunifu kunufaika na uchumi unaokua kwa kasi duniani wa biashara ya mtandaoni na kidijitali kwa ajili ya ajira na kukuza biashara zao.

"Mbali na kutoa uunganishaji wa intaneti wa kasi ya juu, vituo vimeundwa ili kutoa vifaa na huduma za kisasa za kiufundi, vijijumuisha vyumba vya mikutano, hafla na nafasi za mafunzo," Tanui alidokeza.

"Tutatekeleza chombo cha uchunguzi wa kidijitali kinachojulikana kwa jina la 'Pasha' kwa umma kuripotoni visa vyote vya kunyimwa au huduma duni na taasisi za serikali ya kitaifa na kaunti. Matukio haya yatatolewa kuchunguzwa na umma na vyombo vya habari ili kuwafanya watumishi wa umma kuwajibika zaidi kwa walipa kodi," Kuria alisema.

Zaidi ya hayo, Waziri alisema kuwa Serikali inapanga kubadilisha Huduma ya Vijana kwa Taifa (NYS) kuwa chuo muhimu cha uongozi kwa wale wanaoingia katika utumishi wa umma na vikosi vya usalama. NYS pia itakuwa mwanakandarasi atakayendekeza wa serikali za kitaifa na kaunti, pamoja

National slum upgrading and prevention strategy: A new dawn for Kenyan slums

The Second Kenya Informal Settlement Programme (KISIP 2) project was initiated in 2021 with the aim of improving the lives of people residing in informal settlements, strengthening institutional capacity for slum upgrading in Kenya, and dignifying the residents of these settlements. MyGov reporter Mutiso Mbithi interviewed Mr. George Arwa, the National Coordinator of this Sh20 billion Vision 2030 Programme, to delve into its details.

Here are some excerpts from the interview.

Q: Coordinator, what is the Second Kenya Informal Settlement Improvement Project (KISIP2)?

A: The KISIP 2, commonly known as KISIP 2, is a government project funded by the World Bank, the Agence Française de Développement (AFD), and the European Union (EU). Its objective is to improve access to basic services and land tenure security for residents in participating urban informal settlements and to enhance institutional capacity for slum upgrading in Kenya. It's a Vision 2030 project and is currently under the State Department for Housing and Urban Development in the Ministry of Lands, Public Works, Housing, and Urban Development.

Q: Could you explain the project's conceptualization briefly?

A: Unplanned informal settlements, a result of rapid urbaniza-

tion, pose a significant challenge to Kenya's socio-economic development. To address this, the Government of Kenya, with support from the World Bank and other development partners, launched the KISIP 2 program in March 2021. Its purpose is to systematically upgrade informal settlements and assist national and county governments in developing long-term slum upgrading and prevention strategies.

Q: What role does this project play in Kenya's socio-economic development?

A: KISIP 2 supports Kenya's urban development agenda and aligns with international goals such as the Sustainable Development Goals. It also contributes to Kenya Vision 2030's objective of well-housed populations living in environmentally secure urban environments. The project actively



involves youth in crime prevention and promotes their inclusion in all program activities.

Q: KISIP 2 has various components. Can you briefly explain them?

A: KISIP 2 comprises several components, each led by a Component Head. The first is Integrated Settlement Upgrading, with sub-components like Land Tenure Regularization, which coordinates tenure regularization for residents on uncontested public lands. The second is Infrastructure Upgrading, which oversees investments in services and infrastructure. The third is Socio-Economic Inclusion Planning, which identifies community needs and vulnerable populations, raises awareness on green zones, and addresses crime and violence prevention. The In-

stitutional Capacity Development for Slum Upgrading component strengthens the capacity of national and county government institutions. Lastly, Program Management and Coordination supports project management and coordination activities for both national and county governments.

Q: How does KISIP 2 ensure gender inclusivity in project implementation?

A: The project prioritizes gender mainstreaming, enhancing the role of women and marginalized groups in decision-making processes during implementation.

Q: The Social and Affordable Housing Agenda is a key part of the Government's Bottom-Up Economic Transformation Agenda (BETA). How does KISIP contribute to this initiative?

A: KISIP 2 supports the agenda by providing land tenure security, which enables planned neighborhoods and stimulates housing development. Improved infrastructure also promotes accessibility, stimulating housing, drainage, and sanitation improvements.

Q: The State Department for Housing and Urban Development recently launched the National Slum Upgrading and Prevention Strategy. What are its goals?

A: The strategy aims to improve the quality of life for residents in Kenya's slums by providing appropriate security of tenure, infrastructure, social amenities, and

facilitating adequate social housing.

Q: What challenges has the project faced during its implementation?

A: COVID-19 lock-downs disrupted some interventions. Delayed submissions from county governments and lengthy procurement processes were challenges, but strategies have been implemented for ongoing engagement and alignment with project timelines.

Q: How does the community participate in project implementation?

A: The project ensures inclusivity by involving various community stakeholders, establishing committees, and supporting settlement-level institutions.

Q: What is KISIP2 doing to help provide jobs to Kenyan youth?

A: The project creates jobs for youth through infrastructure projects and other initiatives. Contractors are encouraged to involve local labor for manual jobs, and knowledge transfer opportunities are provided to benefit youth.

Q: What are the eligibility criteria for counties to participate in KISIP interventions?

A: KISIP 2 is currently working in 33 counties, and participation is open to all 47 counties. They were invited to submit settlements for consideration based on land status, settlement morphology, and location.

KEMRI urged to enhance surveillance for emerging health threats

The Kenya Medical Research Institute (KEMRI) has received an urgent call to strengthen its surveillance and emergency response programs, enhancing its capacity to rapidly detect and respond to emerging health threats.

During the inauguration of the Fifth Kemri/Japan International Cooperation Agency (JICA) Country Training Programme (TCTP) in Nairobi, Principal Secretary for Medical Services, Harry Kimtai, emphasized the importance of boosting laboratory capacity and preparedness to effectively combat public health emergencies in Eastern Africa.

The TCTP has brought together 14 participants from 10 African nations, including Kenya, Burundi, Eritrea, Ethiopia, South Sudan, Uganda, Djibouti, Madagascar, Seychelles, and Tanzania. Operating under the theme "Strengthening Laboratory Preparedness for Building Resilience against Public Health Emergencies in Eastern Africa," the training initiative aims to enhance the continent's responsiveness, preparedness, and prevention of epidemics, pandemics, and other critical health crises.

The program seeks to increase the continent's capacity to respond to, prepare for, and prevent epidemics, pandemics, and other public health crises. Harry

Kimtai, the PS, stressed that the primary focus of the program is to equip health-care professionals with the skills and knowledge required to effectively address infectious diseases such as Ebola, HIV/AIDS, tuberculosis, and malaria.

Mr. Kimtai stressed the Ministry's commitment to enhancing the country's health infrastructure and building national and local capacities. This includes establishing efficient, transparent, equitable, and accountable health systems to enhance essential service delivery. Moreover, the Ministry has actively supported research and development efforts while empowering health service providers.

The PS emphasized the vital role that a healthy population plays in Kenya's journey toward becoming a middle-income country.

"Being a regional hub, Kenya shares borders with nations that are still developing their health systems. This impacts the efficiency of the national immunization program and necessitates a concerted effort to improve health infrastructure," he noted.

The TCTP also seeks to empower laboratory managers and related personnel across Eastern Africa, recognizing their pivotal role in preparedness and response to disease outbreaks and public health emergencies.
