Dandora. Wamepanda miche 3,084 ya mianzi wakilenga miche ya miti 20,000 kwenye hifadhi za vyango vya maji, alisema.

"Kwa miaka mingi, mito na vijito vya Kaunti ya Jiji la Nairobi vimeduwa maeneo ya wazi ya kutupa taka, sio tu katika mitaa ya mabaanda lakini pia maeneo ya mijini na kando ya miji kutokana na ukosefu wa mifumo bora ya kusafisha na kufufua eneo la Nairobi," katibu alisema.

Dkt Ronoh alisema kuwa tabia hiyo iliyoenea imesababisha uchafuzi mkubwa wa vyango vya maji kwa plastiki, taka ngumu na taka oevu.

"Athari ni mbaya kutokana na mito kujaa maji wakati wa mvua kutokana na kujaa kwa udongo na kuzibwa kwa uchafu unaotupwa

Hali hii inasababisha kuzaana kwa wadudu wae-nezao magonjwa na hivyo kuhatarisha zaidi mfumo wa ikolojia wa mto huo," akasema Katbu.
