"Kenya inahitaji tani milioni 55 za chakula cha wanyama kavu kila mwaka lakini inazalisha asilimia 40 pekee, na kuacha pengo kubwa la usambazaji wa tani milioni 33. Kwa bahati mbaya, pengo hili lazima lijazwe kuititia uagizaji bidhaa kutoka nje, na kua-



cha sekta hii muhimu katika hali ya hatari sana," Dkt Mutua alisema.

Alibainisha kuwa Wizara inmeunda Sera ya Kitaifa ya Chakula ili kukabiliana na matokeo kwamba sekta ya mifugo ya Kenya inakabiliwa na kiwango cha asilimia 26 ya utapiamlo, ambao umesababisha kudumaa na kuathiri vibaya uzalishaji.

Dkt. Mutua alikuwa akizungumza mjini Naivasha wakati wa warsha ya siku tano iliyohudhuriwa na wawakilishi kutoka nchi sita za Afrika wanaofanya majaribio ya mpango wa Resilient African Feed and

Fodder Systems (RAFFS). Warsha hiyo iliyandalawa na Taasisi ya Umoja wa Afrika-InterAfrican Bureau for Animal Resources (AU-IBAR), ililenga kushughulikia masuala yanayokabilii hesabu ya malisho na uwiano barani Afrika, kuweka hadhi ya sasa ya sekta ya chakula, na kukabiliana juu ya mbinu ya pamoja ya bara. Dkt Mutua alisema kutokana na ripoti ya utafiti huo iliyofanywa kwa awamu mbili, Wizara ya Kilimo na Maendeleo ya Mifugo imekuja na afua mbalimbali ambazo ni pamoja na kukuza na

kuweka kipaumbele cha mnyororo wa thamani wa malisho 10 ili kuzalisha malisho yanayohitajika nchini.

Alibainisha kuwa mkakati wa serikali wa taifa wa malisho utasaidia kukabiliana na upungufu wa vyakula vya mifugo na ubaba wa maji kwa mifugo na ubora wa malisho kwa kuangalia vyanzo vya nishati kama vile mahindi na mtama na vyanzo vyenye protini nyingi kama vile soya, alizeti na mbege za pamba na protini ya wanyama.

KEPROBA na AFA zatia saini kukuza kahawa ya Kenya kote ulimwenguni

The National Treasury & Economic Planning is in the process of recruiting members of the Competition Authority of Kenya (CAK) for the vacant positions that have arisen under section 10(1)(f) of the Competition Act, 2010 (Revised in 2019). Pursuant therefrom, the Cabinet Secretary for National Treasury & Economic Planning hereby invites applications from suitably qualified persons for the vacant positions of members of the CAK.

THE COMPETITION AUTHORITY OF KENYA

The CAK is established under section 7 of the Competition Act, 2010. Its functions, as stipulated under section 9 of the Act, are to -

- Promote and enforce compliance with the Act;
- Receive and investigate complaints from legal or natural persons and consumer bodies;
- Promote public knowledge, awareness and understanding of the obligations, rights and remedies under the Act and the duties, functions and activities of the Authority;
- Promote the creation of consumer bodies and the establishment of good and proper standards and rules to be followed by such bodies in protecting competition and consumer welfare;
- Recognize consumer bodies duly registered under the appropriate national laws as the proper bodies, in their areas of operation, to represent consumers before the Authority;
- Make available to consumers information and guidelines relating to the obligations of persons under the Act and the rights and remedies available to consumers under the Act;
- Carry out inquiries, studies and research into matters relating to competition and the protection of the interests of consumers;
- Study government policies, procedures and programmes, legislation and proposals for legislation to assess their effects on competition and consumer welfare and publicize the results of such studies;
- Investigate impediments to competition, including entry into and exit from markets, in the economy as a whole or in particular sectors and publicize the results of such investigations;
- Investigate policies, procedures and programmes of regulatory authorities to assess their effects on competition and consumer welfare and publicize the results of such studies;
- Participate in deliberations and proceedings of government, government commissions, regulatory authorities and other bodies in relation to competition and consumer welfare;
- Make representations to government, government commissions, regulatory authorities and other bodies on matters relating to competition and consumer welfare;
- Liaise with regulatory bodies and other public bodies in all matters relating to competition and consumer welfare; and
- Advise the government on matters relating to competition and consumer welfare.

Position of Member of the Board of Competition Authority of Kenya

Section 10(1) of the Act provides that the Authority shall comprise, in addition to the chairman and ex-officio members, five (5) other members appointed by the Cabinet Secretary. A member appointed under this section shall hold office for a period of three years, on such terms and conditions as may be specified in the instrument of appointment, and is eligible for re-appointment, subject to a maximum of two terms of office.

In line with section 10(2), the persons proposed to be members of the Authority under section (10)(1)(f) shall, before their appointment to the Authority, be vetted and approved by Parliament through the relevant Committee of Parliament.

Qualifications for Appointment as Member

Interested candidates for the position of member of the Competition Authority of Kenya must be persons of high integrity and must hold a minimum of a university degree from a recognized university. The candidates must have extensive experience at management level, in the public or private sector, in competition and consumer welfare matters. Further, the candidates should satisfy the requirements of Chapter Six of the Constitution of Kenya.

Applicants must attach the following documents:

- Detailed curriculum vitae, with at least three (3) referees and their contacts, including telephone contacts;

Sony sugar embarks on a Sh400m maintenance to restore full production capacity

The South Nyanza (Sony) Sugar Company is set for a major maintenance operation to restore the plant's ability to mill at full capacity.

The maintenance, scheduled to start in mid-October to late November this year, will require at least Sh400 million to boost the factory's ability to mill cane beyond 1,500 tonnes per day.

According to the managing director Martin Dima, the company has already started to acquire the necessary tools and spares both locally and abroad.

The plant has a capacity to crush up to 3,000 tonnes if the fatigued machine is properly maintained or replaced.

The 1979 installed machine has been working for over 45 years and it is worn and torn.

Since Dima was appointed three months ago, there has been an

improvement in the operation of the machine allowing it to crush between 1,700 to 2,200 tonnes of cane per day as compared to the previous 800 tonnes.

The Sh865-million worth semi-autonomous company has not had a substantive managing director for close to eight years, and the appointment of Dima three months ago has breathed life into the factory putting it on the right path of restoring its lost glory.

The frequent breakdown of the plant has however reduced its effectiveness in maximizing its full potential of crashing at least 3,000 tonnes of cane per day.

The old machines have also reduced the sugar production, which under normal circumstances is one tonne of sugar per 10 tonnes of cane. These frequent breakdowns have however led to the plant crushing only 12 tonnes of cane to produce one tonne of sugar.

Dima has overseen the transformation of the

mill's ability to produce 1,500 tonnes of sugar weekly from the previous 700 tonnes of bagged sugar, doubling the company's final output.

Despite these challenges, he acknowledged that the company has restored farmers' confidence by boosting operational frameworks through the efforts that have been effectively put in place.

The resolved payment delays to farmers and prompt payment to 1,500 direct employees and other 3,000 indirectly employed staff has greatly elevated the morale of farmers and the workforce, he said.

The MD disclosed that the company has been able to reduce the five-month delay period of paying farmers to within a month which has seen an increase in cane deliveries to the factory.

"When I was appointed a substantive managing director, I found a lapse of five months of non-payment to farmers. Currently, we are paying

farmers that delivered their canes this August," Dima said.

Dima explained that going forward Sony Sugar wants to reduce the payment window to within a week to further improve the economic status of cane farmers who play a crucial role in ensuring the factory operates optimally.

The revival of the com-

pany will also require increased acreage of cane to fully utilise the company's capacity to crush 3,000 tonnes of cane per day.

The factory has 2,400 hectares of nuclear under cane with an additional 6,000 hectares from contracted farmers.

Currently, Sony Sugar has more than 25,000 contracted farmers from the counties of Narok,

Homabay, Kisii and Migori.

Dima emphasized the need to increase cane acreage to continuously provide raw materials to the company.

In the recent past, many cane farmers in South Nyanza diversified their cane farming to other crops after years of disappointments over delayed payments.



Government to implement ICT Sector Working Group recommendations for digital transformation

The Ministry of ICT and the Digital Economy will adopt a multi-stakeholder project coordination and delivery unit and high-level project governance framework to guide the implementation of recommendations by the ICT Sector Working Group (SWG).

The ICT SWG was tasked with reviewing the current ICT policies, legislative frameworks, and institutional capacities, and propose actionable reforms that will propel Kenya into a vibrant digital economy over the next 15 to 20 years.

The SWG was to assess and advise the MICDE on the necessary reforms to enable it to fulfill its mandate and meet expectations in a fast-changing operational environment and draft relevant bills, policies and strategy documents.

The MICDE Cabinet Secretary, Dr Margaret Ndung'u (pictured), accompanied by ICT and Digital Economy Principal Secretary Eng. John Tanui and the Principal Secretary for Broadcasting and Telecommunications Prof Edward Kisang'ani received the SWG Final Report which has impactful recommendations across ten ICT thematic areas.

In his presentation, the SWG Chairperson Prof Timothy Waema said the SWG Final Report has



given several recommendations which include developing a National AI and Emerging Technology Policy, revising the National ICT Policy, 2019 to align to industry trends, formulating the National Data Policy and enacting Kenya's Data Act and developing a National Cybersecurity Policy, amongst others.

In her address, the CS noted that to keep track of the implementation progress of the SWG Report recommendations, the Government will establish a multi-stakeholder project coordination and delivery unit that will be based within the Ministry.

The delivery unit, along with a project delivery committee composed of industry experts, development partners, academia, media and civil society will bring together experts to guide the implementation process.

In addition, the ministry will adopt a high-level project governance framework that will include a change & transformation management office (CTMO) chaired by the CS, with PSS and CEOs of the critical SAGAs as members and members from the private sector and the civil society.

The CS, who appreciated the SWG for formulating the well detailed report, reiterated that successful implementation of the recommendations will unlock new levels of innovation, increase access to digital services, and position Kenya as a leader in the global digital economy.

"We have the opportunity to foster a generation of digital entrepreneurs, to strengthen our infrastructure, and ensure that every Kenyan benefits from this digital transformation," the CS said.

The CS said the SWG's recommendations align well with the ministry's priority areas which include accelerating broadband access and connectivity, fast-tracking digital skilling and job creation, promoting the development, adoption and usage of emerging technologies for social economic and gender de-

velopment, promoting multi-stakeholder and inclusive approach to digital projects planning and implementation amongst others.

To ensure the successful execution of the recommendations outlined in the Report, the SWG has also provided detailed strategies for enhancing successful implementation.

CS Ndung'u stated that MICDE will collaborate with other key agencies to develop a National Portfolio Programme and Project Management Policy to ease the management of ICT projects and ensure that all ICT initiatives at both national and county levels are not duplicated and are aligned with the national goals.

Jinsi majiko ya kisasa yanavyobadilisha maisha katika kampeni kukabiliana na uchafuzi unaotokana na upishi

Kuenea kwa matumizi ya makaa na kuni kwa kupikia mionganoni mwa jamii za vijijini katika ukanda wa Ziwa Victoria kunaleta madhara makubwa kwa mazin-gira na afya ya jamii. Kwa kuwa mafuriko na ukame umeongezeka mara kwa mara na kukithiri, na kuathiri maisha, jumuiya za mitaa zinahimi-zwa kubadili vyanzo vya nishati safi kama hatua ya kukabiliana na mabadiliko ya hali ya hewa, uchafuzi wa hewa na hatari za afya.

Mbinu za jadi za kupikia kwa kutumia majiko yasiyofaa hutoa masizi (kaboni nyeusi) na vichafuzi vingine hatari kwenye angahewa, na kuchangia kwa kiasi kikubwa kuzorota kwa mazingira. Kulingana na Muungano wa Kupikia Safi (CCA), takriban tani bilioni moja za metriki za kaboni dioksidi (CO_2) sawa huzalishwa kila mwaka kutokana na uchomaji wa nishati ya kuni, ambayo ni sawa na asilimia mbili ya uzalishaji wa CO_2 duniani.

Ulimwenguni kote, kribu watu bilioni 2.3 bado wanategemea mafuta ya taa, kuni, na mkaa kupikia, na hivyo kuchangia pakubwa katika uchafuzi wa mazingira. Upikaji wa kaya, upashaji joto, na mwangaza hu-wajibika kwa hadi asilimia 25 ya hewa chafu ya kaboni nyeusi, na katika

nchi kama Kenya, kupikia pekee huchangia asilimia 60 hadi 80 ya uzalishaji huu. Athari za kiafya za kutumia njia za kupikia asili ni kali, haswa kwa wanawake na watoto. CCA inakadiria kuwa karibu nusu milioni ya vivo vya mapema hutoke kila mwaka barani Afrika kutokana na uchafuzi wa hewa wa kaya.

Kuhamishia majiko na mafuta safi kunaweza kupunguza matumizi ya nishati kwa asilimia 30 hadi 60, na hivyo kupunguza uzalishaji unaodhuru hali ya hewa, kulingana na CCA. Ili kushughulikia hili, Nyalore Impact Enterprise, iliyoko katika Kaunti ya Homa Bay, inatoa suluhu za nishati safi

kama vile jiko la shinikizo la umeme (Quooker Digi) na jiko la kisasa la biomasi. Ubunifu huu una-saidia kupunguza ukataji miti na hewa ucaa katika ukanda wa Ziwa Victoria.

Tangu kuanzishwa kwake mwaka wa 2016, Nyalore Impact imekuwa mstari wa mbele kutetea suluhu za upishi safi kwa wakazi wa mashambani, ikiwiana na malengo madhubuti ya Kenya ya kuzalisha asilimia 100 ya nishati yake ya umeme kutoka vyanzo vya nishati safi ifikapo 2030 na kufikia asilimia 100 ya upishi safi ifikapo 2028.

Benter Akinyi, mwenye umri wa miaka 37, mkazi wa kijiji cha Abouro huko Ndhiwa, Kaunti ya Homa Bay, amepata maboresho makubwa katika maisha yake tangu atumie kifaa cha Quooker Digi mwaka wa 2021. Hapo awali, Akinyi alitegemea mkaa na kuni, ambazo hazikumu-hatarisha tu. afya ya familia lakini pia ilichangia uharibifu wa mazingira.

"Kuta za jikoni yangu zilifunika na masizi, na moshi wa kuni ulisababisha kikohozi cha mara kwa mara na maumivu ya kifua kwa familia yangu," Akinyi alikumbuka. Tangu kugeukia chaguo la kupikia safi zaidi, ustawi wa familia ya Akinyi umeboresha huku pia ukupunguza kwa kiasi kikubwa gharama za nishati ya kaya. Hapo awali, alitumia takriban Sh7,400



kila wiki kununuwa makaa. Sasa, akiwa na jiko hilo lisilotumia nishati, ye yeuhuhifadhi hadi asilimia 70 ya kiasi hicho, na hivyo kutoa pesa kwa ajili ya mahitaji mengine ya familia.

Vile vile, Mary Ouma, mama wa watoto watano mwenye umri wa miaka 43 kutoka Kijiji cha Thuon Gweno huko Ndhiwa, Kaunti ya Homa Bay, alitupilia mbali mahali pa moto la jadi la mawe matatu mnamo 2018 kwa ajili ya jiko la kupikia

biomasi ambalo hutumia briketi za makaa na pellets. Gharama kubwa ya nishati asilia na maswala ya kiafya yalisukuma familia yake kutafuta njia mbadala, huku briketi za mkaa zikonekana kuwa chanzo cha gharama nafuu na safi cha nishati.

"Tunanunua briketi kutoka kwa wasambazaji wa Nyalore Impact, na ni nafuu," Ouma alieleza. Mlo wa kiasili wa mahindi na maharagwe kwa kaya ya watu watano sasa un-agharimu takriban Sh13 kwa kutumia briketi, ambayo ni nafuu mara tisa kuliko kupika mlo huo huo kwa kutumia mkaa wa kuni au mafuta ya taa ambayo gharama yake ni Sh85 na 125 mtawalia.

Doroth y Otieno, mwanazilishi na Mkurugenzi Mtendaji wa Nyalore Impact, alishiriki kwamba wameuza zaidi ya uniti 500 za jiko la shinikizo la umeme na uniti 5,000 za jiko la biomasi kwa jamii zisizo na uwezo, na kupunguza uzalishaji wa kaboni kwa zaidi ya tani 1,000 kila mwaka. Kwa sasa, majiko hayo yanapatikana kwa reja reja kwa gharama ya kuanzia Sh2,500 hadi Sh11,000. Hata hivyo, ili kufanya vifaa kuwa vya bei nafuu, Nyalore Impact inatoa chaguo za malipo ya awamu ili kuwesheha kaya za kipato cha chini na wa-

fanyabiashara wadogo kushinda kikwazo cha gharama ya awali.

Suluhu za kupikia safi ni sehemu muhimu ya Mpango wa Mpito wa Nishati na Uwekezaji wa Kenya (2023-2050), unaolenga kukomesha mbinu za jadi za kupika na kukuza majiko na vifaa vyenye ufanisi kwa wakazi wote wa mashambani ifikapo 2030. Dk. Fatih Birol, Mkurugenzi Mtendaji wa Shirika la Kimataifa la Nishati (IEA), lisilisitiza udharura wa juhud hizi katika Kongamano la 9 la Kila Mwaka la IEA kuhusu Ufanisi wa Nishati jijini Nairobi.

Dkt. Birol aliwasihii watunga sera na serikali za dunia kuharakisha upitishaji wa sera zinazotumia nishati vizuri kama ilivy-obainishwa katika Zana mpya ya Sera ya Ufanisi wa Nishati ya IEA 2024. Sera hii inalenga kuongeza maradufu maendeleo ya ufanisi wa nishati duniani ifikapo mwaka wa 2030. "Licha ya matarajio yaliyoonyeshwa kwenye COP28, na maendeleo mazuri katika nchi na kanda nyingi, bado hatuoni maendeleo muhimu ya ufanisi wa nishati duniani kote. Serikali lazima ziharakishe hatua, na seka ya kibinasi pia inapaswa kutekeleza jukumu lake. Tumeona maendeleo makubwa, ikiwa ni pamoa na kutoka nchi kama Kenya," Dk. Birol alisema.

Base Titanium yatoa ziara ya kufahamu wa mgodi wa Kwale ikikaribia kufungwa

Hivi majuzi, kampuni ya Base Titanium ili-wakaribisha wawakilishi wa vyombo vya habari kwenye tovuti yao ya Kwale Mine kwa ziara ya kina, ikitoa maarifa ya kina kuhusu shughuli zao ili kuboresha uelewa wa michakato, changamoto na mafanikio ya kampuni huku mgodi huo ukikabiliwa na kufungwa kwa sababu ya kuharibika kwa rasilimali za madini.

Ziara hiyo ililenga kutoa fursa ya uwazi na kutafakari juu ya athari za mradi unapokaribia awamu yake ya mwisho.

Ziara hiyo ilionyesha vifengele kadhaa muhimu vya shughuli za Base Titanium, kuanzia na kitalu chao cha miti asilia, ambacho kinaangazia dhamira yao ya upandaji miti upya na uendelevu wa mazingira. Mgodi wa Kwale wa Base Titanium ulianza kufanya kazi mwaka wa 2011, na uchimbaji uchimbaji ukianzia kwenye Mlima wa Kati mnamo Oktoba 2013. Ni mradi wa kwanza wa uchimbaji mkubwa wa madini nichini Kenya na unachangia asilimia 65 ya sekta ya madini nichini.

Wawakilishi wa vyombo vya habari walipewa uchunguzi wa kina wa shughuli za uchimbaji madini za kampuni na maeneo yaliyokarabatiwa, wakionyesha juhudi kubwa za baada ya

uchimbaji madini zilizofanywa kurejesha ardhi katika hali yake ya asili.

Akizungumza na wawakilishi wa vyombo vya habari, Meneja Mkuu wa Mambo ya Nje wa Base Titanium, Simon Wall, alisitiza kuwa ingawa shughuli za uchimbaji madini zinatarajiwa kukamilika Desemba, uwepo wa kampuni hiyo hautaishia hapo. Alifahamisha kuwa usindikaji na usafirishaji wa madini utaendelea, pamoja na juhudi kubwa za ukarabati wa mazingira ambazo bado zinahitajit kushughulikiwa.

Shughuli hizi za baada ya uchimbaji madini, alisitiza, zinahakikisha

kuwa kampuni inaendelea kujishughulisha katika eneo hilo, kwa kuzingatia kutimiza ahadi zake za mazingira na utendaji. Titanium juu ya utambuzi wa programu ya awali ya kujifunza. Alibainisha kuwa hii ni fursa ambapo wengi wa wafanyakazi wao walifanya kazi katika eneo la mgodi na hawakuwahi kuwa na mafunzo rasmi na vyeti.

Simon Wall pia alian-gazia wajibu wa Base Titanium wa kulipa mra-baha moja kwa moja kwa Serikali ya Kitaifa kupitia Wizara ya Madini ambayo walifanya kila mwezi. Kati ya jumla ya mirahaba, asilimia 70 huhifadhiwa

na Serikali ya Kitaifa, asilimia 20 hutengewa Serikali ya Kaunti, na asilimia 10 inaekezwa kwa jamii ya eneo hilo.

Alisema bado wanaendelea na mazungumzo na Serikali kuhusu fidia ya miundombinu ya kudumu kama njia za umeme, mabwawa na vituo vidogo. Ujenzi wa mgodi huo uligharimu bilioni 26 katika uwekezaji, 9 kati yake zilitumika kwa maudhui ya ndani, 3.7 iliwekeza katika miundombinu ya kijamii, uboreshaji wa maisha, afya na elimu.

“Ingawa uchimbaji wa Madini unavyoisha mwezi Desemba, bado tunahitaji mwaka mmoja au miwili

ili kukamilisha mchakato wetu wa ukarabati,” Wall alisema.

Kuhusu kupunguzwa kazi kwa wafanyakazi, alibainisha kuwa ingawa sio wafanyakazi wengi ambao wameathiriwa katika hatua hii, mchakato utaanza kwa dhati mwishoni mwa Desemba. Upungufu huo utafanyakira katika awamu 2-3, na awamu kuu ya kwanza itafanyakira mwishoni mwa Desemba, ikifuatiwa na nyingine mwezi Machi, na awamu ya mwisho mwezi Juni.

Base Titanium imeunda zaidi ya kazi 1600 za moja kwa moja, kazi 1430 zisizo za moja kwa moja katika

mnyororo wa usambazaji na ajira 1380 zilizosababishwa kuititia matumizi ya watumiaji.

Meneja wa Mazingira wa Base Titanium, Nick Okello, alisema kuwa wanafanya kazi kwa bidii katika juhudi za ukarabati huku wakifutu kwa karibu mambo muhimu ya kimazingira. Hizi ni pamoa na ubora wa hewa na maji, viwango vya mionzi, na udhibiti wa taka, kuhakikisha kwamba vifengele vyote vinakidhi viwango vinavyohitajika. Alisema kuwa wamekarabati zaidi ya hekta 500 katika eneo la kusini mwa dune, 250 katika dune ya kati na 250 katika Dune ya Kaskazini.

Okello alisitisiza kuwa kampuni hiyo hutumia mbinu mbili za urekeb-ishaji. Kwanza hufanya uundaji wa ardhi ili kuhakikisha mifereji ya maji inayofaa ambayo inalingana na mtiririko wa maji asilia kuelekea jamii inayozungu.

“Baada ya kuchagiza, tunaweka udongo wa juu na kutathmini ni virutubisho gani vinakosekana kwenye udongo ili kubaini nyongeza inayofaa. Mchakato wa ukarabati huanza kwa kupanda nyasi kama spishi ya kwanza, ikifuatiwa na vichaka na miti,” Okello alisema.

Alihakikisha kuwa katika kipindi cha miaka 5 hadi 10, juhudi hizi zinatarajiwa kurejesha ardhi katika hali inayolingana na bioanuwai iliyo karibu kama walivoyfanya kwenye eneo la kati.

Ziara hiyo pia ilijumuisha kutembelea miradi kadhaa ya jamii ambayo Base Titanium imetekeleza kwa ushirikiano na Kamati za CDAC.

Nakuru yazindua baiskeli za umeme za bei nafuu kwa wana boda boda

Serikali ya Kaunti ya Nakuru imezindua pikipiki za umeme kama sehemu ya mpito wake wa uhamaji wa umeme, unaolenga kupunguza alama za kaboni. Utawala wa kitengo cha ugatuza umeashiria kujitolea kwake kuunga mkono mpango wa serikali ya kitaifa wa kukomesha zaidi ya pikipiki milioni mbili zinazotumia mafuta huku Kenya ikianzisha enzi ya e-mobility.

Waziri wa Kaunti (CECM) anayesimamia Barabara, Uchukuzi, na Kazi za Umma Mhandisi Michael Kamau alifichua kuwa, pamoja na vituo vinane vya kutoza malipo vinavyofanya kazi na vingine viwili vikiendelea kujengwa, Nakuru iko katika njia thabiti ya kukumbatia uhamaji unaozingatia mazingira. "Ili Kenya kufikia utoaji wa hewa ya chini ya kaboni, tunahitaji teknolojia bora katika sekta ya uchukuzi. Pikipiki hizo za umeme zitasidia kupunguza utovu wa nidhamu na kuboresha usalama katika mfumo wa usafiri kwani zina vikomo vya mwendo kasi," Mhandisi Kamau alisema. Aliongeza, "Hii e-boda boda haiwezi kuzidi kilomita 90 kwa saa. Hii ni kuwadhibiti madereva wazembe na kuokoa mai-sha."

Mhandisi Kamau pia al-

itaja kuwa kaunti imeshirikiana na washikadau mbalimbali kuunda sera kuhusu e-mobility, na kuimarisha kujitolea kwa Nakuru kwa ufumbuzi endelevu wa usafiri. Waziri aliyeandamana na Meneja wa Jiji, Gitau Thabanja, Maafisa Wakau Samwel Ndegwa (Mundombinu), Benard Sang (Biashara), na Msemaji wa Chama cha Boda Boda Nakuru, Stephen Mwanda, walieleza kuwa pikipiki hizo haziwezi kuibwa kwa sababu zinaweza kufatiliwa kutoka eneo la mbali. inaweza kuzimwa kwa mbali ikiwa imiebiwa. "Sekta ya e-mobility tunayoanzisha Nakuru itakuwa na ufuutiliaji. Mtu akijaribu kuiba pikipiki hii inaweza kuzimwa," alisema. Mhandisi Kamau alibainisha kuwa baiskeli hizo za e-mobility zitakuwa nafuu kwa waendeshaji boda boda, huku kila baiskeli ikigharimtu takriban Sh160,000. Alieleza kuwa waendesa boda boda wamekuwa wakikibiliwa na gharama kubwa siku za nyuma, huku wengine wakilipa hadi Sh300,000 kwa pikipiki zinazotumia mafuta. CECM ilisisitiza zaidi kwamba waendeshaji wataokoa gharama za mafuta, kwani gharama za kutoza hazitakuwa kubwa kama zile za mafuta.

Alisema kuwa, licha ya kuwa chaguo kuu la usafirishaji wa maili ya

mwisho kwa mizigo na watu, sekta hiyo imeja vifo zaidi ya 3,000 kila mwaka. Pikipiki hizo za e-mobility zitakuwa na vidhibiti mwendo na kamera za dashi ili kufuatilia na kudhibiti mwendo kasi. "Sekta ya bodaboda ina kiwango kikubwa cha ajali, ikirekodi vifo 3,000 kila mwaka. Tutadhibiti mwendo kasi ili kuhakikisha usalama wa wasafiri na abiria wao," aliongeza.

Pikipiki hizo zimetengeneza na ARC Ride, kampuni ya kutengenza pikipiki za umeme zinazopatikana Rwanda, Uganda, Tanzania na sasa Kenya. Kulingana na ARC Ride, e-boda boda zinahitaji malipo moja tu usiku.. Baiskeli hizo zinaweza kufikia kasi ya juu ya kilomita 90 kwa saa, kubeba mizigo ya hadi kilo 250, na kusafiri umbali wa kilomita 90. Waendeshaji pia wataruhusiwa kubadilisha betri zao ambazo zimeisha kwa zile zenye chaji kikamilifu katika vituo vya kubadilishana betri vya baiskeli ya umeme vya ARC Ride.

Kulingana na Meneja wa Jiji Thabanja, mpango huo unalenga kuharakisha kuptishwa kwa e-mobility, kuwawezesha vijana, na kupunguza gharama za uendeshaji katika sekta ya boda boda. Wahudumu wa bodaboda wamekuwa wakilalamikia gharama ya mafuta inayoongezeka kila mara. Thabanja

alisema kuwa pikipiki hizi mpya zitaokoa tasnia ya bodaboda kutoka kwa bei ya juu ya mafuta, akitisitiza mchanggo mkubwa wa uhamaji wa kielektroniki katika uhifadhi wa mazingira. Aliongeza kuwa pikipiki za umeme zitapunguza kwa kiasi kikubwa uchafuzi wa kelele huku zikiimrisha kujitolea kwa Nakuru kwa mazoea rafiki kwa mazingira.

Utafiti wa hivi

Mchanganyiko wa nishati nchini Kenya unafaa sana kusaidia uhamaji wa kielektroniki, na karibu asilimia 90 ya nishati nchini inatoka kwa vifaa mbadala, - Hurst-Croft

majuzi wa e-mobility wa Chuo Kikuu cha Strathmore unaonyesha kuwa baiskeli moja ya petroli hutoa tani 4.2 za gesi ya kaboni kila mwaka, kumaanisha kuwa sekta ya bodaboda milioni mbili, ambayo inachangia Sh1 bilioni katika uchumi wa Kenya, inamomonyoa mapato haya kwa kuzalisha angalau milioni 8.4. tani za kaboni. Kwa ujumla, sekta ya uchukuzi inachangia kwa kiasi kikubwa asilimia 20 ya jumla ya uzalishaji wa hewa ukaa nchini.

Thabanja alionyesha kuwa idadi ya magari ya umeme na pikipiki zilizosajiliwa nchini Kenya iliongezekwa kwa zaidi ya mara tano mwaka jana huku mashirika zaidi na watu binafsi wakihama kwenda kufanya usafi. Data kutoka kwa Mamlaka ya Udhibiti wa Nishati na Petroli (EPRA) inayoesha kuwa Mamlaka ya Kitaifa ya Uchukuzi na

Usalama (NTSA) ilisajili magari 2,694 ya umeme (EVs) mnamo 2023, na hivyo kuashiria ongezeko kubwa kutoka vitengo 475 mwaka uliopita. Idadi hii inazidi jumla ya idadi ya EVs ambazo zilikuwa zimesajiliwa hapo awali nchini Kenya, na kufanya jumla ya EVs zilizosajiliwa kufikia 2023 hadi 3,753.

Afisa Mkuu Mtendaji wa ARC Ride, Joseph Hurst-Croft, alisema kuwa Kenya ni mojawapo ya nchi barani Afrika zenyne soko kubwa zaidi la pikipiki za umeme, hali inayovutia makampuni ya kimataifa kuanzisha mitambo ya kuunganisha mashinani, na hivyo kutengeneza fursa za ajira. na kuboresha Pato la Taifa la nchi. "Mchanganyiko wa nishati nchini Kenya unafaa sana kusaidia uhamaji wa kielektroniki, na karibu asilimia 90 ya nishati nchini inatoka kwa vifaa mbadala," Bw. Hurst-Croft alisema.

Mfumo mpya wa maji taka, mtambo wa kusafisha maji kubadilisha pakubwa sura ya mji wa Kapsowar

Mradi huo ni wa ushirikiano kati ya Wakala wa Maendeleo ya Maji ya Ziwa Victoria Kaskazini (LVNWDA), Wakala wa Maendeleo ya Ujenzi wa Maji ya Ufa Kaskazini (NRWWDA), na Kampuni ya Majisafi na Usafi wa Mazingira ya Cherangany Marakwet (CHÉMAWASCO).

Kulingana na David Kimitai, Mkurugenzi wa CHE-MAWASCO, mtambo wa sasa wa kusafisha maji umekuwa duni katika kuhudumia wakazi wanaoongezeka wa mji huo.

"Kiwanda cha sasa hakiwezi kukidhi mahitaji ya wakazi

wengi kutokana na mgao wa maji. Mara tu kiwanda kipyaki kapojengwa, kiwango cha maji kinachopatikana kwa kila mita ya ujazo kitaongezeka, na kuhakikisha kuwa wakazi wanapata maji saa 24 kwa siku," Kimutai alisema.

Masuala ya mazingira pia yametolewa kama sehemu ya upangaji wa mradi. Cloud Lumumba, mwanamazingira katika LVNWDA alieleza hitaji la mji wa ziada ya mita za ujazo 2,500 za maji kila siku. "Ili hili liwezekane, ni lazima tujenge mfumo wa majitaka unaotegemewa ili kushughulikia utokaji. Takriban asilimia 80 ya maji yanarudishwa kwa mazingira, kwa hivyo udhibiti sahihi wa taka ni muhimu," Lumumba alisema wakati wa kongamano la ushiriki wa umma katika mji wa Kapsowar.

Alisema, "Tulizingatia kwa makini ardhi na mteremko wa eneo hilo, huku mji ukielekea maeneo mawili mashuhuri. Maeneo matatu yalizingatiwa kwa mfumo wa maji taka, Kapsowar, Kipsaiya, na Kap-

"Wakati pendekezo la kiwanda kikubwa zaidi cha matibabu lilipowasilishwa, swali liliibuka kuhusu kudhibiti taka. Mfumo wa mifereji ya maji taka ukawa sehemu muhimu ya mpango huo, na tumetambua Ng'orng'oro huko Kapsowar kama eneo kuu la kutibu taka," aliongeza.

Vincent Otieno, mhandisi katika LVNWDA, alitoa mwanga juu ya vipengele vya kifundi vya mfumo wa maji taka, akielezea kuwa usafi wa mazingira unahusisha hatua mbili muhimu: usafishaji katika eneo na nje ya eneo.

Alisema, "Tulizingatia kwa makini ardhi na mteremko wa eneo hilo, huku mji ukielekea maeneo mawili mashuhuri. Maeneo matatu yalizingatiwa kwa mfumo wa maji taka, Kapsowar, Kipsaiya, na Kap-

samai. Laini kuu ya maji taka itapita kando ya bonde, na Ng'orng'oro kama kituo kikuu cha matibabu.

Otieno aliangazia kuwa Kapsowar imekuwa ikikabiliwa na magonjwa yanayosababishwa na maji kutoptana na ukosefu wa mfumo wa maji taka. "Bila ya usafi wa mazingira, magonjwa yanayotokana na maji yamekuwa wasiwasni. Mfumo wa maji taka utakuwa muhimu katika kushughulikia suala hili".

Pia alitaja kuwa ingawa Arorr ilizingatiwa kama eneo lin-alowezekana la usimamizi wa taka, ilionekana kuwa haiwezi kutumika kwa sababu ya wasiwasni wa usalama na eneo lake lenye mwinuko.

"Msimamo wa Arorr ni mzuri kwa usambazaji wa maji lakini si kwa usimamizi wa maji taka," Otieno alibainisha, aliongeza

kuwa mipango ya kuboresha usambazaji wa maji ya Arorr bado itaendelea, ikiwa ni pamoja na ufungaji wa tank kubwa la maji taka baadaye baada ya kuboresha usambazaji wake wa maji.

Katika maeneo ya vijijini ambako mfumo wa maji taka unawenza usifikie kama vile Lawich na Sisiya, vitalu vya udhu vyenye vyoo na bafu vitajengwa. "Vitalu hivi vya udhu vitahudumia maeneo ambayo hayajafunika na njia kuu za maji taka," Otieno alieleza.

Msimamizi wa Wadi ya Kaunti Ndogo ya Marakwet Magharibi, Patrick Maiyo, aliwataka wakazi kuunga mkono kikamilifu mradi huo, akitisitiza manufaa ambayo utaleta katika mji huo.

"Ikiwa tutakumbatia mfumo wa maji taka na mtambo wa kusafisha maji, Kapsowar itaborehwa, "alisema Maiyo.



Alisema utafiti alioufanya hivi karibuni katika maeneo ya migodi ulibaini kuwa watu wengi

walikuwa wakilalamika kuumwa na kichwa hasa nyakatia zioni na kifua.

“Kulikuwa na kundi hili la wanawake amba walizungumza kuhusu kuharibika kwa mimba mara kwa mara mionganini mwa madhara mengine,” Dk. Orwa alisema.

Alisema utupaji taka usiofaa unasababisha viumbe vya kemikali vilivyooshwa na maji kupita kwenye vyanzo vya maji.

“Nina uhakika kemikali hizi zimeingizwa hata kwenye mimea ambayo wanyama hulisha baadaye na baada ya muda mrefu, binadamu hula mimea na wanyama,” alisema.

Mbali na changamoto za utupaji taka za madini, wanasayansi hao pia walitoa wito wa kuzingatiwa kwa haraka kwa usimamizi wa taka za plastiki.

Kulingana na Dkt. Christine Betty Nagawa wa Chuo Kikuu cha Makerere, mabadiliko ya halijoto husababisha kuharibika kwa plastiki hadi plastiki ndogo ambayo huathiri afya ya binadamu na wanyama.

“Tunaishi katika enzi ya plastiki ambapo karibu kila kitu tunachotumia kimetengenezwa kwa plastiki,”

Dkt. Nagawa alisema na kuongeza, “Chembe za plastiki zisizozidi milimita tano zina athari kwa afya ya binadamu, wanyama na mazingira.” Kwa mfano wa uharibifu wa mazingira, Dkt. Nagawa alisema tafiti za hivi karibuni zimeonyesha kuwa samaki katika ukanda huo hawazaliani tena kwa kiwango kinachotarajiwa kwa sababu plastiki ndogo hujilimbikiza kwenye utumbo na viungo vyao vya uzazi.

Serikali ya Trans Nzioa inapanga kutoka huduma kwa njia ya kidijitali katika vituo vyote vya afya katika eneo hilo.

Akizungumza baada ya kufanya mukutano wa mashauriano na wawakilishi wa USAID Ampath Uzima katika makao makuu ya kaunti, Gavana George Natembaya alisema uwekaji wa huduma za afya katika vituo vyote vya afya katika kidijitali ni eneo la kipaumbele kwa serikali yake.

Alielea kuwa pindi itakapotekelezwa, utoaji wa huduma utaimarishwa katika ngazi ya vituo kando na kuimarisha mifumo ya afya ya jamii.

“Hivi karibuni tunazindua mpango wa mafaribio wa mpango huu katika Kaunti Ndogo ya Endebees tukiwa na matumaini kamili ambayo pindi tu yatakopotekelezwa yatakuza uwezo wa kaunti yetu katika kujitegemea katika huduma ya afya katika njia ifaayo,” akasema.

Akipongeza USAID Ampath Uzima kwa mchango mkubwa amba Shirika hilo limepiga katika sekta ya afya, Gavana Natembaya alisema uhusiano wa karibu wa kufanya kazi na washirika wa maendeleo ni sehemu muhimu ya kutimiza ndoto za maendeleo ya kaunti zaidi katika sekta ya afya.

Katika mwaka uliopita wa kifedha wa Ampath, Gavana Natembaya alifichua kuwa kaunti ilipokea takriban Sh213 milioni kutoka kwa shirika hilo ili kuboresha shughuli za afya.

Afya ya uzazi, afya ya mama na mtoto ilipata mgao mkubwa zaidi wa Sh137 milioni, Mpango wa HIV ulitengewa Sh64 milioni huku yatima na Wato wanaoishi katika mazingira magumu (OVC) wakipata Sh12 milioni.

Katika mijadala ulioweka kipaumbele kuanisha shughuli zijazo za Ampath katika mwaka mpya wa kifedha na maeneo ya kipaumbele ya serikali ya kaunti katika sekta ya afya, Gavana Natembaya alisema uwepo wa Ampath katika eneo hilo haulinganishwi katika sekta ya afya.

“Juhudi na dhamira ambayo Ampath imeweka katika kuboresha huduma za afya katika kaunti yetu haiwezi kulinganishwa. Tukiendelea mbele, tunaahidi kuendelea kukuza mahusiano hayo ambayo yana manufaa makubwa kwa watu wetu,” alisema na kuongeza kuwa rasilimali ambazo shirika limetenga kwa ajili ya kuendelea kusaidia zitasaidia kuendeleza huduma muhimu za afya.

Wakulima 4,000 wanufaika na mbegu za alizeti zilizoidhinishwa Nakuru

Takriban wakulima 4,000 walipokea mbegu za alizeti zilizoidhinishwa kutoka kwa Serikali ya Kaunti ya Nakuru katika hatua iliyo-lenga kuimarisha uzalishaji wa alizeti katika eneo hilo ili kupunguza bili za uagizaji wa mafuta ya kula na bei ya chini ya mafuta ya kupikia nchini.

Afisa wa Mazao wa Kaunti hiyo Bi Lilian Samoei alisema kuwa kilo 15,000 za mbegu zilizoidhinishwa zilisambawza kwa wakulima waliosajiliwa ili kupandwa kwenye ardhi ya ekari 5,000 kote kaunti hiyo.

Alibainisha kuwa kaunti inalenga kuongeza ekari inayotolewa kwa kilimo cha alizeti hadi zaidi ya ekari 15,000 katika muda wa miaka mitatu ijayo katika kaunti ndogo kumi na moja.

Akiangazia kwamba Kenya hutumia angalau Sh160 bilioni kila mwaka kuagiza mafuta ya kula, hasa kutoka nchi za Kusini-mashariki mwa Asia, afisa huyo wa mazao alisema kuwa utawala wa Gavana Kihika umeanza-sha mradi wa kukuza alizeti ili kuongeza uzalishaji wa ndani wa zao la mafuta

na kusaidia kukabiliana na kupanda kwa gharama za mafuta ya kula. nchini.

Afisa mazao aliezea kuwa mpango wa alizeti ulikuwa unaratibu usambazaji wa nyenzo za upanzi zilizoidhinishwa kwa wakulima, mbolea ya ruzuku, kutoa uhusiano wa soko na kuongeza thamani ili kukuza kipato cha wakulima.

Afisa huyo aliongeza kuwa serikali ya kaunti imedhamiria kuwawezesha wakulima kupata mbegu bora za alizeti na kuimarisha huduma za kilimo kwa wakulima ili kuongeza bidhaa za mafuta ya kula.

"Tunakuza uzalishaji wa alizeti ili kuweka pesa mikononi mwa watu wetu," Bi Samoei aliongeza.

Afisa mazao alisema aina mbili kuu za alizeti ambazo ni aina ya mseto na aina ya uchavushaji wazi (OPV)

kwa sekta ya umma na binafsi utawala wa Gavana Kihika ulikuwa unawawezesha wakulima kupata huduma kama vile kulima ardhi, usimamizi na huduma za ugani wakati wa uenezi.

Afisa huyo alisema ya kaunti imejitolea kusaidia wakulima ili kuhakikisha wanalima alizeti kwa njia ya kuridhisha, na kuongeza kuwa siku za usoni kaunti ina nia ya kuwasaidia kwa mashine za kuwawezesha kuzalisha mafuta yao ya kupikia kwa ajili ya kuuza katika masoko ya humu nchini. Alikuwa na matu-

maini kwamba uzalishaji wa mafuta ya kula utasaidia kuondoa umaskini katika eneo hilo na aliwaambia wakulima kuchukua hatua hiyo kwa umakini ili kuhakikisha wanavuna kiasi kilicholengwa cha alizeti kwa kutumia kanuni bora za kilimo.

Bi Samoei alisema serikali ya kaunti inahimiza kilimo cha mazao ya mafuta ili kupunguza bili ya kuagiza mafuta ya kula na kupunguza bei ya mafuta ya kupikia nchini Kenya.

Alisema ingawa alizeti inastahimili ukame na inaweza kuendana na maeneo mengi ya kikolojia, Kenya kwa sasa inazalisha chini ya asilimia 50 ya mahitaji yake.

Serikali yaanza ujenzi wa barabara ya kupitia juu ya Ngong kwa gharama ya 3B

■ Ujenzi wa daraja la juu ya Sh3.58 bilioni la Barabara ya Ngong Road-Naivasha jijini Nairobi umeanza, kulingana na Afisa Mkuu wa Mawasiliano wa Mamalaka ya Barabara za Mijini (KURA) John Cheboi.

Cheboi alisema kuwa mradi

huso ulio katika Junction Mall, unalenga kuimarisha ufanisi wa Barabara ya Ngong kupitia mgawanyo wa daraja ili kubakiliana na msongamano wa magari unaoendelea.

"Mradi huo unafadhiliwa kikamilifu na mkopo wa masharti naafuu wa Sh3.58 bilioni (EUR 25.3 milioni) kutoka kwa Mfuko wa Kimataifa wa Mashirika ya Serikali ya Uhispainia (FIEM) na unatarajiwu kuhakimilika Julai 2027," alisema. Cheboi pia alifichua kuwa mradi huo una-

lingana na mifikia mpana wa serikali wa kuimarisha miundombinu, unaolenga kukuza ukuaji wa uchumi wa muda mrefu na kuimariswa mifumo ya uchukuzi mijini.

"Mpango huu umeundwa

kusaidia maendeleo ya nchi na kurahisisha usa-firishaji wa watu na bidhaa kote Nairobi," alisema. Cheboi alifichua kuwa Barabara mpya ya Ngong Road-Naivasha Flyover italeta manufaa mbalimbali kwa wakazi wa Nairobi, kuanzia na kupunguza kwa kiasi kikubwa msongamano wa magari.

"Kwa kuondoa vikwazo katika makutano muhimu, barabara ya juu itapunguza sana muda wa kusafiri kwa madereva, watumiaji wa usafiri wa umma, na watembea kwa miguu sawa.

"Usalama pia utaimarishwa kupitia kujumuishwa kwa vifaa vya usafiri usio wa magari (NMT), kuhakikisha usafiri salama kwa watembea kwa miguu na waendesa baisiki, huku uwekaji wa taa za kisasa za barabarani uboresha mwonekano," alisema.

Cheboi alisema mifumo iliyoboreshwa ya mifereji ya maji itasaidia kupunguza hatari ya mafuriko ya mara kwa mara.

Wanafunzi wa Kenya kupokea mafunzo ya ubaharia Uholanzi

■ Mamlaka ya Usafiri wa Baharini ya Kenya, kwa ushirikiano na Chuo cha Bahari cha Kenya Bandari, itatoa mafunzo kwa kada kumi kupitia mpango mpya unaotolewa na kampuni ya usafirishaji ya Maersk Ltd, kwa lengo la kuimarisha elimu ya baharini.

Katibu Mkuu wa Masuala ya Meli na Meli, Geoffrey Kaituko, alipata fursa hii ya mafunzo wakati wa ziara yake ya hivi karibuni huko Copenhagen, Denmark. Mafunzo hayo yatakayofanya kila mwaka yataendeshwa ndani ya meli za Maersk kwa muda wa miezi kumi na mbili.

Kaituko alibainisha kuwa uhusiano huu baina ya nchi mbili na Denmark umeimarishwa, na kuashiria mojawapo ya matokeo chanya kutoka kwa Mkataba wa Maelewano wa 2021 (MoU). Aliyezea kuwa MoU inayosubiri kutekelezwa inalenga katika kuimarisha elimu na mafunzo ya baharini kupitia makubaliano na Bandari Maritime Academy.

Alisitisiza kwamba wanabahari wa Kenya wataniafaika na Mafunzo ya Wakati wa Bahari, ambayo yanalenga kuwapa ujuzi

muhimu kabla ya kuajiriwa na kampuni moja kuu ya meli duniani.

"Wakati wa baharini ni moja ya mahitaji ya lazima kwa kadeti kabla ya kupata kazi kwenye meli. Hii imetuwa changamoto kwa makadeti nchini Kenya, kwani nchi haina kundi la kitaifa la meli za wafanya-biashara," alisema Kaituko. Waziri Mkuu aliyasema haya wakati wa mukutano na waandishi wa habari kuhusu Mafunzo ya Wakati wa Bahari yaliyotolewa kwa wanafunzi wa Kenya na kampuni ya Maersk Ltd mjini Nairobi. Aliangazia fursa kwa Wakenya kupata mafunzo baharini na uwezekano wa kupata ajira na Maersk na kampuni zingine. Mpango huo utakaoendeshwa kila mwaka, unatarajiwu kufunga fursa zaidi katika sekta ya bahari.

Kaituko pia alidokeza kuwa Uchumi wa Bluu ni mojawapo ya sekta muhimu zinazobukia zinazoweza kusukuma ukuaji wa uchumi wa Kenya. Alisema alishiriki katika mukutano wa ngazi ya juu wa Usafirishaji Salama na Uondojo kaboni.

"Hii itatuwezesha kuhi-fadhi soko la faida la Umoja wa Ulaya, ambalo linachukua zaidi ya asilimia

lake kwenye uharibifu wa misitu na upotevu wa bayo-anuwai na kukuza bidhaa zisizo na ukataji miti.

Bw Gachagua, ambaye alitwikwa jukumu la Rais William Ruto kuongoza mageuzi katika Sekta Ndogo ya Kahawa, alisema hatua zinachukuliwa kuhakikisha sekta ya kahawa inawiana

na kanuni za Ulaya dhidi ya ukataji miti.

Wakati huo huo, Naibu Rais alilitwaka vyama vya ushiriwa vya Kahawa kuchapisha na kutoa maelezo ya kina kuhusu gharama zao za kifedha na makato kwa wanachama wao.

Hii inakuja huku kukiwa na juhudni kubwa za kuimarisha usimamizi bora wa fedha katika harakati za ushiriwa kupitia marekebisho ya sheria, udhibiti na sera pamoja na sekta ndogo ya kahawa.

Bw Gachagua aliwataka maafisa wa usimamizi wa Sacco kufichua kikamilifu gharama za kifedha.

Aliezea kuwa jambo hilo litawawezesha wakulima kuhoji gharama zozote wanazoziona ni za kutiliwa shaka, hivyo kuchangia katika utawala bora na uwajibikaji wa jamii.
