Naibu Mkuu wa Wafanyakazi wa Usimamizi wa Utendaji na Utekelezaji, Eliud Owalo, asema serikali inatathmini ni kwa kiasi gani wizara, idara na mashirika (MDAs) zimeoanisha Mipango yao Mkakati na mfumo mzima wa sera

Serikali imeanzisha mpango wa kuthibitisha mikataba ya utendaji kazi kwa mwaka wa fedha 2024/25 ili kuimarisha utoaji wa huduma na kuharakisha kufikia malengo yake ya maendeleo.

Naibu Mkuu wa Utumishi na Usimamizi wa Utekelezaji, Eliud Owalo, alisema kuwa serikali inatathmini ni kwa kiasi gani wizara, idara na wakala (MDAs) zimeoanisha mipango mkakati yao ya kipindi cha 2023/24 hadi 2027/28 na jumla ya mfumo wa sera. Mfumo huu umejikita katika Ajenda ya Mabadiliko ya Kiuchumi ya Chini-juu (BETA).

Owalo alieleza kuwa taasisi zote za serikali zimeoanisha mfumo yao ya sera na Mpango wa Nne wa Muda wa Kati (MTP4 2023-2027) wa Dira ya 2030,

mpango wa BETA, pamoja na mifumo mingine kama vile Ajenda 2063 ya Umoja wa Afrika (AU) na Maendeleo Endelelu. Malengo (SDGs).

"Ili kutekeleza mipango hii, wizara husika zimeandaa mpango kazi ya mwaka ambayo kandarasi za utendaji za mwaka zimejikita. Mantiki ya mfumo wa kandarasi ya utendakazi ni kushikilia taasisi na watu binafsi kuwajibika kwa matokeo yao," Owalo alisema.

Alisisitiza kuwa mwanzoni mwa kila mwaka wa fedha, Wizara, Idara na Wakala zote za Serikali zinatakiwa kusaini mikataba ya utendakazi, kwa kuzingatia viwango vya chini vya ufaulu wa kiasi na ubora.

Shule za Sekondari za Vijana kote nchini zitaanza kupokea vitabu vya darasa la 9 kuanzia mwezi ujao.

Ugawaji huo umepangwa kuanza Oktoba 1 mwaka huu hadi Januari 31, 2025, katika shule zaidi ya 20,000 zilizotambuliwa kuwa mwenyeji wa Shule za Sekondari za Vijana (JSS), kama ilivyotathminiwa na Wizara ya Elimu. Mpango huu ni sehemu ya mpango wa serikali wa kusambaza vitabu zaidi ya milioni 9.6 kwa shule za msingi za umma nchini kote, ukilenga wanafunzi kutoka darasa la 1 hadi la 9 ifikapo mwaka ujao. Katibu wa Elimu ya Msingi, Dkt. Belio

Kipsang, alisema kuwa serikali ina furaha kufikia uwiano wa 1:1 katika mwanafunzi na kitabu. Alibainisha kuwa Kenya ni nchi ya kwanza Afrika Mashariki kutekeleza sera katika sekta ya elimu ambapo kila mwanafunzi wa darasa la 1 hadi 9 atakuwa na kitabu chake cha kujifunzia.

"Serikali iko mbioni kufikia uwiano wa 1:1 katika mwanafunzi na kitabu ili kuhakikisha ufundishaji na ujifunzaji mzuri katika shule kote nchini. Vitabu hivi vinatara-jija kufikia shule zote ambazo zimepatikana zinafa kudahili wanafunzi wa darasa la 9," Dkt. Kipsang alisema.

Usambazaji vitabu vya Darasa la 9 kuanza Oktoba katika shule za JSS

ENDELEA KUTOKA UK 1

Akizungumza katika Kaunti ya Nakuru baada ya kutathmini utayari wa kuwabadilisha wanafunzi hadi darasa la 9, Dkt. Kipsang alithibitisha kuwa serikali itatoa vitabu vyote tisa vya masomo ya kutahiniwa.

"Taasisi ya Ukuzaji Mtaala ya Kenya (KICD) imetayarisha nyenzo zote za kufundishia kwa wanafunzi wa Darasa la 9. Pamoja na wachapishaji wetu, tumechapisha vitabu vyote vinavyohitajika. Usambazaji unaanza Oktoba na utakamilika Januari mwaka ujao," aliongeza.

Katibu alisisitiza kuwa ni vitabu vilivyoindishwa na KICD pekee vinavyopaswa kutumiwa, kwani vimefanyiwa tathmini ya kina ili kuhakikisha vinaafiki mahitaji ya mtaala. Dk. Kipsang pia aliorodhesha baadhi ya wachapishaji waliopewa kandarasi ya kuchapisha na kusambaza vitabu vya darasa la 7 vya masomo mbalimbali, vikiwemo Oxford University Press, Kenya Literature Bureau,

East African Educational Publishers, Longhorn Publishers, Storymoja Publishers, Mountain Top Publishers, Jomo Kenyatta Foundation, Spotlight, Wachapishaji, na Moran Publishers, miongoni mwa wengine.

Alikariri kuwa vitabu vilivyoindishwa vinakidi viwango vya kimataifa. Ingawa shule za umma zitapokea vitabu hivyo, shule za kibinasi zitahitaji kuvinunua kutoka kwa maduka ya vitabu kote nchini.

Dkt. Kipsang pia alithibitisha dhamira ya serikali, kupitia Tume ya Huduma kwa Walimu (TSC), kutoa ajira ya kudumu kwa walimu tarajali zaidi ya 46,000 wa Shule ya Sekondari ya Vi-jana (JSS). Alieleza kuwa serikali imetenga Sh18 bilioni kwa TSC kubadilisha walimu tarajali hadi nyadhifa za kudumu na za pensheni.

"Walimu hawa wanganenzi wametekeleza jukumu muhimu katika kuimashwa JSS katika kipindi cha miaka mitatu iliypita. Tume ya TSC pia inapitia mchakato wa upatanishi, ambao

utatoa maendeleo ya kazi kwa walimu ambao wameendeleza sifa zao za kitaaluma, "alisema.

Mara tu walimu wa sasa wa tarajali watakapothibitishwa, serikali inapanga kuajiri walimu tarajali wa ziada 20,000, na kufanya jumla ya walimu wa JSS kufikia 76,000.

Zaidi ya hayo, serikali inajenga madarasa 11,000 nchi nzima ili ku-saidia utekelezaji kamili wa shule za msingi za sekondari. Wakati huo huo, Waziri Mkuu alitangaza kuwa fedha za Sh3,000 zilizotengwa kwa shule zitatumika kwa matengenezo na samani za madawati.

Kipsang pia alifichua kuwa mnamo Ju-lai mwaka huu, Wizara ilifanya tathmini ya awali ya majoribio kwa wanafunzi wa darasa la 9 ili kuwasaidia walimu kuijandaa kwa tathmini za mwaka ujao. Tathmini nyininge ya majoribio imepangwa kufanyika baadaye mwaka huu kwa wanafunzi wa darasa la 6, kwa kuakisi mtihani watakaufanya Novemba mwakani.

ENDELEA KUTOKA UK 1

Owalo albainisha kuwa mojawapo ya mae-neo muhimu ya kuzingatia ni kufuata ajenda ya serikali ya uwekaji digitali, haswa ujumuishaji wa huduma kwenye juk-waa la e-Citizen. Mpango huu unalenga kuongeza ufanisi na kwa njia ya kuendesha. "Pia tunatathmini utumiaji wa fedha za wafadhili ili kuhakikisha thamani yake inakuzwa na kutathmini ufanisi wa matumizi ya fedha," aliongeza. Owalo alieleza kuwa timu ya Utendaji na Usimamizi wa Utekelezaji pia inatathmini utekelezaji

wa maamuzi ya Baraza la Mawaziri, hasa katika kesi ambapo ucheleweshaji umetoka katika kubadilisha memo za Baraza la Mawaziri kuwa mifumo wezeshi ya sera au sheria zilizopitishwa bungeni. Alisisitiza mafanikio ya Wizara ya Kilimo katika miaka miwili iliyopita. miaka, ikiwa ni pamoja na utekelezaji wa programu ya kina ya ruzuku ya mbolea ambayo imepunguza kwa kiasi kikubwa gharama ya mbolea kwa wakulima wadogo.

Usambazaji wa mifuko

ya mbolea uliongezeka kwa milioni 7.2, kutoka milioni 1.4 mwaka 2022 hadi milioni 8.6 ifikapo 2024, ikiwa ni ongezeko la 514%. Zaidi ya hayo, gharama ya mbolea kwa kila gunia ilishuka kutoka Sh7,500 mwaka wa 2022 hadi Sh2,500 mwaka wa 2024, punguzo la 66%, ambalo limesababisha kuongezeza kwa mazao na kuimarka kwa usalama wa chakula. Owalo pia albainisha kuwa wizara imefaulu kupunguza gharama ya pakiti ya kilo mbili ya unga wa mahindi ("unga") kutoka Sh250 hadi Sh120.

Uingereza yajitolea kutekeleza mageuzi ya kidijitali katika sekta ya kilimo Kenya

Uingereza imejitolea kuunga mkono serikali ya Kenya katika kuimarisha mageuzi ya kidijitali nchini.

Akizungumza wakati wa uzinduzi wa mpango kazi wa jamii na jukwaa la kidijitali la kilimo katika Kituo cha Mafunzo ya Kilimo cha Busia, Naibu Balozi wa Uingereza nchini Ed Barnett alisema kwamba Uingereza ina mengi ya kujifunza kutoka kwa wavumbuzi wa Kenya na pia Kenya kutoka kwa Uingereza. "Hapa Busia, tunataka kutafsiri ahadi hiyo katika malengo yanayoonekana kupitia usaidizi wa majukwaa ya kidijitali ya kilimo," alisema.

Dkt. Barnett alitangaza kuwa Uingereza itaanisha mradi wa Sh390 milioni katika Kaunti za Busia na Mandera ili kusaidia vijana, wanawake na watu wenye ulemavu.

Aidha alisema mradi huo utatoa ujuzi wa kusoma na kuandika wa kidijitali kwa wakulima na wananchi wengine ili ku-

wawezesha kutumia zana na majukwaa ya kidijitali kupata maudhui na huduma muhimu.

"Itawafundisha vijana kukuza ujuzi wao wa kidijitali kama mabingwa wa kidijitali wa jamii, watapitisha mafunzo haya ambayo yanajumuisha ujuzi wa kifedha, ujasiriamali na afya ya kisaikolojia-kijamii na kiakili kwa

jamii pana," alisema.

Afisa huyo aliongeza kuwa mradi huo ni sehemu ya mpango mpana wa kufikia kidijitali kote nchini Kenya ulioanza mwaka wa 2019 na ume-wafikia zaidi ya watu milioni tano.

"Ukiangalia takwimu, malipo ya bonasi katika viwanda vingi vya KTDA yameboreshwa na ni ya juu zaidi katika idadi ya viwanda, hasa mashariki mwa Bonde la Ufa," alisema.

Kiwanda cha Chai cha Gacharage kutoka Kaunti ya Murang'a kinaongoza orodha ya viwanda vinyosimamiwa na KTDA vilivyo na malipo ya juu zaidi ya bonasi, kikanganza kiwango cha Sh62.80 kwa kilo. Inafuatwa na Mununga kwa Sh62.65,

huku Makomboki ikishika nafasi ya tatu kwa kima cha Sh62.50.

Naibu Rais Gachagua alibainisha kuwa maandamano ya wakulima katika maeneo kama vile Githambo Tea Factory huko Murang'a, pamoja na viwanda vingine katika kaunti za Nandi na Bomet, ni sehemu ya mageuzi yanayolenga kuwaelimi-

sha wakulima wadogo.

"Maandamano yanafanya katika maeneo am-bayo wakurugenzi wa chai wameongeza gharama ya uzalishaji, na wakulima wanazua maswali kutokana na uelewa wao zaidi."

Wakurugenzi wamekuwa na safari nyingi na posho, hivyo gharama ya uzalishaji ni kula kwa

faida ya mkulima wa chai. Wakulima wanafahamu kwa sababu ya mageuzi," aliongeza.

Naibu Rais alisema wakulima watapata faida zaidi pindi Sheria ya Chai itakapotekeleza kikamilifu kufuatia kuondolewa kwa kesi mahakamani ambazo zili-kuwa kikwazo.

"Nilifanya kongamano

la chai huko Kericho na kuwaleta pamoja wadau wote. Lakini kulikuwa na tatizo kubwa katika utekelezaji wa Sheria ya Chai kwa sababu wadau mbalimbali walikuwa wamekwenda mahakamani. "Kupitia uingiliaji wangu, nimefanikiwa kujadili kesi hizo zote ili ziondolewe, na Sheria ya Chai itatekelezwa hadi mwisho na wakulima watapata faida kwenye uwekezaji," Bw Gachagua alisema. Alisema kuwa alikuwa amefungua mwamo katika Mnada wa Chai wa Mombasa na hisa sasa zinaendelea.

"Tulikuwa na changamoto na chai kutoka Mkoja wa Magharibi wa Bonde la Ufa (Kericho, Bomet na Nandi) kwa sababu walikuwa wameweka bei iliyohifadhiwa ambayo ilikuwa ya juu sana dhidi ya ubora, kwa hivyo, hisa hazikuwa zikisonga.

Wizara ya Afya inatekeleza Mfumo wa Kusimamia Teknolojia ya Habari ya Huduma ya Afya (IHTS) ili kufanya huduma za afya ziweze kumudu na kufikiwa na Wakanya wote. Katibu wa Huduma za Matibabu Harry Kimutai anasema kuwa wizara hiyo imejitolea kuafikia Mpango wa Afya kwa Wote (UHC) ili kuhakikisha kuwa kila Mkenya anapata huduma bora za afya, bila kujali eneo au hali ya kiuchumi.

Katika taarifa kwa vyombo vya habari, Kimutai alisisitiza kuwa ahadi hii si mradi tu bali ni dhamira ya kitaifa ya kuokoa maisha, kuokoa muda na kupunguza gharama kwa Wakenya wote. Ili kusaidia utekelezaji wa mpango wa UHC, Katibu alitangaza kwamba Wizara ya Afya imetua kandarasi ya utekelezaji wa IHTS kwa muungano unaoongozwa na Safaricom Plc. Muungano huo unajumuisha kampuni ya kimataifa ya kuweka kidijitali ya kuhudumia wagonywa ya Apeiro Limited (Apeiro Digital) na kampuni ya teknolojia ya biashara ya Konvergenz Network Solutions Limited (KNS). The National Biosafety Authority is a State Corporation established under Section 5 of the Biosafety Act, No. 2 of 2009, to exercise general supervision and control over the transfer, handling and use of genetically modified organisms (GMOs) with a view to ensuring safety of human and animal health and provision of an adequate level of protection of the environment.

The Authority wishes to bring to your attention the provision of Section 18(1) of the Biosafety Act which prohibits any person from conducting any activity involving genetically modified organisms (GMOs) without the written approval of the Authority. These activities include research, placing on the market, import, transit or export of GMOs.

By virtue of the above provision, this notice requires that any person or institution carrying out any of the above activities involving GMOs, including in plants, animals, microorganisms, and research in pharmaceuticals and vaccines should first seek and obtain approval from the Authority; and those with ongoing research to regularize their projects within three (3) months from the date of this notice. Under Section 3 of the Act, finished and approved pharmaceutical products for human use which are or may be products of genetic modification are exempt from this notice.

THE RATIONALE FOR PERFORMANCE CONTRACTING IN THE PUBLIC SERVICE

In 2001, the Government of Kenya launched several reform initiatives to enhance performance in the public service and ensure effective service delivery. These initiatives were grounded in a Results-Based Management (RBM) framework and included the introduction of Strategic Planning, Annual Work Planning, Performance Contracting, Rapid Results Initiatives (RRI), Programme-Based Budgeting (PBB), Monitoring and Evaluation, the Staff Performance Appraisal System (SPAS), and Business Process Re-engineering (BPR), among others.

The Government has been implementing these Performance Management initiatives to align planning, budgeting, implementation, and the delivery of targeted results. These initiatives also aim to accelerate the realization of the National Development Agenda, as outlined in Kenya Vision 2030 and its Medium Term Plans (MTPs), as well as the Kenya Kwanza Administration's Bottom-up Economic Transformation Agenda (BETA). They are integrated at the organizational level within the Strategic Plans for Ministries, Departments, State Corporations, and Tertiary Institutions (MDAs).

Performance Management aims to achieve the following objectives: provide a framework that connects national and MDAs' development planning, budgeting, and implementation processes to ensure optimal program execution and the delivery of targeted results; enhance the capacity of the public service to deliver services more efficiently and effectively; and focus public service efforts on facilitating the achievement of the National Development Agenda. Additionally, Performance Management establishes a framework for cascading strategic intent and promotes the participation of all stakeholders. It improves the implementation of projects and programs, enhances service delivery to citizens, and fosters a performance and results-oriented culture with the appropriate values and ethos within the public service. Furthermore, it links rewards and sanctions to performance outcomes.

Since its launch in 2004, Performance Contracting has been utilized by successive governments to drive the National Development Agenda and foster a results-based culture in public service delivery. It has ensured clear allocation of roles and responsibilities among various accountability centers, enhancing the overall performance of public institutions. Additionally, Performance Contracting has reduced duplication of functions among public sector organizations, improved the utilization of public resources, and boosted revenue generation. Furthermore, it has increased transparency in government operations and promoted accountability for results by linking rewards to measurable performance.

The Performance Contracts (PCs) for Government Ministries, Departments, and Agencies (MDAs) are derived from their respective Strategic Plans, which are aligned with the Fourth Medium-Term Plan (MTP IV) 2023-2027 and the Government's Bottom-up Economic Transformation Agenda (BETA). The commitments outlined in the Performance Contracts are based on each MDA's man-

date, priorities, approved budget, and Annual Work Plan for the financial year. They are also aligned with the available human capital and equipment or facilities necessary to support the achievement of set targets.

The target-setting process involves examining the baseline performance levels from the previous financial year, along with the available resources, systems, and the current operational environment to facilitate the achievement of the established targets.

Performance Contracts for Cabinet Secretaries for the current 2024/25 financial year were negotiated within the MDAs and vetted by a technical team from the Office of the Deputy Chief of Staff for Performance and Delivery Management in the Executive Office of the President. This process is followed by ongoing validation of commitments with Cabinet Sec-

retaries, aimed at establishing a common understanding and promoting ownership of the commitments outlined in the Performance Contracts. The validation also facilitates the clear apportionment of targets to accountability centers at various levels within the ministries. This exercise is a critical step in preparing for the signing of the Performance Contracts between His Excellency the President and the Cabinet Secretaries, ensuring effective leadership and implementation of the commitments.

Upon signing the Performance Contracts, all

Cabinet Secretaries will cascade their commitments to their respective Principal Secretaries, Heads of Directorates, Divisions, Sections, and Units, and ultimately to all officers within the respective MDAs. Additionally, Cabinet Secretaries are expected to sign Performance Contracts with state corporations and Semi-Autonomous Government Agencies (SAGAs) under their jurisdiction.

Every three months during the financial year, each State Department and its State Corporations are required to prepare and submit a Quarterly Performance Report, detailing their achievements against the set targets. A Mid-Term Review is conducted at the six-month mark to assess progress and identify strategies for accelerating results, particularly in areas where performance is lagging. At the end of the financial year, an Annual Performance Report is compiled, allowing for the evaluation of results and providing feedback to MDAs, along with key lessons for improving future performance.

In Performance Management, it is a widely accepted fact that people deliver what is inspected, not just what is expected, and what gets measured gets done.

One of the key challenges identified in the implementation of the Government's performance contracting system is the weak connection between actual performance by MDAs and the communication of results to key stakeholders, particularly the public. It has been observed that Government MDAs often achieve significant results with the potential for a positive impact, yet these achievements remain largely unknown to the public, who are the primary beneficiaries. To address this issue, the Office of the Deputy Chief of Staff for Performance and Delivery Management, in collaboration with all ministries, is launching a major awareness and publicity campaign aimed at informing the public about key results and milestones achieved by MDAs and their relevance to the daily lives of Wananchi. This campaign is also expected to provide an opportunity to gather feedback and enhance public confidence in government institutions.

It is H.E President Dr William Samoei Ruto's belief that everyone, one appointed to public service, is accountable for results to the citizens.

hivi majuzi na kurejeshwa katika nchi walizotoka kuto-kana na kuwepo kwa magonjwa ya nondo ya Uongo katika bidhaa hizo.

Alifichua kuwa mizozo inayoendelea duniani, ikiwa ni pamoja na vita vya Israel-Gaza na mzozo wa Russia-Ukraine, imeathiri kwa kiasi kikubwa sekta ya bustani ya ndani, na kusababisha kuongezeka kwa gharama za uzalishaji na bei ya juu kwa bidhaa zinazopelekwa kwenye masoko ya Ulaya.

“Migogoro ya kimataifa inayoendelea imeathiri usafirishaji wa mazao ya bustani njia ya bahari kutokana na mashambulizi kwenye njia muhimu hasa kwenye Bahari Nyekundu huku makundi ya waasi yakiongeza mashambulizi, na kuwalazimu wauzaji bidhaa kutoka nje kutumia njia mbadala, na kusababisha gharama kubwa za usafirishaji wa bidhaa zinazosafirishwa nje ya nchi,” McGonnell alisema.
