Tume ya Kuajiri Walimu (TSC) itanza kufunza upya walimu 70,000 kutoka shule za umma na za kibin-afsi, zikiwemo shule za watoto wenyewe mahitaji maalumu, ili kutayarisha kundi la kwanza la mtaala wa CBC kuingia Darasa

la 9 Januari. Akihutubia zaidi ya walimu wakuu 15,000 jijini Mombasa katika siku ya tatu ya kongamano la Chama cha Walimu Wakuu wa Shule za Msingi Kenya (KEPSHA), Afisa Mkuu Mtendaji wa TSC Dkt Nancy Macharia alisema Bunge la

Kitaifa limetenga Sh1 bilioni kwa zoezi hilo. "Maelezo kuhusu mafunzo hayo yametolewa, na mafunzo hayo yataanza baada ya kukamilika kwa mitihani inayoendelea ya KCSE," akasema Dkt. Macharia. Alisema Tume hiyo ilitoa mafunzo kwa walimu 60,642

Alitangaza pia kwamba Tume hiyo iko katika hatua za mwisho za kubadili walimu 46,000 wanaofanya kazi kama vibarua kuwa wa kudumu.

Alihimiza walimu wajitahidi akisema Darasa la 9 litakuwa kundi la kwanza kufanya mtihani ambaa utaamua kusajiliwa kwa shule za upili. Walimuwa shule za msingi wame-takiwa wakumbati ubunifu wa kidijitali ili kuhakikisha wanafunzi wanapata elimu bora bila kujali asili zao.

Mkuu wa Utumishi wa Umma, Felix Koskei, amehimiza walimu wafikirie jinsi wanavyoweza kushirikiana vyema na washikadau husika ili kuwapa wanafunzi uwezo, ujuzi, mitazamo na maadili yanayohitajika ili kustawi katika karne ya 21.

"Kwa kuwa tunasimama katika njia panda ya mapinduzi ya kidijitali, ni lazima tutambue kwamba elimu si njia ya maarifa tu; ni msingi wa uvumbuzi, usawa, na uendelevu," akasema Koskei akifungua Kongamano la Chama cha Walimu Wakuu wa Shule za Msingi (KEPSHA) mjini Mombasa. Kongamano hilo la 25, lililohudhuriwa na walimu wakuu zaidi ya 15,000, likiwa na mada: "Uongozi Badilifu katika Mpito wa Kidijitali kwa Elimu ya

Msingi Jumuishi na Endelevu Kenya." Koskei alisema safari ya kuelekea mfumo kamilwa elimu ya kidijitali inatokana na maono ya ujumuishi na maendeleo.

Alisema kuwa kwa kutumia teknolojia ya kidijitali, nchi itawea kupanua uwezo wa kupatikana kwa nafasi za mafunzo bora popote pale, hata maeneo ya mbali zaidi.

"Kupitia majukwaa ya kidijitali, wanafunzi katika maeneo ambayo hayajafikiwa vizuri wanaweza kuunganishwa na rasilimali za elimu sawa na walio katika maeneo ya mijini, na kuziba pengo katika usawa wa elimu.

iTax System Authentication Procedure for Mobile Phone Contacts

Kenya Revenue Authority (KRA) reminds all taxpayers that further to our Public Notice on "Taxpayer Register Data Clean Up Exercise" dated 24th June, 2024, all registered taxpayers are required to authenticate the mobile telephone number registered in iTax upon logging into the system.

The authentication procedure is as follows;

- Log in to the iTax system using your PIN number and password. iTax will display the current mobile phone number linked to your PIN.
- If the mobile telephone number displayed is **accurate and the preferred number**, click on "send verification code" and a code will be sent to the displayed mobile phone number.
- If the mobile telephone number contact is **not accurate or not the preferred number**, change the number on the displayed pop up to your preferred phone number and then click on "send the verification code". A code will be sent to the new preferred mobile phone number.
- Enter the verification code received on your selected mobile phone number to log into iTax.

Applicability of Insurance Relief to Contributions made to the Social Health Insurance Fund (SHIF)

Following the implementation of the Social Health Insurance Act, Kenya Revenue Authority (KRA) would like to provide clarity on the applicability of insurance relief to contributions made to the Social Health Insurance Fund (SHIF) as follows:-

- The Income Tax Act provides for insurance relief for a health policy whose term commences on or after the 1st January, 2007 or a contribution made to the National Health Insurance Fund (NHIF).
- The relief as provided refers to the NHIF under the National Health Insurance Fund Act, which was repealed by the Social Health Insurance Act.
- The relief as currently provided under the Income Tax Act **does not apply** to contributions made to the SHIF under the Social Health Insurance Act.

The Tax Laws (Amendment) Bill, 2024 has proposed an amendment to the law to provide for a deduction of the SHIF contributions against taxable income.

Serikali sasa yazindua mpango kabambe wa maendeleo kwa kaunti za kaskazini mwa Kenya

Serikali inatekeleza mpango mkuu wa maendeleo katika kaunti za Marsabit na Turkana ili kubadilisha mai-sha na kuharakisha ukuaji katika eneo hili linalokumbwa na umaskini. Mpango huo wa miaka sita wa Kuhimili Ukame Kaskazini mwa Kenya (DRPNK), ambaa unafadiliwa na serikali ikisaidiwa na Serikali Ujerumani kwa gharama ya Sh2,625 bilioni, ulianza katikati ya 2019.

Mpango huo, ambaa ume-pangiwa kukamilika Desemba 2025, unatarajiwaa kuweka msingi thabiti wa kubadilisha maisha ya zaidi ya watu 595,000 katika kaunti hizo mbili.

Katika maelezo yake, Gavana Ali alisema mpango huo unaafaa kwa mkoaa huo kwani utasidai katika kutafuta suluhu la tatizo la uhaba wa maji na kuimarisha uzalishaji wa chakula katika kaunti hiyo ambaa umetengewa Sh1 bilioni.

Alisema mipango ya kutilmia maji itaimarisha uwezo wa kilimo hivyo basi kuimarisha usalama wa chakula ambaa umeepukika katika eneo hilo kwa muda mrefu.

Aliwataka wakazi wa eneo hilo kuendelea kufanya shughuli mbalimbali za kiuchumi kwa kukumbatia kilimo cha mazao na hasa wakati huu ambapo fursa ya kufanya kilimo cha umwagiliaji inatolewa ili wajitegemee kwa chakula na kuongeza ziada kwa ajili ya kujoongezea kipato.

Kenya na China zimeanzisha ushirikiano wa kitalii wa muongo mmoja ili kui-marisha juhud za pamoja za kukuza uchumi na utamaduni wa pande zote. Katika mkutano uliofanyika jijini Nairobi, John Ololtuaa, Katibu Mkuu wa Wizara ya Mambo ya Nje ya Kenya ya Utalii na Lu Yingchuan, Naibu Waziri wa Wizara ya Utamaduni na Utalii ya China wame-sisitiza umuhimu utalii endelevu na kubadilis-hana utamaduni katika kukuza ustawi wa nchi zote mbili. "Mkutano huu ni zaidi ya mazungumzo ya kidiplomasia; ni uwekezaji katika mustakabali wa mataifa yetu. Maono yetu ya pamoja ya utalii endelevu yanaunda fursa ya kukuza uchumi wa ndani, kulinda urithi wetu wa

kitamaduni, na kuungan-ishia watu wetu," akasema Ololtuaa.

Utalii bado ni kichocheo chenye nguvu cha kiuchumi nchini Kenya, ukichangia asilimia nne katika Pato la Taifa (GDP) na kuzalisha nafasi za kazi milioni 2.3.

Asili yake ya elimu na uzoefu mkubwa wa kitaaluma husisitiza uongozi wake wa kipekee na ustadi wa kimkakati, akiedeleta uvumbuzi kila wakati na kutoa matokeo yanayoonekana.

Bi Kiogora awali aliwahi kuwa Kaimu Afisa Mkuu Mtendaji wa Baraza la Kitaala la Vijana (NYC), wakala wa serikali chini ya Wizara ya Masuala ya Vijana, Uchumi wa Ubunifu na Michezo, kuanzia Agosti 2023 hadi Oktoba 2024.

Katika jukumu hili, aliongoza mipango inayolenga kuwawezesha vijana na kukuza ushiriki wao wadhati katika mabadiliko ya kijamii na kiuchumi.

Wakati wa uongozi wake katika NYC, Kiogora alionyesha kujitolea kwa maendeleo na ushirikishwaji wa vijana na akitekeleza kwa ufanisi dhamira kuu ya shirika ya kuimarisha uwezo na ushirikiano wa vijana kupitia mipango ya ushirikiano na ushirikiano wa kimkakati.

Mafanikio yake ni pamoja na kuandaa kwa mafanikio Mkutano wa kihistoria wa Vijana wa Connekt Africa huko Nairobi (Desembba 2023), ambaa ulivutia mkusanyiko wa kuvutia wa zaidi ya wajumbe 20,000 kutoka zaidi ya mataifa 40.

Aliongoza utekelezaji wa Mpango Mkakati wa NYC (April 2024) na kuratibu kwa mafanikio maa-dhimisho ya Wiki ya Kimataifa ya Vijana kwa miaka miwili mfululizo (2023 na 2024).

Akiwa kiongozi mashuhuri katika maendeleo ya vijana, Margaret alitekeleza jukumu muhimu katika kuunda sera za vi-

Mawazo yangu yametekwa na tukio la kushangaza sana ambapo Wakanya wanaonekana kushuku miradi mingi inayoanzishwa na serikali, ambayo baadhi yake huishia mahakamani, na kusababisha kuchelewesha utekelezaji wake. Inashangaza kutambua, kwa mfano, kwamba mageuzi ya Huduma ya Afya kwa Wote, maarufu kama SHA au SHIF, yamecheleweshwa kwa karibu mwaka mzima, tangu sheria hizo tatu mpya zikubaliwe na Rais William Ruto mnamo Oktoba 19, 2023, katika

Ikulu ya Nairobi. Rais Ruto alikuwa amepanga Machi 1, 2024, kuwa tarehe ya kuanza, lakini hii ilicheleweshwa kwa saba hadi Oktoba 1, 2024, kutokana na maelfu ya kesi mahakamani na migomo ya madaktari na wataalamu wengine wa matibabu.

Mabadiliko daima yanapingwa. Mpango wa BETA ni mpango endeleu unaobainisha vipaumbele muhimu: kilimo na usalama wa chakula, huduma ya afya kwa wote, makazi na maendeleo ya mijini, bishara ndogo na za kati, na mfumo mkuu wa digitali na uchumi wa ubunifu, kama vichochoe vikuu vya uchumi wetu. Nguzo hizi tano hazihitaji tu sera wezeshi na sheria bali pia miradi muhimu itakayosaidia kuzitimiza. Kwa mfano, mpango wa ruzuku ya mbolea ume-fanya maajabu katika kupunguza gharama ya maisha.

Kupunguzwa kwa mchango wa kila mwezi kutoka Ksh 500 hadi Ksh 300 kumeongeza idadi ya wanaonufaika amba wako wana mapato

ya duni. Zaidi ya hayo, ongezeko la michango ya Wakenya wanaolipwa huhakikisha kutakuwa na rasilimali za kutosha za kufadhili upya mfumo wetu wa huduma za afya. Mpango wa ujenzi wa nyumba pia una rasilimali nyingi kuititia ushuru wa nyumba, ambaa umefanya gharama ya kumiliki nyumba kuwa chini ya Ksh 500,000 kwa watu wenye mapato ya chini. Hakika, Hazina ya Hustler imewezesha zaidi ya Wakenya milioni 22 kupoza zaidi ya Sh51 bilioni kufikia sasa, ili kukuza biasara zao.

Hata hivyo, kuna baa-dhi ya miradi mikubwa ya miundomsingi ambayo ufadhili wake hauwezi kutegemea tu kodi au kukopa. Hii ni kuto-kana na kupungua kwa uwezo wa kukopa kujikosababishwa na deni lililokuwepo kabla ya utawala wa 5 kuingia madarakan na kushindwa kwa Mswada wa Fedha. Hii imesababisha serikali kugeukia Ushirika kati ya Sekta ya Umma na Kibinafsi (PPPs) kama njia mbadala ya kufadhili maendeleo.

PS Dagar noted that his officers including top management are committed to combating corruption guided by the overarching theme of enhancing governance and firmly upholding a zero-tolerance to corruption within the public service.

"In line with Ethics and Anti-Corruption, Corruption Prevention Committee Guidelines 2023, I appointed the State department for Transport Corruption Prevention Committee (CPC)

Serikali inakagua upya Sera ya Taifa ya Mbegu, 2010 na kuandaa sheria ya kisasa na jumuishi zaidi ya mbegu na aina za mmea ili kuongeza uzalishaji wa mbegu bora na kupambana na bidhaa ghushii. Katibu wa Baraza la Mawaziri la Kilimo na Maendeleo ya Mifugo Dk Andrew Karanja alisema wizara hiyo pia inashughulikia kuimarisha sera za kilimo zinazohusiana na mifumo ya kisheria inayounga mkono mifumo jumuishi ya mbegu na wakulima wa mbegu nchini ku-zalisha mbegu bora huku wakiimarisha ushindani wa sekta.

"Nchini Kenya, ambapo kilimo ni sehemu muhimu ya uchumi wetu, kuhakikisha upatikanaji wa mbegu bora ni muhimu katika kuflikia tija iliyoboreshwa na usalama wa chakula. Ni muhimu tutengeneze sekta thabiti na endelevu ya mbegu ambayo sio tu itaimarisha usalama wa chakula lakini pia kuwawezesha wakulima wetu na kuchoechea ukuaji wa uchumi," CS alisema.

Dkt Karanja, katika hotuba iliyosomwa kwa niaba yake na Naibu Mkurugenzi -Usimamizi wa Rasilimali za Mazao Leonard Kubok wakati wa Kongamano la 12 la Muungano wa Biashara ya Mbegu nchini (STAK) na Maonesho ya Mbegu, alisema Kenya kwa miaka mingi imeendeleza sekta ya mbegu iliyochangamka na yenye ushindani ambayo anasimama nje katika kanda na bara.

"Sekta yetu ya mbegu imefanywa huria, na jukumu la serikali limebaki kuwa la udhibiti wa sekta na udhibiti wa ubora. Huduma ya Ulaguzi wa Afya ya Mimea (KE-PHIS) imeendelea kuchukua jukumu muhimu la udhibiti katika kurahisisha shughuli za sekta ya mbegu ili kuhakikisha kwamba wakulima wanapata mbegu bora," CS alisema.

Dkt Karanja alisema uzalishaji wa mbegu zilizoidhinishwa umeimariika kwa kiasi kikubwa na kampuni za mbegu zinaendelea kuchukua jukumu kubwa katika utafiti, ufgaji, uzalishaji na biashara ya mbegu za aina bora za mazao.

"Pamoja na maendeleo yaliyopatikana, sekta ya mbegu inaendelea kukabiliwa na changamoto kubwa. Matumizi ya mbegu na mahitaji yameongezeka hasa kwa mbegu ya mahindi na mahitaji ya mbegu ya mahindi kwa mwaka ya tani 52,066 (MT) na mahitaji ya mbegu ya maharagwe ya MT 86,078. Hata hivyo, usambazaji wa makampuni ya mbegu hauwezi kukidhi mahitaji haya," akasema Waziri.

Dkt Karanja alisema kuwepo kwa mbegu ghushii bado nitatizo kubwa na licha ya jitihada za kutekeleza hatua za kiusalamu kama vile kuweka stika ili kuhakiki mbegu halisi, wakulima wengi bado wanakumbana na bidhaa feki ambazo husababisha mavuno duni na upotevu wa fedha.

Waziri huyo alieleza kuwa upatikanaji wa mbegu bora mara nyingi ni mdogo kutoptana na gharama kubwa, ambayo inaweza kuwa kikwazo kwa wakulima wadogo, na kuongeza kuwa bei ya mbegu bora ni kikwazo, hasa katika sekta kama kilimo cha viazi, ambapo wakulima wameonyesha kukatishwa tamaa na kilimo. uwezo wa kumudu aina zilizoidhinishwa.



Kulingana na Jonah Kipruto, Afisa Mkuu wa Ardhi, Nyumba, Mipango ya Kimwili, Maendeleo ya Miji, Maji, Mazingira na Mabadiliko ya Tabianchi katika Serikali ya Kaunti ya Nandi, baadhi ya miradi tayari inaendelea. Alithibitisha kuwa Sh30 milioni za awali zimefadili uwekaji wa minara mitatu ya juu ya mlingoti, na jukwaa la kisasa lime-

“Tumeweza kukamilisha taa tatu kati ya tano zilizopangwa,” Kipruto alisema katika mji wa Mosoriot alipokuwa akikutana na maafisa wa kitaifa wa KISIP 2 katika ziara yao ya maendeleo ya miradi huo. Kipruto alisema kuwa mwanakandarasi alifaulu kupewa zabuni ya Sh270 milioni iliyosalia baada ya kufuata utaratibu mkali wa utoaji zabuni.

“Hapa ni makazi ambapo

tunafanya kazi za miundombinu, kwa mfano tu-mekamilisha vitengo 35 vya vibanda vya soko katika hatua hii ya magari ya abiria ambayo tunakusudia kuhamishia kwa wafanyakishara wanawake ambaa sasa wanafanya biashara kando ya barabara,” alisema.

Afisa Mkuu huyo alifichua kuwa nia ya kuwashamisha wafanyakishara wadogo na magari ya abiria kando ya barabara inalenga kumpunguza ajali na kuleta utulivu katika mji una-

okua kwa kasi wa Nandi. Alisema ujenzi uliokusud-iwa wa hadi kilomita tatu za barabara kwa kiwango cha lami ndani ya mji wa Mosoriot ni sehemu ya kazi za miundombinu iliyopangwa kurekebisha viwango vya mji.

“Shughuli hizi zote zinazofanyika hapa zimeunda ajira haswa kwa vijana na wanawake, hali ambayo imepunguza uhalifu katika mji,” Kipruto alifchua.

Kulingana naye, gharama ya kununua ardhi

imepanda ghafla ndani ya mji wa Mosoriot kutoka Sh1 milioni hadi Sh2 milioni kwa kila shamba huku mahitaji ya nyumba za makazi na biashara yakivuka mipaka.

Robert Kiptoo Mwakili-shi wa jumuiya ya mradi wa KISIP 2 wa Mosoriot alisema mradi huo umeajiri zaidi ya vijana 100 wa kiume na wa kike ambaa hulipwa angalau Sh700 kila siku.

“Walikuwa wakiuza pombe haramu ili kuishi lakini kwa kuwa wali-

kuwa wakijishughulisha na kazi za KISIP 2, unywaji na uuzaaji wa pombe haramu ndani ya mji wa Mosoriot umezungua,” alisema.

Afisa Mkuu wa Fedha wa Serikali ya Kaunti ya Nandi Priscah Muge alisema uchapishaji wa kina ulifanywa kabla ya kutambuliwa kwa miradi hiyo na kwamba idara yake ambayo inasimamia fedha itahakikisha miradi hiyo inakamilika ndani ya kipindi cha kandarasi ya mwaka mmoja.

“Mara tu programu hizi zitakapokamilika, tunatarajia kuwa mji huu utapandishwa hadhi ya manispaa kutohaka na mifano ya maendeleo ambayo itafikiwa,” Afisa Mkuu wa Fedha alisema.

Alikariri kuwa taasisi nyingi karibu na mji wa Mosoriot zinawezesha miundombinu kuvutia wawekezaji zaidi kuwekeza katika mji huo. DRAFT PUBLIC FINANCE MANAGEMENT (PUBLIC OFFICERS MEDICAL SCHEME FUND) REGULATIONS, 2024

The State Department for Public Service was established under Executive Order No. 2 of 2023 – Organization of Government of the Republic of Kenya, to provide policy direction and management of the human resource function in the public service. The State Department for Public Services provides human resources policy leadership, advisory services, technical support, and coordination for the public service. It is under the Ministry of Public Service & Human Capital Development.

The Government of Kenya introduced a comprehensive Medical Insurance Scheme for civil servants and disciplined services and their eligible dependents named Comprehensive Medical Insurance Scheme for Civil Servants & Disciplined Services (the Scheme). The scheme was rolled out with effect from 1st January 2012 and has been in operation until the establishment of the Social Health Authority.

The Scheme started with basic coverage of a principal member and three (3) dependents and was four years later enhanced to a principal member and six (6) dependents. The benefits package was also improved and currently includes outpatient, inpatient, and specialized services, dental, optical, annual medical checkups for member and spouse, road ambulance, emergency air rescue services, overseas treatment, group life and last expense cover.

Social Health Authority facilitates access for all Kenyan residents to a comprehensive range of quality health services. These services include integrated preventive, promotive, curative, rehabilitative, and palliative health services at level 4, 5, and 6 health facilities.

For civil servants to continue receiving this benefit from the Scheme as part of their remunerations, a Fund is proposed to enable civil servants first to receive the comprehensive range of quality health services from the Social Health Authority and, once this is exhausted, proceed with the limits provided for under the comprehensive medical insurance scheme for civil servants and disciplined services (renamed Public Officers Medical Scheme). The proposed Public Officers Medical Scheme include civil servants and any other participating group of public officers. Funds recovered from their medical benefits will be channelled to the Fund established to support the Scheme. Civil servants and all other participating public servants of the proposed Public Officers Medical Scheme shall continue contributing to the Social Health Authority through payroll deductions.

The State Department for Public Service has now proposed the establishment of a Fund to be called the Public Officers Medical Scheme Fund, which will receive funds from the medical benefits recovered being part of public officers' contractual remunerations.

The proposed Public Officers Medical Scheme Fund will finance the provision of a medical scheme for public officers in addition to the social health insurance benefit package provided for under the Social Health Insurance Act. This means that the limits provided under the social health insurance benefit will have to be exhausted by a member or qualifying dependent first before the limits under the Public Officers Medical Scheme are considered. Accordingly, an Inter-Agency Team composed of public officers drawn from the Executive Office of the President, the Office of Chief of Staff and Head of Public Service, the Ministry of Health State Department for Medical Services, the National Treasury, the Office of the Attorney General and Department of Justice, and the Civil Service Unions and has now finalized preparing the draft Public Finance Management (Public Officers Medical Scheme Fund) Regulations, 2024.

Now, pursuant to Section 4 (a) and 5 (3) (a) and (b) of the Statutory Instruments Act, 2013, the National Treasury & Economic Planning invites members of the public to submit any comments, inputs or memoranda they may have on the said draft Public Finance Management (Public Officers Medical Scheme Fund) Regulations, 2024 in the format provided on the website.

KALRO and KOPIA equips Mwea farmers with seed production skills

Farmers in the Mwea Irrigation Scheme have been trained in producing quality seeds and using certified seeds to increase yields, supporting food security in the country.

The training, conducted by the Kenya Agricultural and Livestock Research Organisation (KALRO) in partnership with the Korean Programme for International Cooperation in Agriculture Technology (KOPIA), equipped farmers with the skills, knowledge, and information needed to produce high-quality rice seeds.

Dr. Ruth Musila, Director of KALRO in Mwea, noted that studies show the use of certified seeds can significantly increase crop yields, especially for cereals. Speaking at a workshop held at the KALRO Mwea Research Centre, she explained that the shortage of certified seedlings has forced farmers to rely on farm-saved seeds, which has negatively impacted harvests.

"Farmers have been using farm-saved seeds, which generally reduce production. These are seeds that are grown, harvested, and then

replanted, leading to lower output. Certified seeds, however, have a higher germination rate, are free from pests and diseases, and can increase yields by up to 25 percent," she said.

Dr. Lusike Wasilwa, Director of Crop Systems at KALRO, added that the training will target over 500 Mwea rice seed producers in different phases. She highlighted that rice consumption per capita in Kenya has doubled, and the country currently cannot produce enough rice to meet domestic demand.

"The per capita consumption of rice has grown

from 12 kilograms in 2016 to currently 28 kilograms, with this high consumption we are unable to produce enough," Dr Lusike said.

She added that with current importation of 80 per cent of rice, Kenya is losing foreign exchange, attributing it to insufficient seeds in the country.

She said it is impossible to import over 1000 tonnes of seedlings, necessitating the need for local production by farmers in places like Mwea who enjoy irrigation services. "Through government's Bottom-up Economic Transformational Agenda strategy to reduce imports,

rice is one of the commodities to reduce. We want to produce enough quality seedling which will lead to increase in production"

Wasilwa also noted that apart from the researched varieties from KALRO they are getting other countries from partner-countries producing rice with expected over 15 varieties in next three years.

The Korean Programme for International Co-operation in Agriculture Technology (KOPIA), which teamed up with KALRO training, aims to address challenges related to seedling production with technology.

Farmers trained on nutrition-sensitive agricultural practices

Farmers affiliated with the Kihiko Agribusiness Group in Solai Ward, Rongai Sub-County, were trained in nutrition-sensitive agriculture (NSA) by sub-county agricultural officers. The training focused on educating farmers about diverse food groups and promoting the cultivation of nutrient-dense crops to address malnutrition in the community.

The County Executive for Agriculture, Leonard Bor, said the initiative aligns with the county's broader nutrition-sensitive interventions aimed at combating various forms of malnutrition, including stunting, underweight, and obesity. By integrating nutritional considerations into agricultural practices, NSA seeks to improve the nutritional value of food produced and consumed within the community.

He added that by encouraging farmers to cultivate a variety of nutrient-rich crops, such as beans and various vegetables, the training aims to enhance dietary diversity and address underlying causes of malnutrition, such as limited access to nutritious foods.

This approach not only improves food security

but also contributes to the overall health and well-being of the community.

Additionally, he said nutrition is a critical factor in the overall health and development of children in rural Kenya, adding that malnutrition, stunting, and wasting remain significant challenges, particularly in these areas.

He highlighted the consequences of stunting,

a condition caused by chronic undernutrition, which affects 20 percent of children under the age of five in rural Kenya, compared to 12 percent in urban areas. Furthermore, he stated that 11 percent of children in Kenya are underweight, and 4 percent are wasted, a condition characterized by acute malnutrition.

Bor noted that these statistics emphasize the urgent need to address malnutrition in rural Kenya, as it has long-term consequences for children's physical and cognitive development, as well as their overall well-being. Appreciating the training, village elder Peter Rono remarked on the noticeable difference between children raised in rural areas and those in urban areas.

Rice growers opt to biological control of snails in their farms

Rice fields in Mwea are now battlegrounds as local farmers struggle to protect their crops from the devastating impact of snails.

The snail, notorious for its ability to slash yields, feeds voraciously on young rice seedlings leaving farmers in distress and economies vulnerable to substantial losses. During the practical Training Unlocks Rice Farmers' Agribusiness Potential on raising quality seedlings, transplanting and management of seedbeds organized by Kenya Agricultural and Livestock Research Organization (KALRO), control of snails emerged as a major challenge among rice farmers.

He stated that the platform unites a wealth of expertise, knowledge, and experience from across regions, focusing on fostering invaluable insights that strengthen the collective response to weather and climate change challenges.

The PS acknowledged support from the AUC and funding by the EU under the ClimSA program to enhance the meteorological infrastructure.

As research continues to come up with effective methods of control the organisation advised to intermittently drain water after transplanting.

"We have advised them to drain water after transplanting because the pest, snail, cannot survive without water. We still encourage them to use biological methods as opposed to chemicals that may have side effects," she said.

At the Kiriko Demonstration Farm in Mwea, farmers acquired a range of farm management and other skills that enabled them to select appropriate methods to manage the crop enabling them to get maximum output and profits.

Lydia Mundia, a rice farmer, said the detrimental effects of snail invasion extend beyond crop-related concerns.

New satellite weather system to improve forecasting and disaster management

The Kenya Meteorological Department (KMD) has received and installed the Intra-ACP Climate Services and Related Applications Systems (ClimSA) with the aim of delivering training on the Preparation for Use of Meteosat in Africa (PUMA) applications and systems to over 200 forecasters and technical experts, improving forecasting techniques in the African region.

The ClimSA program is supported by the European Union (EU) through the African Union Commission (AUC) to install 56 meteorological data access infrastructure PUMA stations and Climate Services for Sustainable Adaptation Actions Infrastructure

(ClimSA Systems) by the end of the project.

The system further aims to utilize imagery and data captured via satellite to provide tailored weather updates and warnings, which in turn support sectors including agriculture, disaster management,

and public safety across Sub-Saharan Africa. It also trains experts on the system hardware, administration, maintenance, troubleshooting, and practical sessions on using the new technology.

Speaking virtually from his office in Nairobi, the

Principal Secretary (PS) for Environment and Climate Change, Dr. Festus Ng'eno, maintained that the government is ready to support the improvement of meteorological infrastructure to enhance observation techniques and ensure reliable, timely, and accurate climate information for decision-making.
