## Government lowers fees in public universities

**Education Cabinet Secretary Julius Ogamba directed public universities to implement the Student-Centered Funding Model for both first-year and continuing students beginning September 1**

The Ministry of Education has reduced the fees payable by students across all academic programmes in public universities.

Education Cabinet Secretary Julius Ogamba made the announcement during the 29th graduation ceremony of Moi

Teachers Training College in Baringo. He said the decision followed extensive consultations involving the ministry, the public, students, and stakeholders in higher education.

Ogamba directed public universities to implement the Student-Centered Funding Model for both first-year and continuing students beginning Sep-

# Government lowers fees in all public universities

tember 1. He urged institutions to update their admissions and finance portals, emphasizing the government's commitment to supporting all deserving learners.

Under the new funding model, the Higher Education Loans Board (HELB) and the Universities Fund are expected to support 201,696 first-year university students, over 237,000 Technical and Vocational Education and Training (TVET) students, and 257,523 continuing students this academic year.

Ogamba also announced that the disbursement of HELB loans will begin on August 15, following an increase in government funding from Sh36 billion to Sh41 billion. He said this will ensure students can begin their academic journey without financial disruption.

He encouraged the 2024 KCSE cohort to apply for the first quarter of scholarship funds for the 2025/2026 financial year. The application portal will remain open until August 31.

"The government is committed to ensuring that no student is left behind due to lack of

school fees," Ogamba affirmed. He also addressed concerns about capitation for basic education, saying it is a constitutional right for all learners and that the government will allocate sufficient resources to support the programme.

Joseph Makilap, a member of the National Assembly's Education Committee, also reassured the public that there are enough resources to ensure the success of the education sector.

He noted that the contentious Sh22,000 per student capitation figure is often overstated,

as deductions are typically made for textbooks and related materials.

However, Makilap assured that whenever there is a shortage, parliamentarians are always ready to put more resources in the next supplementary budget for all learners same as for the first-year students who will join in September.

The institution graduated 272 students who had pursued diploma courses in primary education and early childhood development education.

# Electricity consumption hits new high, driven by 400,000 new connections

Electricity demand has reached a new peak driven by new customer connections and increased consumption of grid power during the ongoing cold season.

Data from Kenya Power's National Control Centre shows that peak demand surged twice in July, with a record high of 2,362.28 MW being registered.

Peak demand – the highest level of electricity consumption recorded at the National Control Centre – rose to 2,325 MW, surpassing the previous peak of 2,316 MW recorded in February 2025. Kenya Power's Managing Director and CEO, Dr. Eng. Joseph Siror, said they expect the momentum to continue as the company rolls out more connectivity projects across the country.

"The new peak demand is a testament to our commitment to expanding national electricity access through the implementation of various electrification projects. When we analyze our electricity dispatch data, we observe that demand has risen by 46 MW over the last five months, since February, when we recorded the year's first peak," he explained.

During the last financial year, which ended on June 30, 2025, Kenya Power connected a total of 401,848 new customers.

In addition to new connections, the increased demand is also attributed to the cold season, which has led to higher electricity use for heating homes and offices.

Eng. Siror added that the company is at various stages of implementing last-mile connectivity projects commissioned across the country. In addition to these projects, the company is also carrying out other connectivity projects targeting various customer categories, including commercial and industrial consumers.

# Tough measures as Government targets illegal chemists

The Government has issued a stern warning to investors in the health sector against trading in, importing, or handling unregistered pharmaceutical products in Kenya.

Health Cabinet Secretary Aden Duale directed all stakeholders to desist from handling any un-

registered products and to ensure that all pharmaceutical products in their possession are duly registered and approved by the Pharmacy and Poisons Board (PPB).

Duale also ordered an intensified crackdown on unlicensed pharmacies and pharmacists to protect public health, adding that the operation will involve the Pharmacy and Poisons Board (PPB) and the National Police Service. The op-

eration will target illegal chemists, distributors, and those selling counterfeit or substandard medications.

The CS affirmed that those found operating pharmaceutical outlets without proper licensing, or handling unregistered pharmaceuticals, will face arrest, prosecution, seizure of products, and closure of their premises. He issued a warning to absentee superintendents

who leave licensed pharmacies in the hands of unqualified personnel, adding that the culprits will face disciplinary proceedings if they fail to comply.

“Essentially, you cannot use other people to commit a crime while you are comfortable somewhere,” he warned. Duale spoke at Nyayo Gardens in Nakuru County, where he officiated the launch of the devolved unit’s ‘Taifa Care’ program under the Universal Health Coverage (UHC) initiative.

The CS, who vowed to supervise extensive crackdown on rogue pharmacists, said PPB was currently actively monitoring the market and will take action against anyone found violating the regulatory framework.

He said the government was particularly concerned about the sale of fake and counterfeit drugs, improper storage of medications and dispensing without qualified medical guidance, all of which pose serious risks to public health.

“The government is also urging the public to remain vigilant and report any suspicious pharmaceutical activity to the authorities,” he appealed.

The CS noted that the PPB had developed guidelines for good distribution practices, transportation of pharmaceuticals and also for safe management of pharmaceutical waste. The guidelines, he said were available and all health practitioners were advised to familiarize with the provision of the

guidelines. The CS also emphasized on the need for the public to use the health safety code 21031 displayed in registered pharmacy outlets to verify legality of the premises they are buying medicines from.

Duale said collaborative efforts between the government and the professionals in the health sector was crucial for the successful battle against the merchants of the harmful drugs.

“Don’t dispense unregistered or unprescribed drugs over the counter. We must also have a good record of all the drugs dispensed,” he advised. The Cabinet Secretary was accompanied by Governor Susan Kihika, County Commissioner Lyford Kibaara, Nakuru Women Representative Lizz Chelule and Members of Parliament Samuel Arama (Nakuru Town West) Irene Mrembo (Bahati) and David Gikaria (Nakuru Town East).

The CS also put on notice wholesalers supplying pharmaceutical products without proper documentation saying that the Ministry through PPB will shift attention to wholesalers who supply illegal outlets without identifying the documentation of those purchasing drugs.

“Such wholesalers will be profiled and also prosecuted. We are using our inspectors who are cracking down on the illegal chemists and will be able to get invoices of those supplying them,” he noted.

# Kenyans to receive national IDs in 7 days under new system

The Cabinet Secretary for Interior and National Administration, Kipchumba Murkomen, has launched the Mobile Live Capture Unit in Uasin Gishu County—a revolutionary technological intervention that will enable Kenyans to receive national identification cards within three to seven days.

The initiative underscores the government's unwavering commitment to providing civil registration services to facilitate identification, access to essential services, and national security.

Speaking during the launch at the County Commissioner's Office in Eldoret, the CS announced that the service is free of charge and is available only to Kenyan citizens who are fully recognized by the area chief.

He reminded the local administrators to be keen to ensure security at the grassroots is guaranteed by vetting people for IDs after the old system was scrapped, noting that they will bear full responsibility in case one unlawfully acquires Kenyan ID under their watch.

The CS, further, un-

derscored the benefits of the crucial document for identification purposes, access to jobs, social security benefits, financial services among others as he rallied the youth to take advantage of the current technological system to get IDs in order to exercise their democratic rights like participating in elections.

He commended the system's efficiency and effectiveness in providing a secure and convenient way to access services, manage personal information and participate in the digital economy.

The Mobile Live Capture Unit, a portable battery-powered machine, is used to capture data of ID applicants and submitted electronically for processing.

He mentioned that the initial vetting process unreasonably affected communities especially in border and pastoralist regions, aggravating inequality in access to government services, identification and, by extension public service jobs, voting, education, and formal employment.

"The initiative aligns with the government's broader agenda to use technology and innovation to improve public service delivery, especially for historically underserved populations and restore confidence between citizens and state institutions in regions where registration has long been viewed as a privilege rather than a right," said Murkomen.

# 4-K Clubs redefine the future of agricultural education

Nestled within the rolling plains of Mbololo Ward on the outskirts of Voi Town, a quiet revolution is taking root at Mkwachunyi Primary School.

Here, a determined group of 29 girls and 27 boys has embraced the spirit of Kuungana, Kufanya, Kusaidia Kenya through their thriving 4-K Club.

What began as a simple agricultural initiative under the Competency-Based Curriculum (CBC) has blossomed into a movement—one that nurtures not just crops, but future leaders, environmental stewards, and entrepreneurs.

The journey began in 2021, following the government's renewed push to revive the once-thriving 4-K Club movement. Originally launched in the 1960s under the slogan Kuungana, Kufanya, Kusaidia Kenya, the program was designed to equip learners with agricultural skills and instill a spirit of community service. After losing momentum in the late 1990s, the Ministry of Agriculture and Livestock Development, in collaboration with the Ministry of Education and other key stakeholders, revived the pro-

gram in June 2021. The revival came at just the right time for Mkwachunyi Primary School. Teachers and parents saw an opportunity to go beyond the classroom and provide learners with hands-on experience in agriculture, environmental conservation, and entrepreneurship.

the money to buy more seeds. Now we see that farming can also be a business."

The 4-K Club's efforts go beyond farming to embrace environmental conservation. With support from the Kenya Forest Service and the National Drought Management Authority, the school has planted over 300 indigenous and fruit trees, transforming the grounds into a green sanctuary.

Creative container gardens built from old tires, buckets, and sacks, showcase how waste can be turned into life-giving spaces.

The success of Mkwachunyi's 4-K Club is rooted in community collaboration. Teachers have allocated land, built rabbit cages, and even joined students in the fields. Parents and local agricultural officers have lent their time, expertise, and resources to mentor the young farmers.

The County Government of Taita-Taveta led by Deputy Governor Christine Kilalo supported the school by fencing the farm and linking it with devel-

melons lingers in the air.

"Our learners do not just read about agriculture, they live it. From planting seeds and tending crops to harvesting and composting with rabbit manure, the children gain real-world skills that no textbook can teach," says James Kariuki, the club's patron.

The club has also ventured into mushroom farming with guidance from the University of Nairobi led by Prof. Dolar Kilalo. The pupils have mastered everything from sterilization techniques to sustainable harvesting, opening their eyes to modern, profitable farming methods.

Traditional crops like maize and green grams continue to anchor their projects, and the proceeds from their harvests fund future activities. One of the club members explains stating, "We sold our green grams to a teacher and used

# State revives key sugar factories in economic boost for Nyanza

The Government has partnered with private investors to revive and restore operations at the Sony, Muhoroni, Chemelil, Miwani, and Nzoia sugar factories, which have long been the backbone of the region's economic activities.

"We aim to ensure that farmers receive better,

timely, and regular payments for their mature cane, and also receive annual bonuses, just like coffee, pyrethrum, and tea farmers," Deputy President Prof. Kithure Kindiki (pictured) said.

The deputy president reaffirmed the government's commitment to economically transform the Nyanza region through investments in critical sectors such as agricul-

ture, transport, fishing, energy, and education.

Prof. Kindiki noted that under the broad-based government, the lake-side region has witnessed major development programmes aimed at improving the livelihoods of local residents.

He made the remarks during an economic empowerment programme for women, youth, and people with disabilities,

pletion of the stalled road projects in the region highlighting the 52 kilometer Mamboleo - Miwani - Muhoroni road whose construction has resumed in earnest to facilitate effective movement of people and goods.

At the same time, the DP stated that the government has elaborate plans of increasing the number of citizens with active health insurance.

Presently, he noted, only 25 million Kenyans are enrolled into the Social Health Authority insurance (SHA)

"So far, almost 50% of Kenyans have health cover. We aim to attain 100% health insurance coverage in the next two years," he stated.

The DP lauded Kisumu County with a population of 1.2 million people for registering 600,000 people into SHA so far.

To empower the youth economically, Prof Kindiki said the President has ordered the return of the Kazi Mtaani programme across all counties to employ jobless youth in environmental clean-up projects.

Kisumu, he observed, has benefited from the affordable housing programme with 2,348 units at Lumumba Estate.

"The affordable housing programme will be expanded to other satellite towns including Muhoroni, and also build student hostels for Jaramogi Oginga Odinga KMTCC, Kisumu National Polytechnic among other institutions of learning.

as well as the launch of the Shield Okumba SACCO in Muhoroni Sub-County, Kisumu County.

The deputy president also announced that 17 Economic Stimulus Programme (ESP) markets are currently under construction across Kisumu County to provide small-scale traders with a dignified environment to earn a livelihood.

The state has prioritised the construction of fish landing sites and equipping them with modern facilities across the lake-side counties in an effort to revitalise the fisherfolk economy, boost fish production, encourage value addition and ensure sustainability of the sector.

"The president is building fish landing sites along Lake Victoria from Homa Bay, Migori, Kisumu, Siaya, and Busia Counties. They will be equipped with cold storage facilities to prevent fish from rotting," Prof Kindiki noted, adding that the government will provide grants to the fisherfolk through the Beach Management Units to boost fish production.

Gitambaya and Fort Jesus, two densely populated informal settlements in Kiambu County, are set for significant transformation under a 10-year Community Development Plan (CDP) aimed at improving residents' quality of life.

At the heart of this vision is the construction of a multipurpose social hall—a flagship facility poised to become the social and economic hub of the community.

The plan, spearheaded through the Kenya Informal Settlements Improvement Project Phase 2 (KISIP 2), forms part of a broader effort to address historical underdevelopment in informal areas.

Residents of Gitambaya gathered in large numbers to celebrate and officially endorse their newly launched CDP—a decade-long blueprint offering more than just roads and streetlights. It introduces spaces for learning, enterprise, and childcare, laying a foundation for long-term community empowerment. The CDP proposes the construction of a multipurpose social hall that will house an ICT hub, a bakery, a day-care centre, and other essential amenities. The facility will be managed



by local Community-Based Organizations (CBOs), ensuring that the development remains community-led and sustainable.

“This plan is a direct result of the community's voice,” said Ms. Joann Kihori, Ruiru Municipal Manager. “It reflects their hopes and provides a platform for inclusive development, where residents are not just beneficiaries but active drivers of their future.”

The initiative falls under Component 2 of the Kenya Informal Settlements Improvement Project Phase 2 (KISIP 2), which focuses on socio-economic inclusion.

The plan is funded by the World Bank and implemented by Kiambu County Government with support from the Pamoja Trust and other technical partners.

According to the County KISIP Coordinator Mr. Julius Mwololo, “The CDP will not only guide infrastructure but

also ensure residents are socio-economically uplifted. Through community-driven models, we aim to reduce poverty, connect people to employment, and build resilience.”

By tapping into the energy of local CBOs, the plan aims to empower women and youth, improve service delivery, and create opportunities for entrepreneurship, especially in underserved populations.

# Gov't scales up drought relief, development projects in Baringo

The Ministry of Public Service, Human Capital Development, and Special Programmes has intensified drought relief and development initiatives in Baringo County as part of broader efforts to cushion vulnerable families and enhance resilience in arid and semi-arid regions.

During a visit to Kolowa and Chemolingot in Tiaty Constituency, Cabinet Secretary for Public Service Geoffrey Ruku led a government delegation in distributing food and non-food items to households affected by prolonged drought.

The emergency intervention was conducted under the State Department for Special Programmes, which is coordinating humanitarian responses in arid and semi-arid lands (ASALs) across the country.

Ruku said the government is committed to addressing the immediate needs of communities facing food insecurity while laying the groundwork for sustainable development. "We continue to support vulnerable communities across the country in response to droughts and other emerging humanitarian crises," he said.

The CS was accompanied by local leaders, including Tiaty MP Wil-



liam Kamket, Baringo County Woman Representative Jematiah Seron, and Kacheliba MP Titus Lotee. The leaders lauded the initiative and called for sustained government support to mitigate the impact of failed rains and food scarcity in the region.

In addition to the relief efforts, the government is implementing several long-term development projects to address water scarcity and boost food production. Among them is the Cheraik Irrigation Project, which is already operational, and the

Radat Dam, currently under construction. The Chemeron Dam is also being rehabilitated to supply water to over 10,500 households and more than 150,000 livestock.

The projects aim to improve water access in Baringo, where only 39 percent of residents had reliable water sources according to the 2019 Kenya National Bureau of Statistics census—a figure that may have declined due to successive droughts.

# CS Ogamba denies plans to shut down satellite campuses

Ministry of Education Cabinet Secretary Migosi Ogamba has denied claims by a section of the media that the government plans to close some satellite institutions of higher learning.

Ogamba clarified that the government is undertaking a rationalisation exercise to ensure all resources are optimally utilized for the benefit of learners.

Speaking at Riokindo Boys High School in Bokimonge Ward, Bomachoge Borabu Constituency in Kisii County during the school's prize-giving day to honour students who excelled in last year's KCSE exams, the CS said that a similar rationalisation of institutional staffing is also underway.

He emphasized that the exercise would be conducted in accordance with the law, with full respect for the rights of all individuals involved and affected.

The CS also noted that the rationalisation extends to the funding of higher education, school bursaries, and donations from other non-centralized sources to ensure resources are allocated more efficiently and governance is streamlined.

On the issue of delayed capitation, the CS cited challenges such as financial limitations and conflicting

government requirements but assured that efforts are being made to secure sufficient allocations and eliminate existing hurdles.

He applauded the school for attaining a mean grade of 9.2 points (B) and encouraged them to work hard to reach their target of 9.7 points in this year's KCSE exams.

Ogamba further explained that the school, which was recently upgraded along with six others in the county, will offer three pathways under the competency-based curriculum for Grade 10 students starting in 2026.

The CS promised that the state will support the institution with infrastructure including classrooms, dormitories and laboratories.

He said there was a budget commitment to do 1600 laboratories in various schools in the country, besides funds being set aside to employ 100,000 more teachers, in the efforts to reach the Kenya Kwanza manifesto target of up to 116, 000 by end of 2025.

On bargaining agreements, Ogamba said all CBAs will be signed at the beginning of the cycle instead of end for sake of clarity and continuity so that teachers and students remain in class.

He explained there were plans to employ the over 65,000 teachers who were jobless despite having TSC numbers.

On the number of CBE classrooms, he said the government had already constructed 23,000 of them for grade 9 since last year.

# Farmers in drought hit Laikipia shift from maize to more lucrative coffee growing

Laikipia County, a semi-arid region traditionally known for livestock rearing is experiencing a shift as farmers venture into high-value coffee farming.

Amid the scorching sun, blossoming coffee bushes thrive on the farm of Peter Kimani, a budding farmer in Tandare Village, Kinamba Ward.

Kimani, who has dedicated his one-and-a-quarter-acre piece of land to coffee farming, reveals he began in 2022 and, after making his first sale, has never looked back.

He explains that while maize has long been the area's primary cash crop, the impressive returns from coffee are prompting farmers to replace maize

with coffee, hoping to reap greater profits from the berries.

"Maize has been our

cash crop for many years, but now it is being replaced by coffee due to the good returns. An acre of

maize yields a net profit of about Sh30,000 annually, whereas the same piece of land planted with coffee earns Sh240,000. Coffee is clearly the better option," says Kimani, as he proudly shows this writer his well-utilized land. He adds that his sales have increased significantly, with a recent earning of Sh320,000.

Despite the unpredictable weather patterns in the county and the fact that coffee requires altitudes between 1,000 and 2,000 meters to thrive, Kimani—who grows nearly a thousand Batian variety coffee bushes—says they rely on shallow rains and dams to sustain their farming.

Kimani who is also the Secretary of Ng'arua Coffee Farmers' Cooperative Society highlights that since they are yet to come up with their own factory, they use portable machines to remove the red husk, then wash and dry for market.

He says a kilo of parchment fetches at Sh330 while dried one goes for Sh200 at New Kenya Planters Cooperative Union (NKPCU).

"Since we do not have a processing factory it's upon the farmers to do their

pulping and dry then we sell the produce as members of the society aimed to get good returns," notes Kimani.

He points out that, they discourage members from selling to brokers aimed for them to benefit from the cooperative society through advance pay and training, brokers have been frequenting the area

from the counties of Nyeri, Kirinyaga and Nairobi.

Kimani is among hundreds of farmers across the six wards of Sossian, Githiga, Marmanet, Igwamiti, Ol Moran and Ngobit in Laikipia county who had depended on maize farming but now embraced the top-rated coffee farming to turn around their economic fortune.

## State constructs Sh100m Somare Dam to boost water access for 5,000 Moyale residents

The State Department for ASALs and Regional Development is constructing the Sh100 million Somare Dam in an effort to transform the livelihoods of over 5,000 people in Moyale's arid and underserved region.

Principal Secretary for the State Department for ASALs and Regional Development, Kello Harsama, said the project will hold an impressive 160 million litres of water upon completion. It is being implemented by the Ewaso Ng'iro North Development Authority (ENNDA) under the stewardship of the State Department.

Harsama hailed the initiative as a strategic investment under the Bottom-Up Economic Transformation Agenda (BETA),

which seeks to empower historically marginalized communities and unlock the development potential of Kenya's Arid and Semi-Arid Lands (ASALs).

"A key component of the government's push to boost rural infrastructure, the Somare Dam is designed to provide sustainable access to water for domestic use, livestock, and small-scale irrigation, offering relief to residents who have long relied on seasonal rainfall and distant water sources," he said.

The PS disclosed that the project features a 10-metre-high earth embankment dam, a modern intake and spillway system, advanced treatment facilities, and extensive water distribution infrastructure.

"This includes solar-powered and grid-supported submersible pumps, elevated tanks, water

kiosks, livestock troughs, and community taps – all tailored to serve the unique needs of Moyale's pastoralist communities," he added.

The dam site, he pointed out, is also being secured with perimeter fencing to ensure sustainability and safety.

Harsama described the dam as a transformative force for

borderland communities adding: "This dam is more than a water project, it is a symbol of transformation. It reflects our resolve to take development to the grassroots.

The PS averred that through the BETA framework, "We are not only bringing services closer to the people but restoring dignity and hope in communities

that have long been forgotten."

He emphasized the pivotal role water plays in driving rural economies, enhancing food security, and promoting peace and cohesion in fragile regions like Moyale, which often bear the brunt of drought, climate shocks, and resource-based conflicts.

The inspection, the PS noted, comes at a time when the government is scaling up high-impact projects in ASALs counties, reinforcing its commitment to equitable development, agricultural productivity, and climate resilience.

Harsama disclosed that the Somare Dam is expected to reduce the burden on women and children who trek long distances in search of water, while also improving livestock health and spurring agricultural activities.

"With implementation already in high gear, the dam is poised to become a flagship symbol of the government's renewed focus on marginalized regions anchoring not just water security, but a future of opportunities, prosperity, and lasting peace in Kenya's northern frontier," he said.

# New pact to roll out internationally accredited courses in local polytechnics

The State Department for Technical and Vocational Education and Training (SDTVET) has signed a partnership agreement with the Australia-based Signet Institute to roll out internationally accredited courses aimed at equipping Kenyan youth with globally competitive skills.

Speaking during the launch of the Signet Institute of Australia office at The Eldoret National

Polytechnic (TENP), TVET Director John Tuwei underscored the significance of the programme, which will initially be piloted in seven technical institutions before being extended to more TVETs in subsequent phases.

He noted that the initiative would enhance the productivity of young people and enable them to earn self-sustaining incomes while working abroad, thereby boosting foreign inflows and improving the country's economy.

"We are collaborating as a government with the Signet Institute of Australia to roll out courses that are internationally accredited. We have signed the agreement, and it will cover several national polytechnics, including the Eldoret National Polytechnic," said the TVET Director.

He mentioned that they had already launched an office for Signet that will coordinate in collaboration with Kenyan institutions, at Kabete National Polytechnic and the Nairobi

National Polytechnic. "This is a pilot and based on the uptake, we'll be increasing this. We start with seven national polytechnics and maybe we'll start with 100 students. And this will be growing gradually depending on the skills requirement outside there," explained Tuwei.

In his remarks, the Kenya High Commissioner to Australia Dr. Wilson Kogo commended the milestone achieved in TVET modernization noting that upskilling of the human capital in Kenya is key in order to leverage on the opportunities available internationally.

He welcomed the collaboration which he said will strengthen the relationship between Kenya and Australia and support both economies through labour mobility.

The High Commissioner pointed out that many regions outside there, be it Europe, America, Australia and others, are really asking for labour noting that the question that is in the minds of everybody else is on the kind of training that we have in Kenya if it does really resonate with needs and the expectations other regions like Australia.

"That is what we are focusing on and asking ourselves the question, why is it that at one point, if you have a nurse from here going to Australia, they cannot be allowed to practice, and yet we have trained? Why is it that you have plumbers who have been trained in our institutions here, but when they go to other regions, probably they are not allowed to practice," exclaimed Dr. Kogo.

He lauded the training standards in Kenya's TVET emphasizing the need to upgrade them to the global standards through linkages and collaborations with international institutions like Signet Institute so as to match the skills required in Australia which is in dire need of labour due to its fast-aging population.

Dr Kogo hinted on bringing in more countries whose market need is not covered in Kenyan training so that any gaps can actually be taken care of as far as labour mobility is concerned.

"Australia is one of them. We want to be probably going forward, be even a source of labour to the wonderful country of Australia. That is what we have in mind.

But the question is, can we address the gaps? We have done a good job, but Australia could be requiring a little bit more than what we have managed to do in our institutions," added the High Commissioner to Australia.

The Head of Sales and Marketing, Signet Institute, Muhammad Imran Ali described the collaboration as a snowball effect—a process where an initial small event or action triggers a chain reaction, causing it to grow larger and potentially more impactful over time.

He mentioned that Kenyans, through the programme, have advantage of two snowball effects. One is that slowly youth will learn, use their skills to go abroad and develop themselves. And on the other side when they are developed, they will start sending remittance back home and that will have a ripple snowball effect to bring up the economy.

"Australia has an ageing population. We have many people to look after, but we don't have young people like you to do that," said Ali.

## State gains in agriculture, jobs creation MSMEs, and digitization

Good day dear fellow lover of the written word. I hope your week has been great. Last week, we focused on what the 5th administration led by H.E President William Ruto has achieved so far in matters economy, health and education. Today, we have many more achievements in areas such as Agriculture, Job creation and digitization of government services; wins that can only serve to make our country a true middle level economy.

In agriculture, we have moved from struggle, to surplus. Previously, there was a lot of exploitation of farmers by middlemen and cartels; through fake farm inputs, and unsustainable subsidies. Cartels thrived, and racketeers profited at the expense of the common good of all farmers. In return, farm inputs became expensive, and farming became less profitable. The game changer was when 6.6 million farmers were registered digitally, ensuring more accurate mapping of farming activities, thus cutting out fraudsters and

conmen enabling real farmers to direct support from the Government.

A good example is the fertilizer distribution programme. A 50kg bag now retails at Ksh. 2,500 down from Ksh. 7,500. More farmers are using certified fertilizer, thus enhancing yields. In addition, Milk prices have risen by 29%, with dairy farmers now earning Ksh.45 per litre up from Ksh. 35 per litre, with exports doubling to Ksh. 7.2B. Coffee prices have more than doubled, from Ksh.65 in 2022 to Ksh.148/kg in 2025. Export earnings from coffee also grew by Ksh. 34B to stand at Ksh.170B.

In the tea sector, farmers now earn Ksh.60/kg of green leaf, up from Ksh.50 with national earnings rising to Ksh. 215B up from 138B. Further, maize harvests jumped from 40 million bags in 2022 to 64 million bags in 2024 thanks to production support and good rains.

In the sugar sector, production rose from 490,000 metric tonnes to 815,000 metric tonnes, a 66% growth, reducing imports by 70%, and increasing income from



Ksh.50 billion to Ksh.90 Billion. For the first time in Kenya's history, sugar farmers received a bonus. Even more transformative, Kenya is now on the verge of achieving sugar self-sufficiency. Once the remaining 30% import gap is closed, Kenya will move from deficit to surplus, with sugar ready for export. Going forward, the government is leasing out 4 sugar factories in order to turn Kenya into a sugar exporter.

This way, there shall be more disposable income, lower cost of food, better earnings for farmers, jobs creation across various value chains, reduced reliance on food imports (rice, maize, sugar etc), and data-based planning and decision making to enhance food security.

Our urban areas are being renewed through

the affordable housing program, that is not only helping Kenyans get jobs, but also giving them dignity and decency. So far, over 1,000 slum dwellers have been resettled in the new Mukuru Estate, and 44 out of 47 counties have ongoing AFP construction works. In total, over 171,000 housing units are underway, and over 320,000 construction jobs have been created for our youth. This has led to secure, decent housing for low-income families, dignified living, better healthier environment, and safer neighborhoods.

The transformation and stabilization of our economy is also happening in the Micro, Medium, and Small Enterprises (MSMEs). Financial access through the Hustler Fund that was launched within the first 100 days of President Ruto administration has 25 million Kenyans getting over Ksh.70B. These are mostly youth, mama mboga, bodaboda riders, and artisans who have saved over Ksh.4.5B, through the platform. loans are collateral-free, and 7 Million blacklisted Kenyans are

now restored to the credit system, based on smart credit scoring. As a result, new businesses have been started, women, youth and PWDs are now able to access capital more easily, and more digital lenders are now regulated thus reducing predatory lending habits of shylocks.

Over and above the jobs created so far, there are 110,000 new opportunities in green public works (ClimateWorx), 182,000 digital jobs through Jitume labs & TVETs, and over 400,000 Kenyans are now working abroad in health, farming, hospitality, construction, domestic, and other industries. This means that more Kenyan youth are not idling at home but can now send money back home to their families, with diaspora remittances hitting over 638.5 billion last year alone. Local economies are now thriving, hardware stores, salons, boda boda and food kiosks are benefiting from new earnings.

Kenya is the silicon savannah for Africa, with over 24,000km of fibre laid, connecting remote areas to the world. So far,

1,494 free Wi-Fi hotspots have been installed in markets, towns, schools, up from none few years ago. In addition, eCitizen services grew from 353 to 22,500, with 316 digital hubs now operational. A further 404 are under construction, while 20,000 laptops/devices have been distributed. So far, over 1.8M youth have been trained in digital skills, with over 300,000 of them now earning online through the Ajira, BPO, gig economy. This has led to increased online learning, and access to information and digital assets for decision making.

In conclusion, President William Ruto's Transformation Agenda is on course, and it's about: lower cost of living, building a healthy nation, creating more jobs and income opportunities, providing affordable and dignified housing for all, empowering farmers, and providing relevant education for our children.

We are stronger together. United we stand, divided we fall.

## Environment conservationists push for sustainable restoration of rangelands

Kenya is actively engaged in national rangelands restoration efforts, aiming to revitalize degraded ecosystems and support sustainable livelihoods.

Speaking in during a rangeland's restoration forum in Nairobi, Principal Secretary State Department for Environment and Climate Change Dr. Eng. Festus Ng'eno, in a speech read by Environment Secretary Dr. Selly Kimosop, said that these efforts are

part of a broader national commitment to landscape restoration, with specific targets for restoring forests and rangelands.

"The Ministry is also working towards increasing tree cover, reducing greenhouse gas emissions and addressing land degradation,"

"On the same score, environment conservationists are pushing for the prioritization of sustainable restoration of rangelands in Arid and Semi-Arid Lands, to cushion these regions from the

effects of extreme weather conditions," said Dr. Ng'eno.

The PS said that Kenya has pledged to restore 10.6 million hectares of degraded forests and rangelands by 2032 by planting and growing 15 billion trees.

He said that land conversion to farmland, over-exploitation, frequent fire regimes, the introduction of non-native plants, overexploitation of water resources, overutilization of wild species, and the long-term effects of cli-

mate change are some of the major factors that lead to dryland degradation.

"The preservation of biodiversity, food security, economic growth, livelihoods, and human well-being will all be enhanced by the sustainable management of drylands," said the PS.

Dr Ng'eno disclosed that the southern rangelands of Kenya are 50% degraded and 40% highly eroded, with hard pans, bare ground, and the intrusion of invasive species being the main indicators of land

degradation.

"There are many invasive species, primarily Ipomea carnea, Ipomea hildebrandtii, Gutenbergia (Erlangea), Prosopis juliflora and Parthenium hysterophorus. Over the previous 20 years, excessive logging, overstocking, and intensive farming have caused the disappearance of native vegetation," said the PS.

National Environment Management Authority (NEMA) Director General Dr. Mamo Boru said that community led restoration programs are being supported and implemented in Arid and Semi-arid areas under a four year 'National Child Project programme.'

Dr Boru said that rangelands are not just vast use-

less landscapes; but they are the lifeline of millions of pastoralists and Agro-pastoralist communities in the drylands.

"They support biodiversity, contribute significantly to our national economy, and play a crucial role in climate resilience and food security," he said.

Dr Boru reaffirmed NEMA's commitment to working collaboratively with all partners to ensure that the policies, strategies, and programs developed are inclusive, practical and impactful. ## KenGen unveils first battery storage system for its data centre

The Kenya Electricity Generating Company PLC (KenGen) has commissioned a new Battery Energy Storage System (BESS) to supply uninterrupted renewable power to its modular data centre.

The milestone marks a new frontier in the company's long-term green energy strategy as Kenya accelerates adoption of clean energy technologies. Speaking during the

ceremony at the company's Nairobi headquarters, KenGen's Managing Director and CEO Eng. Peter Njenga said, "This commissioning marks a crucial step in our journey toward a low-carbon, digitally resilient future."

The newly installed 1.16 megawatt-hour (MWh) BESS will serve KenGen's 52-kilowatt Modular Data Center (MDC) at its Nairobi headquarters.

The state-of-the-art facility comprises 356

U-spaces and is purpose-built to support KenGen's expanding digital infrastructure.

The storage system is designed to guarantee stable electricity even during periods of low grid demand, underscoring the role of battery technology in enhancing energy resilience.

The launch is a cornerstone of KenGen's Good to Great (G2G) 2034 strategic blueprint, which targets the rollout of 500MWh of energy storage capacity over the next decade.

"By integrating battery storage into our data infrastructure, we are not only reducing our carbon footprint but also showcasing how energy utilities can lead in sustainable innovation," he said.

The facility will serve internal operations and provide a model for how utilities can use renewable storage to meet increasing demands for computing and connectivity, he said.

## ARA, COMESA strengthen regional cooperation to tackle financial crime and terrorism

Kenya Assets Recovery Agency (ARA) in collaboration with Common Market for Eastern and Southern Africa (COMESA) conducted a Regional Training of Law Enforcement Agencies (LEAS) in Nairobi, Kenya to combat financial crime and terrorism.

The training focused on financial investigations and on the management, recovery, and disposal of seized, forfeited, or confiscated assets.

It charted a new frontier toward implementing an Anti-Money Laundering (AML) and Countering Financing of Terrorism (CFT) program aligned with Financial Action Task Force (FATF) standards.

"This program represents not just a learning opportunity but a collective resolve and shared

commitment among COMESA Member States. It strengthens regional cooperation and builds robust frameworks to tackle financial crime, recover proceeds, and combat transnational organized crime through asset recovery," said Acting Director General Mark Ogonji.

The workshop under-

scored the importance of strengthening AML/CFT regimes across COMESA Member States. It aligned the regional agenda with the decision taken at the 19th COMESA Ministers of Foreign Affairs meeting in Bujumbura.

The session also emphasized the need to build stronger capacities within Financial Intelligence

Units (FIUs) and law enforcement agencies, while updating AML/CFT legal frameworks in line with FATF standards.

COMESA has developed two strategic documents: a Regional Training Manual on Financial Investigations and Asset Forfeiture and a Regional Strategy on Combating Transnational Organized Crime, Anti-Money Laundering, and Counter-Financing of Terrorism.

Some of the criminal activities noted were drug trafficking, human trafficking, arm trafficking, wildlife trafficking and counterfeit goods. Corruption was noted as the most significant impediment.

"We must pursue proactive international cooperation, because criminals do not respect borders," said Ogonji.

"COMESA's leadership in convening this training clearly demonstrates

that Africa is leading the region in designing continental solutions to transverse crime," he added.

The Ag Director-General said that Kenya's Assets Recovery Agency has made considerable strides in recent years in recovering proceeds and instrumentalities of crime.

"However, it continues to face challenges such as asset concealment through complex corporate structures, virtual assets, cross-border recoveries, and difficulties in managing seized, preserved and forfeited assets," he said.

Mr. Ogonji called upon continuous dialogue and sharing information among COMESA member states while also bringing every key player on board by enhancing capacity building and mobilizing resources.

ARA is committed to deepening cooperation. I

invite all the team players for further engagement to move the \*Assets Recovery\* forward. In exercise of its mandate the Agency has enhanced its efforts to combat money laundering financing and proliferation financing.

Ogonji pointed out that the need to introduce civil forfeiture in COMESA countries was noted as a crucial mechanism to empower law enforcement and prosecutorial authorities to confiscate illicit assets on a civil standard of proof circumventing the delays or impossibility of criminal conviction, enhancing regional asset-recovery rates, and deterring corruption networks more effectively.

Stakeholders identified mutual legal assistance to facilitate litigation and manage virtual assets among COMESA Member States.

# State hands over Sh5.5b Nasewa Housing Project site to contractor

The State Department for Housing and Urban Development has handed over the proposed Sh5.5 billion Nasewa Industrial Park Affordable Housing Project site to the contractor, who is expected to commence work immediately.

Speaking during the occasion, Cassius Kusienya, Secretary of the Integrated Project Delivery Unit for the Affordable Housing Programme, said the site will have 2,000 housing units along with associated infrastructure.

“We will have a Level 3 hospital, an ECD kindergarten, a primary school, a social hall, a shopping centre, a police post, and the chief’s office. Other amenities in the project will include two basketball courts, a football pitch, and a volleyball pitch,” he said.

Kusienya urged the contractor to adhere to the agreed project timeline, adding that sufficient funds have been allocated to ensure timely completion.

“The project will take 24 months, and the contractor is starting work immediately. Adequate funds have been provided, so there should be no delays in honoring payment certificates. We expect continuous progress and timely delivery,” he said.

He added that the project will offer an opportunity for work-

ers on site to gain accreditation from relevant government bodies, provided they meet the required standards.

“This project is going to provide employment as there is a clear directive that 70% of the job be given to the local community. We are also going to collaborate with the National Construction Authority, NITA and TVETS to do onsite assessment for those with skills to be accredited. This will enhance their skills and give them the opportunity to work at other places when certified.” He said

The official urged the contractor to ensure there is proper consideration of occupational safety and health to avoid injuries and fatalities adding that enforcement officers will be doing routine inspection at the site to ensure the work place policy is observed and complied with.

“The houses we are going to construct will pull together a minimum of 5,000 people and with the accompanying infrastructure, this will change this area. There will also be employment opportunities for around 3,000 people when the project is done. There will also be jobs for those who will be working in other amenities like hospitals and schools” he said.

“I want people from this area to start registering with Boma yangu so that when these houses are done, they will not be taken by people from other



places. We should also benefit by getting and staying in those houses something that is possible regardless of our economic status” he said

Busia County Director for Housing, Jason Abuga called on the community to fully support the project due to its benefit.

“This is our project and we should now own it by ensuring we cooperate and work well with the contractor. When you get an opportunity to work at the site, ensure you follow all the set guidelines including the safety measures and even time

so that there is smooth working relationship between you and the people in charge’ he said

Abuga added that the government is determined to ensure that many other projects are established in Nasewa to add on the existing EPZA and the County Aggregated Industrial Park (CAIP) that will ensure the area have been fully transformed to an industrial area.

Busia Assistant County Commissioner Jackline Sabulei assured the team of the security during the progress of the work.

# Treasury, EACC step up anti-graft fight with institutional reforms

The National Treasury has reaffirmed its commitment to intensifying the fight against corruption through institutional reforms and closer collaboration with the Ethics and Anti-Corruption Commission (EACC), in a move aimed at safeguarding public funds and enhancing service delivery.

Speaking during a courtesy call at the EACC headquarters, Cabinet Secretary (CS) for the National Treasury and Economic Planning, John Mbadi, noted that corruption remains a significant threat to Kenya’s development, with billions lost daily.

He emphasized the Treasury’s role in eliminating financial leakages by implementing strategic reforms to promote accountability and transparency.

“I actually requested this meeting because we are part-

ners in this assignment. Kenyans expect us to protect the taxes they work hard to pay,” stated Mbadi.

“It is estimated, as was once stated by former President Uhuru Kenyatta, that Kenya loses about Sh2 billion daily to corruption. If put to proper use, this money could transform lives,” he added.

The CS outlined ongoing Treasury reforms, including the rollout of the electronic government procurement (e-GP) system to seal loopholes in public procurement—a key area of concern in corruption cases.

He also highlighted the transition from cash-based to accrual-based accounting, which would enable better tracking and valuation of public assets and liabilities.

Mbadi disclosed that through zero-based budgeting, the Treasury aims to eliminate dis-

crepancies in government expenditure, such as inflated costs of common items.

“We are also finalising integration of the payroll system across all Ministries, Departments, Agencies, and County Assemblies to address ghost workers and multiple payroll issues,” he explained, hinting that implementation would begin in August.

On pension reforms, Mbadi

announced improved timelines for disbursement, with 97 percent of pension claims settled by June and monthly pensions now paid earlier, warning that any corruption in the Pension Department would be dealt with decisively. Further, the CS revealed that the Treasury is also pushing for the adoption of a Treasury Single Account (TSA) to centralize cash management and avoid instances where the

government unknowingly borrows its own funds.

Significantly, Mbadi celebrated the recent presidential assent to the Conflict-of-Interest Bill, now law, which he said would empower the EACC and help prevent public officials from abusing their positions.

He also confirmed that EACC received 100 percent of its allocation in the last financial year and pledged further support within the limited fiscal space, including provision of vehicles and additional staff.

“We are not shying away from empowering EACC. We are also committed to strengthening other institutions such as the Office of the Auditor General, Controller of Budget and the Judiciary,” affirmed the CS.

He reiterated that his ministry would remain transparent and cooperative in all matters concerning the fight against corruption.

In a quick rejoinder, EACC Chairperson Dr. David Oginde welcomed the Treasury’s commitment and emphasized the importance of a collaborative, multi-agency approach in the fight against corruption.

# State completes major road projects, unlocking development in Vihiga's rural heartland

The Government has made significant strides in road infrastructure development in Vihiga County through the Kenya Rural Roads Authority (KeRRA).

Two major roads now completed and awaiting official commissioning. The Gisambai-Hamisi-Senende Road, a 13.5-kilometre stretch launched in 2020, is now 98 percent complete and has been upgraded to bitumen standards.

Similarly, the Ekwanda-Lwanda-Esirulo-Magada Road, spanning 27 kilometres and also upgraded to bitumen standards, is 96 percent complete.

Meanwhile, several other road projects are underway, including the Mbale-Mbihi-Magada-Wemilabi-Luanda Road, a 20.8-kilometre stretch currently at 15.6 percent completion, and the Mago-Mululu-Wangulu and Lusuli-Vokoli Road, measuring 20 kilometres and now 14.5 percent complete. Both roads are being upgraded to bitumen standards.

The 24-kilometre Stendikisa-Luanda Road is undergoing reconstruction and rehabilitation and is currently 51 percent complete.

According to KeRRA Regional Engineer Michael Outa, the ongoing road projects have made notable progress, a success he attributes to the involvement of local contractors and labour drawn from surrounding communities.

"We have held several barazas with residents, and their cooperation during construction has been commendable," said Eng. Outa. He, however, cited a few challenges affecting some of the ongoing projects, including the need to relocate electricity poles—an issue awaiting resolution by Kenya Power—and the rising cost of raw materials, particularly the scarcity of quality murram.

Residents have responded positively to the ongoing works, expressing optimism about the potential benefits. Local leaders have also hailed the projects, calling them a "game-changer" for the county's socio-economic transformation.

Acting County Commissioner Florence Sitawa underscored the impact of the improved roads on local mobility and access to essential services.

"These roads are transforming how people access health

care and education. Students can now get to school more easily, and emergency response is quicker," said Sitawa.

Gisambai Ward MCA Eric Odei, commenting on the nearing completion of the Gisambai-Hamisi-Senende Road, lauded the government's commitment to rural development.

"This road is more than just a transport link—it is a symbol of the government's pledge to deliver tangible development to our rural communities," said

Odei. He noted that the road would boost connectivity within the constituency, enhance access to markets, schools, and health facilities, and stimulate

trade and mobility.

"The improved infrastructure reflects the government's agenda of equitable development and regional integration. As Gisambai becomes more accessible, the benefits will ripple across Vihiga County," he added.

The project is expected to spur further investment, streamline logistics, and open up remote areas to greater economic potential, making road infrastructure a cornerstone of de-

## Lower Kuja Rice Scheme outperforms national average at 3.6 tonnes

Farmers from the Lower Kuja Irrigation Scheme in Nyatike Sub-county, Migori County, have been praised for achieving rice productivity levels that surpass the national average per acre.

According to the Chief Executive Officer (CEO) of the National Irrigation Authority (NIA), Eng. Charles Muasya, the Lower Kuja Rice Scheme has been producing 3.6 tonnes per acre, compared to the national average of 2.8 tonnes per acre.

Muasya, who spoke during the issuance of cheques worth Sh15.2 million to compensate farmers affected by the infrastructural expansion of the Kuja Irrigation Scheme, said that the scheme's rice productivity exceeds that of all other rice schemes in the country, making it one of the most productive rice systems nationwide.

The Sh152 million compensation package will benefit 177 farmers following a wayleave agreement between the farmers and the NIA to facilitate canal construction within the Lower Kuja Irrigation Scheme.

In April this year, NIA gave out a land compensation package of Sh17 million to 77 farmers in the Lower Kuja Irrigation scheme, bringing the total cash compensation to Sh 36 million.

The government, through NIA, had promised to pay Sh 68 million to compensate all the affected farmers in the scheme to open up the 19,000 acres scheme for irrigation.

The current 7,200-acre scheme under rice production is able to generate an annual income of Sh 3.7 billion, making it one of the viable economic ventures in Migori County.

The official, however, disclosed that the remaining compensation package of Sh 32 million can be paid before the end of the 2025/2026 Financial Year (FY) if the court cases by affected farmers are withdrawn and consent forms signed.

Muasya encouraged farmers to invest the money in the project to ensure the revenue generated from the scheme benefits the Nyatike community and Migori County.

Already, farmers in the scheme have a ready market with the National Cereal and Produce Board (NCPB) opening a depot in the area.

# Gov't taps Kericho for tea value addition and agro-processing drive

The government is positioning Kericho County as a model for county-based industrialization, anchored in tea value addition and agro-processing, as part of a broader national strategy to drive economic transformation through devolved units.

Speaking during the official opening of the Kericho County Enterprise and Investment Summit at Kiprugut Chumo Sta-

dium in Kericho Town, Cabinet Secretary for Investments, Trade and Industry, Lee Kinyanjui, said Kericho's strong agricultural base and infrastructure potential place it at the forefront of Kenya's regional industrial growth agenda.

The CS disclosed that the Ministry is in discussion with the County government to convert some 88 acres of land in Kericho into a Special Economic Zone (SEZ), while consultations were at an advanced stage for

another Special Economic Zone in Londiani targeting the floriculture industry.

At the same time, Kinyanjui announced that Sotik Tea, one of the leading producers in the South Rift has already been gazetted as a Special Economic Zone (SEZ).

"The Ministry is in talks with Kenya Tea Packers Limited (KETEPA) to set up a common user facility within the SEZ for tea blending, packaging, and value addition," he added. The CS noted that the

tea sector had demonstrated resilience amid declining performance in other export commodities, saying that according to the Economic Survey of 2025, Kenya exported 626,000 metric tonnes of tea in 2024, an 11 percent increase from 564,000 tonnes in 2023.

He further pointed out that export earnings from tea rose marginally from Sh188 billion in 2023 to Sh189 billion in 2024, cementing tea's position as Kenya's second-largest foreign exchange earner.

# Ministry announces revival of National Youth Council elections

The Government has formally announced the commencement of preparations for the long-overdue National Youth Council (NYC) elections, marking the first time the polls will be held since 2012.

The announcement signals a renewed effort by the government to entrench democratic participation among the youth and uphold inclusive representation through transparent governance.

Speaking during a press briefing at the State Department for Youth Affairs and Communities in Nairobi, Principal Secretary Fikirini Jacobs confirmed that the Ministry had received official communication from the Cabinet Secretary authorizing the electoral process.

“We have now received formal communication from the Cabinet Secretary, granting authority to conduct the NYC elections. This gives us the go-ahead to begin structured, inclusive, and transparent preparations,” said Mr. Jacobs. Mr. Jacobs emphasized that the NYC elections are not merely a formality, but

a vital step toward empowering Kenya’s young population to engage actively in governance and policy-making.

He stated that the elections reaffirm the government’s commitment to ensuring that the voices of the youth are not only heard but also reflected in national decision-making platforms. “These elections are not only about leadership; they affirm our collective belief that young people must have a seat at the table in shaping Kenya’s governance and development,” he said. Established under the National Youth Council Act, Cap. 132 of the Laws of Kenya, the NYC serves as the legally recognized umbrella body representing the interests of Kenyan youth.

The Council is composed of eight youth elected through a national process and up to eight others nominated by the Cabinet Secretary responsible for youth affairs. The first NYC election took place in 2012, and while the term of that council was extended once, it eventually lapsed in 2019.

Efforts to hold fresh elections were derailed in 2022 due to the General Election, while a 2023

amendment bill that proposed a transition from elections to a competitive selection model through County Youth Directors was rejected.

Following the Cabinet’s approval in July 2025, the Ministry now has the mandate and resources required to deliver a credible election.

Mr. Jacobs stated that the elections will be conducted in four structured phases. In the first phase, eligible youth candidates must be nominated by at least 50 registered youth voters. At the ward level, each of the 1,450 wards nationwide will elect six delegates three male and three female bringing the

total to 8,700 delegates.

These delegates will then proceed to the constituency level, where two youth (one male and one female) from each of the 290 constituencies will be elected, bringing the number of constituency delegates to 580.

The final stage of the election will take place at the National Youth Congress, where the 580 constituency delegates will elect eight youth to serve as NYC Council members.

The Cabinet Secretary will nominate an additional eight members per the NYC Act, and Congress will also nominate 31 substitute members to support leadership transitions and ensure operational continuity within the Council.

To qualify for election, a youth must be under 35 years of age as of December 31 of the election year, possess a minimum of a secondary school certificate, and provide a police clearance certificate or a letter of recommendation from the local Chief and also Candidates are required to meet the integrity standards outlined under Chapter Six of the Constitution and uphold inclusivity for persons with disabilities.

# Lady builds thriving dairy business from six cows

In the rolling hills of Kasphat, Kiambaa Sub-County, Susan Nduta has built a successful dairy farming enterprise that produces 180 litres of fresh milk daily—demonstrating how modern farming techniques can transform rural livelihoods.

Nduta’s farm is home to six Friesian Holstein cows and three calves, with each mature cow producing an impressive 30 litres of milk per day.

This high-yielding breed has become the backbone of her thriving dairy business, which serves both local communities and commercial suppliers.

The dairy operation has grown to support two full-time employees, creating employment opportunities in the rural area while meeting the increasing demand for fresh milk in the region. The business model combines direct sales to local residents with bulk supply contracts to commercial milk

buyers, ensuring steady income streams.

Nduta explained the key to her success during a recent visit to the farm:

“When I started this dairy business, I focused on getting the right breed and providing proper nutrition for my cows. The Friesian Holstein breed has proven to be excellent for our climate,” she said.

The farm emphasizes proper animal husbandry practices including regular veterinary care, balanced feeding, and maintaining clean milking conditions to ensure high milk quality and quantity.

The operation maintains well-stocked stores of hay and other organic cow feed products to ensure livestock receive consistent, quality nutrition throughout the year.

Douglas Wanjala, one of the farm workers, highlighted the importance of proper care in maintaining high milk production. “The cows are well-fed and healthy, which is why we get consistent milk production every day. Good feeding and clean conditions make all the difference,” he said.

The operation serves dual markets, supplying fresh milk directly to local households while also meeting the demands of commercial milk suppliers who distribute to urban markets. This diversified approach has helped stabilize income and reduce dependence on a single market channel.

Nduta’s efforts demonstrate how agricultural entrepreneurship can drive economic development in rural areas.

# You must deliver services efficiently to citizens, Koskei tells public officers

The Head of Public Service demands for tangible results from public sector workers as citizens expectations from Government rise

The Chief of Staff and Head of Public Service Felix Koskei has reaffirmed the Government's commitment to transform the Public Service into a more accountable and results-driven institution. Mr Koskei said there is no option; public officers must work for the people and be held accountable for their actions.

The official, who spoke during a consultative meeting on July 30, 2025, with all Principal Secretaries, various Heads in Ministries, Departments and Agencies, noted that citizens expectations and demands for tangible outcomes from the Government should be met.

"As I have often said – and I truly believe this – the Public Service is one of the strongest vehicles to help deliver real, meaningful change to our citizens," he said.

To streamline the sector, Mr Koskei said the Government is introducing the "Matrix of Legal Consequences" for violations in Public Service

The framework intends to guide how the Government responds to persistent violations from some public officers.

"We have observed over time, certain issues – ranging from delayed resolution of audit queries to non-compliance with policy directives – continue to recur despite repeated sensitisation and engagement," he said.

These left unaddressed, he said, not only slow down service delivery but also risk undermining public confidence in institutions and the broader reform agenda of the Government.

The Matrix, therefore, is being introduced to cure such violations. "The Matrix is about restoring clarity and timeliness in how we respond to institutional challenges. One concern we have consistently noted is that, in some cases, corrective action is taken long after the act – when the damage is already done. We must shift to a posture of prompt, proportionate and lawful response," he said.

The framework, according to him, is anchored on principles of fairness, consistency and due process, and it aligns with the values set out in Articles 10 and 232 of the Constitution, particularly on integrity, accountability and high standards of professional ethics in Public Service.

The Matrix targets to cure cases of impunity, absenteeism, negligence or chronic under-performance.

Mr Koskei noted that the Matrix applies to all Cabinet Secretaries, Principal Secretaries and senior leadership across the board.

He said the Government made various promises to citizens on efficiency, reforms and better outcomes.

And as President William Ruto's reign reaches its mid-point in the first term, Mr Koskei said that it is critical the promises made must start to translate into tangible impact.

"That is what the President expects. That is what the public deserves. And that is what we must hold ourselves accountable for," he said.

He noted that stories of achievement, of accountability and of prudence in the use of public resources must become the foundation upon which the Government implements its full programme.

"What we need now is a leadership culture that is proactive, firm but fair, and focused on outcomes. One that takes action early, consistently and in line with our values. And that begins with us. Not just as supervisors, but as stewards of public trust. If we act, our teams will follow suit. If we stay silent, we risk normalising indiscipline and inefficiency," he said.

He added, "It should be too dangerous to play with public resources, because every shilling misused is a promise to Kenyans broken."

Mr Koskei reminded all National Government institutions of the need to respect and comply with County Government laws when undertaking development projects within county jurisdictions.

## INFOBOX

## Four Action Points

In line with resolutions of the engagement and directives outlined in the Circular that the Head of Public Service dispatched after the meeting, the following actions were agreed to be undertaken across all Public Service institutions:

- \* **Mandatory Dissemination and Officer Acknowledgement of the Matrix and related guidelines through structured meetings across all institutions. Every officer must sign and acknowledge receipt and understanding.**
- \* **Structured Reporting and Filing of Compliance Returns: Documented proof of dissemination, including signed staff registers, must be submitted to the respective Principal Secretaries. PSs will consolidate these returns and forward them to my Office through the Department of Audit, Legal and Regulatory Compliance. These records will support ongoing tracking and enforcement of directives.**
- \* **Strict Timelines for Execution: All the directives must be concluded in 21 days from the day of the meeting without exception. Delays or non-compliance will themselves constitute infractions subject to disciplinary action.**

He noted with concern that there are some National Government institutions that are still bypassing key requirements, particularly in physical planning and development control.

"You are all aware that County Governments were assigned clear mandates regarding planning, development control, and public works. These include approval of development plans, issuance of building permits, and enforcement of zoning regulations," he said.

Therefore, he directed that all State Corporations and Agencies must engage County Governments while undertaking development projects within county jurisdictions at every stage of project planning and execution.

He added that all development proposals must be professionally prepared, lawfully approved and subjected to Environmental and Social Impact Assessments (ESIAs).

He ordered that projects already underway without approvals must be regularised by December 31, 2025, with compliance audits submitted by June 30, 2026. ■



# East Africa displays good preps, football prowess as CHAN starts

Host nations showcase not only football mastery but also exceptional preparations as tournament starts

East African teams registered a good start in the African Nations Championships (CHAN) 2024, with Kenya beating DR Congo 1-0 and Tanzania routing Burkina Faso 2-0.

With the region being the host of the tournament, there is a lot of expectations from fans in Kenya, Uganda and Tanzania.

Regional pride has soared as fans from Nairobi, Dar es Salaam and Kampala rally behind their teams with renewed optimism.

Stadiums in the three countries were packed to the brim in the opening matches, with fans singing, dancing and cheering the teams from the start of the games to the end.

And the teams did not disappoint; Harambee Stars goal was scored by Austin Odhiambo in the final minutes of the first half, throwing the stadium into frenzy.

Harambee Stars held onto the crucial goal in the second half, defying spirited efforts by DR Congo to equalise.

For the win, each Harambee Stars player pockets Sh1 million as promised by President William Ruto.

The match was a perfect start for Kenya as Harambee Stars started their Group A campaign against the two-time CHAN champions.

In Tanzania, Taifa Stars goal scorers were Abdul Sopo through a penalty in the first half and defender Mohamed Hussein in the second half.

The strong opening performances have not only sparked dreams of reaching the knock-out stages for the teams but also stoked hopes that East Africa could finally carve out its right legacy in continental football.

The smooth start of the tournament shows how the preparations made by the three East African countries have paid off.

For Kenya, the Government improved the infrastructure of both Nyayo and Kasarani Stadiums, the venues of the games.

This included the refurbishment of seats, upgrading of floodlights and introduction of cutting-edge pitch technology to meet CAF standards.

VAR was used in the Kenyan game with DR Congo, with the referee reviewing a goal by the latter in the fifth minute and disallowing it due to offside.

The Government further revamped training


grounds to accommodate visiting teams, ensuring top-tier facilities for every player, from warm-up sessions to tactical drills.






## Kenya races to meet EU deforestation rules ahead of December 2025 deadline

Kenya is expected to fully comply with the European Union Deforestation Regulation (EUDR) by 30th December 2025, in its bid to continue exporting products to the European Union (EU) market.

Agriculture and Food Authority (AFA) Director General, Dr. Bruno Linyiru, said the EUDR requires all companies exporting agricultural products to the EU to prove that their goods were not produced as a result of deforestation.

“These products must be traceable to land that has not been deforested since 31st December 2020,” he added.

Dr. Linyiru noted that the regulation applies to commodities linked to deforestation, such as coffee, cocoa, soy, beef, palm oil, rubber, and wood.

To implement the regulation, Dr. Linyiru said the Ministry of Agriculture and Livestock Development has initiated a process to map all parcels of land under coffee farming.

“Approximately 30 per cent of the national coffee area in 16 counties out of 33, has been Geo-Mapped using satellite imagery.

This represents 32,688 Ha of the total 109,384 Ha coffee area countrywide,” he

added.

According to him, the remaining areas will be mapped by several teams under the EUDR Data Committee: State Department of Agriculture (SDA), State Department for Cooperatives, Kenya Forest Service (KFS), Kenya Space Agency (KSA), Directorate of Remote Survey and Remote Sensing (DRSRS) and Kenya Agriculture and Livestock Research Organization (KALRO), under AFA supervision.

Dr. Linyiru added that the exercise is part of AFA's mandate as the regulator of

scheduled crops under the Crops Act, 2013.

“The regulation was initially set to take effect by 30th December 2024, but the EU extended the deadline to 2025,” he said

He explained that the EUDR aims to ensure that products traded and consumed in the EU and globally do not contribute to

forest degradation.

Kenya exports 95 per cent of its coffee, with approximately 55 per cent targeting the EU, mainly Belgium, Germany, Sweden, and Finland.

Over the past five years, Kenya exported 122,699 Metric Tonnes (MT) of clean coffee to the EU, valued at USD 695.7 million, equivalent to about Sh90 billion.

Smallholder farmers contribute approximately 60 per cent of Kenya's total coffee production, forming the backbone of the rural economy in 33 coffee-growing counties.

## Uasin Gishu exports first batch of Ayrshire heifers to Nigeria

Uasin Gishu County's livestock industry has received a major boost following the airlifting of 50 in-calf Ayrshire heifers to Nigeria, marking a significant step in the county's mission to economically empower local farmers and position itself as a leader in quality livestock breeding.

The heifers, sourced by Kinanie Agrovet Suppliers from farmers across the county, were flown out of Eldoret International Air-

port—marking the county's first-ever export of quality livestock breeds to West Africa.

This achievement represents a key milestone in Governor Jonathan Bii's Nguzo Kumi agenda, which he unveiled during his campaigns to transform agriculture and enhance farmers' economic well-being.

“Continued investment in livestock development by the county government aligns with the Governor's goal to make Uasin Gishu a regional hub for livestock

breeding and international trade through a modern, farmer-focused approach to agriculture,” said the County Chief Officer for Agriculture and Livestock Development, Eng. Abraham Kiptalam.

“This is the result of the county government's commitment to modernis-

ing livestock development and encouraging farmers to manage agriculture as a business,” he added.

He further noted that the county has subsidised artificial insemination (AI) services and revamped cattle dips to enhance disease control and extension support.

### Salient School to make way for new university

Salient Secondary School in Kaptein Ward, Ol Kalou Constituency, Nyandarua County, is set to be phased out to pave the way for the establishment of Nyandarua University College.

This follows a public participation forum led by Nyandarua Governor Kiarie Badilisha, which proposed relocating the university from its initially proposed site at the Ol Joro Orok Agricultural Training Centre to Salient High School. The move aims to meet the requirements of the Commission for University Education.

The institution will be the first university in the region, as Nyandarua is the only county in the Mount Kenya Region without a university.

According to Governor Badilisha, over 300 students currently enrolled at Salient High School will be transferred to neighboring schools starting next year. The university is expected to admit its first cohort of

students in September this year.

“This is a major milestone for the people of Nyandarua. We saw it fit to conduct a public participation exercise, and the residents unanimously agreed to close the school to make way for a university—something we have long desired,” said Governor Badilisha.

The university will begin as a constituent college of the University of Nairobi, with the Governor assuring locals that all necessary preparations to ensure smooth operations are complete. The campus will be constructed on a 50-acre parcel of land coupled with an extra land out of the Salient Secondary School grounds, with funding from both the national and county governments.

Area MP David Kiaraho and Nyandarua Senator John Methu urged residents to support the initiative and not politicize the decision to close Salient Secondary School saying that the benefits outweigh the consequences.

### Kenya-Pakistan forum targets boost in trade

Kenya and Pakistan have renewed their commitment to deepening bilateral trade and investment ties.

This agreement was reached during a high-level Pakistan-Kenya Business Council (PKBC) Importers Networking Forum held in Nairobi, which aimed to reinforce bilateral relations through expanded economic cooperation, diversified exports, and strengthened private sector linkages.

Speaking at the forum, themed “Unlocking Trade, Investment, and Cultural Opportunities between Kenya and Pakistan,” Principal Secretary for Trade Regina Ombam described the gathering as a timely opportunity to enhance cooperation between the two nations.

She noted that the presence of government officials, importers, exporters, insurers, financiers, and logistics experts underscored the strategic intent to pursue a future of shared prosperity.

“Kenya and Pakistan have enjoyed warm and enduring relations since

1963,” stated Ombam, citing educational cooperation under the Pakistan Technical Assistance Programme and signed Memoranda of Understanding in tourism, agriculture, ICT, and vocational training.

Additionally, she said, “Our economies are complementary, and this relationship presents untapped potential.” In 2024, bilateral trade stood at approximately USD 910 million, up from USD 752.6 million the previous year. Kenya's tea accounts for over 80 percent of exports to Pakistan, while Pakistan remains a key supplier to Kenya of cereals, pharmaceuticals and surgical equipment.

However, the PS underscored the need to diversify Kenya's export base to include horticulture, nuts, textiles, and processed foods, and stressed the urgency of moving beyond raw trade to value-added manufacturing.

She also encouraged joint investments in sectors like agro-processing, ICT, renewable energy, and logistics by exploiting Kenya's strategic position in AfCFTA.
