(HoAGW4RP)**, and intends to apply part of the proceeds toward payments under the contracts for **KE-GARISSA-545156-CW-RFB-LOT I** and **KE-GARISSA-545162-CW-RFB-LOT II**.
2. The County Government of Garissa - Garissa Rural Water and Sanitation Company Limited (**GARUWASCO**) now invites sealed Bids from eligible Bidders for the following projects:
